Senate Joint Resolution No. 1, offered by Senator 5. Buzbee. 6. PRESIDENT: 7. For what purpose does Senator Buzbee arise? 8. SENATOR BUZBEE: 9. Mr. President, if I could have the attention of the 10. membership just a second. Senate Joint Resolution No. 11. 1, which I have just introduced into this Special Session, 12. deals with one of the calls of this Special Session and that 13. is the State Board of Elections. What Senate Joint Resolution 14. No. 1 would do is it would eliminate that section of the 15. Constitution which created the State Board of Elections. 16. This year, the State Board of Elections asking...asked for 17. 2.8 million dollars in their appropriation bill. We reduced 18. it to 2.6 million. The last year that the election function 19. was contained in the Index Division of the Secretary 20. of State's Office, it cost us one hundred thousand dollars. 21. And so as a result, we can see that the costs have increased 22. twenty-six times in about four years. Now, in my opinion, 23. this is not the time to debate the issue, obviously, but 24. in my opinion, the twenty-six time cost increase is certainly 25. not merited considering the political haggling and political 26. patronage hiring that's been going on in the State Board of 27. Elections both at the contractual level and at the employee 28. level. We can put it back in the Secretary of State's 29. Office and the Index Division for about a hundred to a hundred 30. and fifty thousand a year and run these elections the way 31. they're supposed to be run. So, what I'm...the reason I'm 32. making this point at this time is that I am asking anybody...

all of you who have complained and I've heard many of you

complain loud and vociferously and long about the State ı. Board of Elections. This will give you the opportunity to 2. do the ultimate. We can finally sever that unneeded body 3. from the halls of Government of Illinois and I'd 4. like to ask you to join me in cosponsoring Senate Joint 5. Resolution No. 1 which will do away with the State Board 6. of Elections and then we can statutorily put it back where 7. it can be done efficiently and without all of the 8. patronage abuse that we've seen in the present State 9. Board of Elections. Thank you. 10. PRESIDENT: 11. For what purpose does Senator Graham arise? 12. SENATOR GRAHAM: 13. I would like to arise to answer partially some of the 14. statements made by the Senator indroducing the resolution. 15. I'd like to suggest, Senator Buzbee, that I have my feelings 16. about the State Board of Elections to have had in the past 17. and I'm not their great defender by any manner or means, but 18. as long as we're going to gore an animal, let's do it with 19. some finesse. Now, the hundred thousand dollars or whatever 20. you're talking about when the Index Bureau had it the last 21. time, that expense was not...did not...their obligation did not 22. incur financial disclosure and economic statements and many of 23. those other things that we voted upon ourselves because of newspaper

pressure and we give them that burden. Now, don't try to kid

anybody that wherever this thing goes, we're going to get by for
26.

a hundred thousand dollars. Now, let's be fair about it.

And wherever this goes, whatever department it goes in, I'm
