- 1. is adopted. A Message from the Governor.
- 2. SECRETARY:
- 3. To the Honorable members of the Senate, the 80th
- 4. General Assembly.
- 5. On October 23rd, 1977, I submitted the name of Mabrey
- 6. Robey to your Honorable Body for its advise and consent to
- 7. his appointment as State Equal Opportunity Officer. I must
- 8. now withdraw that nomination because it has come to light
- 9. that when this office was created by Public Act 79-1153
- 10. the legislation failed to specify a salary for the position.
- 11. Thus, were Mr. Robey to be confirmed he would not be entitled
- 12. to the monetary...remuneration for his work. The position
- 13. requires full time employment with a salary...commensurate
- 14. with duties imposed. Since it is unfair to ask Mr. Robey
- 15. to perform these important duties for no compensation, I
- 16. have requested that Mr. Robey and Mr. Robey has tendered
- 17. his resignation as State Equal Employment Opportunity Officer.
- 18. However, he will continue to perform the duties of the office
- 19. for State agencies under the direction of the Department
- 20. of Personnel. In order to make the State Equal... Employment
- 21. Opportunity Officer a useful position, I urge that Public
- 22. Act 79-1153 be amended to provide a salary for the office.

- 24. PRESIDING OFFICER: (SENATOR ROCK)
- 25. Resolutions.
- 26. SECRETARY:
- 27. Senate Resolution 241 offered by Senators Walsh and
- 28. Rock. It's congratulatory.
- 29. Senate Resolution 242 offered by Senator Nimrod. It's
- 30. congratulatory.
- 31. Senate Resolution 243 offered by Senator Demuzio, Hynes
- 32. and all members. It's congratulatory.
- 33. Senate Resolution 244 offered by Senators Mitchler and

- Sangmeister. And it's congratulatory.
- 2. PRESIDING OFFICER: (SENATOR ROCK)
- Is there leave to place those resolutions on the Consent
- 4. Calendar? Leave is granted. So ordered.
- 5. SECRETARY:
- Senate Resolution 245 introduced by Senator D'Arco.
- 7. PRESIDING OFFICER: (SENATOR ROCK)
- 8. Executive. Senator D'Arco, for what purpose do you
- 9. arise?
- 10. SENATOR D'ARCO:
- 11. It's my understanding, Mr. Chairman, I mean Mr. President,
- 12. that Exec is notgoing to meet. Is it possible to suspend the
- 13. rules and have that resolution rereferred to Judiciary so I
- 14. could have it heard tomorrow sometime? Because Exec. is not
- 15. going to meet, I mean. I would appreciate that.
- 16. PRESIDING OFFICER: (SENATOR ROCK)
- 17. Well, the...the matter...while not, apparently, controversial
- 18. is substantive...as opposed to congratulatory. And in the
- 19. ordinary course of Senate business would be referred to the
- 20. Senate Executive Committee, as the Chair has ordered. You are
- 21. perfectly in order to make a motion to suspend the rules and
- 22. either ask for the immediate consideration or ask for a rereferral
- 23. to that committee that you deem properly equipped to handle this
- 24. resolution. That...that motion is certainly in order. Perhaps,
- 25. if you would explain the resolution, that might generate less
- 26. heat.
- 27. SENATOR D'ARCO:
- 28. I'm not sure which resolution this is. I have two of them.
- 29. PRESIDING OFFICER: (SENATOR ROCK)
- 30. Well...
- 31. SENATOR D'ARCO:
- 32. Is this the one with the heat or without the heat?
- 33. PRESIDING OFFICER: (SENATOR ROCK)

- 1. This...this is the one referring to the operation of the
- Criminal Justice Referral System of the Chicago Bar Association.
- 3. SENATOR D'ARCO:
- 4. Yes.
- 5. PRESIDING OFFICER: (SENATOR ROCK)
- I don't know if that's the heat or the other one is
- 7. worse. I...
- 8. SENATOR D'ARCO:
- Right. What this does, all it says is that there seems
- 10. to be some discrepancies in the Criminal Justice Referral
- System, as to who, in fact, is being referred by the
- 12. system to the courts and the Circuit Court of Cook County.
- And the question becomes whether or not we should, as a
- legislative Body, look into this situation to, in fact,
- 15. determine if there is some discrepancies involved and whether
- 16. or not they are doing what their purpose was originally set
- out to do, which was to help young budding attorneys trying
- 17. out to do, which was so that I is to make a living having them assigned to particular courts
- 19. in order to generate some business for them. The ... the question
- 20. that's being generated is being generated by attorneys that
- have been around for a long time and the young attorneys
- 21. who have somewhat limited experience and need the money are
- 23. not getting the business from this Criminal Justice Referral
- 24. System and that was the original intent of this system. And
- 25. I think there might be some question whether they're, truthfully,
- 26. carrying out what they intended in the purpose that created
- 27. this system. So that's primarily what this resolution does
- 28. and it...what it asks for is a Legislative Committee to be
- 29. appointed to investigate the system with subpoena power in
- 30. order to, if necessary, subpoena some of the records and
- documents of the system and subpoena some of the witnesses
 that work in the system to determine what, in fact, is going
- on within this system. So that's what it does. Now, I would

- 1. like to have it either heard immediately or if you would so
- 2. desire, I would have it heard in Judic II and whatever is the
- 3. ...what the Body decides I'll go along with and...
- 4. PRESIDING OFFICER: (SENATOR ROCK)
- 5. Senator Shapiro.
- 6. SENATOR SHAPIRO:
- Well, I would like to respectfully suggest that we suspend
- 8. the rules so this can be heard in committee. I think it's far too
- 9. complex to bring before the Body for judgment at this time.
- 10. And I understand Judiciary II is meeting this evening.
- 11. PRESIDING OFFICER: (SENATOR ROCK)
- 12. My understanding was tomorrow, but either way I think
- 13. the Senator...he agrees it should go to committee, but he
- 14. was concerned that Exec was not scheduled. Senator D'Arco
- 15. has moved to suspend the rules and have this Senate Resolution
- 16. referred to the Committee on Judiciary II. All those in favor
- 17. signify by saying Aye. All those opposed. The Ayes have it.
- 18. So ordered. Resolutions. Senator Berning, for what purpose
- 19. do you arise? Berning.
- 20. SENATOR BERNING:
- 21. Point of information, Mr. President. I seem...I seem to
- 22. gather from the earlier discussion that there will be no
- 23. Senate Executive Committee meeting. What that means, I don't
- 24. know. Forever or just this week.
- 25. PRESIDING OFFICER: (SENATOR ROCK)
- 26. I...I would assume that just this week.
- 27. SENATOR BERNING:
- 28. I have a resolution also, which is much less complex
- 29. than Senator D'Arco's. I would very much like to have
- 30. action on it. Is there a committee which could consider
- 31. that? Or when will Executive meet? Can we find that out?
- 32. PRESIDING OFFICER: (SENATOR ROCK)
- Well, I...I do not see the Chairman, frankly, in his

- place. Might...might we defer that question until the
- Chairman of Executive comes back. I'm sure that meetings
- will...we will in fact have meetings. It's on...we are
- 4. in, as you well know, Annual Session and I'm sure the committee
- as a standing committee will meet.
- SENATOR BERNING:
- Well, that...that would be my normal assumption. That's
- 8. what intrigued me when the comment was made that there would
- 9. be no meeting. If there will be a meeting then fine. Then it
- would accomodate Senator D'Arco as well.
- 11. PRESIDING OFFICER: (SENATOR ROCK)
- 12. All right. Resolutions.
- 13. SECRETARY:
- 14. Senate Resolution 246 introduced by Senator D'Arco.
- 15. PRESIDING OFFICER: (SENATOR ROCK)
- 16. Senator D'Arco.
- 17. SENATOR D'ARCO:
- 18. This is basically a non controversial resolution. All
- 19. it says is that the Congress of the United States should
- 20. recognize Taiwan as the...
- 21. PRESIDING OFFICER: (SENATOR ROCK)
- 22. Executive. Resolutions.
- 23. SECRETARY:
- 24. Senate Joint Resolution 57 offered by Senators Buzbee,
- 25. Carroll, Sommer and Regner.
- 26. PRESIDING OFFICER: (SENATOR ROCK)
- 27. Senator Buzbee.
- 28. SENATOR BUZBEE:
- 29. Thank you, Mr. President. Mr. President, this is the
- 30. resolution which would create the Joint Committee on Financial
- 31. Management Systems consisting of four members of the Senate.
- 32. Two appointed by the President. Two appointed by the Minority
- 33. Leader and four members of the House. Two appointed by the

- Speaker and two appointed by the Minority Leader. The
- committee would meet and choose and study the feasibility
- 3. and cost of establishing a Legislative Financial Manage-
- ment System. I am now moving at this time to discharge the
- committee and bring it to the proper order where we can
- 6. act upon it. Leadership on both sides is aware of this.
- And I believe have...I have their concurrence.
- 8. PRESIDING OFFICER: (SENATOR ROCK)
- All right. I think the proper motion will be to suspend
- 10. the rules for the immediate consideration and adoption of
- ll. Senate Joint Resolution 57. You've heard the motion. All
- 12. those in favor signify by saying Aye. All those opposed.
- 13. The Ayes have it. The rules are suspended. Senator Buzbee
- 14. now moves the adoption of Senate Joint Resolution 57. Is
- 15. there any discussion? All those in favor signify by saying
- 16. Aye. All those opposed. The Ayes have it. The resolution
- 17. is adopted. Senator Netsch for what purpose do you arise?
- 18. Senator Netsch.
- 19. SENATOR NETSCH:
- 20. Thank you. Since the subject came up in connection with
- 21. Senator D'Arco's motion, I think I might just make the announce-
- 22. ment right now and I will try to repeat it later on also. We...
- 23. Judiciary II is not going to meet this evening. We're going
- 24. to meet at two o'clock tomorrow. Senator Bowers is aware of
- 25. that and Senator Roe is aware of that and I would just simply
- 26. call it to the attention of all the members of Judiciary II.
- 27. PRESIDING OFFICER: (SENATOR ROCK)
- 28. All right. The Chair would like to point out that
- 29. Senator Netsch was, again, out of order in terms of an
- 30. announcement. We are not about to break up. We have yet
- 31. to hit the Calendar, so let's bear that in mind. Senator
- 32. Nimrod for what purpose do you arise?
- 33. SENATOR NIMROD:

- 1. Yes, Mr. President, we're...we're on the order of
- resolution and motions. Is it proper to make a motion at
- 3. this time to discharge the committee on...on the bill?
- 4. PRESIDING OFFICER: (SENATOR ROCK)
- We are...we are not on the Order of Motion. We are
- 6. on the Order of Resolutions. We will get to the Order of
- 7. Motions. On the Order of Senate Bills, 3rd reading. Ring
- 8. the bell, Mr. Sergeant-at-Arms. Senate Bill 1390. On the
- Order of Senate Bills, 3rd reading, Senate Bill 1390. Senator
- 10. Vadalabene. Read the bill, Mr. Secretary.
- 11. SECRETARY:
- 12. Senate Bill 1390.
- 13. (Secretary reads title of bill)
- 14. 3rd reading of the bill.
- 15. PRESIDING OFFICER: (SENATOR ROCK)
- 16. Senator Vadalabene.
- 17. SENATOR VADALABENE:
- 18. Yes, thank you, Mr. President and members of the Senate.
- 19. Senate Bill 1390 comes under the conformance of Public Act 880
- 20. 20 signed by Governor Thompson on June 3rd, 1977 appropriated
- 21. two hundred and fifty-two thousand dollars to the Capital
- 22. Development Board for necessary repairs to the 5th District
- 23. Appellate Court building located in Mt. Vernon, Illinois. This
- 24. building is more than a hundred and fifty years old and has
- 25. been designated as a National Historic Site. The beams
- 26. supporting the roof are falling in from age and it has been
- 27. necessary to prop up the roof to keep it from collapsing
- 28. The Capital Developement Board is presently in the process
- 29. of obtaining contracts to do the rehabilitation work. Senate
- 30. Bill 1390 is a bookkeeping procedure within the appropriation
- 31. of the Capital Developement Board to permit them to seek re-
- 32. imbursement up to sixty-three thousand dollars from Federal
- 33. funds granted to the Illinois Conservation Department for

- 1. preservation of National Historic Sites in Illinois. There
- 2. is no new money involved in Senate Bill 1390 and after it is
- passed it will be, in effect, recover sixty-three thousand
- 4. dollars of the funds spent on the building from the Federal
- 5. grant and I would appreciate a favorable vote.
- 6. PRESIDING OFFICER: (SENATOR ROCK)
- 7. Any discussion? The question is, shall Senate Bill
- 8. 1390 pass. Those in favor will vote Aye. Those opposed
- 9. will vote Nay. The voting is open. Have all voted who
- 10. wish? Have all voted who wish? Take the record. On that
- 11. question, the Ayes are 54, the Nays are None. None Voting
- 12. Present. Senate Bill 1390 having received the constitutional
- 13. majority is declared passed. On the Order of Senate Bills,
- 3rd reading, Senate Bill 1391. Read the bill, Mr. Secretary.
- 15. SECRETARY:
- 16. Senate Bill 1391.
- 17. (Secretary reads title of bill)
- 18. 3rd reading of the bill.
- 19. PRESIDING OFFICER: (SENATOR ROCK)
- 20. Senator Vadalabene.
- 21. SENATOR VADALABENE:
- Yes, thank you, Mr. President and members of the Senate.
- 23. Senate Bill 1391 amends the appropriation to the Supreme Court
- for the operation of the 5th District Appellate ... Appellate Clerk
- 25. to provide for an additional twenty-seven thousand four hundred
- 26. and sixty-five dollars which is necessitated by reason of the
- fact that it has now become absolutely imperative that the
- 28. building be vacated until after it is repaired because it
- has been declared to be unsafe by the structural engineers
- employed both by the administrative office and the Capital
- Development Board. They have made arrangements to relocate
- 32. the 5th DistrictAppellate Court in a building across the
- street from the Appellate Court Building and have entered into

- a lease for a one year period to permit the repairs to be
- made at a monthly rental of fourteen hundred and fifty-five
- 3. dollars and forty-two cents. Seventeen thousand four hundred
- 4. and sixty-five of additional funds sought in the bill are for
- 5. rental payments, two thousand dollars are for telecommunications
- 6. in the temporary building and approximately three thousand
- dollars are moving expenses into the temporary building and
- then back into the Appellate Court Building after it is repaired.
- 9. And the rest of the twenty-seven thousand dollar appropriation
- 10. is for utility costs in the temporary building. It is vitally
- important that these bills be passed and signed by the
- 12. Governor and I would appreciate a favorable vote.
- 13. PRESIDING OFFICER: (SENATOR ROCK)
- 14. Is there any discussion? Senator Regner.
- 15. SENATOR REGNER:
- 16. Yes, Mr. President and members of the Senate. What
- 17. Senator Sam just said is that this is a moving expense for the
- 18. building we already approved.
- 19. PRESIDING OFFICER: (SENATOR ROCK)
- 20. Further discussion? Question is, shall Senate Bill 1391
- 21. pass. Those in favor will vote Aye. Those opposed will vote
- 22. Nay. The voting is open. Have all voted who wish? Have all
- 23. voted who wish? Take the record. On that question, the Ayes
- 24. are 55, the Nays are None. None Voting Present. Senate Bill
- 25. 1391 having received the constitutional majority is declared

- 4. I move to...I move that Senate Bill No. 24 Do Pass, the

- 9. SENATOR GROTBERG:
- 10. Thank you, Mr. President. Senate Bill 24 went out of
- 11. this Chamber 49 to nothing and went out of the House some
- 12. 167 to nothing creating the...an exemption under the Securities
- 13. Act for Small Town Redevelopment Corporations so that they do
- 14. not have to go through full cost of registration. Was an
- 15. excellent bill and everyone in this General Assembly thought
- 16. it was and after a long talk with the Governor last Monday
- 17. morning he thinks it's pretty good now and has no particular
- 18. objection to it. I can't understand, really, why it was
- 19. vetoed because it was initialed okay and evidently got caught
- 20. in the switches in his office. I can only tell you what he
- 21. told me as we sat down and talked. He would prefer no overrides
- 22. of any of his bills, I'm sure, but on this one he has...has
- 23. softened his position and I would encourage all...all Republicans
- 24. and Democrats alike to help me get the necessary 36 votes to
- 25. restore. This is four years of hard work that just went down
- 26. the chute in error and I would appreciate a roll call.

- 13. PRESIDING OFFICER: (SENATOR ROCK)
- 14. Senator Donnewald.
- 15. SENATOR DONNEWALD:
- 16. Yes, Mr. President. I...I think that everyone in the
- 17. chamber is fully aware of what the bill was intended to do
- 18. as it passed originally from this Body and then over to the
- 19. House and subsequently passed that Body. And was sent to the
- 20. Governor and vetoed. Now, Mr. President, may I have some
- 21. order?
- 22. PRESIDING OFFICER: (SENATOR ROCK)
- 23. Will the members please be in their seats? Those not
- entitled to the Floor please vacate. Senator Donnewald.
- 25. SENATOR DONNEWALD:
- 26. The bill was introduced on March the 16th of this year
- 27. and after the bill had been introduced I called together
- 28. members of the Pollution Control Board and also members of
- 29. the Illinois Environmental Protection Agency, plus the coal
- 30. industry members, plus the members of the Association of
- 31. Electric Cooperatives. At that time I requested that the
- 32. bill, as introduced, be amended to the satisfaction of all
- 33. parties. For a month and a half there was discussion between

those parties. After the month and a half had expired they
l.
      came to me and determined it and explained that they had
2.
      reached agreement. I, then, pursued the bill on the Order
3.
      of 2nd reading, adopted the amendments that they requested
4.
      and then the bill went to the Order of 3rd reading and passed
5.
      with some forty votes and seven in opposition. 42 to 7 I'm
6.
             Now, Mr. President, after the bill left this Chamber
7.
      it went to the House and then the Chairman of the Pollution
8.
      Control Board began to write many, many letters and the
9.
      media both...the printed media, principally, took up the
10.
      call...the argument that the Chairman of the Pollution Control
11.
      Board did make. And I might add, Mr. President, that they...
12.
      the arguments made are certainly not justified and I feel
13.
       compelled, Mr. President and members of this Body, to
14.
       attempt to override the bill that Governor Thompson has, in
15.
       fact, vetoed. There are several items that I need call your
16.
       attention, you'll...you'll note that I have distributed from
17.
       the...to the various members materials pertinent or relative
18.
       to this bill. I think there are several items that should be
19.
       responded to. In the bill, 281, the Governor stated in his
20.
      V eto Message that it alters the intent of the original
21.
       Environmental Protection Act that regulations be based on
 22.
       technical findings. My response to that is, the bill...bill
 23.
       merely requires the Illinois regulations to be...no more
 24.
       stringent than necessary to meet the Federal standards.
 25.
       regulations necessary to implement Senate Bill
 26.
        281 had been the subject of public hearings for three years
 27.
       before the Illinois Pollution Control Board. And that is on
 28.
        docket No. R75-5. In spite of that three years they have
 29.
        never come to any conclusion. This bill seeks to do that
 30.
        very thing and that was one of the principal reasons.
 31.
        the bill, as introduced does not affect Northeastern Illinois,
```

the Peoria...area and the metroeast area. This only applies

32.

to those areas other than those mentioned in downstate Illinois. l. The Governor also stated in his message and Mr. Dumelle 2. Chairman of the Pollution Control Board stated that there is 3. increasing evidence that soy beans and corn are sensitive to 4. acid rainfall. Well, my response to that is there's no con-5. clusive evidence that acid rainfall adversly affects the crops. 6. Researchers from Oak Ridge National Laboratory have stated that 7. even in the event of the worst set of conditions they cannot 8. prove that they do, in fact, harm crops. Senate Bill...Chair-9. man Dumelle also states, Mr. President, that Senate Bill 281 10. could prevent protection of Illinois agriculture, if needed, from 11. acid rain effects. Now in response to that, very little research 12. has been done concerning acid rainfall. Nitrogen fixation in 13. soy beans. This is by Mr. Pat Irving, doctoral student conduct-14. ing the...the field research in Illinois for the Argonne National 15. Laboratory. It is also stated in the Collinsville Herald, quote 16. "it is questionable whether acid rain has a definite affect on 17. Now Mr. Dumelle also stated in the October...27th 18. statement, quote "truthfully we don't have exact information 19. on the effect on crops or acid rain. We don't have a decent 20. modering network." The Governor also stated that most electric 21. generation stations outside the major metropolitan areas 22. already are using Illinois coal, all but one are meeting the 23. Pollution Control Board 's present standards. Now this is 24. quite important. Responding to that, it is not true that all 25. but one of the electric generating stations located outside the 26. major metropolitan areas are meeting present board standards. 27. Six plants cannot meet the present rule. The agency and the 28. board neglect to mention that some existing power plants located 29. in rural areas are burning higher cost, lower sulfur content 30. western produced coal are operating at a reduced output. I'm 31. not talking about the present standards. I'm talking about 32. the proposed new standards now being considered by the Illinois 33.

- l. Pollution Control Board. It is estimated that eleven of the
- seventeen existing coal fired stations will not meet the new
- limit proposed by the agency under Rule 204E1. These include
- Central Illinois Public Service Company, Illinois Power
- 5. Company, Baldwin; Commonwealth Edison Company, Kincaid and
- 6. Dixon; Electric Energy Incorporated, Joppa; Southern Illinois
- Power Cooperative, Marion; City, Water, Light and Power,
- 8. Springfield; Fairfield Municipal Power Station, Western
- 9. Illinois Power Cooperative at...Pearl Power Station. These
- 10. utility plants plus many private industries will have to turn
- 11. to imported, higher cost, low sulfur content western produced
- 12. coal or install scrubbers if they are to meet the PCB's
- 13. proposed regulations. Mr. Dumelle also stated no additional
- 14. use of Illinois coal would result from Senate Bill 281. Al
- 15. rural power plants in Illinois now use Illinois coal. Response
- 16. to that in a letter June 16th, 1977 from Patrick E. Lynch,
- 17. Deputy Director of the Illinois...Environmental Protection
- 18. Agency to Senator Hynes and myself and many others and I quote,
- 19. "these provisions will certainly assure the continued use of
- 20. Illinois coal where it is currently used and could provide
- 21. for substantially increased use of Illinois coal. They will
- 22. also remove the considerable regulatory uncertainty that now
- 23. exists. During 1976 fifty...fifty-six percent of Illinois
- 24. produced coal was shipped out of State. Yet, production
- 25. declined. Illinois is losing its in-State and out-of-State
- 26. markets to western produced coal, according to our own Illinois
- 27. State Geological Survey. Mr. Dumelle also stated and I'm
- 28. going to try to be very brief with this, this part. That
- 29. portions of Senate Bill 281 are clearly not allowable under
- 30. the Clean Air Act amendments approved by the President in
- 31. August of 1977. Intermittent Control System, for example,
- 32. are not permitted in lieu of Constant Emission Source
- 33. Controls. The response to that, the Clean Air Act amendments

- of 1977 do not affect Senate Bill 281. I could go on. Mr.
- Demille also stated that Senate Bill 281 would mandate State
- emission limits, such as being Illinois air quality...bringing
- air...air quality to the very edge of the health standards
- for sulfur dioxide. The response to that particular comment,
- the regulation to implement Senate Bill 281 will reduce sulfur
- dioxide emissions at eleven of seventeen power plants proposed
- 8. by Rule 204. Well, Ladies and Gentlemen of the Senate, I have
- a great deal more material. I think that the...I think that
- 10. you've been fully advised of exactly what this bill does. It
- 11. allows...it allows our coal producers in Illinois to sell our
- 12. product to Illinois. Now the argument that many of you
- 13. probably received, also stated that the sulfur emissions
- 14. have caused twenty-one thousand deaths throughtout the
- 15. continental United States. Well, Ladies and Gentlmen, that
- 16. may or may not be true. It can't be proven. But there are
- 17. many, many, many more people that have died because of secondary
- 18. inhalation of tobacco smoke. And I hear Amen. Well, Mr.
- 19. President, with that I would now move that the motion that I
- 20. made as to the override of the Governor's Veto, Senate Bill
- 21. 281, be adopted. Thank you.
- 22. PRESIDING OFFICER: (SENATOR ROCK)
- 23. Any discussion? Senator Glass.
- 24. SENATOR GLASS:
- 25. Thank you, Mr. President and Ladies and Gentlmen. I
- 26. oppose Senator Donnewald's motion and I would like to point
- 27. out, briefly, three reasons. As the Governor in his veto
- 28. message notes, this would change the policy of our Act, where-
- 29. by we ask for detailed studies and examinations before regulations
- 30. are promulgated. This would simply require us to accept the
- 31. Federal mandate and as he points out the national standards
- 32. only consider the health effects of sulfur dioxide as a gas
- and not the effects of the associated sulfate and acid rain.

- 1. But...but on the...on the impact that it is supposed to
- 2. have on...on the coal industry and maybe Senator Donnewald
- 3. would like to comment on this in closing if it's in error,
- 4. but the Governor says that he is aware of those arguments,
- 5. but that they're without merit because most electric
- 6. generating stations outside the major metropolitan areas
- 7. already are using Illinois coal and all but one meet the
- 8. present standards. And if that's true, and since this bill
- 9. only applies to areas outside the metropolitan area, I don't
- 10. ...I don't see how it's going to increase the...the coal
- 11. use. But maybe I'm missing something if Senator Donnewald
- 12. would care to comment on that. But I think we ought to give
- 13. the board an opportunity to finish the work that is now in
- 14. progress. And...and the Governor knows that he has asked
- 15. the agency to expedite that work. And they are, apparently,
- 16. working on new standards and then they may have even, I guess
- 17. they haven't promulgated them yet, but he has indicated his
- 18. desire that our agency finishes work on these and I, therefore,
- 19. think passage of this bill is premature and the veto is a good
- 20. one and should be sustained.
- 21. PRESIDING OFFICER: (SENATOR ROCK)
- 22. Further discussion? Senator Shapiro.
- 23. SENATOR SHAPIRO:
- 24. I just want to point out to the assembly that this Senator
- 25. Donnewald's presentation is the longest that I've ever heard
- 26. him read.
- 27. PRESIDING OFFICER: (SENATOR ROCK)
- 28. Further discussion? Senator Wooten.
- 29. SENATOR WOOTEN:
- 30. Thank you, Mr. President. I just want to add to this that
- 31. the question of sulfur rain, of acid rain is a very difficult
- one to deal with and it takes a little, I suppose, a look
- 33. beyond our borders. The effect of acid rain is not felt in

- 1. Illinois. We merely help generate the substance which will
- produce acid rain on the east coast. And while it is true,
- 3. research on soy bean crops is still questionable, there is
- 4. no question as to the effect acid rain has on the forests
- 5. of the East. It has already had a diastrous effect on the
- 6. forests in the northeastern part of the country. There is
- 7. no question many different communities and states contribute
- 8. to that. But simply because we can change the regulations
- here and get a little more into the air and it won't hurt
- 10. us as a state, I don't think it's really responsible to
- 11. contribute to the total amount. And we really have not
- 12. taken a serious look at where this state stands in terms of
- 13. the Air Quality Act, 1975. We're going to find and be assured
- 14. of this, when the Federal Government moves in and takes over
- 15. our whole program because we keep sliding back, we're going
- 16. to find that it will have a serious effect on industry in this
- 17. State. A damaging effect. The far more prudent thing, is to
- 18. continue with our present program, whereby, we make judgments
- 19. based on our own experience, our own need rather than taking
- 20. an arbitrary and very general Federal regulation. The State
- 21. chamber is pushing for this and I think they are their own
- 22. worst enemy, in this instance. That it will just look a
- 23. little past the next election and the one after that, we're
- 24. going to find that this kind of action is going to place us
- 25. in some serious problems. Just in terms of what it will do
- 26. to industry when the Federal Government finally takes over
- 27. our program, because we're really not moving to meet the '75
- 28. standards, we just continue to back up.
- 29. PRESIDING OFFICER: (SENATOR ROCK)
- 30. Further discussion? Senator Johns.
- 31. SENATOR JOHNS:
- 32. Mr. President, thank you. Illinois has one-fifth of
- 33. the nation's supply of coal. Forty-four percent more than

- a lot of other states. A hundred and sixty-eight billion ı.
- tons locked up. Here we are holding that resource and 2.
- denying the use in our own State. I rise in support of 3.
- the override of the Governor's Veto. Production is falling 4.
- in Illinois, but it's ironic that twenty-two other states 5.
- buy our coal, twenty-two other states and I think some-6.
- thing else should be taken into consideration, is that as 7.
- we burn western coal it takes a ton and a half of that coal 8.
- to get the BTU's that we get out of one ton of Illinois 9.
- coal. One and a half tons for every...every ton of Illinois 10.
- coal. And I think that our scientists will tell us that 11.
- there is an emission from the burning of other coal. There's 12.
- a residual emission and I think we ought to take a look at 13.
- that. And I was amazed at Senator Wooten saying that, of 14.
- course, our acid rain fall falls on the eastern states. And 15.
- really, they have no scientific fact yet to tell us that it's 16.
- been doing harm to that forest yet, in my humble opinion. 17.
- ninety-five percent of the coal of Illinois remains untouched. 18.
- We need that coal. We need the production. It's the only 19.
- reason it's causing the failure of production in Illinois. 20.
- We went to far in our EPA standards. The Federal Govern-21.
- ment doesn't have as stringent a standard as we do here. 22.
- And that's ironic. I don't know why we always have to over-23.
- do some things like that, but we did. The EPA as it was set 24.
- up, I think, went: too far. We gave them too much money. They're 25.
- $t\infty$ strong. They're overworking themselves. And I urge you to 26.
- help the coal industry. I have one county that has the largest 27.
- reserve in the State of Illinois within it, Franklin County. 28.
- All of that coal, all of that coal in all those mines is 29.
- being shipped out of State and what a cost it is to our

- State. Here we have a God-given resource that could make 31.
- Southern Illinois stand on its own two feet. Let us be 32.
- wealthy in our own regards and we deny it by stringent 33.

- 1. standards on the burning of high sulfur coal. And I urge
- you to give very, very serious consideration to this over-
- 3. ride and I urge you to do so today.
- 4. PRESIDING OFFICER: (SENATOR ROCK)
- 5. Further discussion? Senator Knuppel.
- 6. SENATOR KNUPPEL:
- 7. Well, while I know he campaigned in a shirt that said,
- 8. I'm a country boy, I don't know how many soy beans may have
- 9. been raised by the Governor and I just have to have a couple
- 10. of fields of soy beans that sit out about eight or nine miles
- 11. under the smoke stack of the...of the Illinois Power Company
- 12. power station at Havana and they burn coal...for a long time
- 13. and you know those soy beans just jump right out of the ground
- 14. and grow like the dickens and I just had a hell of a crop. So
- 15. I don't think the acid rain...we had quite a bit of rain, too.
- 16. And I don't think that acid rain bothered them a bit. And so
- 17. I...I 'd be tickled to death if they'd burn that Illinois
- 18. coal so they'd grow a little faster.
- 19. PRESIDING OFFICER: (SENATOR ROCK)
- 20. Any further discussion? Senator Graham.
- 21. SENATOR GRAHAM:
- 22. Just one little remark that I would like to have Senator
- 23. Johns attend himself to. If this is overridden I think, perhaps,
- 24. there'd be no need for that Severence Tax. Maybe think about
- 25. that.
- 26. PRESIDING OFFICER: (SENATOR ROCK)
- 27. Any further discussion? Senator Johns.
- 28. SENATOR JOHNS:
- 29. On a point of personal privilege.
- 30. PRESIDING OFFICER: (SENATOR ROCK)
- 31. State you point, Sir.
- 32. SENATOR JOHNS:
- 33. Indeed, I do feel the need for the overriding of the

- 1. Governor's veto on the Severance Tax. This coupled with the
- 2. production would make Illinois a very, very wealthy State and
- 3. I urge you to be giving thought to that measure. Think,
- snakebites.
- 5. PRESIDING OFFICER: (SENATOR ROCK)
- Further discussion? Senator Donnewald may close the
- 7. debate.
- 8. SENATOR DONNEWALD:
- 9. Very briefly and I'm not going to read much of it, Senator
- 10. Shapiro. But I do want to respond. I don't think you heard
- 11. my first reading, Senator Glass and that, of course, was the
- 12. fact that if the regulations that are going to be imposed
- 13. there will be eleven out of seventeen power plants that will
- 14. not meet the standards if we do not enact this particular
- 15. legislation. I...in closing I...I'm amazed and astounded that
- 16. the Chairman of the Pollution Control Board or his people
- 17. agreed to the bill that we're voting on right now. Voting
- 18. ...voting to override. They agreed to the terms...embodied
- 19. in this bill. Suddenly, he disagrees. Now I'm wondering
- 20. if he's worthy of his position because he doesn't know what's
- 21. going on in his particular department...
- 22. PRESIDING OFFICER: (SENATOR ROCK)
- 23. Question is...
- 24. SENATOR DONNEWALD:
- 25. ...with that I urge your support.
- 26. PRESIDING OFFICER: (SENATOR ROCK)
- 27. Question is, shall Senate Bill 281 pass the veto of the
- 28. Governor to the contrary notwithstanding. Those in favor
- 29. will vote Aye. Those opposed will vote Nay. The voting is
- 30. open. Have all voted who wish? Have all voted who wish?
- 31. Take the record. On that question the Ayes are 43, the Nays
- 32. are 8. None Voting Present. Senate Bill 281 having received
- 33. the required three-fifths vote is declared passed. The veto

- 1. of the Governor to the contrary notwithstanding. On the
- Order of Total Vetoes, Senate Bill 187. Read the motion,
- Mr. Secretary.
- SECRETARY:
- 5. I move that Senate Bill 187 Do Pass the veto of the
- 6. Governor to the contrary notwithstanding. Signed, Senator
- 7. David Regner.
- 8. PRESIDING OFFICER: (SENATOR ROCK)
- 9. Senator Regner.
- 10. SENATOR REGNER:
- 11. Yes, Mr. President and members of the Senate. This is
- 12. the bill which states that if through the Department of Mental
- 13. Health's program of deinstitutionalizing patients and sending
- 14. them out to to community mental health centers, is through
- 15. their program to do this, the population at that community
- 16. ...mental health center increases by over three percent in a
- 17. year, in any given year, then the State will send the money
- 18. along to pay for that cost of those patients and that care
- 19. that's over a...over a three percent increase. There were
- 20. several items in the Governor's veto message and his ob-
- 21. jection to it but they all boil down to the Department of
- 22. Mental Health working against the bill the same as they did
- 23. in the Spring both in the House and in the Senate. That it
- 24. loses control for the department. I think it's an absolutely
- 25. necessary piece of...legislation in order to protect the local
- 26. community...mental health centers from being overloaded.
- 27. And if an extremely large number of new patients were
- 28. sent to a mental health center and they had no money coming
- 29. along from the State to provide for these services. They'd
- 30. have two choices. Either to discharge other patients or to
- 31. reduce the services they provide. I think it's an excellent
- 32. piece of legislation and I move that the Senate...Senate Bill
- 33. Do Pass, 187 Do Pass the Veto of the Governor to the contrary of

- notwithstanding.
- PRESIDING OFFICER: (SENATOR ROCK)
- 3. Is there any discussion? Question is, shall Senate
- 4. Bill 187 pass the Veto of the Governor to the contrary not-
- 5. withstanding. Those in favor will vote Aye. Those opposed
- 6. will vote Nay. The voting is open. Have all voted who wish?
- 7. Have all voted who wish? Take the record. On that question
- 8. the Ayes are 47, the Nays are 1. 1 Voting Present. Senate
- 9. Bill 187 having received the required three-fifths vote
- 10. is declared passed. The veto of the Governor to the contrary
- 11. notwithstanding. Senator Buzbee, for what purpose do you
- 12. arise?
- 13. SENATOR BUZBEE:
- 14. Mr. President, I was called off the Floor to speak to
- 15. a lobbyist and I...had I had been here I would have voted
- 16. Aye. The lobbyist is a...never mind. Thank you.
- 17. PRESIDING OFFICER: (SENATOR ROCK)
- 18. Your remarks will be journalized for perpetuity. Any
- 19. other member have a motion with respect to the Order of Total
- 20. Vetoes? On the Order...if we'll turn to page 9 on the Order
- 21. of Item Vetoes. Does any member have a motion filed which he
- 22. wishes to call at this time? On the Order of Item Reductions.
- 23. Are there any members having motions they wish to call at this
- 24. time? Page 10 on the Calendar under the order of business,
- 25. Specific Recommendations for Change. Are there any members
- 26. having motions they wish to call? All right. On the Order
- 27. of Specific Recommendations for Change, page 13 of the Calendar,
- 28. Senate Bill 1308. Read the motion, Mr. Secretary.
- 29. SECRETARY:
- 30. I move to accept the specific recommendations of the
- 31. Governor to Senate Bill 1308 in the manner and form as
- 32. follows. Signed, Senator Don Moore.
- 33. PRESIDING OFFICER: (SENATOR ROCK)

- 1. Senator Don Moore.
- 2. SENATOR DON MOORE:
- Thank you, Mr. President and members of the Senate.
- 4. Senate Bill 1308 was a bill which was worked out by the
- 5. Illinois Department of Public Aid and the nursing home
- 6. industry in the State of Illinois and the health care
- 7. industry and the Department of Public Aid Under Federal
- 8. Law the State of Illinois Department of Public Aid is
- 9. mandated to reimburse our nursing home facilities on a
- 10. cost related basis effective January 1, 1978. This bill
- 11. was put in in response to that so there would be some guidelines
- 12. et cetera set up to pay our nursing homes on a cost related
- 13. basis. The fiscal impact...we have about nineteen million
- 14. in the budget starting January 1. There were because of
- 15. certain things in the bill relating to capital, to de-
- 16. preciation and so forth, it was the Governor's feelings
- 17. that the cost could go as high as sixty million. So ir
- 18. negotiating with the Illinois Health Care Association and
- 19. his office they did come up with these specific recommendations
- 20. dealing with ancilliary services, capital, et cetera. To
- 21. my knowledge there's no objection to the Governor's specific
- 22. recommendations and I would move for a favorable roll call, Mr. President
- 23. PRESIDING OFFICER: (SENATOR ROCK)
- 24. Is there any discussion? Question is shall the Senate
- 25. accept specific recommendations of the Governor as to Senate
- 26. Bill 1308 in the manner and form just stated by Senator
- 27. Don Moore. Those in favor will vote Aye. Those opposed
- 28. will vote Nay. The voting is open. Have all voted who wish?
- Have all voted who wish? Take the record. On that question
- 30. the Ayes are 52, the Nays are 1. 1 Voting Present. The
- 31. specific recommendations of the Governor as to Senate Bill
- 32. 1308 having received the required majority vote of Senators
- 33. elected are declared accepted. On the Order of Specific

- Recommendations for Change. There's a motion filed with respect
- to Senate Bill 66 found at page 11 of the Calendar. Mr.
- Secretary, read the motion.
- SECRETARY:
- I move to accept the specific recommendations of the
- 6. Governor as to Senate Bill 66 in the manner and form as follows.
- 7. Signed, Senator Schaffer.
- 8. PRESIDING OFFICER: (SENATOR ROCK)
- 9. Senator Schaffer.
- 10. SENATOR SCHAFFER:
- 11. Mr. President. Senate Bill 66 extended the publication
- 12. time formunicipalities from ten to thirty days. We evidently
- 13. had a mistake in the bill and we failed to change one ten day
- 14. reference to thirty. The Governor's people caught it. It's
- 15. a technical change. I move that we concur on the Governor's
- 16. changes.
- 17. PRESIDING OFFICER: (SENATOR ROCK)
- 18. Any discussion? The question is, shall the Senate
- 19. accept the Specific Recommendations of the Governor as to
- 20. Senate Bill 66 in the manner and form just stated by Senator
- 21. Schaffer. Those in favor will vote Aye. Those opposed will
- 22. vote Nay. The voting is open. Have all voted who wish? Have
- 23. all voted who wish? Take the record. On that question, the
- 24. Ayes are 54, the Nays are None. None Voting Present. The
- 25. Specific Recommendations of the Governor as to Senate Bill
- 26. 66 having received the required majority vote of Senators
- 27. elected are declared accepted. Senator Grotberg, for what
- 28. purpose do you arise?
- 29. SENATOR GROTBERG:
- 30. On 301, Mr. President, I would move to accept the changes
- of the Governor.
- 32. PRESIDING OFFICER: (SENATOR ROCK)
- On the Order of Specific Recommendations for Change,

- 1. Senate Bill 301. Read the motion, Mr. Secretary.
- 2. SECRETARY:
- I move to accept the Specific Recommendations of the
- 4. Governor as to Senate Bill 301 in the manner and form as
- 5. follows. Signed by Senator Grotberg.
- 6. PRESIDING OFFICER: (SENATOR ROCK)
- Senator Grotherg.
- 8. SENATOR GROTBERG:
- 9. Thank you, Mr. President and members of the Senate.
- 10. This is the Children and Family Services bill to create an

Thank you, Mr. President. This is one of the bills 4. that was originally proposed by and the work product of the 5. Economic and Fiscal Commission and it deals with the detailing 6. 7. of additional information in the budget document, primarily, so that members of the General Assembly can have more 8. relevant information on which to make budgetary decisions. 9. The two points on which the Governor asked for changes were 10. in that...in that area where we required that the Capital 11. Development projects be listed with a great deal of specificity 12. in the budget document so that we would know beforehand how 13. much was being allocated to which project. The Governor 14. asked that we accept some wording which would ease that 15. burden, somewhat, on the Governor's Office and the Bureau of 16. the Budget. Specifically, so that they would not have to 17. list every single, minute project, some of which they do 18. not have fully worked out or are just simply just to detailed 19. at the time the budget is submitted to the General Assembly. 20. They have, therefore, requested the change in language so 21. that they would submit information on capital projects and 22. capital programs. While I think there may be still some area 23. of disagreement as to how precise the Governor ought to be 24. in his budget with respect to members of the General Assembly. 25. I think that this language is livable and the members of the 26. Economic and Fiscal Commission felt somewhat relaxed about 27. it. We think we can live with it. The other part of it is 28. that they asked for a delayed effective date until 1979. 29. personally, am somewhat object to that, although the reasoning 30. makes a little bit of sense. We have asked that the budget 31. start carrying the kinds of...of detail that is specified in 32. this bill for the prior three years including and up to the

- budget year. The...the Governor's Office and the Bureau of
- 2. the Budget said that they simply could not go back and re-
- 3. construct all of that information and that is why they requested
- 4. the delayed effective date. I am...I'm a little bit reluctant
- 5. to accept that but I think that if we can at least get this
