- 14. less than fifty thousand. This is a...was not...this is

- 2. 3rd reading. House Bill 4, Senator Netsch. Read the
- 3. bill.
- 4. SECRETARY:
- 5. House Bill 4.
- 6. (Secretary reads title of bill)
- 7. 2nd reading of the bill. The Committee on Public Health,
- 8. Welfare and Corrections offers three amendments.
- 9. PRESIDENT:
- Senator Netsch.
- 11. SENATOR NETSCH:
- 12. Thank you...I, Mr. President. I would like at the
- 13. outset to note that there are three Committee Amendments
- 14. which we would like to have placed on the bill today
- 15. and have the bill moved to 3rd reading. I know there
- 16. are several other people who have amendments that they
- 17. are working on who...that may not be ready. And as
- 18. a matter of fact, I have...the department working on
- 19. a couple of amendments that are not yet ready, so we
- 20. will bring it back again for further amendments, but
- 21. we would like to get the Committee Amendments on today.
- 22. Amendment No. 1 was offered in the committee by Senator
- 23. Smith. It changes the word, provider, to, vendor, in
- 24. a number of places throughout the bill. The word, vendor,
- 25. has become the term of art and the request was made that
- 26. we correct the incorrect reference. I move adoption of
- 27. Amendment No. 1 to House Bill 4.
- 28. PRESIDENT:
- 29. Is there any discussion? Senator Netsch moves the
- 30. adoption of Amendment No. 1. All those in favor signify
- 31. by saying Aye. Opposed. The Ayes have it. The amendment
- 32. is adopted. Amendment No. 2, Senator Netsch.
- 33. SENATOR NETSCH:

- 1. I will defer to Senator Schaffer to explain this amend-
- 2. ment.
- 3. PRESIDENT:
- Senator Schaffer.
- 5. SENATOR SCHAFFER:
- 6. Amendment No. 2 makes several language changes to
- 7. clarify the act and bring it in compliance with existing
- 8. department language. It also puts the phrase, knowingly,
- 9. in that the vendor, knowingly, committed the fraud and it
- 10. removes the word, substantially, in compliance with the
- 11. department's Rules and Regulations and just says that
- 12. they have to comply. So that the word substantially would
- 13. ...give grounds as a...for a defense that perhaps ought
- 14. not to be there.
- 15. PRESIDENT:
- 16. Is there any discussion? If not, Senator Schaffer
- 17. moves the adoption of Amendment No. 2. All those in
- 18. favor signify by saying Aye. Opposed. The Ayes have it.
- 19. The amendment is adopted. Amendment No. 3, Senator Netsch.
- 20. SENATOR NETSCH:
- 21. Thank you, Mr. President. Amendment No. 3 was requested
- 22. by the Department of Registration and Education. It provides
- 23. in the sections that require the transmittal of information
- 24. about...defections by Public Aid providers to the licensing
- 25. agencies that any...in the case of transmission of such information
- 26. involving the Department of Registration and Education,
- 27. that the transmittal be subject to the confidentiality
- 28. requirements that may the required by Federal or State
- 29. law and it also provides that the cost shall be borne
- 30. by the department to which the transmittal is made. This
- 31. was considered necessary by the department to maintain its
- 32. obligations. I move...adoption of Amendment No. 3 to
- 33. House Bill 4.

- PRESIDENT:
- Is there any discussion? Senator Netsch moves the
- adoption of Amendment No. 3. All those in favor signify
- by saying Aye. Opposed. The Ayes have it. The amendment
- 5. is adopted. Any further amendments?
- 6. SECRETARY:
- 7. No further Committee Amendments.
- 8. PRESIDENT:
- 9. Any amendments from the Floor? 3rd reading. On the
- Order of Senate Bills 3rd reading. Senate Bill 8, Senator
- 11. Nimpod.
- 12. SENATOR NIMROD:
- 13. Yes, Mr. President, I had... I would like to call that
- 14. bill for a vote today, however I did agree to hold the bill
- 15. for a...an amendment. And I would seek leave to return this
- 16. bill to 2nd reading at this time for purpose of an amendment.
- 17. PRESIDENT:
- 18. Senator Nimrod has asked leave to have Senate Bill 8 brought
- 19. back to the Order of 2nd reading for the purpose of amendment.
- 20. Is leave granted? Leave is granted. On the Order of 2nd reading
- 21. Senate Bill 8.
- 22. SECRETARY:
- 23. Amendment No. 2 offered by Senator Bruce.
- 24. PRESIDENT:
- 25. Senator Bruce.
- 26. SENATOR BRUCE:
- 27. Thank you, Mr. President and members of the Senate. Amend-
- 28. ment No. 2 to Senate Bill 8 has been broadly discussed in many
- 29. forms and it is before you in the following form. There are
- 30. two parts to the amendment. The first part says that if any community
- 31. college in the State of Illinois has not received a per hour
- 32. average grant of seventeen sixty-one, they shall participate
- 33. in a fund which is: only effective for one year, for the next
- 34. fiscal year and is limited to the amount of one million dollars.

- 1. The only college in the State of Illinois that would apply
- or could apply for that money would be the City Colleges
- 3. of Chicago. Additionally, we discussed a...an amendment
- 4. which would add thirty-two cents to each of the eight
- proposed rates and that is what the second part of this
- 6. amendment would do. For any college that could not
- 7. participate in receiving the money under Part A, the one
- 8. million dollars they would receive an additional thirty-
- 9. two cents per credit hour. And that would also apply only
- 10. for the fiscal year '78. If there is any problem...if there's
- 11. not enough money to fund either of the two parts of the program,
- 12. there would be an equivalent proration so that every college
- 13. would only receive the amount of money in an equal basis. No
- 14. one would receive seventeen sixty-one unless everyone received
- 15. the thirty-two cents additional that...would be proposed by
- 16. this amendment. I would move its adoption.
- 17. PRESIDENT:
- 18. Is there any discussion? Senator Glass.
- 19. SENATOR GLASS:
- 20. Thank you, Mr. President. I have a question for the
- 21. sponsor. Senator Bruce, under this amendment what districts
- 22. would benefit?
- 23. PRESIDENT:
- 24. Senator Bruce.
- 25. SENATOR BRUCE:
- 26. All forty-nine campuses. Thirty-nine community colleges
- 27. would participate. The city colleges would receive, if the
- 28. present enrollment figures would continue as...as projected
- 29. one million dollars. The downstate schools would receive
- 30. one point one million dollars.
- 31. PRESIDENT:
- 32. Senator Glass.
- 33. SENATOR GLASS:

- 1. Now is that...that is money that would otherwise laspe.
- 2. Is that...is that right? I was under the impression that...
- 3. that, I don't know, maybe I was mistaken. That there would
- 4. be no money downstate, it would all be in Chicago. Is that
- 5. in error?
- PRESTDENT:
- Senator Bruce.
- 8. SENATOR BRUCE:
- 9. Things have changed over the evening and everyone
- 10. participates. There was appropriated one hundred million
- 11. dollars based on a...a projected F.T.E. of one hundred and
- 12. seventy-six thousand five hundred. Figures given to us
- 13. yesterday indicate that there will be a full time equivalent
- 14. of one hundred and seventy-one thousand, which would mean
- 15. a lapse of...from three to four million dollars so the amount
- 16. of money contained in this amendment would...would be within
- 17. the regular appropriation and if any Senator wishes, I can
- 18. indicate exactly how much money is projected to be received
- 19. by your particular college.
- 20. PRESIDENT:
- 21. Senator Nimrod.
- 22. SENATOR NIMROD:
- 23. Mr. President and fellow Senators. I would move to
- 24. resist this amendment, since it's very obvious, as Senator
- 25. Glass' question has pointed out, that there is an attempt
- 26. here to do something which was improper and was unfair in
- 27. the first place and in order to make something which was
- a bad situation in the first place to award some monies to
- 29. a district over and above the basis of costs and reimbursements
- 30. of cost. We have now taken and said, well, if it's there for
- 31. the City of Chicago to do it, then let's take and give the
- 32. downstate some extra money too, for no reason at all, other
- 33. than it would make it permissible to give Chicago a million

- 1. dollars. Now, I know that this particular amendment was
- 2. discussed very extensively. The first part of this amendment
- 3. was...which provided a million dollars to the City of Chicago
- 4. on the basis of those courses which are remedial, for which
- 5. they are being reimbursed on a cost basis and I know that
- 6. that money which is being put on that basis then if Chicago
- 7. cannot accept it or we will not allow it for Chicago, we
- 8. certainly shouldn't be allowing it for downstate. Now,
- 9. certainly this particular budget which has been appropriated
- 10. for this particular credit hour college grants was done on
- 11. the basis of actual expenditure needed, since it was expected
- 12. that the enrollment will be less. There's no reason for us
- 13. to start a precedent saying that since we appropriate money
- 14. and there's going to be an expected surplus of that particular
- 15. account that we ought to find some way of spending it. That's
- 16. a bad precedent and a bad procedure and we are certainly
- 17. making a reward for a particular grants...acknowledgment
- 18. here, appropriation for something which is truly improper
- 19. and at the same time we take a second improper move and I
- 20. thought there was going to be two amendments, but since there
- 21. ... there evidently the attempt is to bring together...qive
- 22. a little bit to everybody improperly. That's a bad procedure.
- 23. It's a bad amendment. I would move that we resist this amend-
- 24. ment.
- 25. PRESIDENT:
- 26. Senator Hickey.
- 27. SENATOR HICKEY:
- 28. Thank you, Mr. President. As most of you know, I opposed
- 29. vehemently the first proposition, which was talked about and
- 30. discussed for two hours yesterday in the Senate Higher
- 31. Education Committee, which would have given all of this
- 32. money which might otherwise have lapsed to Chicago city
- 33. colleges. I... I think we would have been better off to have

- ...to have left the money lapse. But we're faced with the
- possibility of having no categories set up for the distribution
- of the grants as we do want them provided for and...it seems
- 4. to me that in this deadlock, which holds that as a possibility
- that this is a pretty good compromise. That it certainly
- isn't...isn't perfect but in the situation that we have, it
- seems to me that it is the fairest to the most people and I
- was, particularly...particularly opposed to the first one because
- 9. the downstate colleges would not have been getting share of an
- 10. extra bowl of gravy. This way, I think they'll get, maybe
- 11. not as much as they might get, but they...they're not coming
- 12. out with nothing and we may be able then to go ahead with the
- 13. distribution of the credit hour grants as we had originally
- 14. proposed. So I would urge a...a vote for the amendment.
- 15. PRESIDENT:
- 16. Senator Berman.
- 17. SENATOR BERMAN:
- 18. Thank you, Mr. President. I rise in support of this
- 19. amendment. As previous speakers have indicated this is a
- 20. compromise. This does not address the total needs of the
- 21. Chicago junior colleges, but it takes into recognition a
- 22. fact, which I think, has been overlooked by those people
- 23. who are speaking in opposition to this amendment. And that
- 24. is, that when we switched from a grant system that guaranteed
- 25. seventeen sixty-one across the board and to a cost differential
- 26. system with eight categories that there were...there would be
- 27. a number of school districts primarily Chicago that does a
- 28. great deal of remedial work in their junior colleges that
- 29. would obtain substantially less dollars then we had previously
- 30. given them. And it's been my experience dealing with any
- 31. kind of funded program by the State that we always take steps
- 32. not to hurt anyone as far as dollars are concerned when we
- 33. make so-called reforms. When we make...when we move forward

- 1. we do so but we try not to hurt anyone dollarwise. That's
- 2. the purpose of this amendment. This amendment will move
- 3. forward by giving Chicago the recognition of the guarantee
- 4. that we had previously provided of a seventeen dollars and
- 5. sixty-one cents credit allotment and yet, for those school
- 6. districts that have an average above seventeen sixty-one
- 7. and that's for those districts downstate that they will
- 8. receive additional money also. I think it's a fair compromise.
- 9. It's within the framework of recognition of the needs of
- 10. our young people for their education. I urge your Aye vote
- 11. on this amendment.
- 12. PRESIDENT:
- 13. Senator Regner.
- 14. SENATOR REGNER:
- 15. Mr. President and members of the Senate. It's interesting
- 16. what this amendment is doing. It's trying to make a payment
- 17. to Chicago for violations that they had in the past year. The
- 18. Chicago junior college system filed false claims to the tune
- 19. of about six million dollars. Three point seven million
- 20. ... of those dollars were outright denied and right now there's
- 21. two point three million, that are still in reserve. So what
- 22. this amendment does, it gives Chicago system a million dollars
- 23. to help them pay for the false claims that are still pending
- 24. right now. But in order to make it palatable to downstate we're
- 25. going to give another million dollars to downstate with this
- 26. just so they go along to bail out Chicago again for falsification
- of records. I suggest that it's a terrible amendment. It should
- 28. be defeated.
- 29. PRESIDENT:
- 30. Is there any further discussion? Senator Guidice.
- 31. SENATOR GUIDICE:
- 32. Thank you, Mr. President. Senator Bruce, if these claims
- 33. are false, are you going to pay these claims?

- 1. PRESIDENT:
- Senator Bruce.
- 3. SENATOR BRUCE:
- I was going to reply to that in my closing comments. If
- 5. anyone audits the figures of any community college in this
- State and finds that their claims are false they will have to
- 7. cough up the money back to the State of Illinois. No one is
- 8. alleging here that we are going to pay for students who aren't
- 9. actually enrolled. No. I think that would be false to say
- 10. we're trying to bail out anyone. In fact, several schools
- 11. are audited. If the figures are in error or found to be in
- 12. error the money is returned to the State of Illinois.
- 13. PRESIDENT:
- 14. Is there any further discussion? If not, Senator Bruce
- 15. moves the adoption...Senator Bruce moves the adoption of
- 16. Amendment No. 2. All those in favor signify by saying Aye.
- 17. Opposed. I do hear a request for a roll call. Those in
- 18. favor of the adoption of the amendment will vote Aye. Those
- 19. opposed will vote Nay. The voting is open. Have all voted
- 20. who wish? Have all voted who wish? Take the record. On
- 21. that question, the Ayes are 29, the Nays are 26. None Voting
- 22. Present. The majority of...of the members having voted in the
- 23. affirmative, the amendment is adopted. Senator Nimrod has
- 24. requested a verification of the afirmative votes. Mr. Secretary,
- 25. please read the affirmative votes.
- 26. SECRETARY:

- 26. SENATOR BRUCE:

- 3. Yes, there's two committee amendments...

- 17. Senator Carroll.
- 18. SENATOR CARROLL:
- 19. Thank you, Mr. President, with leave of the Body may we
- 20. discuss both amendments at one time and then if there are no
- 21. problems ask for a vote on both together. Leave having been...
- 22. PRESIDENT:
- 23. Leave is granted.
- 24. SEANTOR CARROLL:
- 25. Amendment No. 1, Committee Amendment No. 1, Mr. President,
- 26. is to inform the Governor what county the prison is going to
- 27. be in. He put it in Marion County. It belongs in Clinton
- County and we have amended the bill accordingly. Amendment No.
- 29. 2 is to take the lump sum project cost, which we've never done
- 30. for any projects before and break it down by line item standard
- 31. accounts for the two prisons and I would move the adoption of
- 32. Committee Amendments No. 1 and 2 with the understanding there
- 33. might be further amendments later.

- 1. PRESIDENT:
- You have heard the motion. Is there any discussion? If
- 3. not, all those in favor of the adoption of Amendments 1 and 2
- 4. signify by saying Aye. Opposed. The Ayes have it. The amend-
- 5. ments are adopted. Any further amendments?
- 6. SECRETARY:
- No further committee amendments.
- 8. PRESIDENT:
- 9. Any amendments from the Floor? 3rd reading. On the
- 10. Order of Senate Bills, 3rd reading, is Senate Bill 8. Senator
- 11. Nimrod. Senator Nimrod, you wish the bill read a third time?
- 12. SENATOR NIMROD:
- 13. Yes, please.
- 14. PRESIDENT:
- 15. Read the bill, Mr. Secretary.
- 16. SECRETARY:
- 17. Senate Bill 8.
- 18. (Secretary reads title of bill)
- 19. 3rd reading of the bill.
- 20. PRESIDENT:
- 21. Senator Nimrod.
- 22. SENATOR NIMROD:
- 23. Mr. President and fellow Senators. What we have here is
- 24. a bill that has a bad amendment on it and I think that the reason
- 25. it says...the whole irony of this whole thing is that Senator
- 26. Bruce has a bill, which...he...it's exactly the same and he does
- 27. not want to amend. He claims that that's an expression of the
- 28. House and that he is not going to amend that bill because the
- 29. House has spoken. Well, then I think that we can do nothing
- 30. else. I must ask that this bill be called for a vote and have
- 31. an expression of the Senate. So that we can see that there has
- 32. been an expression and that this bill is not acceptable to the
- 33. Senate and cannot pass. Because it does provide for a payment

- 1. over and above costs. We are reimbursing on the cost basis and
- when we take and reward someone for monies that they are not
- 3. entitled to under the present bill and then we try to incorporate
- other people on the compromise basis, a compromise takes two
- 5. sides to compromise. Not just one. And I think what we have
- 6. to do is move this bill and show that there is an expression
- 7. and...and that basis, I would ask that all members of this
- 8. side and all those in fairness to vote present so that we can
- 9. have an expression of...of the Senate so that we can then
- 10. proceed to see if there can be, really, an effective compromise
- 11. or not on this very vital issue, which the Governor has
- 12. called within this Special Session to address.
- 13. PRESIDENT:
- 14. Is there any further discussion? If not, the question
- 15. is shall Senate Bill 8 pass? Those in favor will vote Aye.
- 16. Those opposed will vote Nay. The voting is open. For what
- 17. purpose Senator Berman arise?
- 18. SENATOR BERMAN:
- 19. Could we correct the board? It talks about amendment, it
- 20. should read passage or nothing or something. Thank you.
- 21. PRESIDENT:
- 22. Thank you, Senator Berman. The board has been corrected.
- 23. Have all voted who wish? Have all voted who wish? Take the
- 24. record. On that question, the Ayes are 26, the Nays are 1.
- 25. 2 Voting Present. For what purpose Senator Nimrod arise?
- 26. SENATOR NIMROD:
- 27. To postpone consideration.
- 28. PRESIDENT:
- 29. The sponsor has moved to postpone consideration. Consideration
- 30. will be postponed. Is there any further business to come before
- 31. this 2nd Special Session? Senator Vadalabene.
- 32. SENATOR VADALABENE:
- 33. Yes, thank you, Mr. President. On a point of personal

- privilege.
- 2. PRESIDENT:
- 3. State your point, Senator.
- 4. SENATOR VADALABENE:
- Yes, Senator Coffey is not here, I understand. However,
- 6. he did raise a question on a...a fiscal note in regard to
- 7. House Bill 2435. I have filed a fiscal note with the
- 8. Secretary of the Senate and I would also like to read it into
- 9. the record. In regard to House Bill 2435 and the subject
- 10. matter being fiscal note, the following fiscal data is
- ll. relevant to the bill. One, while costs are expected to
- 12. implement the staggered registration system this fiscal year
- 13. the Secretary of State's Office anticipates that we will be
- 14. ...able to implement the system with the current appropriated
- 15. funds. For future fiscal years there will be a trend toward
- 16. a decline of temporary employees, which are hired during peak
- 17. seasonal work to a level permanent staff. And I would like for
- 18. that to be in the record.
- 19. PRESIDENT:
- 20. And that's been filed with the Secretary. Senator Rock.
- 21. SENATOR ROCK:
- 22. Thank you, Mr. President. Before we finally adjourn
- 23. there are two announcements. One, the Committee on Revenue
- 24. pursuant to its earlier recess will meet immediately after
- 25. adjournment, I'm advised, in Room 212 and secondly, on
- 26. next Tuesday, the Adjournment Resolution brings us back into
- 27. Session at noon. There will be a meeting of the Rules Committee
- 28. at eleven thirty a.m. next Tuesday.
- 29. PRESIDENT:
- 30. Senator Netsch.
- 31. SENATOR NETSCH:
- 32. I have an announcement to make, Mr. President. The pages
- 33. are currently handing out and putting on every members desk three

- 1. amendments, which are three of the critical amendments to House
- 2. Bill 1500. The first one, the very thick one, is in substance,
- 3. the bills except for the additional revisions to be made. I...
- 4. we have agreed that these should be made available to the
- 5. members before they go home for the weekend so that they will
- 6. have a chance to familarize themselves with, at least, the major
- 7. provisions of what is going to be offered in various amendments
- 8. . to that bill. So if you will note what is being placed on your
- 9. desk and carry it home with you, it will only cost you another
- five dollars in excess baggage charges. But it is important.
- 11. Thank you.
- 12. PRESIDENT:
- 13. Is there any further business to come before the Senate?
- 14. Senator Vadalabene.
- 15. SENATOR VADALABENE:
- 16. Yes, thank you, Mr. President. In regard to that last
- 17. motion that I had in writing at the Secretary's Desk, that
- 18. should be in the Regular Session and not in this 2nd Special
- 19. Session. So I wish those remarks be stricken and when we
- 20. come back Tuesday I'll put them in the Regular Session. Or
- 21. whenever you get into the Regular Session. Do I need a lawyer.
- 22. PRESIDENT:
- 23. Senator Vadalabene...Senator Vadalabene, I was just
- 24. consulting with my lawyer and the parliamentarian advises me
- 25. that the best thing to do is to simply ignore you and to move
- 26. on. The complexities have tried to...to comply with your
- 27. request are...are beyond us at this point. (Machine cutoff)
- 28. further business to come before the Senate? What purpose does
- 29. Senator Mitchler arise?
- 30. SENATOR MITCHLER:
- 31. Mr. President, I was wondering if Senator Knuppel was
- 32. going to make an announcement about a meeting of the
- 33. Agriculture Committee?

1.	PRESIDENT:
2.	Senator Knuppel.
3.	SENATOR KNUPPEL:
4.	Well, there had been notices that had been delivered to
5.	each of the members and I'd move that we suspend the Six Day
6.	Rule. I don't think that we necessarily have to. What it is
7.	for is for a purpose of voting on 2118, which will be heard
8.	at that vote will be taken in the Agricultural Committee at
9.	eleven thirty on Tuesday.
10.	PRESIDENT:
11.	The notice requirement has been suspended. Senator
12.	Knuppel has made the announcement and written notices will
13.	be sent out I assume, Senator. Is there any further business
14.	to come before the 2nd Special Session? If not, Senator Rock
15.	moves that the 2nd Special Session stand in recess subject
16.	to the call of the Chair. Those in favor signify by saying
17.	Aye. Opposed. The Ayes have it. The 2nd Special Session
18.	stands in recess.

21.	PRESIDENT:
22.	2nd Special Session will please come to order. Is there
23.	any further business to come before the 2nd Special Session?
24.	If not, Senator Netsch moves that the 2nd Special Session
25.	stand adjourned. Those in favor. Opposed. The 2nd Special
26.	Session stands until Tuesday, November 22nd at twelve fifteen or
27.	twelve thirty p.m.
