29. Thank you, Mr. President and Ladies and Gentlemen of the Senate.  
30. Senate Joint Resolution 18 is the adjournment resolution and it says  
31. essentially that when we leave here today we will return on  
32. Thursday, March the 20th at the hour of noon. If I can have Senator  
33. Shapiro's attention. We had discussed at some length yesterday and I  
wholeheartedly concur, that on the 20th and 21st, we are, in fact...  
the schedule is now being passed out, or has been passed out.

1. It seems to me that we might well have less than a full schedule  
2. on the 20th and the 21st if that is agreed to and I think it is,  
3. by most. But, the adjournment resolution, nonetheless, calls for  
4. us to return on noon on the 20th of March. That will afford the  
5. membership an opportunity to introduce those bills that they feel  
6. necessary...and will afford the Governor an opportunity to introduce  
7. the bills to implement his budget. I would move for the suspension  
8. of the rules and the immediate consideration and adoption of this  
9. joint resolution.

10. PRESIDING OFFICER: (SENATOR DONNEWALD)

11. This is, in fact, Resolution numbered 81. And you've  
12. heard the motion. Those in favor indicate by saying Aye.  
13. Those opposed. The Ayes have it. The rules are suspended. Now,  
14. Senator Rock moves for the adoption of the adjournment resolution.  
15. Those in favor indicate by saying Aye. Those opposed Nay. The  
16. Ayes have it. The resolution is adopted. Senator Berning, for  
17. what purpose do you arise?

22. SENATOR BERNING:

23. I'd like to direct a question to Senator Rock. On Thursday,  
24. March 20th, the Rules Committee meets at eleven o'clock in the  
25. President's Office. My inquiry has to do with whether or not there  
26. will be any procedure established for consideration of bills before  
27. the Rules Committee rather than just everyone assembling in  
28. the President's Office and waiting his turn. Can there be some kind  
29. of a schedule?

30. PRESIDING OFFICER: (SENATOR DONNEWALD)

32. SENATOR ROCK:

33. Yes. The Rules Committee will meet on a regular basis and they  
will meet in the President's Office. The procedure will be, in fact,

1. as it has been in the past, and I would hope that the membership  
2. would be aware of that. Now, given the fact that the 20th and  
3. the 21st will be less than a full schedule, that...that committee  
4. meeting of the Rules Committee will, in fact, be transferred or  
5. rescheduled for Wednesday, March 26th.

8. SENATOR BERNING:

9. I didn't make myself totally clear, apparently. Would it not  
10. be desirable, Senator Rock, for a schedule of appearance for  
11. Senators rather than everyone appearing all at the same time and  
12. cluttering up your office and all of us spending a good deal of time  
13. marking time? If we were to be assigned a given hour or moment to  
14. appear before the Rules Committee, it would save your time and our  
15. time, too, I believe.

16. PRESIDING OFFICER: (SENATOR DONNEWALD)

17. Senator Rock.

18. SENATOR ROCK:

19. You will, as you have been in the past, always be first, but  
20. I am sure that we can work that out between Senator Shapiro and  
21. myself, yes. I...I do not, in fact, wish to not accommodate any  
22. member of the Senate and we will attempt to work on a regularly  
23. scheduled basis so that you will have an appointed time at which  
24. to make your pitch.

28. For the purpose of an announcement. I'd like the Journal to
