- 5. may be involved at the request of a local department get
- 6. involved in...in a custodial arrest of suspects. So we're
- 7. trying to cover them. Illinois and California are the only
- 8. two states that do not cover them. But Senator Washington
- 9. asked that we specifically exclude the State of Illinois
- 10. Stop and Frisk powers from these officers so that we're
- Took and 11100 female flow cheek officers to cheek we to
- 11. not conferring that statutory power...power on the Federal
- 12. officers.

- 28. Senator Coffey.
- 29. SENATOR COFFEY:
- 30. I'm sorry I...I didn't get that. I was in the back of
- the room at the time and I apologize for that, but Mr. President
- and members of the Senate I...my good friend, Senator Vadalabene,
- I...I always like to support his bills, but this is one that I 33.

- 1. don't feel that I can and I don't feel that we should because
- 2. of the cost to the State. I think it's setting a bad precedent.
- 3. I think everyone ought to take a real good look at this and...
- 4. actually what the cost will be and when the local community is
- 5. not putting money forth in this project and the State of Illinois
- 6. is picking this cost up, I think it is certainly wrong and
- 7. I would ask my colleagues to vote in opposition of this bill.

- 9. Any further discussion? Senator Kenneth Hall.
- 10. SENATOR KENNETH HALL:
- 11. Thank you, Mr. President, Ladies and Gentlemen of the
- 12. Senate. I rise in support of this bill contrary to what
- 13. Senator says across the way, what this will do if with...we
- 14. don't pass this bill to help have mass transportation in
- 15. that area, we'll have a number of people who won't be able
- 16. to go to jobs and we're short of them now. This will not
- 17. only help the community, but it would...if this does not
- 18. pass, Senator, it will mean that we will be suffering
- 19. more than we are right now. We certainly need mass trans-
- 20. portation in that area.

- 22. Any further discussion? Senator Mitchler.
- 23. SENATOR MITCHLER:
- 24. I have a question to ask the sponsor, Mr. President.
- 25. PRESIDENT:
- 26. Sponsor indicates he will yield. Senator Mitchler.
- 27. SENATOR MITCHLER:
- 28. Senator Vadalabene, if this bill was passed to amend
- 29. the act, the Bistate Metropolitan Development District
- 30. Act, would this eliminate any commitment to provide local
- 31: qualifying match?
- 32. PRESIDENT:
- 33. Senator Vadalabene.

- 1. SENATOR VADALABENE:
- Presently because of the condition of the Metro East Area,
- 3. presently because of the condition of the second most populace
- 4. area in the State of Illinois, there has not been any matching
- 5. monies to present date.
- 6. PRESIDENT:
- Senator Mitchler.
- 8. SENATOR MITCHLER:
- 9. Well, my question really should have been phrased like
- 10. this, would this eliminate any commitment to ever...provide
- 11. local qualifying match?
- 12. PRESIDENT:
- Senator Vadalabene.
- 14. SENATOR VADALABENE:
- 15. It certainly would not, Senator Mitchler and I hope and
- 16. pray to God that someday that Metro East Area, particularly
- 17. the East St. Louis area can come up with additional monies
- 18. so that we can raise our head high just like the rest of
- 19. the places in the State of Illinois so that we can say that
- 20. we don't need anything. But we didn't create that condition
- 21. down there. Now this is not a small bus operation on the
- 22. Illinois side by any stretch of the imagination. We're
- 23. talking about four hundred and eighty-six employees. We're
- 24. talking about a deficit of seven hundred and seventy-one
- 25. thousand dollars that was paid beside the subsidy. This
- 26. v is generating another one thirty-seconds of the sales tax
- 27. gererated in that area. And Gentlemen and members of the
- 28. Senate, if you would see the amount of money generated in
- 29. a sales tax in those three counties that come to the state
- 30. of Illinois, I don't...think you would be complaining about
- 31. keeping four hundred and eighty-six people on the payroll
- 32. in the Metro East Area in the amount of two million, nine
- 33. hundred thousand dollars.

- 1. PRESIDENT:
- Senator Mitchler.
- 3. SENATOR MITCHLER:
- 4. Well, your argument is very well put, Senator Vadalabene,
- 5. for your area, if that's what they think. We have a district
- 6. up in the northeastern section where they also take a portion
- 7. of the sales tax that's generated in that area, plus a five
- 8. percent gasoline tax, plus license fee extractions from
- 9. the City of Chicago, to go into the Regional Transportation
- 10. Authority. And they too, because they get this additional
- 11. money, seem fit to buy scarves and neckties at twenty thousand
- 12. dollars and...and a lot of things and I just don't want to
- 13. let them get too much money in the pot down there in your
- 14. area so they get afflicted like they have up there in the
- 15. six county area, what we call the RTA area, Senator Vadalabene.
- 16. So, I'm going to look very cautiously at whether we dish out
- 17. this additional fund.
- 18. PRESIDENT:
- 19. Further discussion? Senator Knuppel.
- 20. SENATOR KNUPPEL:
- 21. Well, I was surprised, Senator, I thought you said that
- 22. ...that area didn't have anything to do with the...the need
- 23. for this money. Who is responsible for the need, if that
- 24. area's not?
- 25. PRESIDENT:
- 26. Senator Vadalabene.
- 27. SENATOR VADALABENE:
- 28. I wouldn't be up here with a bill if they didn't need
- 29. the money so I don't know where your heard that.
- 30. PRESIDENT:
- 31. Senator Knuppel.
- 32. SENATOR KNUPPEL:
- 33. No, that wasn't...that wasn't my question, Mr...Senator
- 34. Vadalabene. My question was, you made the statement that

- 1. ...that...that they were not responsible for being in need,
- 2. that somebody, you implied, somebody else was responsible
- 3. for that situation. Who? That's what I'm trying to find
- 4. out. When you say something, then it raises my curiosity
- 5. and I want to know if they're not responsible, who in the
- 6. hell is?
- 7. PRESIDENT:
- 8. Senator Vadalabene.
- 9. SENATOR VADALABENE:
- 10. Well, I still don't understand your...your question.
- 11. You know I'm not a lawyer, Senator Knuppel, though I do
- 12. know that there is a high unemployment factor in the Metro
- 13. East Area. I do know that if we lay off an additional four
- 14. hundred and eighty-six people, all we do is worsen the con-
- 15. dition, at least we got these four hundred and eighty-six
- 16. on the payroll.
- 17. PRESIDENT:
- 18. Senator Knuppel.
- 19. SENATOR KNUPPEL:
- 20. We...we need roads pretty badly in west central Illinois
- 21. and 2.9 million dollars down there where people are probably
- 22. close enough to walk...walk to work, we can't. We're...we're,
- 23. you know, a hundred miles away from a job sometime. How...how
- 24. do we intend to even this up?
- 25. PRESIDENT:
- 26. Senator Vadalabene.
- 27. SENATOR VADALABENE:
- 28. Well, I only wish I could give you some of the sales tax money
- 29. generated in that area, now I'm talking about the sales tax
- 30. that's generated in the Metro East Area, the Counties of
- 31. Monroe. St. Clair. and Madison. We're talking about one
- 32. thirty-seconds additional of the monies. They already are
- 33. getting two thirty-seconds. They had a deficit of seven

- 1. hundred and seventy-one thousand dollars which was...which
- 2. is still hanging. We're not asking the State of Illinois
- 3. to clean up that deficit. All we're asking for is an additional
- 4. one thirty-seconds so that the people who need to ride those
- 5. buses back and forth to work, the blind, the drug addicts
- 6. and so forth. We need those buses to run with.
- 7. PRESIDENT:
- 8. Senator Knuppel.
- 9. SENATOR KNUPPEL:
- 10. Well, Senator if they're operating at...at a deficit, it
- 11. would seem to imply that they're not riding the bus and that...
- 12. that's what I'm getting at. Why furnish the bus if they're not
- 13. riding it?
- 14. PRESIDENT:
- 15. Senator Vadalabene.
- 16. SENATOR VADALABENE:
- 17. They...they are riding the buses and I don't...and I don't
- 18. feel that I want to answer any further questions of Senator
- 19. Knuppel.
- 20. PRESIDENT:
- 21. Further discussion? Senator Donnewald.
- 22. SENATOR DONNEWALD: .
- 23. Yes, Mr. President, several of us on this side of the aisle
- 24. are in the bistate area, Senator Buzbee, Senator Demuzio, Senator
- 25. Vadalabene and Senator Hall, including myself and very frankly,
- 26. for the background of what Senator Vadalabene has been trying
- 27. to explain and very well, I might add, the area of Alton and
- 28. Fairview Heights and Belleville have attracted a great deal
- 29. of people from Missouri, Missouri money...it gives us sales
- 30. tax dollars, sales tax money for Illinois which we would
- 31. normally not have were it not for the bistate system. So it's
- 32. an investment and I would certainly urge the members of this
- 33. Body to support this legislation.

- 2. Any further discussion? Will those not entitled to the
- 3. Floor, please vacate. Senator Philip.
- 4. SENATOR PHILIP:
- 5. Thank you, Mr. President. Will the sponsor yield for
- 6. a question?

- 8. Sponsor indicates he will yield. Senator Philip.
- 9. SENATOR PHILIP:
- 10. Yes, Senator Sam, do you have any locally imposed taxes
- 11. to support mass transit in your district?
- 12. PRESIDENT:

- 14. SENATOR VADALABENE:

- 17. Senator Philip.
- 18. SENATOR PHILIP:
- 19. Well, Senator Sam, I might make this point. And I'm just
- 20. guessing that you voted for the RTA and have supported the
- 21. RTA. We have in the suburban area in northern Illinois in the
- 22. five county area what we call the RTA Tax, which is five percent.
- 23. Now, I would suggest this to you. That you put on a five percent
- 24. gas tax in that region and you'll be able to support your mass
- 25. transit just the way we do.
- 26. PRESIDENT:
- 27. Any further discussion? Senator Gitz.
- 28. SENATOR GITZ:
- 29. Will the sponsor yield for a question?
- 30. PRESIDENT:
- 31. Indicates he will yield. Senator Gitz.
- 32. SENATOR GITZ:
- 33. Senator Vadalabene, since this is supported by Missouri

- as well, does this in any way affect their contribution to
- 2. bistate?
- 3. PRESIDENT:
- 4. Senator Vadalabene.
- 5. SENATOR VADALABENE:
- No, incidently, Missouri...the county puts in twenty-three
- 7. million and the City of St. Louis puts in eleven and a half
- 8. million. That's the St. Louis and the county...and the St. Louis
- 9. County portion. However, I would like to, while I'm up on
- 10. the Floor, just say to Senator Pate that you are getting three
- 11. thirty-seconds of the sales tax generated in your area for
- 12. mass transit.
- 13. PRESIDENT:
- 14. Any further discussion? Senator Coffey.
- 15. SENATOR COFFEY:
- 16. Mr. President, I have a question of the sponsor.
- 17. PRESIDENT:
- 18. Indicates he will yield. Senator Coffey.
- 19. SENATOR COFFEY:
- 20. Senator Vadalabene, does...does this...is this a one year
- 21. program or is this from today on as far as this contribution
- 22. by the State?
- 23. PRESIDENT:
- 24. Senator Vadalabene.
- 25. SENATOR VADALABENE:
- 26. Well, this authorization will put it in the Department of
- 27. Transportation Bill and will be three thirty-seconds from now
- 28. on.
- 29. PRESIDENT:
- 30. Senator Coffey.
- 31. SENATOR COFFEY:
- 32. Have you given any consideration if you feel that the need
- 33. is there and there's...until there could be some public input

- 1. to maybe amending it where we're only talking about Fiscal
- Year 1980 rather than continuous?
- 3. PRESIDENT:
- 4. Senator Vadalabene.
- 5. SENATOR VADALABENE:
- 6. Well, I have talked to, there's five Illinois Commissioners
- 7. on the bistate authority and I have talked to them exactly
- 8. what you're saying down the road. Can we, down in the bistate
- 9. area help in some way make some kind of a contribution and
- 10. that is in...that is in the near future or hopefully in the
- 11. near future.
- 12. PRESIDENT:
- 13. Any further discussion? Senator Geo-Karis.
- 14. SENATOR GEO-KARIS:
- 15. Mr. President and...and members of the Senate. Much as
- 16. I like the sponsor of this bill, I note that it would take
- 17. approximately six million dollars from the State treasury
- 18. to help the Bistate Mass Transportation District. And in
- 19. as much as I come from the six collar district, six collar
- 20. counties, that already has had five percent tax, gas tax,
- 21. levied on it, in addition the RTA, that's part of it, now
- 22. claims it doesn't have enough money, if I vote for the
- 23. Senator's bill, there's going to be about six million dollars
- 24. short for...RTA and we've had enough problems with it as...as it
- 25. is now and I'm...I'm afraid, I'm forced to speak against the
