- 10. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 11. Take...take it from the record. Senate Bill 350, Senator
- 12. Becker. Do you wish to call the bill, Senator? Read the
- 13. bill, Mr. Secretary.
- 14. SECRETARY:
- 15. Senate Bill 350.
- 16. (Secretary reads title of bill)
- 17. 2nd reading of the bill. No committee amendments.
- 18. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 19. Are there amendments from the Floor?
- 20. SECRETARY:
- 21. No Floor amendments.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 23. Senator Rock.
- 24. SENATOR ROCK:
- 25. It's again, has been requested apparently, that an amend-
- 26. ment has been required or is to be required of this bill.
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. I'd suggest that you discuss that with the President. Take
- 29. it out of the record. Senate Bill 369, Senator Berman. Senate
- 30. Bills, 3rd reading. Senate Bill 10, Senator Sommer. Senate
- 31. Bill 11, Senator Sommer. Senate Bill 12, Senator Sommer. Senator
- 32. I'd...Senator Sommer, you don't care to call? All right. Senate
- 33. Bill 23, Senator Vadalabene. Read the bill, Mr. Secretary.

- 1. SECRETARY:
- Senate Bill 23.
- 3. (Secretary reads title of bill)
- 4. 3rd reading of the bill.
- 5. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 6. Senator Vadalabene.
- 7. SENATOR VADALABENE:
- 8. Thank you, Mr. President and members of the Senate. In
- 9. regard to Senate Bill 23, solid waste disposal in the St. Louis
- 10. region is approaching a serious crisis. Our Illinois Counties
- 11. of Madison, Monroe and St. Clair produce and dispose of over
- 12. two thousand tons of refuse each day. In St. Louis City
- 13. and three adjacent Missouri counties generates some seven
- 14. thousand tons of trash daily. Of this two thousand tons per
- 15. day end up in Illinois land fills and as a result, the Illinois
- 16. counties with twenty percent of the regions population provide
- 17. land disposal for forty-four percent of its waste. And with
- 18. the City of St. Louis about to shut down its refuse incinerators
- 19. and two of Missouri's five land fills nearing capacity, the
- 20. percentage could increase and still more. Adoption of Senate
- 21. Bill 23 is essential for this project to be realized. And bistate
- 22. lacks express legal authority to build a solid waste to energy
- 23. project and I would appreciate a favorable vote. It passed out
- 24. of committee by an eight to nothing vote.
- 25. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 26. Is there discussion? The question is shall Senate Bill 23
- 27. pass. Those in favor vote Aye. Those opposed Nay. The voting
- 28. is open. Have all those voted who wish? Have all those voted
- 29. who wish? Take the record. On that question the Ayes are 33,
- 30. the Nays are 7, 6 Voting Present. Senate Bill 23 having received
- 31. the constitutional majority is declared passed. Senate Bill 65,
- 32. Senator Jerome Joyce. Senate Bill 97, Senator Sangmeiser. Senate
- 33. Bill 115, Senator Lemke. Senate Bill 122, Senator Lemke. Senate

- 1. Bill 142, Senator Vadalabene. Read the bill, Mr. Secretary.
- 2. SECRETARY:
- 3. Senate Bill 142.
- (Secretary reads title of bill)
- 5. 3rd reading of the bill.
- 6. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 7. Senator Vadalabene.
- 8. SENATOR VADALABENE:
- 9. Yes, thank you, Mr. President. Senate Bill 142 increases
- 10. the Revenue Bonds from...from eight percent and...and the General
- Obligation Bonds from, reduced amount from ten to eight.
- 12. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 13. Is there discussion? The question is shall Senate Bill 142
- 14. pass. Those in favor vote Aye. Those opposed Nay. The voting
- 15. is open. Have all those voted who wish? Have all those voted
- 16. who wish? Take the record. On that question the Ayes are 46,
- 17. the Nays are 2. Senate Bill 142 having received the constitutional
- 18. majority is declared passed. Senate Bill 145, Senator Vadalabene.
- 19. Read the bill, Mr. Secretary.
- 20. SECRETARY:
- 21. Senate Bill 145.
- 22. (Secretary reads title of bill)
- 23. 3rd reading of the bill.
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- 25. Senator Vadalabene.
- 26. SENATOR VADALABENE:
- Thank you, Mr. President, members of the Senate. Senate
- 28. Bill 145 provides that the...Tri City Regional Port District
- 29. is requesting to be exempted from the Industrial Revenue Building
- Bond Act and avoid...to avoid any possible missinterpretation
- between the Act and the Tri City Regional Port District Act
- with regard to the interest limitations. The Tri City Regional 32.
- Port feels the need to increase the interest rate limitations 33.

- 1. in order to issue additional Revenue Bonds at the current
- market rate for such bonds. Industrial Revenue Bonds are not
- 3. an obligation of the unit of government issuing the bonds.
- 4. Unit of government serves only as a conduit between a
- 5. private company and guarantees repayment of the bonds and
- 6. the bond purchaser. In regard to that portion of the bill
- 7. which attempts to exempt the Tri City Regional Port District
- 8. from the application of the...Public Court Corporation Interest
- 9. Rate Act would have no fiscal effect on the State of Illinois
- 10. or any other municipality of the State of Illinois. The
- 11. purpose of the exemption of the Tri City Regional Port District
- 12. from the application of this act is to prevent any conflict
- 13. between the interest rate specified in this act, eight percent,
- 14. and the interest rate of ten percent specified for the Port District
- 15. Revenue Bonds which we just passed as a companion bill to
- 16. Senate Bill 142. And I would appreciate a favorable vote.
- 17. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 18. Senator Rhoads.
- 19. SENATOR RHOADS:
- 20. Thank you, Mr. President. Question of the sponsor if he
- 21. will yield.
- 22. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 23. Indicates he will.
- 24. SENATOR RHOADS:
- 25. Senator, my question relates to the...the last paragraph
- 26. you just read. The relationship between this bill and Senate
- 27. Bill 142 which was just passed. Could you go over that one
- 28. more time please, just a little bit more slowly so we can
- 29. absorb it?
- 30. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Vadalabene.
- 32. SENATOR VADALABENE:
- 33. Well, the way I understand the bill, in Senate Bill 142,

- 1. if we didn't pass this bill, there would be a conflict in the
- 2. interest rates that are presently passed by Senate Bill 142.
- PRESIDING OFFICER: (SENATOR DONNEWALD)
- 4. Senator Rhoads.
- 5. SENATOR RHOADS:
- 6. So what? Wouldn't...wouldn't 142 prevail?
- 7. PRESIDING OFFICER: '(SENATOR DONNEWALD)
- 8. Senator Vadalabene.
- 9. SENATOR VADALABENE:
- 10. Yes, that is correct, but they...this bill is also needed
- 11. to exempt the Tri City Regional Port from the application of
- 12. the Public Corporation .. interest also.
- 13. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 14. Is there further discussion? The question is shall
- 15. Senate Bill 145 pass. Those in favor vote Aye. Those opposed
- 16. Nay. The voting is open. Have all those voted who wish? Have
- 17. all those voted who wish? Take the record. On that question
- 18. the Ayes are 39, the Nays are 3, 5 Voting Present. Senate Bill
- 19. 145 having received the constitutional majority is declared
- 20. passed. Senate Bill 247, Senator Daley. Read the bill, Mr.
- 21. Secretary.
- 22. SECRETARY:
- 23. Senate Bill 247.
- 24. (Secretary reads title of bill)
- 25. 3rd reading of the bill.
- 26. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 27. Senator Daley.
- 28. SENATOR DALEY:
- 29. Mr. President and fellow Senators. This is a bill that
- 30. I put in due to circumstances that involve me during the year.
- 31. That each and every one of us have credit cards, whether for
- 32. our Senate office, whether your local office or whether your
- 33. business office and today I have received from the Illinois

- 1. Bell Telephone, now you can have your own telephone credit
- 2. card. They encourage each and every one of us to have credit
- 3. cards for local calls or long distance phone calls. What I've
- 4. done in this bill is, unknown to me until March, all of a
- 5. sudden using my local credit card call for, at a hospital
- 6. that my son was at, the telephone company informed me over the
- 7. phone, you cannot use your credit card for local calls.
- 8. immediately called the Illinois Bell Telephone Company.
- 9. sat down with their representatives and before the committee
- 10. they told us they had the...the authority from the Illinois
- 11. Commerce Commission to okay this. I talked to the Commerce
- 12. Commission last week, they never heard of it, informally or
- 13. formally, they never made a decision on their authorization
- 14. to discontinue use or local use of credit cards for local
- 15. calls within the City of Chicago and the south suburban
- 16. area. It extends from the north side of Chicago, up from O'Hare...
- 17. O'Hare Field all the way down to Chicago Heights. It's a study
- 18. that the Illinois Bell Telephone is using supposedly to cut
- 19. down fraud. And I mentioned to them, if you cannot use your
- 20. credit card for local calls, you automatically cut down fraud
- 21. if you want...if that's what you're looking for. We found out
- 22. in the testimony, there's more fraud in long distance phone
- 23. calls than in local calls. This allows an individual who has
- 24. a credit card, that applies for and receives a credit card
- 25. from the Illinois Bell Telephone to use it for local credit
- 26. card calls. And that's all the bill does.
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. Is there discussion? Senator Mitchler.
- 29. SENATOR MITCHLER:
- 30. Thank you, Mr. President and members of the Senate. In
- 31. committee the Senate Agriculture, Conservation, Energy Committee,
- 32. where this bill was heard, it was pointed out that the Illinois
- 33. Bell Telephone Company has fraud in the amount of three hundred

- 1. sixty thousand dollars annually through the...fraudulent
- 2. use of credit cards and this is the reason for this bill.
- 3. Let me correct myself, did I say it's three hundred and sixty
- 4. thousand dollars, monthly, is the amount that they have in
- 5. fraudulent use of credit cards and they've evaluated where
- 6. the greatest fraud in the credit cards have been used. And
- 7. they have found that in this area of use in the larger cities
- 8. where someone will come in and make all of their credit cards
- 9. all day long on credit cards is the greatest offender. Now
- 10. that is the reason that they have asked for the termination
- 11. of the use of credit cards in the local credit...in the local
- 12. calling area. Now, what Senator Daley is alluding to, a credit
- 13. card issued by the telephone company is sort of a privilege
- 14. and during the hearing it was brought out that when you use
- 15. a credit card locally, it's costing you forty-eight cents,
- 16. in addition to the...to the regular use. It costs you more
- 17. to use a credit card in making a call than a twenty-cent
- 18. regular call. So this charge to the person using the credit
- 19. card can be justified in the fact that they have an extra
- 20. convenience in that it's billed and they have a billing. Now,
- 21. the problem at the telephone company and their objection to
- 22. Senator Daley's bill...
- 23. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 24. Just...just a moment.
- 25. SENATOR MITCHLER:
- 26. Just let me finish...now...
- 27. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 28. No...just a moment...Senator D'Arco, for what purpose do
- 29. you arise?
- 30. SENATOR D'ARCO:
- 31. I just want to know if he's for or against the bill, that's
- 32. all.
- 33. PRESIDING OFFICER: (SENATOR DONNEWALD)

- Well, no, continue, Senator.
- 2. SENATOR MITCHLER:
- 3. The...the reason that it was opposed in committee by
- 4. the telephone company was because they are experiencing some
- 5. three hundred and sixty thousand dollars a month fraud. Now,
- 6. if they continue to experience this, that three hundred and
- 7. sixty thousand dollars per month has to be passed on to
- 8. the other consumers who do not use a credit card. I'm going
- 9. to support Senator Daley's bill, in answer to the bill, but
- 10. I wanted to bring this out because there may be a bill in
- 11. that will allow that charge to be picked up on to the credit
- 12. card users. Because it shouldn't be that a credit card user
- 13. causes this fraud that has to be passed on to those who do not
- 14. use a credit card. I use a credit card and it was brought
- 15. out that the fraud for long distance calls outside a local
- 16. calling area are even greater than in the local area. Now,
- 17. I have a bill that I...I'm considering introducing before
- 18. the deadline. It would protect those that do not use a
- 19. credit card from having to pick up this tremendous cost of
- 20. fraud that's experienced by and caused by people that do use
- 21. credit cards. I just wanted to put that in the record because
- 22. that was brought out in testimony in the committee. I did not
- 23. know about that and many of you probably are in the same position
- 24. as I was not knowing about it. But maybe we can be more enlightened
- 25. about it. But the ability to use a credit card should be extended
- 26. and if you want to pay extra for it, as you are paying when you're
- 27. using a credit card. Maybe many of you didn't know that...that
- 28. it costs more. And in the last bulletin put out by the Illinois
- 29. Bell Telephone Company with your bill, it has an explanation of
- 30. the additional cost for a credit card call above a regular dialing
- 31. your number. Thank you.
- 32. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Demuzio.

- 1. SENATOR DEMUZIO:
- Thank...thank you, Mr. President. I just want to correct
- 3. something that Senator Mitchler had indicated. He indicated
- 4. that the testimony in committee was that the total one month
- 5. loss in fraudulent local calls was three hundred and sixty
- 6. thousand dollars. That is a yearly figure, I am told, not a
- 7. monthly figure. In addition to that, I was surprised to
- 8. learn that there is twice...twice as much fraud that takes
- 9. place in long distance credit card calls as there is that
- 10. transpires and takes place with local calls. And I would
- 11. suggest to you that if we're going to eliminate the credit
- 12. card usage by local individuals, we have to do it for long
- 13. distance as well. I think that another thing that I was
- 14. surprised to learn that this is only applicable in certain
- 15. parts of Chicago, that this is taking place. That, in fact,
- 16. what they're doing here is that you're discriminating against
- 17. the...the long distance credit card holders and you're also
- 18. discriminating against other areas in the City of Chicago
- 19. by letting them use their local...their credit card for local
- 20. calls and not in the areas to which the Senator is referring.
- 21. I think it's a good bill. If you have a credit card, I think
- 22. it ought to be applicable to both the local calls as well as
- 23. long distance.
- 24. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 25. Senator Grotberg.
- 26. SENATOR GROTBERG:
- 27. A question of the sponsor, Mr. President.
- 28. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 29. Indicates he will respond.
- 30. SENATOR GROTBERG:
- 31. Senator Daley you reiterated...it is only Illinois Bell,
- 32. but the bill reads, oh, I've got five phone companies in my
- 33. district, would they all be involved in this?

- 1. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Daley.
- 3. SENATOR DALEY:
- 4. Yes, as I understand, Illinois Bell Telephone is the only
- 5. one that's doing it. They're the only one that are discriminating
- 6. If you have a credit card, you want to use it for local calls.
- 7. I think the problem is, all the telephone companies send this
- 8. to all the credit...anyone who wants credit. They've been
- 9. sending these, whether in your district or my district and every-
- 10. one gets these...they think they get local...they can use their
- 11. local credit card for local calls or long distance. Besides
- 12. that, it is not forty-seven cents, it's sixty-eight cents for
- 13. a use of a credit card, local credit card, for local call. So
- 14. it's up about twenty cents, even if they charge a dollar fifty,
- 15. they wouldn't have to tell you what they charge prior to it. So
- 16. we can come up with another bill, I know Senator Mitchler will,
- 17. for specific prices for utilities, especially Illinois Bell
- 18. Telephone. In other words, they have to specify what they're
- 19. going to charge before you get a credit card.
- 20. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 21. Senator Nash. Senator Geo-Karis.
- 22. SENATOR GEO-KARIS:
- 23. Mr. President and Ladies and Gentlemen of the Senate, I
- 24. always thought I got a break by using my credit cards until
- 25. I found out at the hearing in which this committee took place,
- 26. this bill was took place, that it does cost us about forty-
- 27. eight cents a call, locally, and also about, I think it was
- 28. sixty-eight or better for long distance. It would seem to
- 29. me if the telephone company wanted to eliminate fraud, it
- 30. should be more discriminating as to where they issued their
- 31. credit cards because I can just picture the situation with
- 32. someone with twenty cents in change making a call on a credit
- 33. card and if it's not allowed to do so, not having any change

- 1. and everybody being closed around and all stores closed
- 2. and if it were an emergency, it couldn't get through. So
- 3. I certainly heartily support the bill and I'm glad it
- 4. applies to all telephone companies because the emergencies
- 5. are there and there's another point. You spend money making
- 6. local calls to your constituents and what have you and believe
- 7. it or not it tolls up, at least if you have a record, you've
- 8. got it for your tax purposes, too.
- 9. PRESIDING OFFICER: (SENATOR DONNEWALD)
- Senator Nimrod.
- 11. SENATOR NIMROD:
- 12. Yeah, a...a question, Mr. President. Senator Daley, in
- 13. reading the bill, it just says that the credit card may be
- 14. used for local calls. I've not looked at the area that
- 15. it's referring to, but maybe you might be able to clarify it
- 16. for me. Can this be interpreted that you cannot use the
- 17. credit calls for long distance calls? Or is there somewhere
- 18. that gives you permission in there.
- 19. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 20. Senator Daley.
- 21. SENATOR DALEY:
- 22. No, the Bell Telephone Company or any telephone company
- 23. is not denied...does not denied use, this is just a study they're
- 24. doing, they haven't received the authorization from the Illinois
- 25. Commerce Commission. Now, there is more of a problem now, once
- 26. the credit card holders find out within that geographical
- 27. district that they just went ahead and did it without authorization
- 28. from the Illinois Commerce Commission. They cannot deny the
- 29. use of a credit card for long distance phone calls.
- 30. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 31. Senator Nimrod.
- 32. SENATOR NIMROD:
- 33. My only comment is, by the way the bill is being written,

- 1. it seems to limit the credit card to local calls only because
- 2. it's the only section it refers to in B unless there's some-
- 3. place else where it refers to that credit cards can be used
- 4. for other calls. This could be interpreted that the law
- 5. gives you only the authority to use it for local calls and
- 6. I...and I don't believe that's your intent. Now, maybe...maybe
- 7. what should be written instead of locals calls, that you should
- 8. be able to make a call anywhere with your credit card. A
- 9. valid credit card should be able to make credit calls anywhere
- 10. and that may...may recover you.
- 11. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 12. Senator Mitchler, do you wish to address the Body again?
- 13. SENATOR MITCHLER:
- 14. Yes, well to correct something. In my opening statement,
- 15. I first alluded to the fact that the fraud in the Chicago
- 16. area where they tested this amounted to about three hundred
- 17. and sixty thousand dollars a year, then I corrected myself
- 18. that it's a month. Now, Senator Demuzio got up and said it
- 19. was a year. Senator Demuzio, we're going by our figures and
- 20. it is three hundred, sixty thousand dollars revenue per month.
- 21. Now, that's a tremendous figure of fraud on credit cards and
  - 22. I first thought it was so great that it must be a year, but
  - 23. it's actually per month. And that amount is passed on to those
  - 24. who don't use a credit card and I think that we ought to correct
- 25. that along with what Senator Daley has.
- 26. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 27. Well, could we continue that debate in Walter's office?
- 28. Senator Daley.
- 29. SENATOR DALEY:
- 30. Yes, Senator Mitchler, the problem is...is the Illinois
- 31. Bell Telephone Company is...allowed anybody the use of a
- 32. credit card. Now, they haven't made any safeguards about
- 33. protecting you, as a credit card holder. What they've done,

- they issued millions of credit cards and anyone can use the
- credit card. I could copy...anyone could copy any number
- and use your credit card at any time. And they haven't made
- 4. any...any alternatives or...or programs to do something about
- the misuse of credit cards. What they've done is they just said
- 6. you can't use them anymore.
- 7. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 8. Senator Demuzio.
- 9. SENATOR DEMUZIO:
- 10. Yes, I wanted to call it to Senator Mitchler's attention
- 11. that our staff has indicated that the eight hundred and twelve
- 12. thousand calls were on a yearly basis and that the amount was
- 13. three hundred and sixty thousand. Since our staff is better
- 14. than your staff we accept your apologizes, Senator Mitchler.
- 15. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 16. We'll have the two staff's debate. Is there further
- 17. discussion? Senator Daley may close...if he so desires.
- 18. The question is shall Senate Bill 247 pass. Those in favor
- 19. vote Aye. Those opposed Nay. The voting is open. Have
- 20. all those voted who wish? Have all those voted who wish?
- 21. Take the record. On that question the Ayes are 38, the Nays
- 22. are 10, 2 Voting Present. Senate Bill 247 having received
- 23. a constitutional majority is declared passed.

- Senate Bill 260.
- 5. (Secretary reads title of bill)
- 6. 3rd reading of the bill.
- 7. PRESIDING OFFICER: (SENATOR DONNEWALD)
- 8. Senator Daley.
- 9. SENATOR DALEY:
- 10. Mr. President and fellow Senators. This is...appropriation
- 11. bill for the Illinois Division of Services for Crippled Children
- 12. ...within the University of Illinois budget. During the years
- 13. I explained prior on my prior bill, that I...I never knew this,
- that outside the City of Chicago, if you...son or daughter has
- 15. cancer, brain surgery, is crippled, he gets a hundred percent
- 16. funding, rehabilitation and medical. Automatically they receive that.
- 17. The Federal law came into effect about 1935. Since 1935 anyone
- 18. living with...outside the City of Chicago is a hundred percent
- 19. funded. If your son or daughter or relative has...is crippled,
- has brain surgery, you apply for monies to be used
- 21. it's a hundred percent rehabilitation or medical money. If
- you have a child or anybody living within the City of Chicago,
- you are denied certain medical money and you're fully denied
- rehabilitation money. I think it's...really it's a disgrace that
- it's lasted this long, but it takes, you know, something to happen
- 26. and someone mentions it to a Senator or someone else and you
- find out that there are thousands of kids today who are crippled
- 28. who have had...without brain surgery who had...various other
- 29. diseases, have never received any medical money or rehabilitation
- money. It's very, very sad. It's a sad comment. What this done
- alone gives five hundred thousand dollars to the Illinois Division
- of Crippled Children. Just this...the last three months, so
- children within the City of Chicago can apply for. I'm coming back with a...an appropriation for next year. I think it's 2.2

- million dollars for the children within the City of Chicago to l.
- receive equal status throughout the State. That's all the bill does. 2.
- PRESIDING OFFICER: (SENATOR DONNEWALD) 3.
- Senator Schaffer. 4.
- SENATOR SCHAFFER: 5.
- Mr. President, I rise in support of this bill. What Senator 6.
- Daley has said is absolutely true, as unbelievable as it might 7.
- sound, for reasons that defy my ability to comprehend. We have had 8.
- a differential for, lo these many years, between the City of 9.
- Chicago and the rest of the State on this important area of service 10.
- to crippled children. There's no justification for the differential. 11.
- Somebody drew a line. I'm amazed that somebody hasn't gone to 12.
