- 12. that we allow everyone who had a bill in the Reference Bureau
- 13. on time to have it, in fact, introduced and considered, to
- 14. suspend the appropriate rules for the purpose of introducing
- 15. these two pieces of legislation whose...whose Legislative
- 16. Reference Bureau numbers we have noted and have given copies
- 17. to the Secretary. One was to be introduced by Senator Carroll
- 18. and one was to be introduced by Senator Nimrod and they just,
- 19. frankly, got lost in the shuffle. So I would move to suspend
- 20. the rules for the purpose of having these two bills introduced,

- 14. SECRETARY:
- 15. No Floor amendments.
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. 3rd reading. It's got a fiscal note on 311, Senator
- 18. Netsch. Senate Bill 312, Senator Netsch. Senate Bill 317,
- 19. Senator Weaver. Senate Bill 317, Mr. Secretary, please.
- 20. SECRETARY:
- 21. Senate Bill 317.
- 22. (Secretary reads title of bill)
- 23. 2nd reading of the bill. The Committee on Appropriations II
- 24. offers one amendment.
- 25. PRESIDING OFFICER: (SENATOR BRUCE)
- 26. Senator Weaver is recognized.
- 27. SENATOR WEAVER:
- 28. Thank you, Mr. President. Committee Amendment No. 1
- 29. adds seventeen thousand nine hundred and forty dollars to
- 30. reflect the contract agreement for those employees covered
- 31. by the AFSCME contract. I'd move its adoption.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- The motion is to adopt Committee Amendment No. 1.

- Is there discussion? All in favor say Aye. Opposed Nay.
- 2. The Ayes have it. Committee Amendment No. 1 is adopted.
- 3. Further committee amendments.
- 4. SECRETARY:
- 5. No further committee amendments.
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- 7. Are there amendments from the Floor?
- 8. SECRETARY:
- No Floor amendments.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. 3rd reading. Senate Bill 318, Senator Weaver. Read
- 12. the bill, Mr. Secretary.
- 13. SECRETARY:
- 14. Senate Bill 318.
- 15. (Secretary reads title of bill)
- 16. 2nd reading of the bill. No committee amendments.
- 17. PRESIDING OFFICER: (SENATOR BRUCE)
- 18. Are there amendments from the Floor?
- 19. SECRETARY:
- 20. Amendment No. 1 offered by Senator Weaver.
- 21. PRESIDING OFFICER: (SENATOR BRUCE)
- 22. Senator Weaver is recognized on Amendment No. 1.
- 23. SENATOR WEAVER:
- 24. Thank you, Mr. President. This amendment would add
- 25. all of the employers contributions in higher education to
- 26. this one bill. In years past we have had one bill that
- 27. reflected the total State's contribution to the pension
- 28. contribution in one bill and this reflects a total of
- 29. sixty million nine hundred and three thousand seven hundred
- 30. dollars, which represents gross pay out plus one percent for
- 31. all of those pensions and I'd move its adoption.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. The motion is to adopt. Is there discussion? All in

- 1. favor say Aye. Opposed Nay. The Ayes have it. The amendment
- 2. is adopted. Further Floor amendments.
- 3. SECRETARY:
- 4. Amendment No. 2 offered by Senator Sommer.
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- 6. Senator Sommer to explain Amendment No. 2.
- 7. SENATOR SOMMER:
- 8. Mr. President and members. The staff incorrectly marked
- 9. that. That...that's Senator Regner's amendment not mine.
- 10. SECRETARY:
- 11. ...offered by Senator Regner.
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- 13. Senator Regner to explain Amendment No. 2.
- 14. SENATOR REGNER:
- 15. Mr. President and members of the Senate. This amendment
- 16. reduces the appropriation by four million six hundred ninety-
- 17. six thousand two hundred. This is a reduction to the...to the
- 18. Governor's level and it provides a gross pay out level. This
- 19. is what was in the budget book and to maintain the integrity and
- 20. that of not overappropriating necessarily but we are
- 21. appropriating sufficent monies for the total pay out level.
- 22. I would move the adoption of Amendment No. 2.
- 23. PRESIDING OFFICER: (SENATOR BRUCE)
- 24. The motion is to adopt Amendment No. 2. Is there discussion?
- 25. Senator Buzbee.
- 26. SENATOR BUZBEE:
- Yes, Mr. President. I rise in opposition to Amendment No. 2.
- 28. We have been telling the various pension systems for years and
- 29. years and years that it's not the legislature's fault that
- 30. there's not sufficent funds in there system to...to start
- 31. toward making up the unfunded liability. Senator Weaver has
- 32. attempted for years to start to provide additional funds. Most
- 33. of us on this side have supported those efforts of his and this

- 1. is an attempt once again to do that. This, by the way, the...
- 2. the bill at the shape that it's in right now with the Weaver
- 3. amendment puts it at exactly where the Board of Higher Education
- 4. recommended and that is it gross pay out plus one percent. The
- 5. time has come and I think Senator Berning has some particular
- 6. feelings about this concept. The time has come for this
- 7. Legislature to say once again to the people that are employed
- 8. in the State of Illinois...employed by the State of Illinois,
- 9. I should say, and to say to the Governor's Office, we are not
- 10. going to let you continue to put off forever the funding of
- 11. the various pension systems. Nobody has ever advocated that
- 12. we have one hundred percent of funding of the unfunded liability.
- 13. Over the years the Pension Laws Commission has made various
- 14. recommendations. Senator Berning is sponsoring a bill right
- 15. now which would require that we put all the pension systems,
- 16. the appropriations and all the pension systems each year at
- 17. gross pay out plus two percent. Now, the Weaver amendment
- 18. doesn't even go quite that far. It just puts it at gross pay
- 19. out plus one percent. The time has come for us to start this
- 20. effort. The price tag is some four and a half million dollars
- 21. in the...in the University Retirement System. It will be
- 22. higher than that when we get to the Downstate Teacher's
- 23. Pension System and to the personnel who are employed...who are
- 24. covered under the Illinois Personnel Code because there are
- 25. more employees in those systems. However, we firmly believe
- 26. in looking at the waste that has been perpetrated in this
- 27. budget called by the Governor. There is sufficent waste to
- 28. eliminate...sufficient places to eliminate waste to more than
- 29. adequately compensate for the putting of dollars in to start
- 30. to indicate that we have a sincerity to start to indicate
- 31. to the employees of the State of Illinois that we are attempting
- 32. to do something about the funding of their pension. Now, I
- 33. submit to you if the Governor is all that concerned about his...

- 1. about the amount of money we're spending he keeps telling that
- 2. to the press and he keeps telling that to the Chamber of Commerce
- 3. and he keeps telling that to the Manufacturers Association and
- 4. then he goes and signs an agreement with AFSCME, which is going
- 5. to cost the taxpayers this year fifty-eight million dollars.
- 6. Fifty-eight million this year. Next year there already is
- 7. signed in this year's contract, there already is signed a
- 8. pay increase for the AFSCME employees next year that will cost
- 9. another forty to fifty million dollars on top of this fifty-
- 10. eight million this year. Now, if he is that concerned, I
- 11. submit to you that he does not have to sign those kind of
- 12. labor contracts and then say to the Legislature now appropriate
- 13. the money that's necessary to fund what I have just done to you
- 14. taxpayers. But this will be the Weaver amendment on this
- 15. particular bill...will indicate to the people of the State of
- 16. Illinois and to in...in particular to those folks who are...
- 17. receive a paycheck from the State of Illinois that we're
- 18. serious about starting to make up that unfunded liability in
- 19. your pension system. The bill is in the shape that it should
- 20. be in with the Weaver amendment. The regular amendment ought
- 21. to be rejected out of hand as being something he's doing because
- 22. the Governor wants him to.
- 23. PRESIDING OFFICER: (SENATOR BRUCE)
- 24. Is there further discussion? Senator Egan.
- 25. SENATOR EGAN:
- 26. Yes, thank you, Mr. Chairman ... Mr. President and members
- 27. of the Senate. I just want to reiterate my support of Senator
- 28. Weaver's amendment, which is Amendment No. 1. It is a relatively,
- 29. I think, quiet agreement among everyone that...that it's time
- 30. that we do something about funding the unfunded liability in
- 31. all the pension systems lest they go bankrupt and the Federal
- 32. Government take over and tell us what to do with them and this
- 33. is a figure which is somewhat arbitrary but is more, perhaps,

- 1. than is practical. However, the figure of one percent is
- 2. extremely important insofar as we do not yet have an agreement
- 3. from the Bureau of the Budget as to what the figures should be
- 4. and we've asked them. Senator Berning can reiterate that. We've
- 5. asked them to give us their opinion how much the figure should
- 6. be, but it's got to be more than gross pay out, so I rise in
- 7. opposition to Senator Sommer's amendment in deference to the
- 8. attitude of...Sommer's name is on that amendment. I guess it
- 9. is Senator Regner's but even...even with more deference to
- 10. your attitude we've got to...we've got to do something better
- 11. than what your amendment does and so therefore, we're...we're
- 12. in support of Senator Weaver's better amendment, which has
- 13. already been adopted.
- 14. PRESIDING OFFICER: (SENATOR BRUCE)
- 15. Is there further discussion? Senator Berning.
- 16. SENATOR BERNING:
- 17. Thank you, Mr. President. For the information of the
- 18. members I want to emphasize that we, a delegation, of members
- 19. of this Senate have met with the Bureau of the Budget. It's
- 20. almost two weeks ago and we are still waiting for word as to
- 21. what the administration feels they can and will support in
- 22. the way of increased funding. Everyone of the Pension Laws
- 23. Commission members as well as the Pension Committee members,
- 24. I believe, almost in toto are of the opinion that we must
- 25. start to amortize that unfunded liability whether it takes
- 26. forty years or twice forty years, but we must start. Lacking
- 27. information yet from the Governor's Office as to what we can
- 28. expect as a result of my Senate Bill 250 and that's the reason
- 29. we're...I am holding it yet. I would suggest that we do take
- 30. this step with Senator Weaver's bill in order to help force
- 31. the issue and I would respectfully take issue with my colleague
- 32. over on this side and suggest that his amendment be rejected.
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- 1. Further discussion? Senator Sommer.
- 2. SENATOR SOMMER:
- 3. Mr. President and members, I'd simply remind you that
- 4. this is one small facet of people who obtain pensions from
- 5. the State. The cost of doing this for everybody has to be
- 6. over twenty some million. Sitting now on our Calendar is
- 7. a Pothole Bill for thirty-five million. A disaster bill
- 8. for thirteen to fifteen million and when we run out of
- 9. money, which we'll do very quickly under...this pace. All
- 10. of you people who vote for this stuff better vote for that
- 11. tax increase to cover it.
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- 13. Is there further discussion? Senator Regner may close.
- 14. SENATOR REGNER:
- 15. You know, Mr. President, I...listening to Senator Buzbee's
- 16. statement I was very amused about one statement he made when he
- 17. was talking about the current AFSCME contract. I happen to be
- 18. in absolute total one hundred percent agreement with what
- 19. Senator Buzbee said on that topic, but Senator, I wonder where
- 20. you were four years ago under former Governor Dan Walker when
- 21. I was fighting the AFSCME issue at that time. If I remember correctly
- 22. you were on the other side at that time. But anyway, to get
- 23. back to this particular appropriation. You know, there are
- 24. only going to be so many dollars available...total dollars
- 25. available for Higher Education. If the universities think that this
- 26. is that high a priority item to reduce proposed pay increases or
- 27. other increases that they're asking for fine, but they're only
- 28. going to be so many dollars available. This is the first bill
- 29. on the Retirement System. If we add the monies to each and
- 30. every retirement system bill it's going to be many, many more
- 31. millions of dollars and just in last statement closing this
- 32. is not net payment it's gross payment. It will allow for some
- 33. monies for investment by the systems.

- PRESIDING OFFICER: (SENATOR BRUCE)
- 2. The motion is to adopt. Those in favor say Aye. There
- 3. has been a request for a roll call. Those in favor will vote
- 4. Ave. Those opposed will vote Nay. The voting is open. Hav
- 5. all voted who wish? Have all voted who wish? Take the record.
- 6. On that question, the Ayes are 7, the Nays are 45. The motion
- 7. to adopt is lost. Further amendments.
- 8. SECRETARY:
- 9. No further amendments.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 3rd reading. Senate Bill 331, Senator Walsh. Senator
- 12. Walsh on the Floor? Okay. Senate Bill 340, Senator Buzbee.
- 13. Read the bill, Mr. Secretary.
- 14. SECRETARY:
- 15. Senate Bill 340.
- 16. (Secretary reads title of bill)
- 17. 2nd reading of the bill. No committee amendments.
- 18. PRESIDING OFFICER: (SENATOR BRUCE)
- 19. Are there amendments from the Floor?
- 20. SECRETARY:
- 21. No Floor amendments.
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- 23. 3rd reading. For what purpose does Senator Rock arise?
- 24. SENATOR ROCK:
- 25. Thank you, Mr. President and Ladies and Gentlemen of the
- Senate. I would propose given the lateness of the starting time,
- 27. that the committees have an inordinate amount of work to do
- 28. this afternoon and I would propose that we now stand adjourned
- 29. until noon tomorrow and we will pick up on 2nd reading where
- 30. we left off so that no one will be out of sorts. Additionally,
- 31. Mr. President, I have caused to be distributed at this moment
- 32. a schedule of committee hearings for the...this week and the
- 33. following two weeks. I would hope that everyone would take a

- 1. look and realize the inordinate amount of work that remains
- 2. to be done in the committees and act accordingly. So, at
- 3. this time, if there are no further announcements or further
- 4. business, I'm prepared to put a motion to adjourn until noon
- 5. tomorrow.
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- 7. For what purpose does Senator Mitchler arise?
- 8. SENATOR MITCHLER:
- 9. Mr. President, I have an inquiry of the President at
- 10. this time. May I...
- 11. PRESIDING OFFICER: (SENATOR BRUCE)
- 12. He indicates he will answer your question. Senator
- 13. Mitchler.
- 14. SENATOR MITCHLER:
- 15. President Rock, on the...on the Calendar we have an order
- 16. of business there on motions and I was wondering at what time
- 17. you are going to move to go the Order of Motions and the
- 18. reason I ask that question, the longer we stay in committees
- 19. the more motions are going to be filed. Now, some of these
- 20. as we know, are just filed, some are with a lot of sincerity
- 21. and I point out I have a Senate Bill 3, which is prefiled
- 22. because I thought it was a type of a piece of legislation
- 23. that should be acted on one way or the other early in the
- 24. Session. Could you give us some indication when we may
- 25. expect that, Sir?
- 26. SENATOR ROCK:
- 27. Yes, we have discussed that with your leadership, Senator,
- 28. and it's the feeling among most of us that there...you are
- 29. correct. There probably will be given the next two weeks of
- 30. committee action more motions to discharge that will be filed.
- 31. Our suggestion is and we are still, frankly, nothing has been
- 32. finalized but the suggestion is that the motions to discharge
- 33. would, in fact, be held until the week of May 4th so that they

- 1. would be well within the committee deadline and yet afford
- 2. the membership an opportunity to hear what they might other-
- 3. wise have missed.
- 4. PRESIDING OFFICER: (SENATOR BRUCE)
- 5. ...Further announcements. Senator Vadalabene.
- 6. SENATOR VADALABENE:
- 7. Yes, I have an announcement...but before I get to...the
- 8. announcement on Amendment No. 2 to Senate Bill 318, I pressed
- 9. my switch to vote No, however the switch was turned off and
- 10. I didn't realize it. Had it been on, I would have voted No.
- 11. Somebody is fooling with my switches again.
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- 13. The record will so indicate. Senator Daley.
- 14. SENATOR DALEY:
- 15. ...Mr. President and fellow Senators, I ask leave of the
- 16. Senate to have Senator Martin as cosponsor of Senate Bill 368,
- 17. with Senator McLendon and myself.
- 18. PRESIDING OFFICER: (SENATOR BRUCE)
- 19. Is there leave? Leave is granted. Senator Joyce.
- 20. SENATOR JEROME JOYCE:
- 21. Yes, Mr. President, Local Government is having a meeting
- 22. at seven o'clock tonight. It was not printed on this Calendar
- 23. but it is on your other Calendar and all of the bills will be
- 24. posted. Sever o'clock tonight.
- 25. PRESIDING OFFICER: (SENATOR BRUCE)
- 26. Seven p.m. for Local Government. For what purpose does
- 27. Senator Vadalabene arise?
- 28. SENATOR VADALABENE:
- 29. Yes, there will be a...a meeting of Executive and Appoint-
- 30. ments and Administration immediately upon adjournment.
- 31. PRESIDING OFFICER: (SENATOR BRUCE)
- 32. All right. Senator Lemke.
- 33. SENATOR VADALABENE:

- 2. PRESIDING OFFICER: (SENATOR BRUCE)
- 3. Did you have an announcement?
- 4. SENATOR LEMKE:
- Sam will make it. Senator...
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Maragos.
- 8. SENATOR MARAGOS:
- 9. Mr. President and members of the Senate. Regarding the
- 10. meeting of the Senate Labor and Commerce Committee this
- 11. afternoon, the Committee as a Whole is going to meet...
- 12. initially in Room 400 and then after initial announcements
- 13. and sending other bills out, which will be heard on Wednesday
