- 21. Senator Savickas to explain Committee Amendment No. 1.

- Yes, Mr. President and members of the Senate. Committee
- 24. Amendment No. 1 is the basic bill. It...it raises from seventy-
- five cents per one hundred dollars of equalized assessed valuation 25.
- to ninety-five cents per hundred dollars of EAV and that's the
- 27. maximum amount of bonds together with all outstanding bonded
- indebtedness the Chicago Park District may issue from time to

- you said seventy-five cents per one hundred dollars of assessed

- 1. valuation to ninety-five cents. Is that by referendum, either
- front door or back door referendum?
- PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Savickas.
- 5 SENATOR SAVICKAS:
- 6. No.
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- 8. Further questions? Senator Grotberg.
- 9. SENATOR GROTBERG:
- Well, thank you, Mr. President. Question of the sponsor,
- 11. please.
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- Indicates he will yield. Senator Grotberg.
- 14. SENATOR GROTBERG:
- Senator Savickas, is this the...the bill that came in as a
- kind of a shell bill and then suddenly it was a twenty-five 16.
- percent or more tax increase for the Park District. Is that 17.
- the same one? My records show it went out on a partisan roll $18.\cdot$
- call and I'm forced to rise on this occasion, Senator.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Savickas.
- 22. SENATOR SAVICKAS:
- Yes. Senator Grotberg, the bill was put in basically as
- a shell bill because it came in at the last minute. The amend-
- ment was finally drafted and we had it for committee to be the 25.
- bill. The amendment was heard in committee and passed out with $26. \,$
- a favorable action and Do Pass as Amended, six to one to four.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Grotberg.
- SENATOR GROTBERG:
- Well, on...on the amendment a moment, Mr. President and 31.
- members of the General Assembly. I did ask in committee if 32.
- it were in the Presidental guidelines and I didn't get a 33.

- 1. responsible answer. It seems like it's a little steep and
- 2. I know the Chicago Park District has to have money, I'm
- 3. not opposed to some kind of an increase. But this is a rather
- 4. giant step in this day and age without referendum and I would
- 5. like to urge my colleagues to oppose this amendment. And a
- 6. roll call.
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- 8. All right. Been a request for a roll call vote at the
- 9. time the motion is put and there will be a roll call. Is
- 10. there further discussion? Senator Weaver.

- 12. Well, Mr. Chairman, just a comment, I guess. I had Senate
- 13. Bill 463 which takes of downstate park districts and that bill
- 14. has a frontdoor referendum and I think all of these tax increases

- 16. backdoor referendum, Senator Savickas.

- 18. Is there further discussion on the Motion to Adopt Committee

- 20. SENATOR SAVICKAS:
- 21. Yes, Mr. President and members of the Senate. This does
- 22. not increase the tax. All it does is allow the park district
- 23. with the increased bonding authority, which allows them with
- 24. increased bonding authority to sell the bonds that may be
- 25. needed. The problem has arisen through the courts denial
- 26. of the personal property tax base. And at this point this
- 27 bill was introduced. Our State Constitution of 1970 mandated
- 28. an abolition of the Personal Property Tax and it affected
- 29. the park district. The park district presently is authorized
- 30. to issue Park Improvement Bonds up to the limit of three
- 31. quarter of one percent of the assessed valuation without
- 32. referendum. This provision was included uniquely and solely
- 33. for the Chicago Park District in recognition of the special

- 1. recreational needs of a large metropolitan area. Under this
- 2. limitation, the Chicago Park District had a total bonding
- 3. power of approximately ninety-six million dollars based on
- 4. the 1977 combined real estate and personal property evaluation.
- 5. The current amount of outstanding Chicago Park District Improve-
- 6. ment Bonds is seventy-one million dollars. And...accordingly
- 7. the district was prepared to issue twenty-four million dollars
- 8. of park improvement bonds in the spring of this year to allow
- g. for further improvements and also for the availability of
- 10. matching funds for the anticipated Urban Park and Recreation
- 11. Program Revenue from grants as established by the Federal
- 12. Government. Based on the 1977 assessed valuation, eighteen
- 13. million of the proposed twenty-four million dollar bond
- 14. issue would have been related to the real estate valuation
- 15. and six million would have been related to the personal
- 16. property valuation. On March 14th of 1979, the Supreme Court
- 17. decision eliminated the Chicago Park District's capability
- 18. to issue the twenty-four million dollar bonds by abolishing
- 19. the Personal Property Tax from the tax base as of January 1st.
- 20. A change in the Chicago Park District's bonding power from
- 21. the present three-quarters of one percent to the ninety-five,
- 22. .95 of one percent of assessed valuation will keep our
- 23. park improvement bonding power limitation at the same eighteen
- 24. million dollar bonding limitation originally proposed against
- 25. the real estate valuation with no increase in the tax obligation
- 26. of real estate property owners. And I think that's important,
- 27. that last statement, with no increase in tax obligation of the
- 28. real estate property owners that existed prior to the Supreme
- 29. Court decision. With this in mind I would solicit a favorable
- 30. vote on adoption of Amendment No. 1 to Senate Bill 602.
- 31. PRESIDING OFFICER: (SENATOR BRUCE)
- The motion is to adopt. Those in favor will vote Aye.
- Those opposed will vote Nay. The voting is open. Have all

- 1. voted who wish? Have all voted who wish? Take the record.
- 2. On that question the Ayes are 28, the Nays are 20, 3 Voting

- 22. SENATOR KNUPPEL:

- 25. bills with the proposition that the bill would be henceforth
- 26. the caption, Knuppel, Johns and Rupp. And the other two bills
- then will be Tabled. And with leave of the Body, I don't know
- 28. where the sponsor is, is Senator Johns here?
- 29. PRESIDING OFFICER: (SENATOR BRUCE)
- He's on the Floor, Senator.
- 31. SENATOR KNUPPEL:
- Is that correct, Senator Johns?
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- 1. The motion...the request, Senator Johns is that the...the
- 2. sponsorship for Senate Bill 673 would be Knuppel-Johns-Rupp.
- 3. SENATOR KNUPPEL:
- 4. That's what the...that's what the agreement was.
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- 6. Is there leave? Leave is granted. Now, Senator Knuppel
- 7. as joint chief sponsor, do you wish the bill read a second
- 8. time today?
- 9. SENATOR KNUPPEL:

- 14. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 15. For what purpose does Senator Ozinga arise?
- 16. SENATOR OZINGA:
- 17. Mr. President, this was up two or three times. I have been
- 18. patient. We have gone to the Order of Business, we were at that
- 19 Order of Business yesterday. We relented because it was a matter
- of time at 2:00 o'clock, if you recall and we agreed to hear it
- 21. this morning sometime. When we were ready at about ten minutes
- 22. after the Session commenced and we've been sitting patiently
- 23. ever since and trying to get this matter up and on the Floor and out
- 24. of this Session. I believe everybody knows it will only take
- 25. a few minutes.
- 26. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 27. Senator Ozinga, I think there's some disagreement. Senator Rock.
- 28 SENATOR ROCK:
- 29. Well, I don't mean to preempt Senator Buzbee, I know he has
- 30. some more to say. But I just...so the record is clear, there was no
- 31. agreement yesterday, at least while I was presiding, that
- 32. ...that this, in fact, we would get to this Order of Business.
- There was an agreement that the motion could well be put, as you are putting it right now. But this determination whether or not

- 1. we're going to go out of order on the daily order of business
- 2. and skip to Consideration Postponed when we, in fact, have
- 3. a number of bills pending on 3rd reading that are of, in my
- 4. judgment, of more significance, is frankly a motion that's
- 5. left to the Body. If you've got thirty votes that say we go to
- 6. this order of business, that's where we'll go. If you don't
- 7. we won't.
- 8. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 9. For what purpose does Senator Buzbee arise?
- 10. SENATOR BUZBEE:
- 11. Well, first of all, Mr. President, I would like to withdraw
- 12. my motion to Table. I would like to remind Senator Ozinga
- 13. that we were not to this order of business yesterday. I specifically
- 14. remember hearing the Senate President say that we were going to
- 15. stop at Senator Knuppel's bill on 3rd reading when we..when we
- 16. got...when we got then to the point of some other business and
- 17. we were not up to this particular order. But I think Senator
- 18. Rock is correct that if you've got thirty votes, you can do
- 19. anything you want to.
- 20. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 21. For what purpose does Senator Shapiro arise?
- 22. SENATOR SHAPIRO:
- 23. Well, Mr. President and Ladies and Gentlemen of the Senate.
- 24. I want to point out to the Body that we have already gone out of
- 25. the order of the regular business today when we considered
- 26. House Bill 533. This is an important State issue, Gentlemen.
- 27. Senator Ozinga has made a legitimate request and I think the Chair
- 28. ought to honor that. He has reiterated to the Chair several
- 29. times that he doesn't intend to make a big issue out of it, that
- 30. there's not going to be an awful lot of debate on it, but there is
- 31. an interest in the bill and I think his request should be
- 32. considered favorably.
- 33. PRESIDING OFFICER: (SENATOR SAVICKAS)

- 1. For what purpose does Senator Rhoads arise?
- 2. SENATOR RHOADS:
- 3. I rise in support of Senator Ozinga's request and just
- 4. want to remind Senator Buzbee that Senator, it's against the rules
- 5. of the Senate to speak with your mouth full.
- 6 PRESIDING OFFICER: ((SENATOR SAVICKAS)
- 7. Senator Ozinga moves that the Senate move to the Order of
- 8. Postponed Consideration. Those in favor indicate by voting
- 9. Aye. Those opposed vote Nay. The voting is open. Have all voted
- who wish? Take the record. Senator Buzbee, for what purpose
- 11. do you arise?
- 12. SENATOR BUZBEE:
- Request verification of the affirmative votes with my mouth
- 14. half full.
- PRESIDING OFFICER: (SENATOR SAVICKAS)
- For what purpose does Sénator Bowers arise?
- 17. SENATOR BOWERS:
- Point of parliamentary inquiry. How many votes does this take?
- PRESIDING OFFICER: (SENATOR SÁVICKAS)
- 20. It takes thirty votes.
- 21. SENATOR BOWERS:
- Under what rule would that be required?
- PRESIDING OFFICER: (SENATOR SAVICKAS)
- Under Rule 4 of the Senate rules. Verification has been
- requested. The roll...on that motion, the Ayes are 30, the 25.
- Nays are 7, none Voting Present. Now, the affirmatives to be 26.
- verified. Mr. Secretary, please verify the affirmatives.
- SECRETARY:
- The following voted in the affirmative:...
- PRESIDING OFFICER: (SENATOR SAVICKAS)
- Wait just...for what purpose does Senator Bruce arise?
- SENATOR BRUCE:
- Well, since this will be the second verification, remind the members that under our new rules, they are to respond when

- 1. their name is called so that it will speed along the verification.
- 2. SECRETARY:
- 3. Becker. Berning. Bloom. Bowers. Coffey. D'Arco.
- 4. D'Arco. Davidson. DeAngelis. Geo-Karis. Grotberg. Jeremiah
- 5. Joyce. Keats. Knuppel. Lemke. Maitland. Martin. McMillan.
- 6. Mitchler. Moore. Nash. Nimrod. Ozinga. Philip. Rhoads.
- 7. Schaffer. Shapiro. Sommer. Walsh. Weaver. Wooten.
- 8. PRESIDING OFFICER: (SENATOR SAVICKAS)
- q Does Senator Buzbee question the presence of any Senator?
- 10. Senator Buzbee.
- 11. SENATOR BUZBEE:
- 12. Senator D'Arco.
- 13. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 14. Is Senator D'Arco here? Mr. Secretary, did Senator D'Arco
- 15. answer the roll call?
- 16. SECRETARY:
- 17. He did not answer the roll call.
- 18. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 19. Is Senator D'Arco present on the Floor? Strike his name
- 20. from the record. For what purpose does Senator Rhoads arise?
- 21. SENATOR BUZBEE:
- 22. I'm not finished yet.
- 23. SENATOR RHOADS:
- 24. Mr....Mr. President, this is a point of order. It takes
- 25. precedence, Senator.
- 26. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 27. State your point. State your point.
- 28. SENATOR RHOADS:
- 29. Senator Buzbee, the galleries are full, we have witnesses
- 30. here. We all saw Senator D'Arco on the Floor, we all saw
- 31. Senator Lemke on the Floor. Now, if you are going to try to
- 32. establish a precedent, that people who are not physically on the
- 33. Floor can be stricken from the roll call, I just want to know if that's the way you're going because...

- 1. PRESIDING OFFICER: (SENATOR SAVICKAS)
- Senator, will you state your point.
- 3. SENATOR RHOADS:
- 4. ...we will ...we will follow the same precedent, Senator.
- 5. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 6. Senator Buzbee.
- 7. SENATOR BUZBEE:
- 8. Well, the Senator's threat strikes fear into the very
- 9. roots of my heart and then his outburst of...with the galleries
- 10. being filled today by the press and by young school
- 11. children, I'm glad to see that he has expressed his true self
- 12. with his outbursts. Now, the fact of the matter is, Senators
- 13. D'Arco or Nash did not answer the roll when it was verified and
- 14. they, in fact, were not on the Floor when the verification
- 15. went through. So, therefore, I would submit to you that
- 16. the required thirty votes were not here, Mr. President. Thank
- 17. you.
- 18. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 19. On that question the Ayes are 29, the Nays are 7 and the
- 20. motion having not received a constitutional majority fails.
- 21. Senator Knuppel, for what purpose do you arise?
- 22. SENATOR KNUPPEL:
- 23. Matter of personal privilege. When we have a circus, I
- 24. want Senator Rhoads to know I am the ringmaster.
- 25. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 26. He will be so informed. For what purpose does Senator Rhoads
- 27. arise?
- 28. SENATOR RHOADS:
- On a point of personal privilege.
- 30. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 31. State your point.
- SENATOR RHOADS:
- Mr. President, I apologize to the Body for the use of off-color language and I defer to ringmaster Knuppel. I won't...try

- 1. not to let it happen again. I do think, however, that this is a good
- 2. example of the mockery of the rules of the Senate. This isn't
- 3. the first time that it's happened. It happened earlier today
- 4. when a committee was meeting while the Senate was in Session.
- 5. Now, the rules are made for...for common sense reasons,
- 6. to protect the rights of...of members and to protect the rights
- 7. of the citizenry that's represented here. We've just seen
- 8. a mockery of those rules in full view of everyone. There
- 9. were thirty affirmative votes physically present on the Floor
- 10. and yet we are announcing a roll call that indicates less than
- 11. thirty affirmative votes. If you want to portray this kind of
- 12. image to the people of Illinois, I think you're making a big
- 13. mistake.
- PRESIDING OFFICER: (SENATOR SAVICKAS)
- For what purpose does Senator Bruce arise?
- 16. SENATOR BRUCE:
- Well, it is only April, so we save these things until
- 18. late June, usually, but I...I just don't think the comment
- 19. that we are running roughshod with the rules over anyone ought
- 20. to go without some challenge. I would just read to the Senate
- Rule 23 concerning verification and because we do get into very
- 22. serious questions about verification and to my knowledge in the
- few years I've served here under three Presiding Officers, I
- frankly feel that everyone is...has bent over backwards to
- make sure that verification is property handled. All it
- says in that rule and it's as clear as can be, "if a Senator
- 27. does not answer, his name shall be stricken from the roll call."
- Now, if anyone objects to that rule, we will have Rules Committee 28.
- meetings throughout this Session. I am sure that that...that rule
- can be challenged, but if he does not answer and he is not 30.
- present, his name should be stricken as provided by our rules 31.
- and that is the way, as far as I...as long as I've been here, 32.
- that is the rule that we followed.

- 1. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 2. Your point...your statement is well taken. For what
- 3. purpose does Senator Ozinga arise?
- 4. SENATOR OZINGA:
- 5. To answer a few remarks that were made. It was said that this
- 6. bill was heard. As you all remember, it was heard with an...
- 7. a preemption clause on the bill. I respected the request at that
- 8. first hearing, moved the bill back, took off the preemption
- 9. and if you will recall, at that first hearing, there were twelve
- 10. switches that did not work. If we could have had it at that time,
- 11. there was a possibility or a probability that this bill would have
- 12. been passed the first time. But with those twelve switches
- 13. not working at that time, we felt, I felt that we did not give
- 14. it a fair hearing and I personally feel that now with the
- 15. preemption clause off, this is in the same exact nature as
- 16. a first hearing on a bill even though because of the switches
- 17. and everybody remembers, there were twelve switches including
- 18. Senator Buzbee, who got up and vehemently protested because his
- 19. switch did not work. Now, even if we did not have his vote on
- 20. that vote...on that roll call, there was a possibility that it would
- 21. have passed the first time around. Now, I respectfully request
- 22. that this be reheard or...at least given us a chance so that the bill
- 23. can get over to the House and have its debates over there. Now,
- 24. I think it's only fair when you say reach this order of
- 25. business, I've been very patient. In fact, the news media have been
- 26. on my back and you all know I've been on your back to try to
- 27. solicit your vote for it and I honestly respectfully state that there
- 28. were more than thirty-seven votes that were in favor of this bill.
- 29. Now, with the games that are being played at this stage, I think that
- 30. the entire world should see and know just exactly. I'm not
- 31. married to the bill, but I think that it's morally right that it should
- 32. be given a fair hearing here as quick as we possibly can and get it
- 33. over to the House.

- 1. PRESIDING OFFICER: (SENATOR SAVICKAS)
- For what purpose does Senator Nimrod arise?
- 3. SENATOR NIMROD:
- 4. Mr. President, I would just ask if when we took the roll on
- 5. this bill, it was called, there...my question is that the procedure
- 6. is that we ask twice if all who have voted...all that wish have
- 7. voted and then we take...for the roll. It was only called
- 8. once in your particular haste or overlook and oversight.
- 9. I just wonder if we might be able to have another roll call on
- 10. that vote of the one...because we really did not have a chance
- 11. to vote on it and if you look at the...listen to the tape,
- 12. I think you will hear that it was only...that it was only acknowledged
- 13. once and it was a fast call. Would you reconsider...
- 14. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 15. Is that a statement or a question?
- 16. SENATOR NIMROD:
- 17. Would you...well, to my...my recollection, it was only called
- 18. once and I would ask if you would allow us to vote on that again.
- 19. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 20. Well, Senator, we have already voted on the issue. For
- 21. what purpose does Senator Berning arise?
- 22. SENATOR BERNING:
- 23. Mr. President, I assume it would not have to be on a point
- 24. of personal privilege.
- 25. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 26. State your point.
- 27. SENATOR BERNING:
- 28. I'm referring back to Rule 23, Mr. President, and the
- 29. sentence read by Senator Bruce is correct. If a Senator does not
- 30. answer, his name shall be stricken from the roll call. That, of
- 31. course, presents a very interesting possibility, but it points
- $_{
 m 32.}$ up to all of us how we can diligently address ourselves to
- 33. an issue or to rules and when a moment of crisis arrives we find we have not thought of everything. I submit to you that when it says

- 1. above, "while the results of any roll call are being
- 2. verified, it shall be in order for any Senator to announce
- 3. his presence on the Floor and thereby having his vote verified."
- 4. Those of us who witnessed Senators on the Floor during the
- 5. verification, are denied the right to say that somebody was
- 6. on the Floor but other Senators can be sitting here on the
- 7. Floor and not respond and I submit according to that rule,
- 8. would be stricken from the roll call. Now, there is something
- 9. that is not quite right with those two provisions, Mr. Chairman.
- 10. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 11. 'Is...
- 12 SENATOR BERNING:
- 13. I respectfully suggest that the Rules Committee reevaluate
- 14. these two provisions.
- 15. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 16. For what purpose does Senator Knuppel arise?
- 17. SENATOR KNUPPEL:
- 18. Well, it's apparent that we're going to have a lot of
- 19. drivel here on both sides. I...I...I agree with Senator Ozinga
- 20. that he's entitled to get this heard...matter heard at an early
- 21. date, but I don't think it's going to happen today, so I'm going
- 22. to move that we adjourn until 12:00 o'clock tomorrow.
- 23. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 24. You've heard the motion. Those in favor indicate by saying
- 25. Aye. Those opposed. The Senate stands adjourned until noon,
- 26. Thursday, April 26, 1979. Are there any announcements?
- 27. Senator Maragos.
- 28. SENATOR MARAGOS:
- 29. Yes, I'd like to...announce that the Labor and Commerce
- 30. will meet at 4:30 instead of 5:00.
- 31. PRESIDING OFFICER: (SENATOR SAVICKAS)
- 32. Thank you.
