18. anyone who has a bill in Judiciary I I can only go along with
19. what Senator Daley has stated, that the rules be suspended,
20. that the committee be discharged and the bills be placed
21. upon the Order of 2nd reading.

23. Well, allow me...allow the Chair to suggest that, at
24. least, the...the motion listing those bills would be in
25. order so that the membership would have some idea upon what...
26. about what they're voting. A motion to discharge a committee
27. will require thirty affirmative votes. Senator D'Arco.

6. Both talked to Senator D'Arco and find out some of his
7. problems.

13. ...temporarily withdrawn. Committee Reports. Hold on
14. just a minute, Mr. Secretary. Senator Ozinga, for what

17. I guess one would have to call this a matter of personal

27. substantial number of us there and at that breakfast this
28. morning the President of this Senate read a prayer or
29. delivered a prayer and I would respectfully request that
30. he give each and every member of this Body a copy of that
31. prayer to be read every morning and I won't say in place of
32. a pastor but at least to get started off on the right foot
33. and I thought this morning, Mr. President, that prayer was

2. put in writing and delivered to each member of this Senate.

28. significantly amended on the Floor but had not had a debt
29. impact note attached to it before that stage and to set out
30. the procedure for that. A third provision was to make...to
31. attempt to deal with the problem of certification by the
32. President of the Senate and the Speaker of the House as
33. being conclusive and that, of course, has to do with bond

1. counsel at a later stage. Most of the rest of it, I believe,
2. could be described as housekeeping. I would move the adoption
3. of Committee Amendment No. 1 to Senate Bill 799.

29. to "advice" and consent of the Senate and I move its adoption.
