32. ask this Body concur with the House action on Senate Bill 248
33. on Amendment No. 1, 2, 3, and 4. House Amendment No. 1 adds

1. nine hundred and eighty thousand five hundred and twenty dollars
2. into Operational Line Items. House Amendment No. 2 adds
3. 8.5..., eight million five hundred and thirty
4. thousand dollars for the RTA, which represents increased
5. collections of Sales Tax in FY-79. House Amendment No. 3 adds
6. thirty-eight thousand for the State's share of the cost of
7. subsidizing Taxicab Transportation Program in Decatur, for
8. thirteen thousand, Champaign, for twenty-five thousand. House
9. Amendment No. 4 adds transfer of funds within the FY-79
10. Appropriations for the State Fire Marshal's Office, in the
11. amount of forty-three thousand dollars. Senate Bill 944 lost
12. in the House, which took care of this originally, because
13. an amendment was tacked on, and I'd ask for a favorable roll
14. call.

15. PRESIDENT:

16. Is there any discussion? Senator Rhoads.

17. SENATOR RHOADS:

18. A question of the sponsor, with regards...

19. PRESIDENT:

20. Indicates he will yield. Senator Rhoads.

21. SENATOR RHOADS:

22. Senator Coffey, with regard to House Amendment No. 2,
23. the eight million five thirty for the RTA, is that simply a
24. flow-through, sort of a pass-through from the increased
25. collections on the Tax?

26. PRESIDENT:

27. Senator Coffey.

28. SENATOR COFFEY:

29. Yes, it automatically goes into the Fund. It's part
30. of the one-thirty second...the RTA's reassessment.

31. PRESIDENT:

32. Further discussion? Senator Mitchler.

33. SENATOR MITCHLER:

Senator Coffey, on House Amendment No. 1 to Senate Bill 248,

1. what part in there refers to the Coastal Zone Management?
2. Is this increase...giving an appropriation to the DOT for
3. Coastal Zone Management Program?

4. PRESIDENT:

5. Senator Coffey.

6. SENATOR COFFEY:

7. Yes, it reduces thirty-three thousand five hundred dollars
8. that was already there for Coastal Zone Management. It's
9. a decrease.

10. PRESIDENT:

11. Senator Mitchler.

12. SENATOR MITCHLER:

13. Well, the Coastal Zone Management Program is defunct.
14. Why would you have any appropriation in there for that?

15. PRESIDENT:

16. Senator Coffey.

17. SENATOR COFFEY:

18. Well, Senator Mitchler, this was last year's appropriation,
19. and they're decreasing it now, in this amendment.

20. PRESIDENT:

21. Senator Keats.

22. SENATOR KEATS:

23. I would ask that we hold this bill until we get this
24. cleared up. That's a non-existent organization, and while
25. we may all gripe about the bureaucracy once in a while, but
26. for us to appropriate to a non-existent organization is not
27. one of our better efforts, and I would ask that this bill
28. be held until we get this cleared up.

29. PRESIDENT:

30. Senator Coffey.

31. SENATOR COFFEY:

32. Well, Mr. President, I might just answer that this money
33. was put in originally, and it wasn't used, and we're taking
it back out. We're not putting anything in.

1. PRESIDENT:

2. Senator Mitchler.

3. SENATOR MITCHLER:

4. Well, maybe that last statement clarifies it, Senator
5. Coffey. You mean there was an appropriation of X amount of
6. dollars for the Coastal Zone Management in FY-'79, and now
7. this is removing that...a portion of that out of the bill?
8. In other words, because they went out of existence...taking
9. out...I have no objections.

10. PRESIDENT:

11. All right. Any further discussion? If not, the question
12. is shall the Senate concur in House Amendments 1, 2, 3, and 4
13. to Senate Bill 248. Those in favor will vote Aye. Those
14. opposed will vote Nay. The voting is open. Have all voted
15. who wish? Have all voted who wish? Take the record. On that
16. question, the Ayes are 40, the Nays are 11. None Voting Present.
17. Senate...The House...The Senate does concur in House Amendments
18. 1, 2, 3, and 4 to Senate Bill 248, and the bill, having
19. received the required constitutional majority, is declared
20. passed. Senator Grotberg, for what purpose do you rise?

21. SENATOR GROTBORG:

22. Mr. President, as regards...House Bill 140. By
23. agreement with the House sponsor, I would like to relinquish
24. the Senate sponsorship to the distinguished Senator Sangmeister.
25. Immediately.

26. PRESIDENT:

27. You've heard the request. Is leave granted? Leave is
28. granted. Senator Donnewald, for what purpose do you rise?

29. SENATOR DONNEWALD:

30. Yes, Mr. President. I would like to re-refer House
31. Bill 853, from Labor and Commerce to the Committee on
32. Education. It's an identical bill.

33. PRESIDENT:

You've heard the request. Is leave granted? Leave is

1. granted. So ordered. Senator Bruce, for what
2. purpose do you rise?

3. SENATOR BRUCE:

4. There's several bills that have been picked up by
5. sponsors, and they should be changed from one sponsor to
6. another, under Rule 4. I would move that the sponsorship
7. of House Bill 1494 be changed from Senator Collins to
8. Senator Rock; that House Bill 1008 be changed from
9. Senator...myself, Bruce, to Jerome Joyce, and House
10. Bill 2012 be changed from Senator D'Arco to myself, and
11. 2006 be changed from Jeremiah Joyce to myself.

12. PRESIDENT:

13. All right. Senator Bruce has moved, pursuant to Rule
14. 4, to exceed the request of the House sponsor. Is leave
15. granted? Leave is granted. So ordered. All right,
16. we have one further FY-'79 Appropriation to deal with, and
17. that is on the Order of House...with leave of the Body, we
18. will go to the Order of House Bills, 2nd reading, House
19. Bill 357, the middle of page 13. Leave is granted. On
20. the Order of House Bills, 2nd reading, House Bill 357.
21. Read the bill, Mr. Secretary.

22. ACTING SECRETARY: (MR. FERNANDES)

23. House Bill 357.

24. (Secretary reads title of bill)

25. 2nd reading of the bill. No Committee Amendments.

26. PRESIDENT:

27. Any amendments from the Floor?

28. ACTING SECRETARY: (MR. FERNANDES)

29. Amendment No. 1, offered by Senator Carroll.

30. PRESIDENT:

31. Senator Carroll.

32. SENATOR CARROLL:

33. Thank you, Mr. President, Ladies and Gentlemen of the
Senate. This would change the transfer to represent the

1. State Appellate Defenders latest estimates of expenditures for
2. FY-79. It is a reduction of some twenty-two hundred twenty-
3. eight dollars, and I would move adoption of Amendment No. 1.

4. PRESIDENT:

5. Senator Carroll has moved the adoption of Amendment No. 1
6. to House Bill 357. Is there any discussion? If not, all in
7. favor signify by saying Aye. All opposed. The Ayes have it.
8. The amendment is adopted. Any further amendments?

9. ACTING SECRETARY: (MR. FERNANDES)

10. No further amendments.

11. PRESIDENT:

12. 3rd reading. It is approaching the hour of two o'clock.
13. There are committees scheduled. Is there any further
14. business or further announcements? Or any announcements?
15. Senator Merlo, for what purpose do you rise?

16. SENATOR MERLO:

17. Mr. President, I would like to seek leave of this Body
18. to return Senate Joint Resolution 40 to be reconsidered. The
19. reason, of course, being we did neglect to adopt an amendment.

20. PRESIDENT:

21. All right. Senator Merlo seeks leave of the Body to go
22. to the Order of Resolutions for the purpose of reconsidering
23. the vote by which Senate Joint Resolution 40 has passed. A
24. Committee Amendment was neglected to be adopted. Senator
25. Merlo moves to reconsider the vote by which Senate Joint
26. Resolution 40 has passed. A roll call will be required.

29. SENATOR RHOADS:

30. Just one technical question, Mr. President. Is that
31. still physically in the possession of the Senate?

32. PRESIDENT:

33. It is. Senator Philip.

SENATOR PHILIP:

1. I just have an announcement, Mr. President...

2. PRESIDENT:

3. Oh...We're...

4. SENATOR PHILIP:

5. I'll wait until after the vote.

6. PRESIDENT:

7. Thank you. All right. Senator Merlo has moved to
8. reconsider the vote by which Senate Joint Resolution 40
9. was declared passed. Those in favor of Senator Merlo's
10. motion will vote Aye. Those opposed will vote Nay. The
11. voting is open. Have all voted who wish? Have all voted
12. who wish? Take the record. On that question, the Ayes are
13. 48, the Nays are none. None Voting Present. The vote by
14. which Senate Joint Resolution 40 was declared passed is now
15. reconsidered. Now pending before the Body is Senate Joint
16. Resolution 40. Senator Merlo.

17. SENATOR MERLO:

18. Mr. President, I believe the next procedure would be
19. to recall it back to 2nd reading for the amendment.

20. PRESIDENT:

21. Well, you can just explain the amendment, and move its
22. adoption.

23. SENATOR MERLO:

24. Okay...All right. The amendment, Ladies and Gentlemen,
25. merely increases the membership on the committee from twelve
26. to sixteen. It also deletes that portion where the special...
27. deletes that portion where the appropriation would be paid
28. out of the Special Committee of the House of Representatives.
29. There is a special appropriation for this particular committee,
30. and I ask the adoption of the resolution...

31. PRESIDENT:

32. Senator Merlo has moved the adoption of Amendment No. 1
33. to Senate Joint Resolution 40. Is there any discussion? If
not, all in favor signify by saying Aye. All opposed. The

1. Ayes have it. The amendment is adopted. All right. Senator
2. Merlo, do you wish immediate consideration and hopefully
3. adoption of Senate Joint Resolution 40?
4. SENATOR MERLO:
5. Yes.
6. PRESIDENT:
7. All right. On the Order of Resolutions, Senate Joint
8. Resolution 40. Senator Merlo.
9. SENATOR MERLO:
10. And now, Mr. Speaker, I move the adoption of the resolution,
11. as amended. Pardon me, Mr. President. I'm sorry.
12. PRESIDENT:
13. I've been called worse.

24. Resolution number 40 is declared passed. Any further business?
25. Senator Shapiro...to come before the Senate? Senator Philip.
26. SENATOR PHILIP:
27. With leave, Mr. President, I'd like to make an announcement.
28. PRESIDENT:
29. You are in order.
30. SENATOR PHILIP:
31. Remind the baseball players in the Senate that we have
32. the Annual Senate-House Softball Game tonight. Six o'clock.
33. Chamberlain Park, and maybe...I'll try to explain where
Chamberlain Park is. You all know where Capitol Avenue is, on

1. the East side of the Capitol. It's approximately twenty
2. blocks straight East. Hope that everybody would be there
3. on time. The baseball players, I hope, would be there at
4. five-thirty. The team has had four practices. The last
5. practice, we beat our Senate Staff eleven to six, two
6. double plays. The team looks very good. If you get ten
7. runs, make a bet.

8. PRESIDENT:

9. Any further discussion? Senator Nimrod.

10. SENATOR NIMROD:

11. Also, Mr. President, thank you...due to your request,
12. and I know the two co-captains...you've issued shirts to
13. all of the Senators. It would be nice if, besides the
14. ballplayers, that we have everyone wear their shirts out
15. there tonight, and let's see if we can't make a good showing.

16. PRESIDENT:

17. All right. Any further business or further announcements?
18. If not, Senator Carroll moves that the Senate stand adjourned
19. until Thursday, June 7, at the hour of noon. The Senate
