- Desk, Resolutions, is Senate Resolution 157. Senator Chew. 33.

- 1. SENATOR CHEW:
- 2. Thank you, Mr. President. This resolution came out of
- 3. Executive. It is requesting that the Legislative Investigating
- 4. Commission investigate the possibility of true shortage of gasoline
- 5. in the State of Illinois and I would move for its adoption.
- 6. PRESIDENT:
- 7. Senator Chew has moved the adoption of Senate Resolution
- 8. 157. Is there any discussion? Senator Washington.
- 9. SENATOR WASHINGTON:
- 10. Yes, will the sponsor yield to a question?
- 11. PRESIDENT:
- 12. Indicates he will yield, Senator Washington.
- 13. SENATOR WASHINGTON:
- 14. Is that commission still meeting? I have been reading in
- 15. the paper that they haven't met in six months.
- 16. PRESIDENT:
- 17. Senator Chew. .
- 18. SENATOR CHEW:
- 19. It has not been disbanded, Senator, and I suppose with
- 20. this resolution they will adhere to the...the...of the...
- 21. of the resolution.
- 22. PRESIDENT:
- Senator Washington.
- 24. SENATOR WASHINGTON:
- I would feel more comfortable if you'd get some kind of
- 26. a statement from the Chairman that they will meet because we've
- 27. got to pass on their budget among other things, if they're not
- 28. spending their money, we should know it.
- 29. PRESIDENT:
- 30. Senator Chew.
- 31. SENATOR CHEW:
- Senator, I think the commission has been doing an excellent
- job. Of course if you are against the resolution simply because

- they have not had anything to investigate, then that's your
- prerogative.
- 3. PRESIDENT:
- Senator Washington.
- 5. SENATOR WASHINGTON:
- 6. I'm not so certain they're doing a good job. They studied
- 7. arson and they came out with the conclusion that arson was
- 8. illegal burning, period. They studied the currency exchanges
- 9. and found that there was no discrimination in...in rates. What
- 10. else did they study, I don't know, red-lining they studied Charlie
- 11. and couldn't find any. Couldn't find any red-lining, Charlie.
- 12. It's right around the corner from where you live.
- 13. PRESIDENT:
- 14. Any further discussion? Sure picked a good place to start,
- 15. Senator D'Arco.
- 16. SENATOR D'ARCO:
- 17. Now Mr...Mr. President, what...what was...what does this
- 18. resolution do? Is that...your...no wait, he's asking the Legislative
- 19. Investigating Commission to investigate something?
- 20. PRESIDENT:
- 21. That is correct.
- 22. SENATOR D'ARCO:
- Well, as far as I'm concerned, I don't think their appropriation
- 24. bill should get out of the Senate. So I don't...I don't see the
- 25. necessity for having them investigate anything, really.
- 26. PRESIDENT:
- 27. Senator Vadalabene.
- 28. SENATOR VADALABENE:
- 29. Yes, and I'm being extremely serious about this, Senator Chew,
- 30. and you have a big smile on your face. I would request this
- 31. Legislative Commission to investigate the cabooses and why there's
- 32. not cabooses on these trains. You fought for them not to be on
- 33. there, I think this commission ought to see why they're not

- 1. on there.

- 3. Senator Chew.
- 4. SENATOR CHEW:
- 5. Senator, I'd be only too glad to vote with you that the
- 6. Legislative Investigating Committee or Commission would
- 7. investigate the caboose on the train. I opposed the amendment
- 8. in which you put in there. I'm not saying it's all God and
- 9. thee, that was the only agency that I thought would be
- 10. adequate to launch this investigation. That is why I put it
- 11. in the resolution. I would ask for a favorable roll call.

- 13. Senator Chew has moved the adoption of Senate Resolution
- 14. 157. A roll call has been requested. Those in favor...those

- 29. Senator DeAngelis has moved the adoption of Senate Resolution
- 30. 175. Is there any discussion? If not, all in favor signify by
- 31. saying Aye. All opposed. The Ayes have it. The resolution is
- 32. adopted. Senate Resolution 183, Senator Newhouse. Senate Resolution
- 33. 196, Senator Johns. Senator Johns.

- 2. Thank you, Mr. President, members of the Senate. This
- 3. particular resolution is directed to President Carter, United
- 4. States Congress and to the Veterans Administrations in Washington.
- 5 For years there has been money available to provide an additional
- 6. sixty bed facility at the Marion Veteran Hospital in Marion,
- 7. Illinois. The Carter Administration and the Veterans Administration
- A. have both seen fit to neglect this money and the urgence of the
- 9. Veterans to do so. The facility would serve a four bed, I mean
- 10. a four state area and also in the resolution, I urge the Congress
- and President to reverse its policy on outpatient care to Veterans.

- Yes, Mr. President, Ladies and Gentlemen of the Senate. This
- 3. resolution calls for three members from each side to be appointed
- 4. to a committee to report back here by the first day that we're
- 5. back in Session this fall on covering the provisions of Senate
- 6. Bill 1361. Which is a bill I had in Elementary and Secondary
- 7. Education which would tighten some of the provisions presently
- 8. existing on sex education. No, that bill was held in committee
- 9. and we felt that hearing...between now and then might bring
- 10. some facts, that's what they asked in the committee, bring
- 11. back some reports back so the committee can decide on the
- 12. bill's provisions. I would move for a favorable roll call.
- 13. PRESIDENT:
- Senator Nimrod has moved the adoption of Senate Resolution
- 15. 205. Is there any discussion? If not, all in favor signify
- 16. by saying Aye. All opposed. The Ayes have it, the resolution
- 17. is adopted. 206, Senator Buzbee. On the Order of Secretary's
- 18. Desk, Resolutions, top of page 40, Senate Resolution 206.
- 19. Senator Buzbee.
- 20. SENATOR BUZBEE:
- Thank you, Mr. President. This calls for the colleges,
- universities, governing boards of the Board of Higher Education
- 23. to continue to undertake their institutional cost studies and
- 24. to address the funding disparities that remain in the FY 81
- 25. appropriation to insure a funding base...an equal...an equitable
- 26. funding base rather than an equal one for all students. This
- 27. is cosponsored by the...two chairmen and the two minority
- 28. spokesmen of the Approporiation Committees and I would ask for
- 29. its adoption.
- 30. PRESIDENT:
- Senator Buzbee has moved the adoption of Senate Resolution
- 206. Is there any discussion? If not, all in favor signify
- by saying Aye. All opposed. The Ayes have it, the resolution 33.

- 1. is adopted. 226, Senator Donnewald, would you mind handling
- 2. that for Senator Netsch and I. I just wanted Senator Donnewald
- 3. to explain it. Senator Netsch.
- 4. SENATOR NETSCH:
- 5. Senator Rock, if you would prefer, I would be happy to
- 6. take the Chair and let you come down and...and handle it.
- 7. PRESIDENT:
- 8. Well, Senator...I'm sure Senator Donnewald can do it.
- 9. Senator Donnewald.
- 10. SENATOR DONNEWALD:
- 11. I'm about to move to Table that resolution.
- 12. PRESIDENT:
- 13. Senator Netsch.
- 14. SENATOR NETSCH:
- 15. It..:it deals only with commemorating the anniversary of
- 16. Illinois' ratification of Women's Sufferage. Now, I know that
- there are a few of you who are sorry it ever happened. But, in
- 18. fact, it's some sixty years past and fellows, why don't you
- 19. just give up and give in. We do vote, we are allowed to vote
- and the world hasn't come to an end because we have voted.
- PRESIDENT:
- All right, we're not going to take a vote on that question.
- I mean whether or not the world's come to an end. Senator
- Netsch has moved the adoption of Senate Resolution 226. All
- in favor signify by saying Aye. All opposed. The Ayes have
- it, the resolution is adopted. 227, Senator Wooten. House
- Joint Resolution 22, Senator Berman. On the Order of Secretary's 27.
- Desk, Resolutions, House Joint Resolution 22. Senator Berman.
- 29. SENATOR BERMAN:
- Thank you, Mr. President. House Joint Resolution 22 calls
- for the creation of a Special Joint Committee of sixteen members 31.
- to investigate and report back by March of 1980 on the long 32.
- term care situation. I'm sure we're all familiar with... with 33.

- 1. many of the issues that are involved and I...in many districts
- 2. throughout the State and especially along the north side of
- 3. Chicago, this is a crucial issue. Move the adoption of House
- 4. Joint Resolution 22.
- 5. PRESIDENT:
- 6. Senator Berman has moved the adoption of House Joint
- 7. Resolution 22. This will require a roll call. Those in favor
- 8. of the adoption will vote Aye. Those opposed will vote No.
- 9. The voting is open. Have all voted who wish? Have all voted
- 10. who wish? Take the record. On that question there are 36
- 11. Ayes, 7 Nays, none Voting Present. House Joint Resolution
- 12. 22 is adopted. Back to page 39, Senate Resolution 203. On
- 13. the Order of Secretary's Desk, Resolutions, page 39 on the
- 14. Calendar, Senate Resolution 203, Senator Savickas.
- 15. SENATOR SAVICKAS:
- 16. Mr. President and members of the Senate. Senate Resolution
- 17. 203 and 204 urge the Senate and the General Assembly to join
- 18. with Viktoras Petkus and Balys Gajauskas, Lithuanians who
- 19. were imprisioned in Russia because of their religious convictions
- 20. and political beliefs and we're just urging that Charles Percy
- 21. and Adlai Stevenson, our U. S. Senators, get a copy of this
- 22. resolution to help them be released from their prison. I would
- 23. appreciate a favorable...adoption of this resolution.
- 24. PRESIDENT:
- 25. All right. Senator...Senator Savickas has moved the adoption
- 26. of Senate Resolutions 203 and 204. Is there any discussion?
- 27. If not, all in favor signify by saying Aye. All opposed. The
- 28. Ayes have it. The resolution...Senate Resolutions 203 and 204
- 29. are adopted. HJR 25, Senator Knuppel. HJR 27, Senator Buzbee.
- 30. On the Order of Secretary's Desk, Resolutions, is House Joint
- 31. Resolution 27, Senator Buzbee.
- 32. SENATOR BUZBEE:
- Thank you, Mr. President. This...directs the Economic and

- 1. Fiscal Commission to undertake a study of economic condition
- 2. of the Illinois Coal Mining Industry and I would ask for its
- 3. adoption.
- 4. PRESIDENT:
- 5. Senator Buzbee has moved the adoption of House Joint
- 6. Resolution 27. All those in favor signify by saying Aye.
- 7. All opposed. The Ayes have it. The amendment...the resolution
- 8. is adopted. HJR 34, Senator Vadalabene. On the Order of Secretary's
- 9. Desk, Resolutions, is House Joint Resolution 34, Senator Vadalabene.
- 10. SENATOR VADALABENE:
- 11. Yes, Mr. President and members of the Senate. House Joint
- 12. Resolution 34 resolves that the Illinois Cities and Villages,
- 13. Municipal Problem Commission consider and recommend changes
- 14. concerning grading schedules for municipal fire protection.
- 15. And the commission is directed to report its findings to the
- 16. General Assembly not later than January 1, 1980 and I move for
- 17. the adoption of HJR 34.
- 18. PRESIDENT:
- 19. Senator Vadalabene has moved the adoption of House Joint
- 20. Resolution 34. Is there any discussion? If not, all in favor
- 21. signify by saying Aye. All opposed. The Ayes have it. The
- 22. resolution is adopted. House Joint Resolution 38, Senator
- 23. Becker. Senator Becker.
- 24. SENATOR BECKER:
- 25. Thank you, Mr. President and members of the Senate. House
- 26. Joint Resolution 38...requests the United States Congress to
- 27. exempt interest on savings accounts of senior citizens from
- 28. Federal Income Tax and I move for the adoption of this amendment.
- 29. PRESIDENT:
- 30. Senator Becker has moved the adoption of House Joint
- 31. Resolution 38. Is there any discussion? Senator Maragos.
- 32. Senator Maragos. Senator Maragos. Going, going, gone. Senator
- 33. Maragos.

- 1. SENATOR MARAGOS:
- 2. I wanted to ask on...does it include any income cap on that
- 3. resolution for over sixty-five or does it include all people
- 4. over sixty-five?
- 5. PRESIDENT:
- 6. Senator Becker.
- 7. SENATOR BECKER:
- 8. Would you repeat that please, Senator.
- 9. PRESIDENT:
- 10. Senator Maragos.
- 11. SENATOR MARAGOS:
- 12. I'm asking whether your resolution has a cap on the income
- 13. of those...of over sixty-five or not? Does it include all people
- 14. over sixty-five?
- 15. PRESIDENT:
- 16. Senator Becker.
- 17. SENATOR BECKER:
- 18. All people over sixty-five, Senator.
- 19. PRESIDENT:
- 20. All right. Senator Becker has moved the adoption of House
- 21. Joint Resolution 38. All in favor signify by saying Aye. All
- opposed. The Ayes have it, the amendment is adopted. On the
- 23. Order of Secretary's Desk, Resolutions, is House Joint Resolution
- 24. 53, Senator Vadalabene.
- 25. SENATOR VADALABENE:
- Yes, thank you, Mr. President. I want the members to listen
- 27. to this resolution 'cause it must be really historic. House
- 28. Joint Resolution addresses itself that the month of May, 1979
- 29. should be...should be proclaimed National Tavern Month. This
- 30. ...this resolution was adopted by voice...by a voice vote in
- 31. the House and there is a technical error in it. The fourth,
- whereas, should have been amended to reflect that corner tavern
- owners may be women. It also that it was resolved that this

- 1. suitable copy of this preamble and resolution be tossed to
- 2. the winds of hilarity. I move that House Joint Resolution
- 3. 53 should be adopted, even through a month behind.
- 4. PRESIDENT:
- 5. Senator Vadalabene has moved the adoption of House Joint
- 6. Resolution 53. Is there any discussion? If not, all in favor
- 7. signify by saying Aye. All opposed. The Ayes have it. House
- 8. Joint Resolution 53 is adopted. HJR 54, on the Order of
- 9. Secretary's Desk, Resolutions, House Joint Resolution 54, Senator
- 10. Coffey.
- 11. SENATOR COFFEY:
- 12. Yes, Mr. President, members of the Senate. House Joint
- 13. Resolution 54 was suggested by several businessmen and...and
- 14. civic leaders in Vermilion County and several of the civic
- 15. groups to direct us to name the Denmark Road Bridge over
- 16. Lake Vermilion to be named after Earl Dallas and which would
- 17. be called the Earl Dallas Bowman Memorial Bridge and I'd
- 18. ask...and also it directs the Department of Transportion to
- 19. erect signs so stated. I'd ask for a favorable roll call.
- 20. PRESIDENT:
- 21. Senator Coffey has moved the adoption of House Joint
- 22. Resolution 54. Is there any discussion? If not, all in
- 23. 'favor signify by saying Aye. All opposed. The Ayes have
- 24. it. House Joint Resolution 54 is adopted. Senator Chew, for
- 25. what purpose do you arise?
- 26. SENATOR CHEW:
- Mr. President, I'm...I would like to make a motion, having
- 28. voted on the prevailing side on...Senate Resolution 157 for
- 29. the purpose of an amendment.
- 30. PRESIDENT:
- 31. Senator Chew has moved to reconsider the vote by which
- 32. Senate Resolution 157 was adopted. All in favor of the Motion
- 33. to reconsider will indicate by saying Aye. All opposed. The

- 1. Ayes have it, the vote is reconsidered. The resolution is
- 2. now on the...back on the Secretary's Desk and will so remain
- 3. until Senator Chew is ready. Senate Joint Resolution 29,
- 4. Senator Johns. Senator Berning.
- 5. SENATOR BERNING:
- 6. Just a question, Mr. President, in relation to HJR 54.
- 7. Would it not be necessary to have a...a bill to designate
- 8. a name. My recollection is that we have done this by
- 9. Statute in the past. Can we do this by just a resolution?
- 10. PRESIDENT:
- 11. We have, in fact, done it by resolution. The Stratton
- 12. Building is...living testimony to that. Senate Joint Resolution
- 13. 29. On the Order of the Secretary's Desk, Resolutions, Senate
- 14. Joint Resolution 29, Senator Johns.
- 15. SENATOR JOHNS:
- 16. Thank you, Mr. President. Be very brief. This directs
- 17. the General Assembly to request the Governor to contact the
- 18. President of the United States and the Secretary of the United
- 19. States, Department of Interior, for the purpose of delaying
- 20. the implementation of the Office of Surface Mining Reclamation
- 21. and enforcements regulations for the the Coal Waste Recovery
- 22. Industry. Under the present regulations, they have a tendency
- 23. to discribe the recovery of coal tailings on the ground as
- 24. ...surface, I mean strip mining. We'd like to eliminate that
- 25. and find funding for this recovery.
- 26. PRESIDENT:
- Is there any discussion? Senator Johns has moved the
- 28. adoption of Senate Joint Resolution 29. If not, all in favor
- 29. signify by saying Aye. All opposed. The Ayes have it, the
- 30. resolution is adopted. Senate Joint Resolution 31, Senator
- Washington. On the Order of Secretary's Desk, Resolutions,
- Senate Joint Resolution 31, Senator Washington.
- 33. SENATOR WASHINGTON:

- 1. Mr. President, members of the Senate. Under the...President
- 2. Carter's cutback in Human Services, the State of Illinois will...
- 3. loose millions of dollars, thousands of jobs and many, many,
- 4. viable human services operations. This amendment simply memoralizes
- 5. Congress to pursue very diligently the idea of...of reordering
- 6. the priorities in Congress with an eye toward beefing up Human
- 7. Service's Funds. It is supported by hundreds of community
- 8. organizations throughout the State, many of whom testified that
- 9. millions and millions of dollars and thousands of jobs would be
- 10. lost to the State. I ask for your support.
- 11. PRESIDENT:
- 12. Senator Washington has moved the adoption of Senate Joint
- 13. Resolution 39...wait just a minute now...there are five or six
- 14. who have indicated they wish to speak. All I'm doing is attempting,
- 15. at least to place the question. Move the adoption of Senate Joint
- 16. Resolution 31. Is there any discussion? Senator Mitchler.
- 17. SENATOR MITCHLER:
- Mr. President and members of the Senate. I don't have the
- 19. entire resolution in front of me, I suppose that's my fault, I
- 20. should have it, but I would like to have Senator Washington at
- 21. least read a portion where he would reorder National spending
- 22. priorities by trimming the United States Military Budget. Now,
- are you advocating that Congress cut out our National Defense
- for the sake of Social Welfare Programs and give away programs
- 25. that have so much eroded into our Federal and State and Local
- 26. fundings?
- 27. PRESIDENT:
- 28. Further discussion? Senator Rhoads. Oh, it was a question.
- 29. Oh, I thought it was a statement, I beg your pardon. Senator Washington.
- 30. SENATOR WASHINGTON:
- 31. It was a loaded question, but considering the source I
- can understand it. No, I'm simply asking that Congress pay
- very close attention to the move in Congress by Elizabeth Hoseman
- 34. of New York and by Senator McGovern of Dakota in terms of looking

- 1. very closely at the reordering of priorities so that we do not
- 2. put an imbalance in military spending to the detriment of
- 3. Human Service Budgets. This is not an erosion of our military
- 4. strength, as a matter of fact, as you well know, our military
- 5. strength is concomitant to our public, citizen strength. If
- 6. we are weak then our military strength is weak and it's simply
- 7. a question of balancing adequately, adequately, those two
- 8. very vital needs, military and human service.
- 9. PRESIDENT:
- 10. Further discussion? Senator Hall.
- 11. SENATOR HALL:
- 12. Thank you, Mr. President, Ladies and Gentlemen of the Senate.
- 13. As the results of this resolution, that we did have a hearing
- 14. in Chicago and on that committee to have that hearing was
- 15. Senator Pate Philip and Senator Egan. And we had twenty-two
- 16. organizations who came to testify. Now, also...as...if you
- 17. notice in the State of Illinois that there are only three states
- 18. that loose more money that they send to Washington than...than
- 19. they get back. It's New York, Los Angeles and Chicago. Chicago's
- 20. loss is 3.3 billion. Now, we're not asking to trim and to cut
- 21. out the defense of the nation, we simply ask that some of this
- 22. money be returned back for jobs and for businesses in this
- 23. great State of Illinois. That's simply what we're asking for
- 24. and I'd urge the support of this resolution.
- 25. PRESIDENT:
- 26. Further discussion? Senator Rhoads.
- 27. SENATOR RHOADS:
- 28. Senator Washington, on the same point,...what is the language
- 29. of the resolution with respect to the military budget. I...now
- 30. I don't get excited about these things because nobody reads
- 31. them anyway, but if you could just enlighten us as to what
- 32. sense of the Body you're asking us to express here, it might help.
- 33. PRESIDENT:

- Senator Washington.
- 2. SENATOR WASHINGTON:
- 3. Go back briefly in time. The President of the United
- 4. States ordered a cut of ten billion approximate dollars
- 5. in the Human Service area to beef up a bit more the military
- 6. defense area. That has been highly controversial. And the
- 7. lineup is not pro-United States or anti-United States, pro-
- 8. jingoism or anti-jingoism. Everybody concerned on both sides
- 9. of this debate are very patriotic people, but what is happening
- 10. in Congress in both Houses is a serious attempt to look back
- 11. at the...priorities and make certain that there's not an
- 12. imbalance one way or the other. The language simply says to
- 13. look at...the military budget with an eye toward possibly
- 14. cutting it back. I don't think we should weigh the jingoistic
- 15. sword here and I don't think we should flaunt our patriotism,
- 16. we all have it. What we want to be...about here, I think, is
- 17. Whether or not our cities and our...particularly our large cities,
- 18. are going to erode under the impact of the loss of tens of
- 19. billions of dollars which will cut back needed programs, take
- 20. out jobs and send most of the money, which...we use on military
- 21. spending, not into the Midwest, but into the Sunbelt. We're
- 22. going to loose millions and millions of dollars, millions...and
- 23. hundreds of thousands of jobs. This is a very, very, serious
- 24. matter. It's not simply a question of budget, it's also a
- 25. question, here my friends, of whether or not the Midwest and
- 26. the Northeast are to continue to be viable, economic bastions
- 27. or are you going to throw all your money into the Southwest or
- 28. Sunbelt. This is very serious business and I wouldn't take it
- 29. lightly.
- 30. PRESIDENT:
- 31. Senator Rhoads.
- 32. SENATOR RHOADS:
- Thank you for your response to my question, Senator Washington,

- 1. but it was partially in error. If you read your own resolution,
- 2. read the two resolving clauses. You are asking us to ask the
- 3. Illinois Congressional Delegation to...reorder our national
- 4. priority spending by transferring unnecessary and wasteful
- 5. funds from the Military Budget to programs aimed at meeting
- 6. human needs. And certainly no one would quarrel with that, if
- 7. it, indeed it can be established that such funds were unnecessary
- 8. and wasteful. Then in the second resolving paragraph, you say
- g. that we want to support and vote for a budget transfer amendment
- 10. to substantially cut the United States Military Budget for Fiscal
- 11. Year 1980 and allocate those funds to State and Local Government
- 12. to create jobs and meet social needs. Now, I don't know why
  , you're asking us to urge our Congressional Delegation on the
- 13. You be asking us to dispersional belegation on the basis of what's in this resolution, there's no prima facie case
- that you have made that we should urge our Congressional Delegation
- to...to vote to cut the Military Budget...in Fiscal '80.
- 17. PRESIDENT:

24.

- Senator Washington.
- SENATOR WASHINGTON:
- I don't know about your side of the aisle, but the majority
- of the Democrats in the Congressional Caucus support this concept.
- This is not just aborning, this thing has been...booting around 22.
- Congress for some time and there are quite a few people support it. As 23.
- I said before, Elizabeth Hoseman of New York leads the charge, if
- $% \left( 1\right) =\left( 1\right) \left( 1\right)$  you want to call it that, in the House of Representatives and 25.
- the great Senator McGovern is heading up the...the fight in the 26.
- Senate and many of our Congressman, certainly most of the Democrats, 27.
- to my knowledge, support this concept. It's supported by the 28.
- Black Caucus, Congressional Caucus. It's supported by many, many 29.
- groups of people, primarily those centered in the large urban  ${\tt 30.}$
- industrial areas of the Northwest, Northeast and Midwest. There  ${\tt 31.}$
- is nothing new and the prima facie case has been made over and 32.

over again by these various groups. It was made in our hearings

- 33.34. in Chicago when they discussed this thing rather throughly.
- .
- 35. PRESIDENT:

- 1. Further discussion? Senator Buzbee.
- SENATOR BUZBEE:
- 3. Thank you, Mr. President. Well, I...I think as a former
- 4. speaker said, it really doesn't make any difference whether
- 5. we pass this or not because the Congress is going to pay about
- 6. as much attention to this as...as nothing. But the fact
- 7. of the matter still remains that the resolution, I can't find
- 8. a copy of the resolution in my book, but...as it is indicated
- g. on the Calendar, it says, it doesn't say anything about reallocating
- 10. resourses from the Sunbelt and from the...the South back to the
- 11. Northeast and the Midwest as we know as...as there is, in fact,
- 12. a bitter Congressional battle going on on that very question
- 13. right now. And, in fact, there has once again, perhaps the
- 14. Civil War is about to erupt again. Because we are, in fact,
- 15. finding Congressmen who are...are aligning in caucus positions
- 16. according to their geography rather than according to their
- 17. political party or political philosophy in a lot of cases.
- 18. However this resolution, as it says on the Calendar, says
- 19. reorder National Spending priorities by trimming United States
- 20. Military Budget. As Chairman of the Appropriations Committee
- 21. in the Illinois Senate, I...find myself a...a big believer
- 22. in Legislative oversight and...and in trimming budgets. As
- a member of the United States Marine Corps Reserve, I'm on
- the other side of the fence and see the result of the trimmed
- budgets and I can assure you, I don't know about the other
- 26. branches of the service, but the Marine Corps is about as trim
- as it can stand to be. We, in fact, are...have been ordered
- recently in the Reserve to cutback on the number of the
- 29. Reserve Officer billets out of a priority of...of money spending.
- We have...we're going to loose some...
- PRESIDENT:
- Will you conclude your remarks, Senator.
- SENATOR BUZBEE:

- 1. ...we're going to loose some two hundred officer billets in
- 2. the Marine Corps Reserve 'cause trimming that has already taken
- 3. place. Again, on the other branch of the service, I don't know,
- 4. but I know the Marine Corps cannot stand to be trimmed much more
- 5. and I'm going to rise in...in opposition to this resolution.
- 6. PRESIDENT:
- 7. Further discussion? Senator Schaffer.
- 8. SENATOR SCHAFFER:
- 9. Mr. President, I have some grave concerns about these
- 10. resolutions and while I agree with a couple speakers, they
- 11. probably aren't even read. Just in the chance that they are
- 12. read and with the Salt discussions going on and frankly, I
- 13. really am concerned about the state of our military preparedness
- 14. and while I also share the concerns of funding local government
- 15. and the various social welfare programs, I want to make sure
- 16. that...my Congressman knows how I feel and therefore I'd request
- 17. a roll call on this resolution.
- 18. PRESIDENT:
- 19. Roll call has been requested. Further discussion? Senator
- 20. Geo-Karis.
- 21. SENATOR GEO-KARIS:
- 22. Mr. President, Ladies and Gentlemen of the Senate. Elizabeth
- 23. Hoseman and George McGovern do not speak for me, I want my
- 24. country to be prepared at all times, if we're prepared we
- 25. don't have anything to worry about. And much as I like the
- 26. sponsor of this resolution, I do not feel that I would be in
- 27. any position ready to vote for a trim of the Military Budget when
- 28. the atom bomb is being developed in all kinds of enemy countries
- 29. and I'm going to speak against the resolution.
- 30. PRESIDENT:
- 31. Further discussion? Senator Nimrod.
- 32. SENATOR NIMROD:
- Yeah, Mr...Mr. President and Ladies and Gentlemen of
- 34. the Senate. One only has to visit SAC NORAD, which some of

- l. you will be visiting here in the next month as a Legislators
- 2. group and you'll find that in twenty-five years, we've stripped
- ourselves of every offensive weapon. We've gone to a volunteer 3.
- 4. Army that is trimmed down as Senator Buzbee has said and I would
- 5. tell you this, that if you want to improve the business climate
- in this State, you don't have to worry about getting it from 6.
- 7. the military, all you got to do is start improving the healthy
- climate to attract business like Caterpillar and...and the a... 8.
- John Deere and the rest of our companies that we're driving 9.
- out of the State by improving and voting for Workmen's Compensation, 10.
- Unemployment Insurance... 11.
- PRESIDENT: 12.
- We're going to get to that very shortly, Senator, thank you. 13.
- SENATOR NIMROD: 14.
- Thank you. 15.
- PRESIDENT: 16.
- Senator Washington has moved the adoption of Senate Joint 17.
- Resolution 31. Senator, you wish to close? 18.
- SENATOR WASHINGTON: 19.
- Yes...yes...yes. 20.
- PRESIDENT: 21.

- All right, Senator Washington. 22.
- SENATOR WASHINGTON: 23.
- Only because the...the matter has been muddled up. This 24.
- is not a challenge to our military strength at all. The President 25.
- simply transferred approximately ten billion dollars from one 26.
- item to the other. There are many people in this country, 27.
- particularly in Congress, feel that he made a mistake and they 28.
- want to go about the business of reexamining that. We have to 29. do something about unemployment in our cities, this is no challenge
- to our military strength, don't waive the atom bomb around here
- 31.
- like it's a...a kite or something, I mean, don't scare the 32.
- hell out of us, just go for this bill. 33.

- 1. PRESIDENT:
- Senator Washington has moved the adoption of Senate Joint
- 3. Resolution 31. Those in favor will vote Aye. Those opposed
- 4. will vote Nay. The voting is open. Have all voted who wish?
- 5. Have all voted who wish? Have all voted who wish? Take the
- 6. record. On that question the Ayes are 20, the Nays are 28,
- 7. 2 Voting Present. The resolution fails. Senate Joint Resolution
- 8. 39, Senator Demuzio. I understand there's an amendment, Senator.
- 9. SECRETARY:
- 10. Senate Resolution...Senate Joint Resolution 39 with
- 11. Committee Amendment No. 1.
- 12. PRESIDENT:
- 13. Senator Demuzio.
- 14. SENATOR DEMUZIO:
- Yes, Committee Amendment No. 1, I assume has not been
- 16. adopted. What it does, it's a technical error, corrects a
- 17. ...a spelling error in the...in the word, nutrition, and designates
- 18. who shall receive copies of the resolution. So at this time,
- 19. I'd like to move for the adoption of the technical amendment
- 20. to Senate Joint Resolution 39.
- 21. PRESIDENT:

31.

- 22. Senator Demuzio has moved the adoption of Committee Amend-
- 23. ment No. 1 to Senate Joint Resolution 39. Is there any discussion?
- 24. If not, all in favor signify by saying Aye. All opposed. Th
- Ayes have it. The amendment is adopted. Senator Demuzio.
- 26. SENATOR DEMUZIO:
- Yes, what... Senate Joint Resolution 39 would ... proposes
- that we urge the United States Congress and Departments of
- State and Federal Governments to provide nutrition programs
- to produce uniform guidelines for all State and Federal Food
- and Nutrition Programs. The guidelines for each nutrition
- program in Illinois and I think in other states, very greatly
- resulting in confusion and a great deal of duplication and 33.
- 34. therefore I move for the adoption.

- 1. PRESIDENT:
- Senator Demuzio, you're quite right, Senator Graham. Will
- 3. the members please be in their seats. Senator Demuzio has moved
- 4. the adoption of Senate Joint Resolution 39. All in favor signify
- 5. by saying Aye. All opposed. The Ayes have it. The resolution
- 6. is adopted. SJR 48, Senator Ozinga.
- 7. SENATOR OZINGA:
- Mr. President, maybe we should have started off with this
- 9. one and changed the date to today. But this is the Biennial
- 10. Resolution asked for by the Good Sisters Little Company of
- 11. Mary Hospital asking for a day of sacrifice and prayer, which
- 12. has...the date on the Calendar is wrong, it has been amended
- 13. and shows August the...
- 14. PRESIDENT:
- I think we have to adopt the amendment...Senator...Mr. Secretary.
- 16. SECRETARY:
- 17. Amendment No. 1 offered by Executive Committee.
- 18. PRESIDENT:
- 19. Senator Ozinga.
- 20. SENATOR OZINGA:
- The amendment merely changes the date from August 15th, which
- is a fair day to August the 6th, which is a fast day.
- PRESIDENT:
- All right. Senator Ozinga has moved...moved the adoption
- of Amendment No. 1 to Senate Joint Resolution 48. Is there
- 26. any discussion? If not, all in favor signify by saying Aye.
- All opposed. The Ayes have it, the amendment is adopted. Senator
- Ozinga...all right, wait just a minute...Senator Graham.
- 29. SENATOR GRAHAM:
- To...Mr. President, as a wonderful Presiding Officer of
- the Senate, can we...please prevail upon our colleagues to get 31.
- in their seats and cut out the racket so we can hear what's going  ${\bf 32.}$
- 33. on
- 34. PRESIDENT:

- 1. I will make every attempt. Will the members please be in
- 2. their seats. Senator Ozinga on Senate Joint Resolution 48 as
- 3. amended.
- 4. SENATOR OZINGA:
- 5. Well, as per just stated, this amendment calls for peace
- 6. and quiet and I would move the adoption.
- 7. PRESIDENT:
- 8. Senate Joint...Senator Ozinga has moved the adoption
- 9. of Senate Joint Resolution 48. All in favor signify by
- 10. saying Aye. All opposed. The Ayes have it, the amendment...
- 11. the resolution is adopted. Senate Joint Resolution 51, Senator
- 12. Buzbee.
- 13. SENATOR BUZBEE:
- 14. Thank you, Mr. President. This directs the Illinois Energy
- 15. Resources Commission to investigate the possibility of...of
- 16. the formation of an Interstate Task Force between states producing
- 17. high sulfur coals and ask the other states around us that produce
- 18. these kind of coals to see if they're interested in...in...
- 19. PRESIDENT:
- 20. Senator Buzbee has moved that the adoption of Senate Joint
- 21. Resolution 51. Is there any discussion? If not, all in favor

- 4. SENATOR DeANGELIS:

- 7. PRESIDENT:
- 8. Senator DeAngelis has moved to reconsider the vote by
- 9. which Senate Resolution 175 was adopted. All in favor signify
- 10. by saying Aye. All opposed. The Ayes have it. The vote is
- 11. reconsidered. Do you wish to go to the question? Senate
- 12. Resolution 175.
- 13. SENATOR DeANGELIS:
- 14. Mr. President, I move that we accept the Committee Amendment
- 15. Number 1.
- 16. PRESIDENT:
- 17. Senator DeAngelis has moved the adoption of Committee Amend-
- 18. ment No. 1 to Senate Resolution 175. Is there any discussion?
- 19. All in favor signify by saying Aye. All opposed. The Ayes
- 20. have it. The amendment is adopted. Senator DeAngelis.
- 21. SENATOR DeAngelis:
- Mr. President, I move for the...passage of Senate Resolution
- 23. 175.
- 24. PRESIDENT:
- 25. Senator DeAngelis again moves the adoption of Senate Resolution
- 26. 175. Senator Walsh.
- 27. SENATOR WALSH:
- 28. Would you just explain to us...why we had to do all that?
- 29. What the committee amendment does?
- 30. PRESIDENT:
- 31 Senator DeAngelis.
- 32. SENATOR DeANGELIS:
- Senator Walsh, the committee amendment merely asks that a

- 1. copy of this resolution be forwarded to the Governor and the
- 2. Department of Transportation.
- PRESTDENT:
- 4. Further discussion? If not, Senator DeAngelis has moved
- 5. the adoption of Senate Resolution 175. All in favor signify
- 6. by saying Aye. All opposed. The Ayes have it. The resolution
- 7. is adopted. All right, if you'll turn to page 46 on the
- 8. Calendar, with leave of the Body, we'll move to the Order of
- 9. business, Motions in Writing. Mr. Secretary.
- 10. SECRETARY:
- 11. Motion in Writing. Having voted on the prevailing side,
- 12. I move to reconsider the vote by which House Bill 685 was
- 13. passed. Dated, June 23rd, '79. Signed, Senator Nimrod.
- 14. PRESIDENT:
- 15. Senator Nimrod.
- 16. SENATOR NIMROD:
- Mr. President, the reason I put in that motion, I thought
- 18. it was a bill that we ought to have at least a chance to discuss
- 19. some views on it. It was on the Agreed Bill yesterday and it's
- 20. Senator Grotberg's...the Senate sponsor of that bill and what
- 21. the bill does, as I understand it. It strikes February 12th
- 22. as Lincoln's Birthday and what it, in fact, does, it allows
- 23. schools to take their choice of having President's Day or
- 24. Lincoln's Day. It seems to me that in this Land of Lincoln,
- 25. we don't need another Monday holiday, which most of the schools
- 26. and teachers will jump on. We ought to keep February 12th
- 27. as a day for the Lincoln's Birthday to commemorate it and I
- 28. think that kind of a subject would warrant some discussion.
- 29. PRESIDENT:
- 30. Senator Nimrod has moved to reconsider the vote by which
- 31. Senate Bill 685 was passed. Thirty affirmative votes will be
- 32. required. Is there any discussion? Senator Grotberg.
- 33. SENATOR GROTBERG:

- 1. Yes, Mr. President, members of the Senate. I rise to
- 2. object, not over the right to hear a bill in a timely fashion. The
- 3. untimeliness of this motion is what has me disturbed. The
- 4. same language as just used in the opening remarks of the
- 5. filer of the motion who says this bill...this bill gets rid
- 6. of Lincoln's Birthday. It has nothing to do with that. It
- 7. does what we did for Memorial Day and I'm not going to debate
- 8. the issue. It gives a local option to school boards, I hope
- 9: to God, Mr. Lincoln is listening so they can see what his
- 10. people have done. His birthday, the world's greatest student
- 11. that suffered so hard, would probably prefer that every kid to
- 12. remember him stayed in school. But the timeliness of this
- 13. motion being filed after we had all left yesterday afternoon,
- 14. the store was closed, the President had ruled. And I find that
- 15. without my knowledge the gentleman, and I use that word, well
- 16. this morning, because he is a gentleman, but that one deed is
- 17. the thing that I'm addressing myself to, it was not a very
- 18. gentlemenly procedure, to run around here after everybody was
- 19. gone to file an untimely list of names, to first of all have
- 20. it taken off the list or to secure thirty votes to kill it.
- 21. I object to the process, not the Body's right in a timely fashion
- 22. to hear any bill that there is. And I would ask that everybody
- 23. layoff this motion just for the good of the order.
- 24. PRESIDENT:
- 25. Further discussion? Senator Maragos.
- 26. SENATOR MARAGOS:
- 27. My question was, is this a timely motion and is it in order,
- 28. Mr...President.
- 29. PRESIDENT:
- 30. It is and it is. Further discussion? Senator Davidson.
- 31. SENATOR DAVIDSON:
- Mr. President and members of the Senate, I rise in support
- , 33. of this motion. I'm one who found...the bill on the Calendar,

- 1. voted No, I don't know how many others did. I opposed this
- 2. bill in committee being from this district where Lincoln does
- 3. lie buried. Many of you bring people to enjoy, to make it
- 4. an optional holiday is a lot of hogwash. Because one school
- 5. district had the problem or thought they had the problem, I
- 6. should say the parents, because they took the Federal holiday
- 7. on a Monday and then had some other kids elsewhere on Lincoln's
- 8. Birthday, I think doesn't merit a change in the Statute so that
- 9. you're going to have a double option. You're going to wind
- 10. up with two holidays and nothing is really going to be done
- 11. to give consideration to the person who saved this nation.
- 12. Two greatest Presidents we had, however you want to cut it,
- 13. was Washington, the first, Abraham Lincoln, who saved the
- 14. nation. Some say...even more important 'cause it did keep
- 15. us as one nation. I urge you to vote to reconsider this
- 16. vote so that this bill can be debated and then hopefully
- 17. defeated, like it should have been.
- 18. PRESIDENT:
- 19. Further discussion? Senator Ozinga.
- 20. SENATOR OZINGA:
- 21. Parliamentary procedure, parliamentary inquiry here. Right
- 22. now, who knows who voted on the prevailing side?
- 23. PRESIDENT:
- 24. Well, we...we are quite aware and...and the motion is in
- 25. order. Senator Nimrod did, in fact, vote on the prevailing
- 26. side.
- 27. SENATOR OZINGA:
- 28. The only reason I asked the question, Senator, is that there
- 29. were a number of us that voted No on this motion and there is the
- 30. possibility that there were enough Noes that this did not carry
- 31. even on the Agreed List.
- 32. PRESIDENT:
- No, that is not the fact. This is a House Bill that was on

- 1. the Agreed List, Senator Nimrod is moving to reconsider the
- 2. vote by which it has passed. Further discussion? Senator
- 3. Mitchler.
- 4. SENATOR MITCHLER:
- 5. Mr. President and members of the Senate. I just ask
- 6. support of Senator Nimrod's motion to put this bill before
- 7. the entire Senate. Let's debate it and let it go up or down.
- 8. I think that's the fair way because it is a rather controversial
- 9. bill and I will not go into the merits of the bill or not, but
- 10. I think that it does warrant our full debate so that we have
- 11. a clear understanding, would not get you involved in any
- 12. problem that could be resulting from the passage of this bill.
- 13. I ask you to support the motion to consider the bill in its
- 14. entirety. Thank you.
- 15. PRESIDENT:
- 16. Senator Moore.
- 17. SENATOR MOORE:
- 18. Thank you, Mr. President. As one who voted against this
- 19. bill, I filed my notice with the Secretary, I am recorded as
- 20. voting No. I think every member of this Body had that opportunity
- 21. and if there would have been more Noes than there were Yeses,
- 22. then this bill would...would have been defeated. Now, I...I
- am going to support Senator Grotberg's position. I... I do not
- 24. think this bill should be discharged at this time. We had our
- chance, everybody who wanted to vote No on it, of which I did, had
- 26. that opportunity and now we're going and we're trying to change
- 27. the rules again. Now perhaps if...if...there would have been
- 28. more homework done by some of the members that feel so strongly
- 29. about this, this bill would have gone down the tube. But this
- 30. is not the appropriate time to go ahead with this motion and
- 31. I support Senator Grotberg's position.
- 32. PRESIDENT:
- Further discussion? Senator D'Arco.

- 1. SENATOR D'ARCO:
- 2. Thank you, Mr. President. I am... I rise in support of this
- 3. motion. There is no question that it's...the motion's legal,
- 4. it's before the Body. A motion to reconsider the vote is in
- 5. order if the President so decides that that is the proper order
- 6. of business and I feel very strongly about leaving the holiday
- 7. the way it is and I'm going to support this motion.
- 8. PRESIDENT:
- 9. All right. Senator Nimrod's moved to reconsider the vote
- 10. by which House Bill 685 was passed. Thirty affirmative votes
- 11. will be required. Senator Nimrod may close.
- 12. SENATOR NIMROD:
- Mr. President, just briefly, all those Senators who voted
- No yesterday, your responses were not accepted. You have voted
- Yes on this bill, if you voted Yes on the support because anyone
- 16. who turned in their slips after...that includes you, Senator
- Moore, that anyone who turned in their slips after the reading
- had started, those names were withdrawn, that's a matter of
- information. So all I'm saying is that we ought to have a
- chance to discuss this bill and have a chance to...so I ask you  $20. \ \ \,$
- if you might consider just voting for this motion so that we 21.
- can consider before this Body.
- PRESIDENT:
- Senator Nimrod has just closed the debate. The question is
- on the Motion to Reconsider the Vote by which House Bill 685 25.
- was passed. Those in favor of the motion will vote Aye. Those 26.
- opposed will vote Nay. The voting is open. Have all voted who 27.
- wish? Have all voted who wish? Take the record. On that question
- the Ayes are 20, the Nays are 11, 1 Voting Present. The motion 29.
- fails. Further Motions in Writing? On the Order of Motions  $30. \,$
- in Writing, top of page 46, House Bill...Motion on House Bill
- 2317. Read the motion, Mr. Secretary. 32.
- SECRETARY:

- 1. I move to take House Bill 2317 from the Table and place
- 2. the bill on the...on the Senate Calendar on the Order of
- 2nd reading. Signed, Senator...Merlo.
- 4. PRESIDENT:
- 5. Senator Nash.
- 6. SENATOR NASH:
- 7. Mr. President, I yield to Senator Merlo to explain his
- 8. motion.
- 9. PRESIDENT:
- 10. Senator Merlo.
- 11. SENATOR MERLO:
- 12. Thank you, Senator Nash and Mr. President and members of
- 13. the Senate. House Bill 2317 is an Illinois State Medical Society
- 14. Bill that was heard in the Senate Insurance Committee of which
- 15. I am a member. I must admit that I totally misunderstood the
- 16. bill, the intent and the impact of it, when it was heard in committee.
- 17. But I was very instrumental in defeating it. In good conscience.
- 18. and because I feel obligated, I would like to have the opportunity,
- 19. of course...that this bill being placed on 2nd reading. What it
- 20. does, the Illinois State Medical Inner Insurance Exchange, uses
- 21. medical review as a method to make sure each physician covered
- 22. is qualified for those medical procedures he's insured for.
- 23. The purpose of this legislation is to extend the confidentiality
- 24. of medical records that hospitals and medical societies presently
- 25. have. And I hope that you will vote favorably on this.
- 26. PRESIDENT:
- 27. Senator Merlo's moved to take from the Table and place on
- 28. the Calendar on the Order of 2nd reading, House Bill 2317.
- 29. Is there any discussion?
- 30. SENATOR MERLO:
- 31. ...Mr. President.
- 32. PRESIDENT:
- 33. Senator Merlo to close.

- 1. SENATOR MERLO:
- 2. May I add that the Committee Chairman, John D'Arco and the
- 3. Senate sponsor, Senator Nash, joins me in this request.
- 4. PRESIDENT:
- 5. You may add, I'm not sure it'll do any good, but you may
- 6. add it. Those in favor of the motion will vote Aye. Those
- 7. opposed will vote Nay. The voting is open. Have all voted
- 8. who wish? Have all voted who wish? Take the record. On that
- 9. question the Ayes are 26, the Nays are 6, 2 Voting Present.
- 10. The motion fails. On the Order of Motions in Writing with
- 11. respect to House Bill 785. Read the motion, Mr. Secretary.
- 12. Yes, Senator Merlo.
- 13. SENATOR MERLO:
- 14. Mr. President, do I understand, now this bill...was a
- 15. tie...bill was a tie vote in committee, five to five. It remains
- 16. in committee, is that correct?
- 17. PRESIDENT:
- 18. Well...the...the motion's failed.
- 19. SENATOR MERLO:
- 20. Oh, no, pardon me, this is not the bill. I'm sorry, Mr.
- 21. President.
- 22. PRESIDENT:
- With respect to House Bill 785. Read the motion, Mr. Secretary.
- 24. SECRETARY:
- 25. Motion in Writing. I move to take House Bills 785 and 786
- 26. from the Table and place them on the Calendar on the Order of
- 27. 2nd reading. Signed, Senator Knuppel.
- 28. PRESIDENT:
- Senator Knuppel.
- 30. SENATOR KNUPPEL:
- 31. House Bill 785, Mr. Chairman and members of the Body is
- 32. a bill which would provide punitive damages for wrongful death
- 33. as now exists in cases where the person does not die. There's

- 1. a...an on...unfair situation exists if a person is injured in
- 2. an automobile accident or some other way and there is willful and wanton
- 3. misconduct...sufficiency, a person can recover punitive damages.
- 4. Not so in a wrongful death action. And for the reason of the
- 5. disparity, I would respectfully request that the bill, now there
- 6. is an amendment which was put on the bill and...to provide that
- 7. municipals are exempted and it looks only forward to...to those
- 8. types of suits which occur or arise after the date hereof. And
- 9. I would respectfully request a favorable roll call to discharge
- 10. House Bill 785 and put it on the Order of 2nd reading.
- 11. PRESIDENT:
- 12. The motion is to take from the Table House Bill 785 and
- 13. 786. Is there any discussion? Senator Moore.
- 14. SENATOR MOORE:
- 15. Thank you, Mr. President. I rise in opposition to this
- 16. motion. This bill was heard in Judiciary, I don't think that
- 17. we are going to...or are ready, at this time, to award punitive
- 18. damages in wrongful death actions. I can just see the, envisioned
- 19. down the road the...the additional cost of our automobile insurances.
- 20. It's going to go on if we do allow this and I would urge defeat of
- 21. this motion.
- 22. PRESIDENT:
- 23. Further discussion? Senator Carroll.
- 24. SENATOR CARROLL:
- Thank you, Mr. President, excuse me, Ladies and Gentlemen
- 26. of the Senate. I am also a member of the Senate Judiciary I
- 27. Committee that heard this and the next bill and the decision of
- 28. that committee was to defeat this legislation. I might remind
- 29. the members of the Body that that committee, made up of
- 30. practicing attorneys is not usually inclined to defeat legislation
- 31. that would produce more income for them if they practiced in
- 32. these fields, and in that committee there had to be a least one
- 33. or two members who practice in this field and we still felt that

- 1. it was a bad idea. The reason it's a bad idea in my opinion
- 2. is two. One, it's an attempt merely to reverse a case that
- 3. was handed down by the courts here in Illinois and I see no
- 4. reason to put in legislation everytime you don't like a court
- 5. opinion in order to reverse that court opinion. Secondly,
- 6. it opens up an area of liability in which there is no real
- 7. way of ever having the risk covered by insurance whether it
- 8. be municipal, quasi municipal or private people. Because any
- 9. one action can cause punitive damages which means the...the
- 10. lid is raised and that any amount of recovery can be had if
- 11. there happens to be a company bus that has an accident
- 12. and then every...passenger could get unlimited recovery from
- 13. that company and bankrupt the company. I don't think it's
- 14. a good idea to go that way. I don't think it's good to open
- 15. the door that far, nor necessary merely to reverse a court
- 16. opinion that we pass this kind of legislation and that's why
- 17. we, in committee, opposed it and I would urge opposition now.
- 18. PRESIDENT:
- 19. All right. Senator Knuppel has moved to take from the Table
- 20. and place on the Order of 2nd reading, House Bills 785 and 786.
- 21. Any further discussion? Senator Knuppel may close.
- 22. SENATOR KNUPPEL:
- Well, of course 786 is a different...different proposition.
- 24. PRESIDENT:
- 25. You wish to split them...split the motions?
- 26. SENATOR KNUPPEL:
- Oh, yeah, they...they should be split, yes.
- 28. PRESIDENT:
- Well, that's not the way you filed the motion.
- 30. SENATOR KNUPPEL:
- 31. Well, I realize that, but they...the're separate bills.
- 32. PRESIDENT:
- Oh, well...do...do it anyway you want then.

- 1. SENATOR KNUPPEL:
- 2. No big deal. But what we've got is this...this...this
- 3. bill was not...brought about by one court decision, this has
- 4. been the law of Illinois for a long time. Wrongful death is
- 5. provided for by Statute. What has happened in Illinois and...it
- 6. has happened...because of the courts more than for any other
- 7. reason. The courts have opened up the area with respect to
- 8. pain and suffering after injury and prior to death...now allowed
- 9. to be recovered in wrongful death action. And of course this
- 10. is what's going to happen eventually in the courts anyway.
- 11. Because if a person is hurt, two people riding in the same
- 12. car, one's hurt, they can get punitive damages, the other one
- 13. cannot. It probably violates equal protection and sooner or
- 14. later the courts are going to hand down that decision. I...I
- 15. still say it's good law, we ought to correct the inequities
- 16. there and I would ask for a favorable roll call.
- 17. PRESIDENT:
- 18. Senator Knuppel has moved to take House Bill 785 and 786
- 19. from the Table and place them on the Calendar on the Order of
- 20. 2nd reading. Those in favor of that motion will vote Aye. Those
- 21. opposed will vote Nay. The voting is open. Have all voted
- 22. who wish? Have all voted who wish? Take the record. On that
- 23. question the Ayes are 10, the Nays are 32, 1 Voting Present.
- The motion fails. On the Order of Motions in Writing with respect
- 25. to House Bill 1053. Read the motion, Mr. Secretary.
- 26. SECRETARY:
- I move to take House Bill 1053 from the Table and place it
- on the Calendar on the Order of 2nd reading. Signed, Senator
- 29. Knuppel.
- PRESIDENT:
- 31. Senator Knuppel.
- 32. SENATOR KNUPPEL:
- What House Bill 1053 does is requires applications for credit

- 1. cards to contain explanations of the persons' rights, particularly
- 2. with respect to discrimination because of sex and other reasons.
- 3. This was originally the law of Illinois and a bill got through
- 4. here someplace with an amendment or something which removes
- 5. the necessity of printing this. This does require more in
- 6. the printing than does the Federal Act, but we should do more
- 7. because we have an equal protection clause in our Constitution.
- 8. I think this is good legislation, it lets the person know at the
- q outset what their rights are and I think that...that everyone
- 10. should know why and be told that they cannot be discriminated
- 11. against in the issuing of a credit card.

- 13. Senator Knuppel has moved to take House Bill 1053 from
- 14. the Table and place it on the Calendar in the Order of 2nd reading.
- 15. Is there any discussion? Senator Nash.

# 16. SENATOR NASH:

- Mr. President and Ladies and Gentlemen of the Senate. This
- 18. bill has...fair...lengthly hearing in the Committee on Finance
- 19. and Credit Regulation and I don't think we should be imposing
- 20. any more regulations on businesses and extra expenses. I urge

- 10. Thank you, Mr...a...I'd like to ask a question first of
- 11. the Chair. That rule, Donnewald's rule, was only in effect
- 12. for yesterday, it's not in effect today is it?
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. No, Senator. The rule is in effect until June 30th, 1979.
- 15. SENATOR KENNETH HALL:
- 16. Well, do I have to put in...in writing to reverse that rule?
- 17. I'd like to ask that question...cause I...I want to make such
- 18. a motion. Do I have to put that in writing to the Chair?
- 19. PRESIDING OFFICER: (SENATOR BRUCE)
- 20. If you were to wish to change the rule, you would put in
- 21. a written request and...and have debate on your rule which
- 22. would change the one ,minute rule to whatever you desire.
- 23. SENATOR KENNETH HALL:
- All right, I'll do that after, but first I want to talk on
- 25. this bill. On...on this particular bill, that I rise in support
- 26. of this bill, because up until five months ago the people who
- 27. were receiving food stamps were not paying any tax on it. Now
- 28. this is no loss to the State, that...because the State never
- 29. realized that anyway. So the thing is, this is an important
- 30. thing for people who are on Public Aid and drawing assistance.
- 31. It's a very vital thing to them. So this bill should be discharged
- 32. from committee. It came up a tie vote and the chairman of the
- 33. committee is in full accord that this bill be taken from the

- committee. And I'd ask a favorable...vote on this discharge.
- 2. PRESIDING OFFICER: (SENATOR BRUCE)
- 3. Further discussion? Senator Egan.
- 4. SENATOR EGAN:
- 5. Thank you, Mr. President, members of the Senate. Just so
- 6. that the...the sponsor of the bill and Senator Merlo understand,
- 7. I was the fifth negative vote that tied the...that tied the bill
- 8. and...and kept it in committee. I really thought that I was
- 9. the...the fifth...the forth and not the fifth. I...I did
- 10. not intend to kill the bill in committee. I think that it has
- 11. enough merit to be debated on the Floor. I told Senator Hall
- 12. that I was...would support this motion.
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. Further discussion? Senator McMillan.
- 15. SENATOR McMILLAN:
- 16. Mr. President, members of the Senate. I fully understand
- 17. the concern of the sponsor of the bill. When the Federal
- 18. Government changed its program it did put the food stamp
- 19. recipient in a position of having to pay sales tax on
- 20. part of their purchase. The bill in question, however, does
- 21. a lot more than just solve the problem. There's no way for
- 22. the retailer, the person at the checkout counter to know
- 23. exactly how...eligible the food stamp holder is. And it provides
- $^{24}$ . a great problem. One person could go in with a few food stamps
- 25. and be an eligible food stamp recipient, but it could get...get
- 26. hundreds of dollars of food through the checkout counter that
- 27. would be exempt from the tax just because he had a small amount
- 28. of food stamps. It causes...it will cause...cost eight to nine
- 29. million dollars as far as the State is concerned. It opens
- 30. it up for a considerable amount of fraud and even though it's
- 31. very well intended and solves the problem in the eyes of a
- 32. few people, it also causes another problem for the State.
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- Senator...your time is expired. Further discussion?
- Senator Buzbee.
- 3. SENATOR BUZBEE:
- 4. Thank you, Mr. President. Mr. President, in a brief explanation
- 5. as to why I'm going to vote No on this motion. I am supporting
- 6. a cost of living increase for Public Aid recipients. I am also
- 7. supporting a...a sales tax elimination, thereof, from food and
- 8. medicines. And...I...I think that we have looked at the total
- 9. revenue and...and dollar picture for the State and...and found
- 10. that both of those, in my mind anyhow, are affordable, but I
- 11. don't think we ought to be doing anything else. So for that
- 12. reason I'm voting No.
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. Further discussion? Senator Walsh.
- 15. SENATOR WALSH:
- 16. Mr. President, members of the...Senate. I...I'm surprised

- 19. in the Revenue Committee, this was the only bill that...that did

- 15. Knuppel has indicated, I have to apologize 'cause I wasn't
- 16 listening, but the...there is an amendment that will be placed
- 17. on this bill that would relate itself to the...to the Sexton
- 18. Case and I will, in fact, support this Discharge Motion.
- 19. PRESIDING OFFICER: (SENATOR BRUCE)
- 20. Is there further discussion? Senator Knuppel may close.
- 21. SENATOR KNUPPEL:
- 22. It's one of the things that's been worked out. I'd ask
- 23. for a favorable roll call.
- 24. PRESIDING OFFICER: (SENATOR BRUCE)
- 25. The question is shall House Bill 114 be discharged from
- 26. further consideration by the...Senator Rock is recognized.
- 27. SENATOR ROCK:
- Yeah, I understand that the debate has been closed and
- 29. I do not wish to...I'll just vote No.
- 30. PRESIDING OFFICER: (SENATOR BRUCE)
- Thank...thank goodness, you didn't let your views be
- 32. known. The question is on the Motion to Discharge House Bill
- 33. 114 from the Committee on Agriculture. Those in favor vote

- 1. Aye. Those opposed vote Nay. The voting is open. Have all
- 2. voted who wish? Have all voted who wish? Take the record.
- 3. On that question the Ayes are 20, the Nays are 22. The Motion
- 4. to Discharge is lost. Motion on House Bill 569 to Discharge
- 5. the Committee on Revenue. Senator Mitchler is recognized.
- 6. SENATOR MITCHLER:
- 7. Mr. President and members of the Senate. House Bill 569
- 8. was, in fact { heard in the Senate Revenue Committee and it
- 9. received a vote of 2 Ayes, 3 Nays and 4 Present. What the
- 10. bill does, it would extend the Senior Citizens Homestead
- 11. Exemption to unremarried surviving spouses of previously
- 12 qualified claimants. The spouse would be required to meet
- 13. the other qualifications of the existing program and be
- 14. sixty-two years of age or older. The idea behind this bill
- 15 is that if a husband and wife living together and the husband
- 16. was sixty-five, he could claim the Homestead Exemption. If
- 17. he died, his wife could continue claiming the Homestead Exemption
- 18. if, in fact, she was sixty-two years of age or older, but not
- 19. sixty-five years of age. I think that this is a good bill and
- 20. I would ask for...approval of the Motion that I have filed
- 21. to Discharge the Committee for House Bill 569 and have it heard
- 22. before the full Senate.
- 23. PRESIDING OFFICER: (SENATOR BRUCE)
- 24. Is there discussion, the Motion to Discharge? Senator
- 25. Egan.
- 26. SENATOR EGAN:
- Yes, Mr. President, thank you. Members of the Senate, I
- 28. was just hoping that Senator Walsh would...express his views
- 29. on this bill also...just so that we keep our record clean.
- 30. PRESIDING OFFICER: (SENATOR BRUCE)
- 31. Further discussion? Senator Walsh.
- 32. SENATOR WALSH:
- Thank you, Mr. Chairman. This is one that you succeeded
- 34. in defeating in the middle of May. I...if Senator Mitchler had

- 1. held this until the end of the call, I think, on the last day you
- were hearing bills, it would have sailed out with the forty-five
- 3. others that went out, except for Sentor Merlo's. I think this
- 4. bill belongs with Senator Merlo's bill in your committee.
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- 6. Is there further discussion, the Motion to Discharge?
- 7. Senator Mitchler may close.
- 8. SENATOR MITCHLER:
- 9. I'd appreciate a favorable vote.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. The question is on the Motion to Discharge House Bill
- 12. 569 from further consideration of the Committee on Revenue.
- 13. Those in favor vote Aye. Those opposed vote Nay. The voting
- 14. is open. Have all voted who wish? Have all voted who wish?
- 15. Take the record. On that question the Ayes are 16, the Nays
- 16. are 29. The Motion to Discharge is lost. House Bill 749,
- 17. Senator Philip, Motion to Discharge Committee on...on Finance.
- 18. SENATOR PHILIP:
- Thank you, Mr. President, Ladies and Gentlemen of the
- 20. Senate. House Bill 749...House Bill 749 would allow State
- 21. and County Treasurers to invest public funds in savings and
- 22. loan. Evidently there was some confusion in the Finance
- 23. Committee. The attitude of...of the people on the other
- 24. side of the aisle was the Cook County Treasurer was against
- 25. the idea. Well that was incorrect, the Cook County Treasurer
- 26. endorses this idea. I'll be happy to answer any questions.
- 27. PRESIDING OFFICER: (SENATOR BRUCE)
- 28. Is there discussion? Senator Demuzio.
- 29. SENATOR DEMUZIO:
- Yes, in keeping with the one minute rule, I intend to
- 31. vote No on this motion.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- Is there further discussion? Senator Philip, do you wish

- 1. to close? The question is on the Motion to Discharge the
- 2. Committee on Finance from further consideration of House
- 3. Bill 749. Those in favor vote Aye. Those opposed vote Nay.
- 4. The voting is open. Have all voted who wish? Have all voted
- 5. who wish? Take the record. On that question the Ayes are 21,
- 6. the Nays are 25. The Motion to Discharge is lost. House Bill
- 7. 1128, Senator Philip, Motion to Discharge the Committee on
- 8. Finance from further consideration of House Bill 1128. Senator
- 9. Philip.
- 10. SENATOR PHILIP:
- 11. Thank you, Mr. President. I will move to Table the Motion
- 12. House Bill 1128 and 1129.
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. The Motion is to Table the motions filed on House Bill 1128
- 15. and 1129. On a Motion to Table those two motions, all in favor
- 16. say Aye. Opposed Nay. The Ayes have it, the two motions
- 17. are Tabled. House Bill 140...1405, Senator Netsch, the Motion
- 18. to take from the Table and placed on the Calendar on the Order
- 19. of 2nd reading. Senator Netsch is recognized.
- 20. SENATOR NETSCH:
- 21. I'm sorry, thank you, Mr. President. The reason why the
- 22 motion was filed was at the suggestion both of the, House sponsor
- 23. and the chairman of the committee. I think there is a great deal
- 24. of confusion and...misexplanation of what the bill was about when
- 25. it was in committee. The bill has been rewritten with an
- 26. amendment, that of course would be placed on, if the motion
- 27. prevailed. Unfortunately, Senator Daley, who was the chairman
- 28. of the committee before, whom it was heard, is not here today.
- 29. I understand that the rewritten language has been shown to him
- 30. and that it...it does indicate that it is very limited in scope.
- 31. The...it was a very modest provision and it was not represented
- 32. to be such in committee. The... I would ask your support so that .
- 33. we would have a chance to present the bill in the form in which
- 34. it was intended to be in the first place, but clearly was not

- 1. as far as the committee was concerned.
- 2. PRESIDING OFFICER: (SENATOR BRUCE)
- 3. Is there discussion of the motion? ... Senator Rock.
- 4. SENATOR ROCK:
- 5. In keeping with the one minute rule, I would urge a No vote.
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- 7. Is there further discussion? The question is...on the
- 8. Motion to take from the Table and have House Bill 1405 placed
- 9. on the Calendar on the Order of 2nd reading. Those in favor
- 10. vote Aye. Those opposed vote Nay. The voting is open.
- 11. Have all voted who wish? Have all voted who wish? Take the
- 12. record. On that question the Ayes are 18, the Nays are 22,
- 13. the Motion to take from the Table is lost. House Bill 2377,
- 14. the Motion to Discharge the Committee on Agriculture, Senator
- 15. Maitland. Senator Maitland is recognized.
- 16. SENATOR MAITLAND:
- 17. Thank you, Mr. President, Ladies and Gentlemen of the
- 18. Senate. House Bill 2377 attempts to raise some fees that
- 19. have not been raised for some twenty years and the expected
- $_{
  m 20.}$  gross here is in excess of two hundred thousand dollars. Un
- 21. fortunately in...in the Agricultural Committee, Conservation
- 22. brought into the committee on the day that this bill was
- 23. heard, a rather large amendment and...and the committee was
- 24. quite concerned about it. We would like to have had those amend-
- 25. ments earlier. By the same token, one amendment was amended
- 26. into this bill, Senate Bill 1118, and that...that is now a
- 27. part of the bill also.
- 28. PRESIDING OFFICER: (SENATOR BRUCE)
- 29. Is there discussion? Senator Donnewald.
- 30. SENATOR DONNEWALD:
- After hard and...long and hard study, I...I think that
- 32. both the bills, 2377 and 78 should certainly be taken and
- placed on the Order of 2nd reading.

- 1. PRESIDING OFFICER: (SENATOR BRUCE)
- Further discussion? Senator Knuppel.
- SENATOR KNUPPEL:
- 4. Well, as...as chairman of the committee I agree that the
- 5. bills were handled by Conservation rather badly in committee
- 6. and these bills do...they're important issues and they should
- 7. be placed on the Order of 2nd reading.
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- 9. Further discussion? Senator Buzbee.
- 10. SENATOR BUZBEE:
- 11. Senator Knuppel said just what I had intended to say, that
- 12. they are needed by the department. I was the one that raised
- 13. the objection about the amendment being offered, a very lengthy
- 14. amendment being offered that day and...and a vote has to be
- 15. taken. I am convinced the department needs this and I
- 16. think we ought to vote to allow these bills to come onto the
- 17. Calendar.
- 18. PRESIDING OFFICER: (SENATOR BRUCE)
- 19. Further discussion? Senator Mitchler.
- 20. SENATOR MITCHLER:
- Mr. President, members of the Senate. As the Minority
- 22. Spokesman of the committee, I ask for a favorable...to...vote
- 23. to discharge both 2377 and 2378 from the committee.
- 24. PRESIDING OFFICER: (SENATOR BRUCE)
- 25. Further discussion? Senator Vadalabene. Okay. Senator
- 26. Maitland...Senator Maitland may close.
- 27. SENATOR MAITLAND:
- 28. Call roll Mr...Mr. President.
- 29. PRESIDING OFFICER: (SENATOR BRUCE)
- 30. On the Motion to Discharge the Committee on Agriculture
- 31. from further consideration of House Bill 2377. Those in
- 32. favor vote Aye. Those opposed vote Nay. The voting is open.
- (Machine cut-off)...wish? Have all voted who wish? Take the

- 1. record. On that question the Ayes are 48, the Nays are 1, none
- 2. Voting Present. The Motion to Discharge the Committee on
- 3. Agriculture prevails and the bill will be placed on the Order
- 4. of 2nd reading on the Calendar. House Bill 2378, a similar
- 5. motion, Senator Maitland.
- 6. SENATOR MAITLAND:
- 7. Thank you, Mr. President. I just would appreciate the
- same roll call.
- 9. PRESIDING OFFICER: (SENATOR BRUCE)
- 10. The question is shall the Committee on Agriculture be
- 11. discharged from further consideration of House Bill 2378.
- 12. Those in favor vote Aye. Those opposed vote Nay. The voting
- 13. is open. Have all voted who wish? Have all voted who wish?
- 14. Take the record. On that question the Ayes are 49, the Nays
- 15. are none, none Voting Present. House Bill 2378 is discharged
- 16. the Committee on...the Committee on Agriculture discharged from
- 17. further consideration House Bill 2378 and will be placed on
- 18. the Order of 2nd reading on the Calendar. House Bill 2419,
- 19. Senator Maitland. Discharge the Committee on Higher Education
- 20. from further consideration of House Bill 2419.
- 21. SENATOR MAITLAND:
- Thank you, Mr. President. I just move to Table that motion.
- 23. PRESIDING OFFICER: (SENATOR BRUCE)
- 24. The Motion is to Table. All in favor say Aye. Opposed
- 25. Nay. The Ayes have it. The Motion is Tabled. House Bill 1617,
- 26. Senator Philip.
- 27. SENATOR PHILIP:
- Thank you, Mr. President, Ladies and Gentlemen...of the Senate.
- 29. House Bill 1617 would provide two additional full Circuit Judges
- 30. for DuPage County. And I don't know what happened in committee
- 31. that morning, but all of the bills that increased judges or
- 32. Appellate Court Judges anywhere in the State of Illinois were
- $\sim$  all killed. And after the 1980 census we'll be entitled to,

- 1. by population, three more Associate Judges. And what we have
- 2. worked out with the Court Administrator is, that instead of
- 3. taking those three associates, that we would take two full
- 4. Courts Circuit Judges. I ask for...favorable consideration.
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- 6. Is there discussion? Senator Carroll.
- 7. SENATOR CARROLL:
- 8. Thank you, Mr. President, Ladies and Gentlemen of the
- 9. Senate. I rise in opposition to this motion. If there is
- 10. anything that lawyers on judiciary are more protective of,
- 11. other than the monies of their fees as I indicated on a prior
- bill, it's opening more judgeships, 'cause most of them
- feel someday that will be their seat. And it was unanimity
- of most of the members of that committee that all judgeships
- be rejected at this time, both in Cook, inDuPage and everywhere
- else. And the committee uniformly defeated additional judge-
- ships, agreeing with the House concept that first there be
- a commission of an existing commission, either the court or
- Judicial Advisory or the Joint Judiciary Committees to determine 19.
- caseloads throughout the State to see when and where judges 20.
- are needed anywhere in the State. So that is why we opposed 21.
- it then and I would oppose it now.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Further discussion? Senator Graham. Senator Geo-Karis.
- SENATOR GEO-KARIS:
- Mr. President and Ladies and Gentlemen of the Senate. 1
- was one of the minority opinion on the Judiciary Advisory 27.
- Council 'cause I feel that Lake County and DuPage do need 28.
- more judges and I'd like to speak in favor of this bill. 29.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Further discussion? Senator Philip may close.
- SENATOR PHILIP:
- Yes, if I remember the correct...the vote in committee was 33.

- 1. on party lines, it wasn't unanimous at all. I also might
- 2. remind people that DuPage and Lake County are the fastest
- 3. growning counties in the State of Illinois, probably the
- 4. fastest growing counties in the midwest. Our bar association
- 5. which is nonpartisan has done a study on caseloads. Our
- 6. judges have some of the heaviest caseloads in the State
- 7. of Illinois, if not the heavest. And I would ask for a
- 8. favorable consideration.
- 9. PRESIDING OFFICER: (SENATOR BRUCE)
- 10. The Motion is to take from the Table and have House Bill
- 11. 7...1617 read a 2nd time. Those in favor will vote Aye. Those
- 12. opposed will vote Nay. The voting is open. Have all voted
- 13. who wish? Have all voted who wish? Take the record. On that
- 14. question the Ayes are 23, the Nays are 23. The Motion to take
- 15. from the Table is lost. House Bill 1906, the Motion to Discharge
- 16. the Committee on Finance from further consideration of House Bill
- 17. 1906. Senator Nash is recognized on his motion.
- 18. SENATOR NASH:
- 19. Mr. President and Ladies and Gentlemen of the Senate. The
- 20. reason House Bill 1906 is in this Calendar is because the Committee
- of Finance and Credit Regulations didn't have time to hear several
- 22. bills. All this bill does is provides the currency exchanges
- 23. may sell tokens for Public Transportation System. It also
- 24. gives the Director of Financial Institution the right to inspect
- 25. currency exchanges. I urge a yes vote.
- 26. PRESIDING OFFICER: (SENATOR BRUCE)
- 27. Is there discussion, the motion? Senator Demuzio.
- 28. SENATOR DEMUZIO:
- Yes, Senator Nash is absolutely correct. We didn't have
- 30. time to...to hear this...legislation and if we did we would
- of...it would of...been defeated substantially. So, I...so
- 32. I urge a No vote on this measure.
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- 1. Is there discussion? Senator Netsch.
- 2. SENATOR NETSCH:
- 3. I know we're not supposed to be totally into the merits of the
- 4. bill right now, but it's hard to separate it. Is there provision
- 5. for charging a fee for the sale of bus tokens by currency exchanges?
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- 7. Senator Nash.
- 8. SENATOR NASH:
- 9. Not to my knowledge.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. Senator Netsch.
- 12. SENATOR NETSCH:
- 13. Is there a prohibition?
- PRESIDING OFFICER: (SENATOR BRUCE)
- 15. Senator Nash.
- 16. SENATOR NASH:
- 17. No.
- 18. PRESIDING OFFICER: (SENATOR BRUCE)
- 19. Senator Netsch.
- SENATOR NETSCH:
- Then within my thirty...my sixty seconds, it's a bad bill
- then because there ought to be a prohibition.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Further discussion? Senator Nash may close on his motion.
- SENATOR NASH:
- Stick with the one minute rule, I urge a yes vote.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Question is on the Motion to Discharge the Committee on
- Finance from further consideration of House Bill 1906. Those 29.
- in favor vote Aye. Those opposed vote Nay. The voting is open.
- (Machine cut-off)...voted who wish? Have all voted who wish?
- Take the record. On that question the Ayes are 23, the Nays are 32.
- 26. The Motion to Discharge is lost. House Bill 2655, the Motion 33.
- 34. to discharge Committee on Finance. The motion is...by Senator

- 1. Knuppel is to Table the Motion. All in favor say Aye. Opposed
- 2. Nay. The Ayes have it. The motion is Tabled. House Bill 733,
- 3. Senator Knuppel. The Motion is...having voted on the prevailing
- 4. side, I move to reconsider the vote by which House Bill 733
- 5. failed. Senator Knuppel.
- 6. SENATOR KNUPPEL:
- 7. Well, 733 was the bill to allow certain pension funds to
- 8. place their money in the Asian bank and I struck the wrong
- 9. key and I did it unintentionally, I voted No, I intended to
- 10. vote Yes. There was a verification of the roll call, it's
- 11. Senator D'Arco's bill. There was a verification of the roll
- 12. call and Senator Daley was struck from the roll call thereby
- 13. leaving only twenty-nine votes. If I had...if my vote had
- 14. been as I had intended to record it, he would have had thirty
- 15. votes. I move for a favorable roll call on reconsideration of
- 16. House Bill 733.
- 17. PRESIDING OFFICER: (SENATOR BRUCE)
- 18. Is there discussion? Senator D'Arco.
- 19. SENATOR D'ARCO:
- 20. I just want to thank Senator Knuppel for the courtesy he's
- 21. showing me on this particular vote.
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- 23. Further discussion? Senator Mitchler.
- 24. SENATOR MITCHLER:
- 25. Well Mr. President and members of the Senate. I voted in
- 26. favor of this bill in committee because it was indicated that
- 27. there would be a higher rate of interest paid to the Retirement
- 28. Systems that invested in the Asian Development Bank. But after
- 29. the bill got out of committee then I learned more about what
- 30. the Asian Development Bank does, investing in Communist countries
- 31. and I certainly oppose it. And since then too I've...what is
- 32. all the interest in getting into these retirement funds into
- 33. this bank? I...I'm going to find out what it's all about after

- 1. the Session. But I'm going to watch this and I'm going to
- 2. keep the roll calls and believe me the veteran's will want
- 3. to know on these roll calls too. Especially the ones that
- 4. fought...especially the ones who fought over in these Communist
- 5. countries.
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- 7. Further discussion? Senator Berning.
- 8. SENATOR BERNING:
- 9. Thank you, Mr. President. This bill is no better today
- 10. that it was the other day. It has been disapproved by the
- 11. Pension Laws Commission and I would urge, strongly urge, that
- 12. we do not move to...or do not vote to discharge this.
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. Senator Egan.
- 15. SENATOR EGAN:
- 16. Thank you, Mr. President and members of the Senate. It
- 17. ...it has not been...turned down by the Pension Laws Commission.
- 18. As a matter of fact, it was approved by them and the last two
- 19. speeches have convinced me that I think we should vote Aye.
- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. Further discussion? Well, now Gentlemen, we will recognize
- those who have not spoken on the issue, then we will go to those
- 23. who...who wish to speak a second time. Further discussion?
- 24 Senator D'Arco. Senator Netsch.
- 25. SENATOR NETSCH:
- 26. This is in part a question directed to the sponsor. Is it
- 27. not true that the General Assembly Retirement System is already
- 28. authorized to invest in the Asian Development Bank as well
- 29. as some other development banks?
- 30. PRESIDING OFFICER: (SENATOR BRUCE)
- 31. Senator D'Arco.
- 32. SENATOR D'ARCO:
- 33. Yeah, that is true.
- 34. PRESIDING OFFICER: (SENATOR BRUCE)

- l. Senator Netsch.
- 2. SENATOR NETSCH:
- 3. What's good enough for us is good enough for the rest of
- 4. the State.
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- 6. Further discussion?
- 7. SENATOR NETSCH:
- Or vice versa.
- 9. PRESIDING OFFICER: (SENATOR BRUCE)
- 10. Further discussion? Senator Rock.
- 11. SENATOR ROCK:
- 12. Yes, thank you, Mr. President, Ladies and Gentlemen of
- 13. the Senate. This is one of a series of bills and I think
- 14. it deserves our attention and I would urge an Aye vote in
- 15. accordance with Senator Knuppels's motion.
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. Further discussion? Senator Geo-Karis.
- 18. SENATOR GEO-KARIS:
  - 19. Mr. President, Ladies and Gentlemen of the Senate. As I
  - 20. said the other day, if the membership of these various unions
  - 21. or of the Legislature would vote to have their money invested
  - 22. in the Asian Bank, I would have no objection. But since only
  - 23. its leadership decides that, I'm not so sure the leadership
  - 24. is...speaking for all the members. And whether...the fact that
  - 25. my pension is invested in there, I don't like the idea one bit,
  - 26. but I worry more about the other people who have been working
  - 27. many more years than I have to have their monies invested and
  - 28. ...and therefore I have to...cast a No vote on this.
  - 29. PRESIDING OFFICER: (SENATOR BRUCE)
  - 30. Senator Rhoads.
  - 31. SENATOR RHOADS:
  - 32. Well, thank you, Mr.President and members of the Senate.
  - 33. In response to Senator Rock, the Body has addressed the...the

- 1. bill on one occasion and the sponsor didn't even see fit to put
- 2. it on Postponed Consideration on that particular day. Why he
- 3. didn't, I don't know, but he chose not to. Well, maybe he was,
- 4. but he still had that option and chose not to exercise it. So
- 5. now we're coming back with it, the...question on the merits of
- 6. the bill is the same as it was the other day. I don't care whether
- 7. the General Assembly Retirement System now has this option or
- 8. not, Senator Netsch. No one has stated in Floor debate that
- 9. we do, in fact, invest in the Asian Development Bank or the
- 10. Inter-American bank or the World Bank or any of the other banks
- 11. with the so-called soft loan windows. Soft loan windows provide
- 12. two percent loans to so-called under...underdeveloped nations
- 13. for which we have no guarantee that they will not be used for
- 14. military purposes.
- 15. PRESIDING OFFICER: (SENATOR BRUCE)
- 16. Senator Rhoads...Senator Rhoads...
- 17. SENATOR RHOADS:
- 18. ... The Congress in 1973...
- 19. PRESIDING OFFICER: (SENATOR BRUCE)
- 20. ...your time has expired. Further discussion? Senator
- 21. Philip. For what purpose does Senator Rhoads arise?
- 22. SENATOR RHOADS:
- 23. To move to suspend the Donnewald rule, this is an important
- 24. bill.
- 25. PRESIDING OFFICER: (SENATOR BRUCE)
- 26. The motion is to suspend the rule eliminating debate to
- 27. one minute. (Machine cut-off)...thirty votes to suspend the
- 28. rule. Those in favor will vote Aye. Those opposed will vote
- 29. Nay. The voting is open. Have all voted who wish? Have all
- 30. voted who wish? Take the record. On that question the Ayes
- 31. are 17, the Nays are 20, 1 Voting Present. The motion to
- 32. suspend the rule is lost. Further discussion? Senator Philip.
- 33. SENATOR PHILIP:

- Thank you, Mr. President, Ladies and Gentlemen of the Senate.
- 2. I have just been informed that the State Board of Investments
- 3. who has had the power to invest in...in the Asian banks has not,
- 4. has not, invested. And I think we ought to keep that in mind.
- 5. ...If...if it's such a good thing, why haven't they done it. Well
- 6. it's quite obviously they have not and they've had a four year
- 7. period to do it I've been told.
- (8. PRESIDING OFFICER: (SENATOR BRUCE)
  - 9. Further discussion? Senator Lemke.
- 10. SENATOR LEMKE:
- 11. I urge the support of this motion. And when I hear somebody
- 12. say that the veterans are going to be mad at us for voting for
- 13. this bill, we all must remember one thing. When a war is over,
- 14. we must help the people rebuild. We have no control over that
- 15. government even if I resent it, being Communistic. But I'm
- 16. saying this, we should not limit opportunities to invest in
- 17. countries that we have treaties with. And Senator Mitchler, it
- 18. wasn't my President that made the treaty...treaty with China,
- 19. it was your President, President Nixon. And I think it was
- 20. a good treaty because it helps us support and get rid of our
- 21. products and what resources, our...our manufactured goods and
- 22. creates jobs and creates business in Illinois. So if this is
- 23. going to help us to bring business in Illinois and to have
- 24. them buy our products in Illinois, I'd say let's vote to
- 25. get this bill and go with the Motion to Discharge.
- 26. PRESIDING OFFICER: (SENATOR BRUCE)
- 27. Further discussion? ... If I might just have the attention
- 28. of the Body. Since we are under the one minute rule and people
- 29. keep calling out time. The Presiding Officer is starting the
- 30. clock the minute you say your first word. The yellow light
- 31. will come on automatically, it will start flashing when you
- 32. have ten seconds. So the fact that the light is flashing does
- 33. not mean your time has concluded. When the light goes solid

- 1. red, that is sixty seconds and if I notice it, I will terminate
- 2. your speaking. Now, further discussion? Senator Nimrod.
- 3. SENATOR NIMROD:
- 4. Thank you, Mr. President. Vietnam and Cambodia would be
- 5. the benefactors of this particular vote and if we want to
- 6. convey to our fellow Illinoisans and to this country that we
- 7. support those regimes where atrocities put Hitler to shame,
- 8. then go ahead and vote for it, but I say you better not if you
- 9. don't want to get the reprocussions.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. Further discussion? Senator...Berning.
- 12. SENATOR BERNING:
- 13. Thank you, Mr. President. I just want to clear up something.
- 14. The Pension Laws Commission on June 12th did reverse itself
- 15. after cursorily considering these, did approve, but on the 12th
- 16. did disapprove this whole series of bills. Secondly, Mr. President
- 17. and members, you may be interested to know that these same bills
- 18. were defeated twice, 1975 and 1977 in this State Legislature.
- 19. I just can't believe that we are willing to take the chance with
- 20. our dollars, particularly when they can be going, our...our
- 21. pensioners' dollars can be going into such places as Nicaragua,
- 22. ...Panama as well as the Indochina countries. And Mr. President
- 23. and members of the Senate, I respectfully suggest that it would
- be the wisest move for us to deny this authority and I suggest
- 25. a No vote.
- 26. PRESIDING OFFICER: (SENATOR BRUCE)
- 27. Further...Senator Merlo.
- 28. SENATOR MERLO:
- Mr. President and members of the Senate. Talk about
- 30. ridiculousness. We've debated this issue three different times
- 31. in the Senate Floor, three different times, and yet you restrict
- 32. any member of the Senate to speak on the bill that they think
- important to one minute. ...Oh, brother...I don't know.
- 34. PRESIDING OFFICER: (SENATOR BRUCE)

- 1. (Machine cut-off)...further discussion? Senator Knuppel
- 2. may close.
- 3. SENATOR KNUPPEL:
- 4. I don't have very much to say, it's been thoroughly debated
- 5. except for one thing. Senator Mitchler doesn't frighten me as
- 6. an ex-Marine with his treat to keep the roll call. I'd suggest
- 7. that he mimeograph fifty-nine copies and he can put my copy
- 8. to the use I used to put our used to put our used Montgomery
- 9. Ward Catalogs to.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. The motion is to...having voted on the prevailing side,
- the motion is to reconsider the vote by which House Bill 733
- 13. failed. Those in favor vote Aye. Those opposed will vote Nay.
- 14. The voting is open. Motion requires thirty affirmative votes.
- 15. Have all voted who wish? Have all voted who wish? Have all
- 16. voted who wish? Take the record. On that question the Ayes
- 17. are 34, the Nays are 16. The motion prevails and the bill
- 18. will be placed on the Order of 3rd reading. For what purpose
- 19. does Senator Rhoads arise?
- 20. SENATOR RHOADS:
- 21. Request a verification of the affirmative vote:
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- There's been a...request for verification. Will the members
- 24. please be in their seats. Will the Sergeant-at-Arms please clear
- 25. the aisles. Secretary will call those who voted in the affirmative.
- 26. SECRETARY:
- The following voted in the affirmative: Becker, Berman,
- Bloom, Bruce, Buzbee, Carroll, Chew, D'Arco, Davidson, DeAngelis,
- Demuzio, Donnewald, Egan, Gitz, Hall, Johns, Jeremiah Joyce, Jerome
- Joyce, Knuppel, Lemke, Maragos, McLendon, Merlo, Nash, Nedza, Nega,
- Netsch, Sangmeister, Savickas, Shaprio, Sommer, Vadalabene, Washington,
- Mr. President.
- PRESIDING OFFICER: (SENATOR BRUCE)

- 1. Senator Rhoads, do you question the presence of any
- 2. member? The roll call has been verified. On a verified roll
- 3. call the Ayes are 34, the Nays are 16. The motion prevails
- 4. and the bill will be placed on the Order of 3rd reading.
- 5. House Bill 1473, Senator Demuzio, Motion to Discharge the
- 6. Committee on Finance. Senator Demuzio is recognized.
- 7. SENATOR DEMUZIO:
- 8. Yes, thank you, Mr. President. House Bill 1473 is the
- 9. bill that...I...we debated an amendment on 737, Senator
- 10. Bloom's bill, substantially, I think, two or three days
- 11. ago. And this bill deals with the emergency merger of a
- 12. State bank with another...State or Federally charted bank
- 13. with the permission, the regulation of the Commissioner of
- 14. Banks and Trust. It also would provide that...on the emergency
- 15. mergers of two banks...the merger shall take place...specifies
- 16. only one bank may be acquired. Senator Harris, former Senator
- 17. Harris, Commissioner Harris indicates that he needs this bill

- 23. Further discussion? Senator Ozinga.
- 24. SENATOR OZINGA:
- Very seldom do I disagree with my chairman, however this is
- 26. the bill that was designed to eliminate a lot of embarrassment
- 27, for a lot of us...to the extent that we hate to disagree with
- 28. the Commissioner's philosophy, however, this bill has been
- 29. debated twice in this House, at least once or twice in the
- 30. other House and it is up now, I believe, here again for more
- 31. consideration. However, in my opinion, and I think the majority
- 32. of the committee's opinion, this was a bad bill and an attempt to
- 33. save you all embarrassment for voting or having to vote against

- 1. a bill of the Commissioner's.
- 2. PRESIDING OFFICER: (SENATOR BRUCE)
- 3. Further discussion? Senator Bloom.
- 4. SENATOR BLOOM:
- 5. Would the sponsor yield to a question?
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- 7. Indicates he will yield. Senator Bloom.
- 8. SENATOR BLOOM:
- Do...do you have a letter from anyone...
- PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Demuzio.
- SENATOR BLOOM:
- ...on this?
- 13.
- SENATOR DEMUZIO:
- Yes, I do, but I...since I gave them all to you, I...they're 15.
- not within my possession.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Bloom.
- SENATOR BLOOM:

- I wasn't referring to 737, I was referring to 1473.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Demuzio.
- SENATOR DEMUZIO:
- 23.
- I...I really don't think so, and in...in all sincerity, if 24.
- $\ldots$  if I do have one, perhaps you might refresh my memory as to 25.
- what it...what it pertains to. 26.
- PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Bloom.
- 28. SENATOR BLOOM:
- 29.
  Well, I don't want to tie up the Body's time. Senator Walsh
- 30.
  wonders whether you'll be interested in amendments to this
- 31.
- measure? Thank you.
- 32.
   PRESIDING OFFICER: (SENATOR BRUCE)
- 33.34. Further discussion? Senator Weaver.

- 1. SENATOR WEAVER:
- 2. Thank you, Mr. President. I was just going to ask Senator
- 3. Demuzio whether he intended to amend this bill.
- 4. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Demuzio.
- 6. SENATOR DEMUZIO:
- 7. Well, the answer to that question is yes. It...it would,

- 34. PRESIDING OFFICER: (SENATOR BRUCE)

- 1. The motion is to discharge the Committee on Finance from
- 2. further consideration of House Bill 1473. Those in favor
- 3. vote Aye. Those opposed vote Nay. The voting is open.
- 4. Have all voted who wish? Have all voted who wish? Have
- 5. all voted who wish? Take the record. On that question the
- 6. Ayes are 23, the Nays are 22. The Motion to Discharge is
- 7. lost.
- 8. PRESIDENT:
- Are there any further Motions in Writing...that have
- 10. been filed, Mr. Secretary?
- 11. SECRETARY:
- 12. I have a Motion in Writing, Mr. President, on House Bill
- 13. 9...or Senate Bill 925 and 926.
- 14. PRESIDENT:
- 15. Read the motion, Mr. Secretary.
- 16. SECRETARY:
- Pursuant to Senate Rule 10, I move to discharge Labor
- 18. and Commerce Committee from further consideration of Senate
- 19. Bills 925 and 926 and that they be placed on the Calendar on
- 20. the Order of 2nd reading for the purpose of immediate consideration
- of amendments and further, I move, to suspend Senate Rule 5C,
- 22. 15, and other appropriate rules for advancing Senate Bills 925
- 23. and 926 to the Order of 3rd reading for immediate passage.
- 24. Signed..dated May the 30th, 1979. Signed, Senator Nimrod.
- 25. PRESIDENT:
- 26. Senator Nimrod.
- 27. SENATOR NIMROD:
- Yes, thank you, Mr. President and Ladies and Gentlemen
- 29. of the Senate. These are the Workmen's Compensation bills
- 30. that we did...that we did successfully discharge last time
- and due to the technicalities, we adjourned and called for
- $\,$  quorums and we were unable to do much with the bills. But
- since that time, I think it's become very evident...I think

- 1. it's become very evident, not only through editorials, but I
- 2. think through what's been happening in the whole business
- 3. climate in the State of Illinois. You know, we're here,
- 4. we...we fool around a lot and we...we do things on a partisan
- 5. basis and we take kind of...stands and issues, but I want to
- 6. tell you, this is probably one of the most serious votes
- 7. that you'll probably make that affect the course and destiny
- 8. of this State over the next twenty years. And what I'm talking
- 9. about is that meetings of...releases and...and meetings with
- 10. the Governor and leadership on Caterpillar indicating that
- 11. their plans are to build and expand plants in Iowa and Indiana
- 12. in the amount of some two hundred and seventy million dollars.
- 13. In fact the John Deere Company has plans for expansion in
- 14. Iowa for some ninety-six million dollars. International
- 15. Harvester has a fifty-five million dollar expansion in other
- 16. than the State of Illinois. Stewart-Warner is building a
- 17. new plant releases and they will not expand in Illinois,
- 18. they're going to Tennessee. Now these are not going to sun
- 19. belt states, these are going to our neighboring states where
- 20. they, in fact, can enjoy a climate which will bring employment
- 21. and prosperity. Now, how long can we go on like this. The
- 22. only thing that International Harvester has scheduled for us
- 23. is an office building, which means no new jobs. Now, there
- 24. are going to be some seventy-eight thousand jobs amounting
- 25. into these lists that I just read from the amount...the
- 26. amount of expansion that's going to be taking place. In fact,
- 27. I think if we were to pass...pass over to the House...the Workmen's...
- 28. PRESIDENT:
- 29. Your time...your time is expired.
- 30. SENATOR NIMROD:
- Thank you. ...the Workmen's Compensated amended bills, I
- 32. would say that we would give them a chance to do it. This is
- 33. the one chance you're going to have to give to the House the

- 1. chance to see what they can do with Workmen's Compensation
- 2. for this time.
- 3. PRESIDENT:
- 4. Further discussion? Senator Savickas.
- 5. SENATOR SAVICKAS:
- 6. Yes, Mr. President and members of the Senate. I oppose
- 7. this Motion to Discharge. We have shown by the agreed policy,
- 8. the agreed bill policy, that labor, business industry, and I'm
- 9. speaking now of General Electric who passed out a position
- 10. paper on Unemployment Insurance supporting their agreed
- 11. policy and agreed position on Unemployment Insurance and the
- 12. Governor's people, they're working toward this end to come
- 13. up with a bill that will solve or alleviate these conditions
- 14. that business is concerned about, that the common working
- 15. man that needs the protection is concerned about and a bill
- 16. that will satisfy the needs and concerns of our small business
- 17. people. I think we should give them this opportunity. They
- 18. will be meeting again, just this past week the Governor
- 19. instituted and asked them all to join back into the agreed bill
- 20. ...process and the unions business have agreed. I think by this
- fall, they will come up with a very satisfactory bill. I think
- 22. they will follow their efforts on the Unemployment Insurance
- $^{23}$ . that business has agreed to and I think we will get this burden
- off our back by the end of the year.
- 25. PRESIDENT:
- Further discussion? Senator Maragos.
- 27. SENATOR MARAGOS:
- 28. Mr. President and members of the Senate. I rise in opposition
- 29. to this motion because first of all it is untimely. This is a
- Senate Bill we're talking about and in order to do justice to
- this particular issue we would need another two weeks. The Senator
- had many times to bring this motion up since May 30th and I think
- it's untimely at this time to come along and try to take a very 33.

- 1. important subject matter of this nature to go ahead at this
- 2. time and I think it's unfair. I should also like to bring
- 3. out the fact that this was defeated, both of these bills
- 4. were defeated in committee, where they had a full hearing.
- 5. PRESIDENT:
- 6. Further discussion? Senator Graham.
- 7. SENATOR GRAHAM:
- 8. Mr. President and members of the Senate. I remember...
- 9. I recognize the untimeliness probably of these, being Senate
- 10. bills. Also remember that we might have an opportunity
- 11. here today even though they may not get through the House
- 12. and get acted upon, we might have an opportunity here today
- 13. to undo some of the wrongs we did in 1975. And as far as
- 14. giving the Governor's people and in business and everything
- 15. another three or four months to screw around and do nothing
- 16. like they've been doing since the first year, that doesn't
- 17. impress me a bit. It impressed me just about as much as...as
- 18. the importance that's been attached to a tax limitation thing.
- 19. I don't think they need any more time, we got a chance to speak
- 20. today how we feel about keeping industry in the State and this
- 21. is our one opportunity.
- 22. PRESIDENT:
- 23. Further discussion? Senator Mitchler.
- 24. SENATOR MITCHLER:
- 25. Mr. President and members of the Senate. Very briefly, the
- 26. business and industry climate in the State of Illinois is in
- 27. a deplorable condition, you know it, I know it, each and every
- 28. one of us knows it. And all this here just talking about it
- 29, and doing nothing is not going to get the job done. And you
- 30. find the Executive Branch of Government going over to Japan
- 31. to try to attract jobs in here, then you have Caterpillar
- 32. Tractor Company, the largest private employer in the State of
- 33. Illinois, going down to the Executive Branch of...of this

- 1. government's office and telling them...that in Illinois their
- 2. Workmen's Comp has increased from three million dollars a year
- 3. to sixteen million dollars a year and that's the reason they're
- 4. going to locate three brand new plants outside the State of
- 5. Illinois instead of locating them in Illinois, which they would
- 6. like to do, and bring some fifteen thousand to twenty thousand
- 7. jobs into Illinois. And these are good paying jobs, not poverty
- 8. level like CETA and...
- 9. PRESIDENT:
- 10. Your time has expired, Senator. Further discussion?
- 11. Senator Knuppel.
- 12. SENATOR KNUPPEL:
- 13. Well I...I appreciate everything that Caterpillar Tractor
- 14. says in their big, they have a big plant in my district and all
- 15. that, but the fact is that notwithstanding the Workmen's
- 16. Compensation increase, their profits rose by some twenty-
- 17. five percent last year.
- 18. PRESIDENT:
- 19. Any further discussion? Senator Nimrod may close.
- 20. SENATOR NIMROD:
- 21. Thank you, Mr. President. I want to remind you that the
- 22. agreed bill team that got together to discuss Workmen's Comp.
- 23. is adjourned and dissolved. That committee cannot reach any
- 24. agreements and has no proposals to make before this Body. Now,
- 25. all I'm telling you is that this is your one chance to tell,
- 26. at least the House members, here's some bills that we want
- 27. to give you a chance to do it. Senator Keats is in the
- 28. hospital, I probably shouldn't have called because he was not
- 29. here today, we're losing one vote there. But I think there
- 30. are enough men who will see and search their hearts to say
- 31. that what's right has to be done. And we've got to rise
- above what we know has been some political pressure from
- 33. the labor leaders and we know that we, at least, have to say

- 19. House Bill 1289.
- 20. (Secretary reads title of bill)
- 21. 3rd reading of the bill.
- PRESIDENT:
- Senator Netsch.
- 24. SENATOR NETSCH:
- Thank you, Mr. President. The next three bills are all
- recommendations of the Dangerous Drugs Advisory Council and
- 27. the Dangerous Drugs...Dangerous Drug Commission. The first
- one deals with the subject of client records, that is Drug 28.
- 29. Abuse Clinic client records and their confidentiality. It
- revises the State law so that it tracts the Federal Law
- which is already applicable to a good many of these products 31.

- 25. (Secretary reads title of bill)
- 26. 3rd reading of the bill.
- 27. PRESIDENT:
- Senator Netsch.
- 29. SENATOR NETSCH:
- Thank you. This bill was amended extensively at the
- 31. recommendation of the Judiciary Committee. In its amended
- form, it does these things. It does revise the definition
- of addict so that those who abuse, for example, certain chemical

  - A question of the sponsor. Does this apply to judgments

- Senator D'Arco.
- 4. SENATOR D'ARCO:
- 5. No.
- 6. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Netsch.
- 8. SENATOR NETSCH:
- That's a pity.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. Further discussion? Senator D'Arco may close.
- 12. SENATOR D'ARCO:
- 13. That's a pity. Vote for this bill.
- 14. PRESIDING OFFICER: (SENATOR BRUCE)
- 15. The question is, shall House Bill 1457 pass. Those in favor

- 29. Yes, Mr. President and members of the Senate. This bill
- 30. changes the definition of residents district to the extent that
- 31. some of our rural areas outside the urban areas...it has circular
- roads and...and...no sidewalks and many other things could by
- the action of our municipal officials reduce the speed to twenty-

- 1. five miles an hour. As for the Municipal League and everyone that's
- 2. ...had an amendment put on and IDOT to make it compatible
- 3. and I ask for a favorable consideration.

- 6. SENATOR GROTBERG:
- 7. A question of the sponsor.
- 8. PRESIDING OFFICER: (SENATOR BRUCE)
- 9. He indicates he will yield. Senator Grotberg.
- 10. SENATOR GROTBERG:
- 11. Not having the bill in front of me, but the...analysis reads
- 12. that it's a minimum of twenty-five miles an hour. If...if that's
- 13. what the bill says, it has a technical problem.
- 14. PRESIDING OFFICER: (SENATOR BRUCE)
- 15. Senator Graham.
- 16. SENATOR GRAHAM:
- 17. I don't know where you got your synopsis, mine says to
- 18. twenty-five miles an hour.
- 19. PRESIDING OFFICER: (SENATOR BRUCE)
- 20. ... Senator Grotberg. Senator Grotberg, did you have further
- 21. questions?
- 22. SENATOR GROTBERG:
- No, just to draw that...attention and I want to make sure
- 24. it's drafted right because I think I know what he's talking about.
- 25. PRESIDING OFFICER: (SENATOR BRUCE)
- 26. ...Further discussion? Senator Savickas.
- 27. SENATOR SAVICKAS:
- Yes, Mr. President, the amendment that's...the Municipal
- 29. League agreed to was just a definition of what a resident district

- 31. (Secretary reads title of bill)
- 32. 3rd reading of the bill.
- 33. PRESIDING OFFICER: (SENATOR BRUCE)



1. Senator Berman. 2. SENATOR BERMAN: 3. Thank you, Mr. President. House Bill 1464. 20. (Secretary reads title of bill) 21. 3rd reading of the bill. 22. PRESIDING OFFICER: (SENATOR BRUCE) 23. Senator Berman. 24. SENATOR BERMAN: 25. Thank you. This bill amends the Governmental Employees Tort 26. Immunity Act. A couple of years ago we changed the purpose of this 27. tax to include the payment not only of the tort liability but also 28. of Workmen's Compensation and...this amendment would extend the 29. purpose of that tax to Unemployment Insurance Act. This is necessary 30. for non-home rule units, school boards in particular to be able to 31. carry the...the burden of the Unemployment Tax that has been imposed 32. upon them. - 4. I'm going to ask the...sponsor a question. What effect does

- 6. state? Answer Yes or No, please.
- 7. PRESIDING OFFICER: (SENATOR BRUCE)
- 8. Senator Berman.
- 9. SENATOR BERMAN:
- 10. Yes or No. Home rule units have the power, I believe, to do
- 11. this on their own. This will primarily...is for the home rule units
- 12. of...for non-home rule units and school districts that are faced
- 13. with the problem of covering their costs of unemployment insurance.
- 14. PRESIDING OFFICER: (SENATOR BRUCE)
- 15. Senator Mitchler.
- 16. SENATOR MITCHLER:
- 17. Well, who would...you mean this would give authority to the
- 18. local school districts to levy a tax to pay for their unemployment
- 19. insurance that was mandated by the Federal Government on us to
- 20. pass on to them? Is that what it is, Senator Berman?

- They are authorized to levy a tax now for Workman's Comp,
- 25. governmental employees liability. This would expand the purposes

- an expansion of the purposes for which that fund could be used.
- 28. PRESIDING OFFICER: (SENATOR BRUCE)
- 29. Further discussion? Senator DeAngelis.
- 30. SENATOR DEANGELIS:
- 31. He answered my question.
- PRESIDING OFFICER: (SENATOR BRUCE)
- 33. All right. Further discussion? Senator Berman may close.

- 1. SENATOR BERMAN:
- 2. I ask for a favorable roll call for your school districts and
- your non-home rule units.
- 4. PRESIDING OFFICER: (SENATOR BRUCE)
- 5. The question is, shall House Bill 1464 pass. Those in favor
- 6. vote Aye. Those opposed vote Nay. The voting is open. Have all
- 7. voted who wish? Have all voted who wish? Take the record. On
- 8. that question, the Ayes are 33, the Nays are 17, 1 Voting Present.
- 9. House Bill 1464 having received the required constitutional
- 10. majority is declared passed. If I might have the attention of the
- 11. Body, we have a distinguished couple today with us. In the gallery
- 12. is Mrs. Ruth Donnewald. Her husband accompanies us on the Floor
- 13. from time to time. I...we understand it is their wedding
- 14. anniversary today. And Mrs. Donnewald, he has worked very hard
- yesterday on the one minute rule to get him home today but it
- 16. didn't work too well. House Bill...for what purpose does Senator

- 18. SENATOR GROTBERG:
- 19. I just want to draw to your attention the concerns about the
- 20. Graham bill have been answered. It was written in a double
- 21. negative and everything is fine, but...

- 24. SENATOR GROTBERG:
- 25. ...it reads...it still...and if you could go back to it, I
- 26. would withdraw my objection.
- PRESIDING OFFICER: (SENATOR BRUCE)
- 28. Is there leave? No, leave is not granted. For what purpose
- does Senator Graham arise?
- 30. SENATOR GRAHAM:
- 31. Who didn't grant the leave? What is the problem?
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- Well, Senator Graham, I asked for leave and there was objection

- 1. to leave being granted. It only takes one Senator to make the
- 2. objection. Senator Savickas, I believe, makes the objection.
- 3. House Bill 1469, Senator Martin. For what purpose does Senator

- 19. House Bill 1459.
- 20. (Secretary reads title of bill)
- 21. 3rd reading of the bill.
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- 23. Senator Graham.
- 24. SENATOR GRAHAM:
- 25. Mr. President, all this bill does is allows some rural
- 26. communities, residence communities the opportunity to lower the
- 27. speed limit to twenty-five miles an hour, if they so desire. It
- 28. doesn't have anything to do with schools or hospitals or anything
- 29. else. I ask for a favorable roll call.
- 30. PRESIDING OFFICER: (SENATOR BRUCE)
- 31. Is there discussion? Senator Savickas.
- SENATOR SAVICKAS:
- ... Yes, Mr. President. Once again I arise to oppose the bill.

- 1. It...it restricts it to twenty-five miles per hour. We have...
- 2. many areas in our counties...I know in Cook County and Cook
- 3. County opposes this, there where we have in the forest preserves
- 4. fifteen miles per hour. We have twenty mile per hour school areas
- 5. and if you're saying, fine, you want to decrease it from forty-five
- 6. to twenty-five in certain residential areas, that's fine, but we
- 7. have areas that are less than twenty-five and this bill would not
- 8. allow that. I would oppose this and I'm sure in many of our
- 9. communities they would oppose this speed limitation.
- 10. PRESIDING OFFICER: (SENATOR BRUCE)
- 11. Is there further discussion? Senator Walsh.
- 12. SENATOR WALSH:
- 13. Well, it's...it's my understanding, Mr. President and members
- 14. of the Senate, that this bill, in no way, would provide for an
- 15. increase in the speed limit...by any interpretation. It would
- 16. provide that the local authorities have the...would have the
- 17. ability to reduce the speed limit and I would hope that everybody
- 18. would take a good look at this bill and if I am incorrect somebody
- 19. call it to my attention, but it provides for a reduction from...
- 20. from thirty to twenty-five. It just gives some authority to local
- 21. government that it does not now have and I think we should be for
- 22. reducing speed limits rather than increasing them in these
- 23. congested areas and I urge an Aye vote.
- 24. PRESIDING OFFICER: (SENATOR BRUCE)
- 25. Further discussion? Senator Rock.
- 26. SENATOR ROCK:
- 27. Well, seldom do I rise in opposition of Senator Walsh, but I
- 28. have to question his logic on this one. It just seems to me that
- 29. rather than affording the local units some additional authority,
- 30. we are, in fact, preempting authority they now have and if, in fact,
- the village of River Forest or...I'm not sure what a residence
- 32. district is, but let's assume for the sake of argument that your
- community and mine would fit within that definition if, in fact,

- 1. they wish to impose a twenty mile an hour school speed limit,
- 2. this would seem to take that away.
- 3. PRESIDING OFFICER: (SENATOR BRUCE)
- 4. Further discussion? Senator Egan.
- 5. SENATOR EGAN:
- 6. Yes, thank you, Mr. President and members of the Senate. I...
- 7. Senator Walsh, I think you are...I think you are in error. There
- g. is a...for example, a...in my district a forest preserve area where
- 9. there are picnic groves and through that road, which is about a
- 10. mile long for their many joggers, they have...for example, they
- 11. have a fifteen mile an hour speed limit, but this bill would...
- 12. would make the fifteen mile speed limit ineffective. It would
- 13. have to be twenty-five and that's why I'm in opposition to the bill.
- 14. I...we're not reducing speed limits, we're raising them. We're
- 15. doing both, actually.
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. Is there further discussion? For what purpose does Senator
- 18. Savickas arise?
- 19. SENATOR SAVICKAS:
- On a question, Mr. President. Is this bill preemptive?
- PRESIDING OFFICER: (SENATOR BRUCE)
- 22. Senator, we've already anticipated your question. We will
- answer that prior to the roll call.
- SENATOR SAVICKAS:
- Thank you.
- PRESIDING OFFICER: (SENATOR BRUCE)
- We are...reviewing the bill. Further discussion?
- Senator Coffey.
- SENATOR COFFEY:
- Yes, Mr. President and members of the Senate. I'm rising in
- 31. favor of this bill. The bill, as it has been drafted, as our staff
- has told us does not address...does not increase the speed limits
- in those school districts to twenty-five where they're twenty or 33.

- in the park districts, it doesn't affect that...that part, it
- 2. only addresses itself strictly to twenty-five mile an hour where
  - now thirty-five mile an hour has been granted in...on our highway
- 4. systems and I'd ask for a favorable roll call.
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- 6. Further discussion? Senator Geo-Karis.
- 7. SENATOR GEO-KARIS:

- 8. Mr. President and Ladies and Gentlemen of the Senate. If you
- 9. will recall I was one of those who questioned the bill. I have
- 10. now had some information on it. In the present...the current law
- 11. only permits reduction in speed of...to thirty-five mile per hours,
- 12. which authorities feel is safe and what this bill does, it gives
- 13. the authorities the right to go...to reduce it to twenty-five
- 14. miles per hour and I...and I want to tell you that the Motor
- 15. Vehicle Laws Commission approved of this bill. The Illinois
- 16. Association of County Superintendent of Highways and the Municipal
- 17. League and I'm satisfied with the examination of the bill and I
- 18. urge a favorable consideration. This will reduce the speed limit,
- 19. not increase it.
- 20. PRESIDING OFFICER: (SENATOR BRUCE)
- 21. Further discussion? Senator Bowers.
- 22. SENATOR BOWERS:
- 23. Well, I don't want to prolong this, Mr. President, but I would
- 24. like to point out to Senator Rock and others that if they will read
- the bill, Section 3, simply deletes or...or makes an exception of
- 26. the new Section, which is 4. It used to be that it was thirty-
- 27. five miles an hour and now they've said except when we've got
- 28. Section 4 and so when Section 4 is met, it can be decreased to
- 29. twenty-five miles an hour and I don't see how that can possibly
- 30. be considered an increase and I would hope we would vote in favor
- 31. of the bill.
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. Senator Hall.

## SENATOR HALL:

- 2. Thank you, Mr. President and Ladies and Gentlemen of the 3. In essence of time, since we're talking about one minute. 4. it was suggested to Senator Graham awhile ago, that it would be 5. wise to pull the bill out because there was some objections over here and then Senator Grotberg gets up and says, I understand 6. 7. that objection has been satisfied and we're ready to go for the 8. bill. I think it would be wise, Senator Graham, for those of us who want to give you a vote, it would be wise for you to hold that 9. vote at this time because you're not going to get the necessary 10. votes to pass this out till this is settled. 11.
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- 13. Further discussion? Senator Graham to close.

## 14. SENATOR GRAHAM:

- For Senator Hall and Senator Savickas and others, this is 15. House Bill 1459. If I take it out, there's no assurance I'll 16. ever get back to it. I had to suspend the rules now. This bill 17. is a simple bill, for goodness sakes. It doesn't take much to 18. understand it. It says that they shall...defines the residence 19. district...residence district, not park district and allows them 20. to reduce the speed limit to twenty-five miles an hour and that 21. those residences shall be not more than three hundred feet apart... 22. not more than three hundred feet apart. This takes care of some 23. of your rural areas. It doesn't do a darn thing, this three 24. hundred feet apart was put in there so there couldn't be a speed 25. trap. There's nothing wrong with this bill at all. It just let's 26. some of the rural resident's that pay a hell of a lot of taxes, it 27 let's them have an opportunity to reduce their speed limits to 28. twenty-five miles an hour if they want to. Let's vote it up or 29. down. If you want to beat a good bill, go ahead and do it. 30. PRESIDING OFFICER: (SENATOR BRUCE) 31.
- 32. Senator Savickas, in answer to your question, under Chapter 95%

- 1. of this Chapter, meaning the Motor Vehicle Code, is a limit on
- the authority of home rule units to adopt local police regulations
- 3. inconsistent herewith except pursuant to Sections 11208 and 209
- 4. and I think that this is not preemptive of their...their...of their
- 5. authority. The question is on the adoption of...of House Bill 1459.
- 6. Those in favor vote Aye. Those opposed vote Nay. The voting is
- 7. open. Have all voted who wish? Have all voted who wish? Take
- 8. the record. On that question, the Ayes are 33, the Nays are 7, 1
- 9. Voting Present. House Bill 1459 having received the required
- 10. constitutional majority is declared passed. House Bill 1469,
- 11. Senator Martin. Read the bill, Mr. Secretary, please.
- 12. SECRETARY:
- 13. House Bill 1469.
- (Secretary reads title of bill)
- 15. 3rd reading of the bill.
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. Senator Martin.
- 18. SENATOR MARTIN:
- 19. This is...this and the next bill are part of a package of
- bills that were worked out in long meetings with the Department
- of...Conservation for snowmobiling obviously in rural areas and
- 22. it's...municipalities, I don't know of any that allows snowmobiles.
- 23. All this one does is change the requirement that they be fifteen
- feet from the road to ten feet. The reason for it is simple. At
- 25. fifteen feet...where all the telephone poles are and everything
- 26. else, so that ten feet is more appropriate. It does not in any
- 27. way expand the roadsthat they can go on. That's all the bill does.
- PRESIDING OFFICER: (SENATOR BRUCE)
- 29. Is there discussion? Senator Savickas.
- 30. SENATOR SAVICKAS:
- Yes, Mr. President and members of the Senate. I rise in
- opposition to House Bill 1469. I know the County of Cook Highway
- Department is opposed to this reduction in feet that the snowmobiles

- 1. can drive on. The other two snowmobile bills were put on the
- 2. Agreed Bill List. Obviously, this does have some concern. We're
- 3. ...we're talking about the agreement with the Department of
- 4. Conservation. The agreement with the Department of Highways in
- 5. Cook County...that they're opposed to it. The traffic comes too
- 6. close to the highways. You have a very hazardous traffic pattern
- 7. in many areas with these snowmobiles and I think for our own
- 8. purposes, as a motoring public that we would be opposed to the
- g. snowmobiles coming this close to the highway and I would suggest
- 10. that, at least, Cook County people oppose this.
- 11. PRESIDING OFFICER: (SENATOR BRUCE)
- 12. Is there further discussion? Senator Sangmeister.
- 13. SENATOR SANGMEISTER:
- 14. Yes, Mr. President and members of the Senate. As a cosponsor
- 15. of this bill and as a snowmobiler, which I might as well put that
- 16. out, I think this is...is good. If you've ever driven in...and
- 17. after all, the right of ways of the highways is where probably where
- 18. ninety percent of the snowmobilers have to go to get any recreation
- 19. in this State and fifteen feet is entirely unconscionable. I
- 20. don't think anybody is obeying it now. Why don't we get our
- 21. snowmobilers in compliance with the law. Ten feet is still plenty
- 22. of clearance with no problems for people driving automobiles and
- 23. I would like you to take a good hard look at this because ten feet,
- 24. I think is very reasonable and that reduction of five feet will put
- 25. some snowmobilers in compliance with the law.
- 26. PRESIDING OFFICER: (SENATOR BRUCE)
- 27. The following Senators have sought recognition. Senators
- 28. Rhoads, Hall, Maitland, Davidson. Senator Hall.
- 29. SENATOR HALL:
- 30. Thank you, Mr. President and Ladies and Gentlemen of the
- 31. Senate. Will the sponsor yield for a question?
- 32. PRESIDING OFFICER: (SENATOR BRUCE)
- 33. ... She indicates she will yield.

- 1. SENATOR HALL:
- Senator, my note says that this allows a...a snowmobile to
- 3. be operated closer to a highway than is currently legal. Is that
- 4. what you're trying to do?
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Martin.
- 7. SENATOR MARTIN:
- 8. It changes it from fifteen feet to ten feet.
- 9. PRESIDING OFFICER: (SENATOR BRUCE)
- 10. Senator Kenneth Hall.
- 11. SENATOR KENNETH HALL:
- 12. My question is, does that make that illegal?
- 13. PRESIDING OFFICER: (SENATOR BRUCE)
- 14. Senator Martin.
- 15. SENATOR MARTIN:
- 16. Does that make what illegal?
- 17. PRESIDING OFFICER: (SENATOR BRUCE)
- 18. Senator Hall.
- 19. SENATOR HALL:
- 20. My note shows that this allows a snowmobile to be operated
- 21. closer to a...highway than is...than is currently legal right
- 22. now to do. Are you trying to get closer?
- 23. PRESIDING OFFICER: (SENATOR BRUCE)
- 24. Senator Martin.
- 25. SENATOR MARTIN:
- 26. Yes. We're changing it from fifteen feet to ten feet, so that
- 27. would be five feet closer.
- 28. PRESIDING OFFICER: (SENATOR BRUCE)
- 29. Senator Hall.
- 30. SENATOR HALL:
- But I mean, are you breaking the law? Is it illegal to do
- 32. that? That's what I'm asking.
- 33. PRESIDING OFFICER: (SENATOR BRUCE)

- ı. Senator Martin.
- 2. SENATOR MARTIN:
- 3. Oh, okay. I... I think... yes, right now you have to be fifteen
- 4. feet away from the highway.
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- 6. Thank you, Senator Martin. Your time has expired. Senator
- 7. . Rhoads.
- 8. SENATOR RHOADS:
- I just wanted to suggest for the benefit of Senator Savickas 9.
- that there are other legislators from Cook County that the Cook 10.
- County Highway Department could communicate their views to. This 11.
- came out by unanimous roll calls according to the digest in...in 12.
- both the committee in the House and the committee in the Senate. 13.
- Now, if the Cook County Highway Department has objections to this 14.
- bill or to the prior bill, why in the world don't they come down 15.
- and testify or let us know before a bill comes up on 3rd reading 16.
- in the opposite Chamber? 17.
- PRESIDING OFFICER: (SENATOR BRUCE) 18.
- Senator...Senator Maitland. 19.
- SENATOR MAITLAND: 20.
- 21.

Thank...thank you, Mr. President and Ladies and Gentlemen of

- the Senate. As Senator Sangmeister said, I, too am a snowmobiler. 22.
- It's very important to us in downstate Illinois and it's not only 23.
- a recreational vehicle, it's an emergency vehicle for many of us, 24.
- many times. The poles, the fences, everything...all right, fifteen 25.
- feet, we simply can't ride there. This simply puts us in compliance 26.
- so we can ride in snowmobiles. 27.
- PRESIDING OFFICER: (SENATOR BRUCE) 28.
- Further discussion? Senator Davidson. 29.
- SENATOR DAVIDSON: 30.
- Yes, Mr. President and members of the Senate. I rise in 31.
- support of this bill. This bill came out of...resolution to solve 32.
- a bad problem. I don't know how many happened up in your area, but 33.

- 1. in our area where the snowmobiles have been not just a recreation
- vehicle, but a vehicle which was been, really used for an errand
- 3. of mercy. We dug a couple of people out of a snowbank in Montgomery
- 4. County with a very ill baby and a guy almost got a ticket because
- 5. he was riding closer than the fifteen feet to the edge of the
- 6. highway. All this does is gives a chance for that snowmobiler who's
- 7. a taxpayer the same as you and I an opportunity to use the public
- 8. thoroughfare that he helped pay for the same as you and I  $\underline{i} n$  an
- 9. area where he can...use his snowmobile. All it does is move him
- 10. from out of the fence line to the shoulder and he's still ten feet
- 11. away from the highway...
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- 13. Senator Davidson...
- 14. SENATOR DAVIDSON:
- 15. It's a good bill.
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. ...your time has expired. Senator Knuppel.
- 18. SENATOR KNUPPEL:
  - 19. Well, I don't know if Senator Hall understood the answer about
  - 20. what was legal and illegal. Now, it's fifteen feet. After we pass
  - 21. this it will be ten feet. We are the law, so we...whoever rides then
  - 22. won't any longer be in violation of the law. If they ride
  - 23. there now, they are. After it's changed, they won't be.
  - 24. PRESIDING OFFICER: (SENATOR BRUCE)
  - 25. Further discussion? Senator Gitz.
  - 26. SENATOR GITZ:
  - 27. Mr. President and members. I would just simply like to say
  - 28. that I think that this is very helpful legislation and I'd like to
  - 29. add one comment that, perhaps, has not been brought out in debate.
  - 30. In Ogle County they were going to use the Snowmobile Association
  - on behalf of the Heart Fund drive. When this was announced the
  - 32. Conservation Department had a lot of deputies and Ogle County
  - had deputies out to make damn sure they could issue as many tickets

- 1. as possible, all under the fifteen feet clause and if this will
- certainly help the...Heart Fund drive among others, it certainly
- 3. rescue some of our snowbound people in the Northern Illinois winters
- 4. I think it will be very helpful.
- 5. PRESIDING OFFICER: (SENATOR BRUCE)
- Senator Vadalabene.
- 7. SENATOR VADALABENE:
- 8: Yes, just briefly, Mr...Mr. President and members of the
- 9. Senate. Senator Maitland mentioned about the poles...giving the
- 10. Poles this privilege and my son is getting a snowmobile and I
- 11. think the Italians would favor this bill also.
- 12. PRESIDING OFFICER: (SENATOR BRUCE)
- 13. Further discussion? Senator Martin may close.
- 14. SENATOR MARTIN:
- 15. Well, just so we don't have a conflict of interest. I am
- 16. not a snowmobiler. The idea of cold, speed and being out, I
- 17. think, I welcome you all to it, but I think it is a reasonable
- 18. bill and to have fifteen feet where people can't ride, switched
- 19. to ten feet is, it seems to me, fair and I would ask that if Cook
- 20. County has objection, it would have been nice to hear about it
- 21. before now.
- 22. PRESIDING OFFICER: (SENATOR BRUCE)
- 23. The question is, shall House Bill 1469 pass. Those in favor
- 24. vote Aye. Those opposed vote Nay. The voting is open. Have all
- 25. voted who wish? Have all voted who wish? Take the record. On
- 26. that question, the Ayes are 41, the Nays are 3, none Voting Present.
- 27. House Bill 1469 having received the constitutional majority is
- 28. declared passed. For what purpose does Senator Rock arise?
- 29. SENATOR ROCK:
- 30. Thank you, Mr. President and Ladies and Gentlemen of the
- 31. Senate. I know there are a couple of announcements, but we are
- 32. going to try as...as we can to stay within the schedule as prescribed
- and I'm going to move that we adjourn until nine o'clock tomorrow

- 1. morning. Now, tomorrow we will go to the Order of 2nd reading.
- 2. There are, roughly, seventy bills on 2nd reading. The majority
- 3. of those obviously are appropriation bills, so I would ask
- 4. everyone to attempt, at least, to get here on time. We'll go
- 5. to 2nd reading, attempt to move all those bills and then move
- 6. right on to 3rd reading. We will also for the information of the
- 7. membership, Senator Shapiro and I have another proposed Agreed
- 8. Bill List, which will be circulated to the membership tomorrow
- 9. in which contains some sixty-five or seventy bills. We will have,
- 10. roughly, at the start of business tomorrow about four hundred and
- 11. ten House Bills on the Calendar and we have, as you well know,
- 12. only until Wednesday to move those bills, so I would urge everyone
- 13. to be present and ready to work because we're going to start
- 14. promptly at nine o'clock tomorrow morning and I would place the
- 15. motion to adjourn until that hour, Mr. President.
- 16. PRESIDING OFFICER: (SENATOR BRUCE)
- 17. Are there announcements prior to voting on Senator Rock's
- 18. motion? Senator Maitland. I'm sorry. Senator McMillan. Senator
- 19. Maitland, your light is on, too. You might...
- 20. SENATOR McMILLAN:
- Mr. President, just to a comment to the Republican members.
- 22. If you'll recall a couple of days ago, it was announced that there
- would be copies available of House Bill 2569, which is the...the
- 24. Corporate Personal Property Tax Replacement Bill and Senator Bruce
- $^{\mbox{\sc has}}$  indicated to me that if...if one hasn't come to you, there are
- 26. some available in his office.
- 27. PRESIDING OFFICER: (SENATOR BRUCE)
- Copies of House Bill 2569 are available in my office for those
- 29. who wish copies...the Corporate Personal Property Tax. Further
- 30. announcements? Senator Vadalabene.
- 31. SENATOR VADALABENE:
- Yes, I would like to ask President Rock just a brief question.
- I passed a bill today...passed a bill up because Senator Keats wasn't
