# SENATOR GEO-KARIS:

It's my pleasure, Mr. President and Ladies and Gentlemen of the Senate, to introduce two winners in the Primary Elections in District 60, William Peterson, who we ran unopposed

and is from Vernon Township, who will be replacing Representative Betty Reed, who is not running again. And Robert Churchill, who was opposed and was elected by thirty votes in the primary in District 62 of the General Assembly Districts from Lake Villa, Illinois. Thank you, Mr. President.
