#### SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is the administration's proposal regarding changing the way we collect tax on alcoholic beverages. And it takes it from the Insurance and Pension and Licensed Activity Committee and puts it in the Revenue Committee where it should be. I've talked to Senator Rock and he's in full agreement.

# SENATOR ROCK:

Thank you, Mr. President. Senator Philip accurately stated that this bill is, in fact, the Governor's liquor tax proposal and it rightfully belongs in a Senate Revenue Committee, and I would agree with this motion and urge your support.

How...how are we going to know when the Rules Committee meets, by...simply by announcement?

### SENATOR DEMUZIO:

Well, then I have another request then. Senate Bill 1313, I would like to add Senator Gitz and Senator Degnan as co-sponsor.

Being at the present time they have two designated for that function, there's not adequate business for two of them to operate and one of the docks is sitting empty. And I ask for a favorable role call.
