11. SENATOR GEO-KARIS:

12. Mr....Mr. President and Ladies and Gentlemen of the Senate,
13. I'm very happy to see that Senator Bowers acknowledged the...
14. the incipience of the golden years of Senator DeAngelis. And
15. if he likes, we can sing happy birthday to him, because we
16. can sing better than he can.

7. Thank you, Mr. President and Ladies and Gentlemen of the
8. Senate. This is to add fifty thousand dollars to the expense
9. line item for the possible deficit, due to the increase
10. costs of travel for members of the General Assembly. I
11. would move adoption of Amendment No. 1.

12. PRESIDING OFFICER: (SENATOR BRUCE)

13. The motion is to adopt. Discussion? All in favor say
14. Aye. Opposed Nay. The Ayes have it. Committee Amendment
15. No. 1 is adopted. Further committee amendments?

24. SENATOR SCHAFFER:

25. Yes. Mr. President, Amendment No. 2...adds forty-nine
26. thousand one hundred dollars to the...line item for Senators'
27. salaries to...comply with the State law, in the event of the
28. death of a Senator, that the...surviving spouse of the deceased
29. Senator receive the salary in a lump sum for the remaining days
30. in the term of the deceased. I think this...we all realize
31. this is because of the death of Senator Kent.

32. PRESIDING OFFICER: (SENATOR BRUCE)

33. Alright. The motion is the adoption of Amendment No. 2.

1. Discussion? All in favor say Aye. Opposed Nay. The Ayes
2. have it. Amendment No. 2 is adopted. Further amendments?

12. Ethnic Heritage site there. 'Cause under the rules, you can't
13. build...can't do any work...only the State Fair Commission can
14. do the work. It doesn't create any new money. So instead of
15. building a temporary site, what this does...

16. PRESIDING OFFICER: (SENATOR BRUCE)

17. May we have some order, please? Senator Lemke.

18. SENATOR LEMKE:

19. ...for an additional ten thousand dollars or so,...they
20. put in underground...plumbing and lighting in the area, which
21. can be reused...for anything else. For making a...a permanent
22. improvement there at the fairgrounds instead of just blowing
23. the money for a...a temporary thing. And what this does is...
24. it doesn't create any new money. I ask for its adoption.

29. PRESIDING OFFICER: (SENATOR DONNEWALD)
30. Is there further discussion? Senator Davidson.
31. SENATOR DAVIDSON:
32. What did that amendment do? I have not seen it and we're
33. talking about...the day we're trying to do for the school

1. districts. If we're adding something different, I'd like
2. to see it, please.
