PRESIDING OFFICER: (SENATOR BRUCE)

For what purpose does Senator Rock arise?

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. If I can have the attention of the membership.

PRESIDING OFFICER: (SENATOR BRUCE)

May I have some attention, please. If we can break up our caucuse in the aisles, we have a couple of pieces of legislation to take action on. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. We will shortly be dealing with the adjournment resolution which will call for us to return to Springfield after we leave today, and we will be leaving today, on April 13th at the hour of two o'clock. Two o'clock on the 13th. Now, there has been some delay in the Reference Bureau through no...no one's fault, it just the...the wealth of business that apparently they have enjoyed over the past few days. So the plan is that when we close business today, we will recess to the call of the Chair, and as the bills come out of the Reference Bureau they're to be delivered. If anybody wants to go home, just deliver them to Senator Philip's office or my office, and we'll make sure they're introduced. And we will keep the Session open, technically open, until the hour of five o'clock, at which point we will reconvene, introduce those bills that have been delivered and then adjourn until the 13th of April. Today we will be considering, hopefully, the Constitutional Amendments, Senate Joint

Resolution 36. Senator Bruce, are you going to call your bill? There will two...two, at least, roll calls and then Senator Sam has a...will ask us to convene into Executive Session for the purpose of advising and consenting to some Gubernatorial nominees. And...all right, Senator Netsch has a bill that she would like to move, so if we...we should be through in less than thirty minutes if everybody just stays on track.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock, do you want to take your motion in writing at this time?

SENATOR ROCK:

Yes.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. Motions in writing, Mr. Secretary.

SENATOR ROCK:

I know of no opposition. We'll just clear the Calendar and make the Secretary's job a little easier. I'm...I move that the bills be re-referred to their respective committees.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. I would move for the suspension of the rules and the immediate consideration and adoption of this joint resolution. It is the adjournment resolution. We just wish to get it over to the House.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is...suspend the rules. On the motion, discussion? All in favor say Aye. Opposed Nay. The Ayes have it. Rules suspended. On the motion to adopt the resolution, discussion? All in favor say Aye. Opposed Nay. The Ayes have it. The resolution is adopted.

PRESIDING OFFICER: (SENATOR BRUCE)

Executive Committee.

ACTING SECRETARY: (MR. FERNANDES)

Senate Resolution No. 447. It's congratulatory.

PRESIDING OFFICER: (SENATOR BRUCE)

Resolution Consent Calendar. Is there leave to go to the Order of Senate Bills 2nd Reading? Leave is granted. Senate bills 2nd reading, there's Senate Bill 1463, are...are there amendments, Mr. Secretary, please. Read the bill a second time, please.

ACTING SECRETARY: (MR. FERNANDES)

Senate Bill 1463.

(Secretary reads title of bill)

2nd reading of the bill. No committee amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

Are there amendments from the Floor?

ACTING SECRETARY: (MR. FERNANDES)

Amendment No. 1 offered by Senator Netsch.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Netsch is recognized.

SENATOR NETSCH:

Thank...thank you, Mr. President. This amendment is pretty much a technical one that was suggested to us by the Appropriations Staff and has been, I believe, cleared with the staff on the other side. This is the bill we talked about yesterday. The amendment would change the effective date of one section of the Act, Section II which, in fact, reappropriates the money for the next fiscal year. The reason being that we then do not have to go through the same emergency process again this Session. The Appropriations Staff felt that it made more sense to have that section become effective on July 1, 1982, which is the time when it will, in fact, have effect. So, that is what the amendment does. It is basically a technical one. I would move its adoption.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is adopt Amendment No. 1. Discussion of that motion? All in favor say Aye. Opposed Nay. The Ayes have it. Amendment is adopted. Further amendments?

ACTING SECRETARY: (MR. FERNANDES)

No further amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. Is there leave to go to the Resolution Consent Calendar? Leave is granted. Are there any...have any objections been filed to any of the resolutions contained upon the Resolution Consent Calendar, Mr. Secretary?

ACTING SECRETARY: (MR. SECRETARY)

No...no objections have been filed.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Geo-Karis, do you have an objection to a resolution?

SENATOR GEO-KARIS:

I just have some other matter, if I may.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. Since there is no objections been filed, Senator Collins moves the...the adoption of the resolutions on the Resolution Consent Calendar. On the motion to adopt, all in favor say Aye. Opposed Nay. The Ayes have it. The Resolution Consent Calendar is adopted. For what purpose does Senator Geo-Karis arise?

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I am the sponsor of Senate Bill 399, which is a subcommittee before Senator Jerry Joyce's committee, and I would like at this time to have leave to Table that bill.

PRESIDING OFFICER: (SENATOR BRUCE)

What's the bill number, Senator?

SENATOR GEO-KARIS:

It's Senate Bill 399.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Geo-Karis moves to discharge the committee from further consideration of Senate Bill 399 and Table that bill. On the motion to discharge and...and Table, all in favor say Aye. Opposed Nay. The Ayes have it. The bill is discharged and Tabled. (Machine cutoff)...go to the Order of Constitutional Amendments? Leave is granted. For what purpose does Senator Nash arise?

SENATOR NASH:

Mr. President and Ladies and Gentlemen of the Senate, I ask leave to be listed as the hyphenated co-sponsor of Senate Bill 1500.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave? Leave is granted. Constitutional Amendments 3rd reading. On page 4 of your Calendar, Senate Joint Resolution 36. Read the resolution, Mr. Secretary, please.

ACTING SECRETARY: (MR. FERNANDES)

Senate Joint Resolution No. 36, Constitutional Amendment.

(Secretary reads SJR No. 36)

3rd reading of the resolution.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock is recognized. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I urge, this afternoon, your support for Senate Joint Resolution 36. It is a proposed amendment to the Constitution, and as we are all well aware, the 1970 Constitution which was approved by the people of this State provides that everyone who is accused of a crime is bailable, is entitled to bail by sufficient sureties, except...except for capital offenses. What we are saying, because, unfortunately, the Judiciary of this State, and we the governmental officials, are sometimes criticized because defendants are released on bail. The fact of the matter is, the Judiciary

has no choice. It is the right of an accused to be released on bail, so what we are attempting, by virtue of this proposed constitutional amendment, is the simple addition of another exception. It is an expanded category of non-bailable offenses, namely, offenses for which a sentence of life imprisonment may be imposed as a consequence of conviction. So, if this is adopted by the people of this State in November of 1982, the judges, in fact, when dealing with an accused will have more discretion. They can, in fact, then under the appropriate circumstances, where the proof is evident, deny bail to those who, frankly, should be denied bail. This amendment has received widespread popular support. I understand copies of the editorial support have been submitted to all the members. I urge your favorable support. We have to get this to the House and out of the House by the first week of May, so that it can rightfully be presented to the people of this State in November of 1982. I urge your support for Senate Joint Resolution 36.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there discussion? Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, this is one of the things that's been...told to me by so many constituents, that we should do something to strengthen the bail requirements. And I certainly speak in favor of this bill because its time has come and is very much needed.

PRESIDING OFFICER: (SENATOR BRUCE)

Further discussion? Further discussion? Senator Egan.

SENATOR EGAN:

Yes, thank you, Mr. President and members of the Senate. I would like to point out in addition to what Senator Rock has said that the provision in the Constitution presently requires, it mandates that habitual offenders be bailed. And this is a loophole...loophole which is gaping. It does not

require the judge to deny bail, it allows the judge to deny bail. There may be circumstances where an habitual offender is properly bailable, as they all are bailed today by that requirement of the Constitution. However, it would seem that in the overwhelming number of cases that such a right should be denied if the judge so feels. And I urge that you consider the fact that this is absolutely essential to the safety of our streets that this Constitutional Amendment be placed on the ballot and be voted on.

PRESIDING OFFICER: (SENATOR BRUCE)

Further discussion? Senator Rock may close.

SENATOR ROCK:

Thank you, Mr. President. I would just add for those who have inquired that this proposed amendment is a result of a joint effort by the Illinois and Chicago Bar Associations, by a special committee chaired by former Appellate Judge Robert English. There was a lot of discussion about one's civil liberties. This is a reasonable approach, and as Senator Egan rightfully pointed out, those who are habitual offenders should be denied bail. And this will afford the judges that opportunity. I urge your favorable support.

PRESIDING OFFICER: (SENATOR BRUCE)

Under Article 14 of the Illinois Constitution, Section 2, amendments to the Illinois Constitution require a three-fifths majority vote. The question is, shall Senate Joint Resolution 36 be passed and approved. Those in favor vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question the Ayes are 54, the Nays are none, none Voting Present. Senate Joint Resolution 36 having received a three-fifths constitutional majority is declared passed. (Machine cut off)...Rock.

SENATOR ROCK:

Thank you, Mr. President. Before I go up to preside, I



would just like the record to reflect that Senator Sangmeister is again absent due to illness and Senator Taylor is absent today because of illness in his family.

PRESIDENT:

All right. With leave of the Body, we'll move to Page 5 on the Calendar on the Order of Consideration Postponed is House Bill 427. Read the bill, Mr. Secretary. I thought...is this to be amended? Oh, I see, all right. Senator Bruce asks leave of the Body to return House Bill 427 to the Order of 2nd Reading for purposes of an amendment. Is leave granted? Leave is granted. On the Order of House Bills 2nd reading, House Bill 427, Mr. Secretary.

ACTING SECRETARY: (MR. FERNANDES)

Amendment No. 1 was adopted on June 24. Senator Bruce offers Amendment No. 2.

PRESIDENT:

Senator Bruce.

SENATOR BRUCE:

Thank you, Mr. President and members of the Senate. The bill as...originally introduced appropriated five hundred and thirty-six thousand dollars for soil surveys. All of that is being deleted from the appropriation bill. This is an appropriation to handle one assistant superintendent of schools in McLean County. We appropriated twenty-five thousand one hundred dollars last year on an early retirement bill, and when they recomputed his retirement credits for military service, he picked up another month of service credit. The bill has to get out of here by April the 15th so that he can receive his check in May. And so this...this amendment, which I propose to place on the bill, will appropriate an additional four hundred and twenty-three dollars and fifty-five cents to the Common School Fund. Ask for its adoption.

PRESIDENT:
