The hour of twelve having arrived the Senate will come to order. Prayer by Reverend Stephen Sotiroff of Blessed Sacrament Church, Springfield. Will the guests in our galleries please rise.

REVEREND STEPHEN SOTIROFF:

(Prayer given by Father Stephen Sotiroff)

PRESIDING OFFICER: (SENATOR DONNEWALD)

Reading of the Journal. Senator Johns.

SENATOR JOHNS:

Thank you, Mr. President. I move that reading and...and approval of the Journal of Tuesday, April the 13th, of the year 19...82 be postponed pending arrival of the printed Journal.

PRESIDING OFFICER: (SENATOR DONNEWALD)

You've heard the motion. Those in favor indicate by saying Aye. Those opposed Nay. The Ayes have it. Motion carries. Committee reports.

ACTING SECRETARY: (MR. FERNANDES)

Rules Committee Report. Pursuant to Amended Rule 5, the Rules Committee met at 11:00 a.m. April 14, 1982 and makes the following report: By unanimous vote the committee ruled that the following bills can be considered during this Session of the Senate:

Mr. President - I am directed to inform the Senate that the House of Representatives has adopted the following Joint Resolution, in the adoption of which I am instructed to ask concurrence of the Senate, to-wit:

House Joint Resolution 79. Senator Davidson will be the Senate sponsor.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Consent Calendar. Senator Bloom, for what purpose do you arise?

SENATOR BLOOM:

A point of personal privilege.

PRESIDING OFFICER: (SENATOR DONNEWALD)

State your point.

SENATOR BLOOM:

Yes, with us today is a delegation from the Peoria County Farm Bureau, friends and neighbors from our neck of the woods. I wonder if they'd be recognized.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Please stand and be recognized. Resolution.

ACTING SECRETARY: (MR. FERNANDES)

Senate Resolution 453, offered by Senator Buzbee. It's a death resolution.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Consent...Senator Buzbee.

SENATOR BUZBEE:

I...I wonder, Mr. President, if at some appropriate time rather than the Consent Calendar...this is...this is a very special person, and I wonder if we might consider that individually rather than on the Consent Calendar.

PRESIDING OFFICER: (SENATOR DONNEWALD)

We...we'll...we'll do that, Senator. We'll have that done. That will remain on the Secretary's Desk. Senator Sommer.

SENATOR SOMMER:

Mr. President, as a matter of personal privilege, I'd like to introduce to the Senate the Eighth Grade Class of the Riverton Middle School here in Sangamon County, now in my new district, formerly in Senator Davidson's district. Would you stand up, students?

PRESIDING OFFICER: (SENATOR DONNEWALD)

Please...please rise and be recognized. Resolutions.

ACTING SECRETARY: (MR. FERNANDES)

Senate Joint Resolution No. 81, offered by Senator Demuzio.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Consent...Executive. Senator Mahar, for what purpose do you arise?

SENATOR MAHAR:

Thank you, Mr. President. As principal sponsor of Senate Bill 1297, I'd like to ask that Senator Sangmeister be added as a hyphenated co-sponsor.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Is there leave? Leave is granted. Senator Lenke, for what purpose do you arise?

SENATOR LEMKE:

I'd like to make...on Senate Joint Resolution 78, which is a resolution we have to get passed to give to Percy and then to take to Washington, regarding the Illinois Michigan Canal, I'd like to make a motion and take it from Executive Committee and have it immediately heard.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Is there discussion? The motion...the motion is to discharge the Committee on Executive concerning Senate Joint Resolution 78. Is there discussion? Those in favor of discharging committee indicate by saying Aye. Those opposed. The Ayes have it. The Committee on Executive is discharged. Now, Senator Lenke wishes to consider this resolution immediately. Chair recognizes Senator Lenke.

SENATOR LEMKE:

I'd like to have this...make a motion...make a motion and have this resolution heard immediately, so we can get it to the House and get it passed, because it's needed for Friday this week.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Would you...there is a request for an explanation of the resolution.

SENATOR LEMKE:

All...all this resolution does is...is request Congress to consider making it a national park of the Illinois Mich-

igan Canal, which is...which is in Illinois. This is a...this is a campaign done bipartisan by the...both Democrats and Republicans in Illinois, and they're having a meeting in Joliet, I believe, Friday. They need the resolution so they can take it to Washington to give to the Department of Conservation, I guess, or National Forest or whatever.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Is there discussion? Question is, shall Senate Joint Resolution 78 be adopted. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. Resolution is adopted. Senator Lenke.

SENATOR LEMKE:

I also would like to have added to Senate Bill 1289 to show the bill as listed as Lemke-Egan as a sponsorship.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Do we have leave for that? Leave is granted. Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. By way of an announcement, the Appropriations I Committee will be meeting tomorrow morning at 9:00 a.m. in Room 400. Room 400 instead of the usual 212. Thank you.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Senator Davidson.

SENATOR DAVIDSON:

Mr...Mr. President, I would like to draw attention to all members of the Senate that on their desk is a memorandum from me concerning the Governor's Prayer Breakfast. Would you please read it and make your ticket need known to me so we can have places in the down-front tables for the members of the Legislature on May the 13th.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Senator...Senator Joyce, Jeremiah.

SENATOR JEREMIAH JOYCE:

Thank you, Mr. President. Mr. President, I would ask that the record show that Senator Savickas be removed as Senate sponsor of House Bill 1690 at the request of the House sponsor and Senator Jeremiah Joyce be listed as sponsor of House Bill 1690. Thank you.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Is there leave? Leave is granted. Senator Buzbee.

SENATOR BUZBEE:

Thank you, Mr. President. Senator Taylor is the Senate sponsor of Senate Bill 1350 and that was inappropriately referred to Appropriations I Committee. At this time, I would like move that that bill be re-referred to Appropriations II Committee. It deals with the Department of Law Enforcement.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Is there leave? Leave is granted. Senator Netsch, are you prepared to proceed on...House...Senate Bills on 3rd reading?

SENATOR NETSCH:

Right.

PRESIDING OFFICER: (SENATOR DONNEWALD)

All right, Senate...Senate Bills 3rd reading, Senate Bill 1463. Read the bill, Mr. Secretary.

ACTING SECRETARY: (MR. SECRETARY)

Senate Bill 1463.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Senator Netsch.

SENATOR NETSCH:

Thank you. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Well, just...just a moment. Will the members please be

in their seats. This is a bill on 3rd reading, could we have your attention, please. Proceed.

SENATOR NETSCH:

Thank you, Mr. President. Senate Bill 1463 results from the deliberations of the Legislative Audit Commission and an audit that was done earlier by the Auditor General. He determined that...the Auditor General determined that some money which the Legislature had appropriated several years ago to the Illinois Industrial Development Authority by all odds should have lapsed and would not been available for reuse although it was originally intended to be a revolving fund. That is due to a series of events that took place in between, including a court decision and the repeal by this Legislature of the underlying Statute. There is no question that the Legislature intended the direct loan money made available to the Industrial Development Authority to be a revolving fund. The question was raised by the Auditor General. The Legislative Audit Commission took testimony on this heard from the members of that...authority, and were told by chairman that the members of the authority felt they could no longer engage in the direct loan program which we had authorized unless the Legislature did something to, in effect, make them honest. They felt they were otherwise subjecting themselves to liability. This bill is the result of that series of events. It reappropriates the money to...which had already been appropriated several years ago to the Illinois Industrial Development Authority to continue the program for which it was originally intended, the direct loan program. It is not new money. It will not take anything out of the State Treasury. Is just simply is a legal device to allow them to continue the program. It is of some urgency, because they are stalled on dead center until we act and pass this bill. I would be happy to answer questions. It is a bipartisan effort and I believe there is no controversy.

Thank you.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Senator Weaver.

SENATOR WEAVER:

Thank you, Mr. President. I agree with everything Senator Netsch has said. This bill should be supported. Past General Assemblies have appropriated this money, and it was the intention that it be a continuing program rather than be reappropriated every year. So I hope we'd all support it.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Senator DeAngelis.

SENATOR DeANGELIS:

Thank you, Mr. President. As the joint sponsor on...on this, I hypothecate everything Senator Netsch has said. Thank you.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Looks like there's no arguments. Is there further discussion? Senator Netsch, you may close if you wish. The question is, shall Senate Bill 1463 pass. Those in favor vote Aye. Those...those opposed Nay. The voting is open...those voted who wish? Have all those voted who wish? Take the record. On that question, the Ayes are 53, the Nays are none. Senate Bill 1463 having received the constitutional majority is declared passed. Resolutions.

ACTING SECRETARY: (MR. FERNANDES)

Senate Resolution 454 offered by Senator Rock and all members of the Senate. It's a death resolution.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Consent Calendar. Senator Netsch, for what purpose do you arise?

SENATOR NETSCH:

For an announcement, when it is appropriate.

PRESIDING OFFICER: (SENATOR DONNEWALD)

You...it is appropriate right now.



SENATOR NETSCH:

The Revenue Committee is scheduled for 9:00 a.m. tomorrow morning. The Revenue Committee will meet at 9:00 a.m. To the best of my knowledge, we now have probably only one bill to be heard. I think the two bills of Senator Sangmeister's will not be heard in his absence, but we will meet and dispose of the one bill.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. I move that the Senate resolve itself into Executive Session for the purpose of acting on the Governor's appointments set forth in the Governor's Messages of February 26, 1982 and March 18, 1982.

PRESIDING OFFICER: (SENATOR DONNEWALD)

SENATOR VADALABENE:

SENATOR ROCK:

Yes, thank you, Mr. President and Ladies and Gentlemen of the Senate. If I can have the attention of the membership for just a couple of announcements. We have, as you know, committees schedules for this afternoon and tomorrow morning. We will adjourn this afternoon until noon tomorrow, and I expect that the Session will not last very long, but there is a Revenue Committee meeting and an Appropriations Committee meeting tomorrow morning, and the Executive, of course, this afternoon. The Rules Committee will meet tomorrow at 11:00 a.m. in Room 400 for those members who wish to have the Rules Committee consider Senate Bills...their Senate Bills, I would suggest very strongly that sometime this afternoon or tomorrow morning, in addition to making an appearance if you feel that's necessary, before the committee at eleven o'clock, contact the members of the working subcommittee, Senators Weaver and Donnewald, who have graciously volunteered to suffer all this flack...between now and then, and afford them the opportunity to review with you legislation which, in the opinion of some, might be an emergency. Finally, I would like to bring to the attention of the membership, we two weeks ago under the auspice of the Commission on Intergovernmental Cooperation sent a memo to all members with respect to the new Internal Revenue Service temporary regulations. As you well know, under the new tax law that was passed there was consideration given to those who are members of the General Assembly with respect to certain tax provisions. We all, of course, wish to obey the law as stated by the Congress, even though the regulation at this point is still temporary. But it does provide for a filing deadline,

a filing at least of a declaration which, of course, is tomorrow, April the 15th. The most recent memo was distributed yesterday. I would urge all members to take a long hard look at that, so that we can all be in compliance with the law as the Congress has announced it. John Latimer, from the staff of the Commission on Intergovernmental Cooperation and Bill Holland, of our Washington office, have been working closely with the Congressional Committee and with the IRS to make sure that...that we in Illinois have the best information, the latest information available. So, if you have any question, I've ask Mr. Latimer to...to present himself as he is here on the Floor. Don't hesitate to stop and talk with him, and...so that we all fully understand what our obligation is under the law as just recently passed. I would urge all of you to reread that memo and get ourselves in compliance with the law. It is a benefit that many of us went to Washington and testified before the House Ways and Means Committee on the...on behalf of the seven thousand plus members of the General Assemblies throughout this country. We feel the Congress has understood our predicament and have afforded to us the opportunity to file amended returns. And I would urge you to do that or at least consider it, and if you have any questions, Mr. Latimer will be available all afternoon and Mr. Holland in Washington, sitting by the phone awaiting any calls from any member.

PRESIDING OFFICER: (SENATOR BRUCE)

Any further business to come before...Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I'd like the record to show that Senator Keats is still in Germany on official business and Senator Becker is still in the hospital.

PRESIDING OFFICER: (SENATOR BRUCE)

ACTING SECRETARY: (MR. FERNANDES)

Senate Resolution 460, by Senator Geo-Karis.

PRESIDING OFFICER: (SENATOR BRUCE)

Executive Committee. For what purpose does Senator Geo-Karis arise?

SENATOR GEO-KARIS:

The resolutions just read are all congratulatory.

PRESIDING OFFICER: (SENATOR BRUCE)

Hold on just a second. Senator, I think that the one dealing with Iran perhaps is not congratulatory. All right, that...that one will go to the Executive Committee. Senator Buzbee, did you...

SENATOR BUZBEE:

Mr...Mr. President, I have a...a death resolution. I...I seldom ever do this...

PRESIDING OFFICER: (SENATOR BRUCE)

All right, Senator Buzbee, why don't we...we have some more business. I'd like to keep that...I didn't know that your...that particular resolution, we'll do that as the last order of business before we conclude. Senator Rock, for what purpose do you arise? May we have some order, please. We're

just about to conclude the business of the Senate. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Just a couple of housekeeping details, Senate Bill 1500 was assigned to the Committee on Reorganization. It really ought to be in the Committee on Public Health, Welfare and Corrections, and I would move that Senate Bill 1500 be re-referred to the Committee on Public Health, Welfare and Corrections.

PRESIDING OFFICER: (SENATOR BRUCE)

All right, and Senator DeAngelis this request is made...at...this is his request that the bill be moved. So it's with agreement of both sides. Motion is to discharge the Committee on Reorganization from further consideration of Senate Bill 1500 and that the bill be re-referred to the Committee on Public Health. On the motion, discussion? All in favor say Aye. Opposed Nay. The Ayes have it. The bill is discharged and re-referred. Senator Rock.

SENATOR ROCK:

Thank you. I further understand, Mr. President, that the Governor has delivered and the Secretary has read-in Executive Orders I and II, and I would move at this time that they be referred to the Committee on Executive Reorganization or the Committee on...whatever the name of that committee is, Reorganization. I would so move, so that that committee can plan a meeting schedule confronted with those two Executive Orders.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. The motion is that Executive Order I and II be referred to the Committee on Executive Reorganization. On the motion, all in favor say Aye. Opposed Nay. The Ayes have it...Executive Orders will be so referred. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. Finally, before we get to the death resolution, I would again ask...request that all members be in their seats. We have a communication from our Secretary, which I would like to share with the members. Addressed to all the honorable members of the Illinois Senate, it says as follows, "I deeply appreciate the beautiful flowers sent to me during my recent stay in the hospital. Your kindness and thoughtfulness is very much appreciated. Hoping to see you all soon, but can make no promises as to when." Signed, Ken Wright. He is, I am told, recuperating well, and we urge him a speedy recovery and, hopefully, a quick return.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. Senator Johns, for what purpose do you arise?

SENATOR JOHNS:

I'd like to have permission to be cosponsor of Senate Bill 791...to be added as a sponsor, Mr. President.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave? Leave is granted. (Machine cutoff)... Buzbee. If we might have the order...order in the Senate, Senator Buzbee has a death resolution of a longtime friend of this General Assembly, and if we can have some order, if we can clear the aisles, if the members would please be in their seats, if our House guests would please find a seat here in the Senate with us for a moment and if the staff would clear the aisles here just for a second. Senator Buzbee is recognized on a death resolution. May we have some order, please. Senator Buzbee.

SENATOR BUZBEE:

Thank you, Mr. President, I...seldom introduce death resolutions, and even when I do, I less seldom ask that they be read. But this is, I think, a very special case, at least, as it pertains to Southern Illinois, in particular, and to the whole State in a more general manner. It's a

short resolution. I would ask the Secretary to read it this time, and then I have a few short comments when he finishes.

PRESIDING OFFICER: (SENATOR BRUCE)

Mr. Secretary.

ACTING SECRETARY: (MR. FERNANDES)

Senate Resolution 454, offered by Senators Buzbee, Rock and all members of the Senate.

(Secretary reads SR 454)

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Buzbee.

SENATOR BUZBEE:

Thank you, Mr. President. I attended Dr. Morris' funeral yesterday, as did Senator Johns, in Shyrock Auditorium on the campus of Southern Illinois University. It was a befitting day. It was a beautiful day. The auditorium was filled with his friends, colleagues. Dr. Morris touched the lives of thousands of individuals in this State in a way that few people seldom have the opportunity to. He not only built Southern Illinois University, he also built and sold Southern Illinois. It was an ongoing work of his life. I first met Dr. Morris as a freshman at SIU during the new student week festivities in the fall of 1955 at an annual watermelon fest that he had for all in coming freshman. I didn't know Dr. Morris well, personally. As a student in that university, I had occasion to speak with him upon...upon occasion a few times during my career there and later after I came back from the military. But I count Dr. Morris, even though I was not close to him at all, I count him as one of the eight or ten people who has touched my life, has had a severe...a profound impact on my life as he had, like I said, thousands of others in this State. He was an educator, he was a politician, he was an administrator, he was a dreamer, and he was a doer in the best sense of all of those words. This State has lost a paramount citizen.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Johns.

SENATOR JOHNS:

Thank you. I wish that since Senator Buzbee had put forth this resolution that I had been allowed to speak and give him the honor of speaking last, but I did attend the services. He was a man that really looked at the hardships of those who had not prepared themselves for college, and he wanted to admit them on the basis that they should be given a chance. This was innovative and it was truly a blessing for thousands of young people who did not have the guidance that's often required to prepare themselves for college. I remember in the eulogy by Dr. Paul Moral, his aid and assistant, that Dr. Morris always had a nod and a handshake and a smile for everyone, and that was sort of a trademark for him, besides his cocked hat that he wore. As member of the student council, I was in his home many times and I loved him dearly. He was...a rather warm and kind individual and always had time for you. I remember, also, the remarks about his beloved wife, Dorothy, that the word Dorothy, in Greek, means a gift of God. And I want to pay tribute to her, too, Senator Buzbee, because she stood by him all these years when he knew no one. And it was a tragedy to me, too, that the students that he had worked so hard for him, turned on him a little bit. And it's like Charlie Chew said, "Did that contribute a little bit to the sad state of affairs and what happened to him?" And I think it did, because I noticed that he didn't carry the spritful walk that he always did when the students turned on him, and yet, he still loved them dearly and kept himself dedicated to them. I remember being with Dorothy, his wife, at SIUE, in Senator Vadalabene's area, when they presented award to him there. We loved him dearly. He contributed more, Paul Simon said, than any man in the history of Southern Illinois to Southern Illinois, and

I think that says enough for all of us.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. Just briefly, I, too, was well acquainted with Deleyte Morris and the late President Reynoldman when they came to Edwardsville. It was through his farsightedness, through his wisdom and through his aggressiveness that we probably have one of the most beautiful campuses, not only in Illinois, but in the country, a twenty-six hundred acre site, where for the first time in a metropolitan area, the second most populous area in the State of Illinois, people could afford to come to SIU Edwardsville to get their college education when they couldn't go anywhere else.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Buzbee moves the adoption of the resolution. All those in favor will please rise. The Resolution is adopted. No further business before the Senate, the Senate stands adjourned until the hour of noon tomorrow.
