PRESIDING OFFICER: (SENATOR DONNEWALD)

The hour of twelve having arrived, the Senate will come to order. Will the guests in our galleries please rise. Prayer by Reverend Eugene Weitzel, Director of Chaplains, St. John's Hospital, Springfield.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Reading of the Journal. Senator Johns.

SENATOR JOHNS:

Mr. President, I move that reading and approval of the Journals of Tuesday, April the 13th and Wednesday, April the 14th, in the year of 1982 be postponed pending arrival of the printed Journals.

PRESIDING OFFICER: (SENATOR DONNEWALD)

You've heard the motion. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. Motion carries. Committee reports.

ACTING SECRETARY: (MR. FERNANDES)

Pursuant to amended Rule 5, the Rules Committee met at 10 a.m. April 15, 1982 and makes the following report:

By unanimous vote the committee ruled that the following bills can be considered during this...this session of the Senate:

Senate Bills 1289, 1296, 1314, 1318, 1369, 1376, 1377, 1379, 1383, 1387, 1389, 1486, 1487, 1497, 1526, 1549, 1560, 1564, 1599, 1610, 1613, 1643 and 1681. The foregoing bills were ordered sent to the Committee on Assignment of Bills.

Senator Egan, the Chairman of the Committee on Executive reports Senate Joint Resolutions numbered 70, 74, 76, Senate Resolution 395 and 445, and House Joint Resolution No. 27 with the recommendation that the Senate adopt the resolutions. Senate Joint Resolution No. 47 with the recommendation that the Senate do not adopt the resolution.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Please add those to the Consent Calendar. Consent Calendar Resolutions. Is there any objection to the resolutions on the Consent Calendar by any of the members?

ACTING SECRETARY: (MR. FERNANDES)

No objections have been filed.

PRESIDING OFFICER: (SENATOR DONNEWALD)

In view of that...Senator Rock moves that we...the adoption of the Consent Calendar Resolutions set forth and Senator Vadalabene seconds it. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. The...the resolutions are adopted. Senate Joint Resolution No. 82, Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the

Senate. Senate Joint Resolution 82 is the adjournment resolution. It calls for us to return to Springfield next Tuesday, April the 20th at the hour of noon. I would move for the suspension of the rules and the immediate consideration and adoption of Senate Joint Resolution 82.

SENATOR ROCK:

I have caused to be distributed the schedule, which I hope is not tentative, but the schedule for May and June so that all members can at least start planning their calendars. I would especially point out the deadline dates so that those who have bills in committee, I hope you will make the proper arrangements with the committee chairman and the committee clerk to have the bills posted and heard, because that first deadline is rapidly approaching, on May the 7th. That is the final day for our committees to report Senate bills except for appropriation bills. So I'd just call that to your attention. If anybody has any questions on the schedule, Senator Philip and I have gone over it and we do not yet know what the House is about, but we're going to try to stick pretty close to this.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Senator Johns, for what purpose do you arise?

SENATOR JOHNS:

I'd just like to have leave to be listed as a sponsor

along with the main sponsors of Senate Joint Resolution 70, Senate Resolution 445, Senate Resolution 395.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Is there leave? Leave is granted. Resolutions.

ACTING SECRETARY: (MR. FERNANDES)

Senate Resolution No. 465 offered by Senator Newhouse and it's a death resolution.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Consent Calendar. Senator DeAngelis.

SENATOR DeANGELIS:

I would like to discharge the Committee of Labor and Commerce from further consideration of Senate Bill 664.

PRESIDING OFFICER: (SENATOR DONNEWALD)

Is there...

SENATOR DeANGELIS:

For the purpose of Tabling it.

PRESIDING OFFICER: (SENATOR DONNEWALD)

...oh, that's better. Is there leave? Leave is granted. Senator DeAngelis now moves that Senate Bill...Senate Bill 664 be Tabled. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. Senate Bill 664 is now Tabled. (Machine cut-off)...further business to come before the Senate? Senator Rock.

SENATOR ROCK:
