SENATOR NEDZA:

Yes, thank you, Mr. President...if...or a motion to discharge Senate Bill 1510 from the...from the Committee on Finance and Credit Regulations from further considerations, and re-refer it back to the Committee on Local Government. I have talked to the Chairman of the Finance Committee and his counterpart on the other side of the aisle, and there is no problem there. I am the sponsor of the bill and I have no difficulty with it.

PRESIDING OFFICER: (SENATOR BRUCE)
