PRESIDING OFFICER: (SENATOR BRUCE)

The hour of eleven-thirty having arrived, the Senate will come to order. Prayer by Reverend George Matranga of Our Savior's Lutheran Church of Springfield, Illinois. And will our guests in the galleries please rise.

REVEREND GEORGE MATRANGA:

(Prayer given Reverend Matranga)

PRESIDING OFFICER: (SENATOR BRUCE)

(Machine cutoff)...of the Journal. Senator Hall.

SENATOR HALL:

Mr. President, I move that reading and approval of the Journals of Tuesday, April 27th and Wednesday, April 28th, in the year of 1982 be postponed pending arrival of the printed Journals.

PRESIDING OFFICER: (SENATOR BRUCE)

Heard the motion. Discussion? All in favor say Aye. Opposed Nay. The Ayes have it and the motion prevails. Committee reports.

ACTING SECRETARY: (MR. FERNANDES)

Senator Egan, the Chairman of the Committee on Executive, reports Senate Bills numbered 1371, 1438, 1470, 1479, 1480, 1530, 1549, 1591, 1592, 1593, 1594, 1609, 1650, 1663 and 1668 with the recommendation the bills Do Pass. Senate Bills number 1566 and 1658 with the recommendation the bills Do Pass.

Senator Nedza, Chairman of the Committee on Local Government, reports Senate Bills number...1368, 1510 and 1599 with the recommendation the bills Do Pass. Senate Bill number 1379, 1384 and 1630 with the recommendation the bills Do Pass as Amended.

Senator Nash, the Chairman of the Committee on Public Health, Welfare and Corrections, reports Senate Bills number 1288, 1522, 1523 and 1654 with the recommendation the bills Do Pass. Senate Bill number 1500, 1564, 1571, 1614 and 1672

with the recommendation the bills Do Pass as Amended.

PRESIDING OFFICER: (SENATOR BRUCE)

For what purpose does Senator Hall arise?

SENATOR HALL:

For the purpose of announcement.

PRESIDING OFFICER: (SENATOR BRUCE)

Make your announcement.

SENATOR HALL:

I...I...I would like to say that Senator Newhouse is absent because of illness in his family and Senator Johns is absent because of illness.

PRESIDING OFFICER: (SENATOR BRUCE)

The Journal will so reflect. All right...we're not on announcements. We've got some business and then we'll get back to announcements. Leave to go to the Order of Resolutions for the adjournment resolution? Leave is granted.

ACTING SECRETARY: (MR. FERNANDES)

Senate Joint Resolution No. 87, offered by Senator Savickas.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Savickas.

ACTING SECRETARY: (MR. FERNANDES)

(Secretary reads SJR 87)

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Savickas.

SENATOR SAVICKAS:

I move the adoption of the adjournment resolution.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to suspend the rules for the immediate consideration and adoption of the adjournment resolution. On

the motion to suspend, all in favor say Aye. Opposed Nay.
On a motion to adopt, all in favor say Aye. Opposed Nay.
The Ayes have it. The resolution is adopted. Resolutions.
ACTING SECRETARY: (MR. FERNANDES)

Senate Resolution No. 494, offered by Senator Rock and
all members...congratulatory.

Senate Resolution 495, offered by Senator Jerome Joyce.
It's congratulatory.

Senate Resolution 496, offered by Senator Hall, Rock and
all members and it's congratulatory.

Senate Resolution 497, offered by Senator Dawson. And
it's congratulatory.

PRESIDING OFFICER: (SENATOR BRUCE)

The last four resolutions just read, they are congratulatory. Is there leave to place then on the Resolution Consent Calendar for consideration today? Is there leave? Leave is granted. Bills...those resolutions will go on the Resolution Consent Calendar. Is there leave to go...is there leave to go to the Resolution Consent Calendar? Leave is granted. Mr. Secretary, have any Senators filed objections to any of the resolutions on the Resolution Consent Calendar?
ACTING SECRETARY: (MR. FERNANDES)

No objections have been filed.

PRESIDING OFFICER: (SENATOR BRUCE)

No objections having been filed, Senator Buzbee moves the adoption of the Resolution Consent Calendar. Those in favor say Aye. Opposed Nay. The Ayes have it and the resolutions are adopted...we have one final order of business, Gentlemen, we will go to the resolution for the Cardinal, but before that we will take announcements. After that is...before the Body we will conduct no other business. Senator Davidson.

SENATOR DAVIDSON:

Mr. President and members of the Senate, I'd like to remind...those of you who received the invitations yesterday

on your desk in relation to the Governor's Prayer Breakfast. If you're going to participate, would you please fill out that card or contact me or my office by next Thursday, at the latest, so the seats we're holding in the down-front tables for you can be released for other individuals, 'cause we're at a sellout crowd and we need to know. PRESIDING OFFICER: (SENATOR BRUCE)

SENATOR BLOOM:

Yes, on a point of personal privilege.

PRESIDING OFFICER: (SENATOR BRUCE)

State your point.

SENATOR BLOOM:

Yes. Seated in the President's gallery...filling the entire gallery, is...some junior students from the Spaulding Academy in Peoria, and I wonder if they'd rise and be recognized by the Body. They're fine young men and women.

PRESIDING OFFICER: (SENATOR BRUCE)

Would our guests please rise and be recognized by the Senate. Senator Berning, do you have an announcement? We're just going to start and go this way. Senator Berning.

SENATOR BERNING:

Thank you...thank you, Mr. President. Let the record show that Senator Becker is absent due to illness.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Nimrod. The Journal will so reflect, Senator Berning. Senator Nimrod.

SENATOR NIMROD:

...Mr. President, I seek leave to be...shown as a co-sponsor on Senate Bill 1299.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave? Leave is granted. Senator Carroll.

SENATOR CARROLL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Just by way of an announcement, the Appropriations Committee which had met this morning had recessed to immediately following adjournment. The meeting will take place in 212 immediately following adjournment for Appropriations I. Thank you.

PRESIDING OFFICER: (SENATOR BRUCE)

If we can clear the aisles, if all the staff would please remove yourself from the Senate seating and go to the back of the Chamber, at least, so we can have...if each Senator would please take his seat, Senator Savickas has a resolution we will read.
