Senator Egan, I...did I hear you say that this is a Floor amendment, first of all? And then secondly, do we have copies of it, because it does affect the Personnel Code in addition to the Pension Code, right?

### SENATOR DEANGELIS:

Thank you, Mr. President. Senator Rhoads, I requested this amendment be put on in committee. It is a technical amendment to, in fact, validate the bill and there is a copy

available.

Senator Rhoads.

SENATOR RHOADS:

Could you explain what the technical amendment is, Senator Egan, please.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Egan.

SENATOR EGAN:

Yes, we're exempting from the Personnel Code certain employees in the Board of Investments. We did not change the Personnel Code which is necessary. The bill itself was deficient insofar as it only exempted the people from the Investment Board bill and not the Personnel Code also. It is...this completes it and it's essentially the same as the bill itself.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rhoads.

SENATOR RHOADS:

All right. The amendment itself, Senator Egan, on page 3, line 27, the only new language appears to be your changing "employed by" to "and employees of". What's the difference in those two terms of art?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Egan.

SENATOR EGAN:

Well...it would read "all investment officers employed by" which would mean only investment officers. We include, in addition thereto, "employees".

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rhoads.

SENATOR RHOADS:

No, you didn't answer my question, Senator Egan. Look at page 3, line 27. You are striking the word memployed by and

you're putting in "and employees of". Now, first of all, I don't see any difference between those two terms. Secondly, is there anything in the...have you changed the title or the...enactment clause of the bill in any way?

#### SENATOR EGAN:

No. No, it...but Senator Rhoads, read it again.

The...the...the word "and" includes employees that are not now included. Employees are in addition to investment officers.

#### SENATOR RHOADS:

I got my answer right here. You're changing the title.

Now, Senator, I see no reason for this amendment.

You're...you're not changing the meaning of the...of the bill
in any way. This is simply a means of changing the title, and
I would like to know why you're changing the title.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Egan.

#### SENATOR EGAN:

No, I'm not changing the title. The only difference...the only change is the addition of the language "employed by". I am not being subversive or I'm not hiding anything, I...it is certainly not my intention to change the...the title, and I'm not changing the title, as I read it.

#### SENATOR PHILIP:

PRESIDENT:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. House Joint Resolution 27 calls for the Department of Transportation to study the feasibility of the tollway and Department of Transportation combining on the finishing of FAP 431. All it is is making that suggestion, I know of no opposition. I'll be happy to answer any questions.

Is there any discussion? If not, those in favor of the adoption of House Joint Resolution 27 will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are...49, the Mays are none, none Voting Present. House Joint Resolution 27 is adopted. House Joint Resolution 42, Senator Bloom. With leave of the Body, on page 11 on the Calendar, on the Order of Conference Committee Reports, there's a Conference Committee report been filed with respect to Senate Bill 791. Secretary indicates that copies have been distributed to all the members. On the question, Senator Lemke.

I move for the adoption of the first Conference Committee report on Senate Bill...791. I think now everybody had adequate time to read the Conference Committee Report and this report does exactly what I said the last time. Number one, it establishes the Senate lottery to determine the length of staggering of terms, creates representative committees in order to separate nominating activities from Senate seats, from nominating activities House seats, requirements as to our...the petitions for citizen initiatives according to the

Supreme Court guidelines recommended by the State Board of Elections. Also, returns the sections in regards to the language of the city being reimbursed by the county for certain election costs. I think it is a good amendment. I ask for its adoption.

#### PRESIDENT:

All right, Senator...Lemke has moved the adoption of the Conference Committee report on Senate Bill 791. Any discussion? Senator Bhoads. Any discussion? Senator...Senator Gitz.

### SENATOR GITZ:

I have one question of the spensor.

### SENATOR GITZ:

Senator Lenke, the only quest on I have in the Conference report is, why it is, and I have been unable to resolve this with the State Board of Elections that we are asking for more signatures to put a policy question in an advisory referendum than we are for a Constitutional Amendment. It seems to me that a Constitutional Amendment is by far more critical and important and long lasting than a advisory referendum. And therefore, it would seem to be that it would have more signatures required instead of the inverse.

# PRESIDENT:

Senator Lemke.

### SENATOR LEMKE:

Senator Gitz, in regards to t at explanation, I've talked to the State Board of Elections. They advise me that there...this is not a change in the existing law it's presently that.

### PRESIDENT:

Senator Gitz.

SENATOR GITZ:

Well, it may be the existing law. That's...they just simply said to me that that was a policy question that we...they didn't have strong feelings one way or the other. And this seems to me to be a logical time to ask a question about why we have it, even if we have it now.

#### PRESIDENT:

Senator Lemke.

### SENATOR LENKE:

Well, I...can only go by the existing law. I'm trying to come along with a...recommended bill by the State Board of Election, and if you want...to exchange...to change the existing law, Senator Gitz, I would suggest that you had put in a bill or find another bill to put it in. This bill has to be passed as emergency, and I didn't...I want to put in any...anything that was too controversial in the bill. And we took out a lot of things that were...could have be controversial. That will come up next time, there'll been some more bills coming through, and I suggest that you amend those.

#### PRESIDENT:

Further discussion? Senator Bhoads.

SENATOR RHOADS:

Thank you, Mr. President and members of the Senate. I rise in support of the adoption of the Conference Committee report as I did last week. I tried to read it very carefully on a number of occasions, and in trying to answer some of the questions that members had last week, I really don't see any hidden land mines in...in the bill. I think it's a good report and ought to be adopted. And I ask for a favorable vote.

### PRESIDENT:

Further discussion? If not, the question is, shall the Senate adopt the Conference Committee report on Senate Bill 791. Those in favor will vote Aye. Those opposed will vote

Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 40, the Nays are 10, 1 Voting Present. The Senate does adopt the Conference Committee report on Senate Bill 791 and the bill having received the required constitutional majority is declared passed. Senator Lemke, for what purpose do you arise?

### SENATOR LEMKE:

Mr. President, I pressed the wrong switch...I pressed the Present button. I would of voted Yes on my own bill. PRESIDENT:

The written record will so reflect. Senator Sangmeister, for what purpose do you arise?

### SENATOR SANGMEISTER:

Thank you, Mr. President and members of the Senate. I was under the misapprehension that committee bills did not need to be...gone through the Rules Committee and...take it from there, and I was wrong on that. So, I would like to at this time move that a committee bill in Judiciary II, the number being Senate Bill 1231, which is a vehicle we're using for some amendments to the Juvenile Code, that the Rules Committee be discharged and that the matter in the posting requirements be waived. And that that bill be heard tomorrow morning in Judiciary II. I've cleared that with Senator Bowers, who I'm sure talked to Senator Philip and I...I don't participate any problem on that.

### PRESIDENT:

All right, you've heard the motion as placed by Senator Sangmeister with respect to Senate Bill 1231, that Rules be discharged from further consideration thereof and that the posting notice be waived so that it can be heard tomorrow morning at nine o'clock in Judiciary II. Is leave granted? Leave is granted. It's so ordered. Further business to come before the Senate? Senator Jeremiah Joyce.

#### SENATOR JEREMIAH JOYCE:
