Amendment No. 1 offered by Senator DeAngelis.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator DeAngelis on...definition of rules. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Amendment No. 1 offered to Senate Bill 1593 contains two provisions that were inadvertently left out of the Secretary of State's merit system and they parallel what is in the State Personnel Code. It would allow the Merit Commission under the Secretary of State to have the authority to hear or conduct investigations of appeals or of layoffs of employees appointed under Jurisdiction B, and secondly, it would...allow any employee reinstated because he was improperly suspended, discharged or laid off to receive back pay with write-offs for any money earned during that period. These...these two provisions are technically in the Personnel

Code, they should have been in, I suspect, the Merit Code for the Secretary of State's Office. I know of no objection, I move the adoption of Amendment No. 1.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to adopt Amendment No. 1. Discussion? All in favor say Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Further amendments?

ACTING SECRETARY: (MR. FERNANDES)

PRESIDING OFFICER: (SENATOR BRUCE)

Senator DeAngelis is recognized.

SENATOR DeANGELIS:

Amendment No. 2 is a technical amendment. It changes the word "qualified."

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to adopt Amendment No. 2. Discussion of the motion? All in favor say Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Further amendments?

ACTING SECRETARY: (MR. FERNANDES)

PRESIDING OFFICER: (SENATOR BRUCE)

Are there amendments from the Floor?

ACTING SECRETARY: (MR. FERNANDES)

Amendment No. 1 offered by Senator Bloom.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Bloom is recognized.

SENATOR BLOOM:

Yes, thank you, Mr. President and fellow Senators. This amendment has been requested by the beauty culture industry. For the past several years the Auditor General has been writing up R and E for an inadequate fee structure, for not covering the cost of processing. Insofar as the beauty culture industry is concerned, this would cover the cost of processing. I'd answer any questions you may have, otherwise, I'd ask for its adoption.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to adopt Amendment No. 1. On...on the motion, is there discussion? All in favor say Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Further amendments?

ACTING SECRETARY: (MR. FERNANDES)

No further amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. 1670, Senator Schaffer. 1671, Senator Simms. 1681, Senator Philip. Well. (Machine cut-off)...purpose does Senator Etheredge arise?

SENATOR ETHEREDGE:

Mr. President, I rise on a point of personal privilege.

PRESIDING OFFICER: (SENATOR BRUCE)

State your point.

SENATOR ETHEREDGE:

Seated in the President's gallery, we have a group of political science students from Waubensee Valley High School. They are accompanied by a member of the faculty, Gary Shepard and by their sponsor, Mary Price. I would like for them to

stand and be recognized.

PRESIDING OFFICER: (SENATOR BRUCE)

Would our guests please stand and be recognized by the Senate. (Machine cut-off)...bills that are presently...Senate bills that are presently on the Order of 3rd Reading, the sponsors indicated they would like to recall to the Order of 2nd Reading for the purpose of an amendment. Senator Lemke, you have Senate Bill 1289, is that correct? Yeah, and Senator Maitland, you'll be the next one on 1663. Alright. Senator Lemke seeks leave of the Senate to return Senate Bill 1289 to the...to the Order of 2nd Reading for the purpose of an amendment. Is there leave? Leave is granted. The bill is on the Order of 2nd Reading. Are there amendments, Mr. Secretary, please?

ACTING SECRETARY: (MR. FERNANDES)

Amendment No. 3 offered by Senator Lemke and Dawson.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Lemke.

SENATOR LEMKE:

What this does, is...is takes...we thought it was in the original one, but this takes out the objectionable line about confiscating gambling devices in bingo parlors without a search warrant. This takes out that language. They have to have a search warrant to confiscate the gambling devices. I ask for its adoption.

PRESIDING OFFICER: (SENATOR BRUCE)

The motion is to adopt Amendment No. 3 to Senate Bill 1289. On the motion to adopt, is there discussion? All in favor say Aye. Opposed Nay. The Ayes have it. Amendment No. 3 is adopted. Further amendments?

ACTING SECRETARY: (MR. FERNANDES)

No further amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. Senate Bill 1663, Senator Maitland. Sena-

tor Maitland asks leave of the Senate to return Senate Bill 1663 to the Order of 2nd Reading for the purpose of an amendment. Is there leave? Leave is granted. Are there amendments, Mr. Secretary?

ACTING SECRETARY: (MR. FERNANDES)

Amendment No. 1 offered by Senator Maitland.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Maitland.

SENATOR MAITLAND:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. When the staff was critiquing the bill, they noticed a...a typo where there was reference to "purchaser" and that language should have said "lessee", and that's all the amendment does, simply deletes "purchaser" and inserts, thereof, "lessee." I would move for its adoption.

PRESIDING OFFICER: (SENATOR BRUCE)

The motion is to adopt Amendment No. 1. Discussion of the motion? All in favor say Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Further amendments?

ACTING SECRETARY: (MR. FERNANDES)

No further amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. Senator Hall and Senator Geo-Karis, and Senator Jeremiah Joyce. On Page 9 and 10 of our Calendar are three House bills that under our rules we cannot consider, and it would be...it would save us some printing time if we could recommit those bills to committee or at least Table the bills and so that we could clear up our Calendar. Alright, we'll just leave them on and have the taxpayers bear the expense of printing bills that we're not going to consider. Senator Rhoads, I don't suppose you want to Table 1902 either. Fine. Senator Schaffer, did you want to call 2211 while we're at that order of business? (Machine cut-off)...purpose does Senator Gitz arise?

SENATOR GITZ:

Mr. President, Senator Simms has indicated he wished to be the Senate sponsor of House Bill 1889, and I'd like leave of the Body for that to be so recorded.

PRESIDING OFFICER: (SENATOR BRUCE)

House Bill 1889. Senator Gitz asks leave of the Senate to show Senator Simms...Senator Simms as the Senate sponsor of House Bill 1889. Is there leave? Leave is granted. UPI is asking leave of the Body to have permission to shoot still photographs. Is there leave? Leave is granted. For what purpose does Senator Totten arise?

SENATOR TOTTEN:

Mr. President, apparently you're looking for something to do. I have...

PRESIDING OFFICER: (SENATOR BRUCE)

I'm talking to Senator Schaffer...

SENATOR TOTTEN:

...I know, but you do have...

PRESIDING OFFICER: (SENATOR BRUCE)

...he's got a couple of bills we'd like to talk about.

SENATOR TOTTEN:

...I do have a motion filed that I would like to take up.

PRESIDING OFFICER: (SENATOR BRUCE)

When we get to the Order of Motions, I'll get back to you.

SENATOR TOTTEN:

Can we get to the Order of Motions?

PRESIDING OFFICER: (SENATOR BRUCE)

I don't think so today. We're pretty pressed for time.

(Machine cut-off)...Senator Degnan arise?

SENATOR DEGNAN:

I'd like to make a motion we go to the Order of Motions in Writing.

PRESIDING OFFICER: (SENATOR BRUCE)

We'll get back to you, just in a second. Is there leave to go to the Order of Secretary's Desk on the Order of Concurrences? We have two nonconcurrences we can get rid of today. Is there leave? Leave is granted. Is Senator Philip on the Floor?...he's indicated that he wished to nonconcur on Senate Bill 512. If you can talk, we've got one other one perhaps some...some other person can handle that nonconcurrency. Senator...on Page 13 of your Calendar is Senate Bill 1193. Senator Grotberg, do you have a motion in relation to that bill? (Machine cut-off)...Grotberg.

SENATOR GROTBORG:

Thank you, Mr. President. I move to nonconcur in House Amendments 3, 4 and 9 to Senate Bill 1193 and ask the House to recede.

PRESIDING OFFICER: (SENATOR BRUCE)

On Senate Bill 1193, Senator Grotberg has asked that the Senate nonconcur with House Amendments 3, 4 and 9. On the motion to nonconcur, is there discussion? All in favor say Aye. Opposed Nay. The Ayes have it. The motion prevails and the Secretary shall so inform the House. (Machine cut-off)...Senator Grotberg arise?

SENATOR GROTBORG:

On a point of personal privilege, Mr. President.

PRESIDING OFFICER: (SENATOR BRUCE)

State your point.

SENATOR GROTBORG:

In the President's gallery to my right in the top row, Mr. and Mrs. Roy Paeth, Rosemarie and Roy Paeth. Roy is the township supervisor of Winfield...Wayne Township in one of my new many townships in my district, and we're just honored that they're down here to find out how it really goes. And, of course, they reside in President...President-elect Philip's county, and I could spend the next half hour talking about these fine people.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright, why don't you just introduce them and...

SENATOR GROTEBERG:

...but as long as they're here, why don't you rise and be recognized. Rosemarie and Roy.

PRESIDING OFFICER: (SENATOR BRUCE)

...would our guests in the gallery please rise and be recognized by the Senate. (Machine cut-off)...what purpose does Senator Rock arise?

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Apparently, the House does not consider this matter of the same urgency that the Senate does, so I would move that we stand adjourned until ten o'clock tomorrow morning.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is that the Senate stands adjourned until 10:00 a.m. On the motion to adjourn, discussion? All in favor say Aye. Opposed Nay. The Ayes have it. The Senate stands adjourned until 10:00 a.m. tomorrow morning. Senator Davidson, you had an announcement.

SENATOR DAVIDSON:
