PRESIDENT:

Thank you, Reverend. Reading of the Journal. SECRETARY:

PRESIDENT:

Senato Johns.

SENATOR JURNS:

Thank you, Mr. President. I move that the Journals just read by the Secretary be approved unless some Senator has additions or corrections to offer.

PRESIDENT:

SENATOR JOHNS:

SENATOR JOHNS:

About this time there are funerals taking place in Marion, Illinois on behalf of the ten victims lost in the tornado. There are over two hundred injured, and I just hope that we could give a moment of silent prayer on behalf of those individuals that have died and those that are injured and in serious condition.

PRESIDENT:

That request is in order. Will the members please rise. Alright, will the members please be in their seats. I'm going to request that the doorkeepers keep the door locked during the course of the program. The Senate will please come to order for the 3rd Annual Memorial Day Program. The Chair will yield to Senator Sam Vadalabene who is the Chairman of the Senate Committee on Veteran's Affairs. Senator Vadalabene.

SENATOR VADALABENE:

Thank you, Mr. President. I will ask our Senators and guests to please rise while the colors are presented by the combined Armed Forces Color Guard from Camp Lincoln here in Springfield, Illinois. The Pleage of Allegiance will be led by Senator Jack Bowers, Senator Jim Donnewald and Senator Walter Nega.

SENATOR NIMBOD:

Thank you. Many of us have served or are serving in the military services of our country, and it's only fitting that we come together to pay this tribute. We gather together

from all walks of life as representatives of the people of our State, and we've been honored by them to provide direction and leadership. This is in admonition to us as legislators, and as was said to Moses when he was in his leadership, "Be the peoples' lawyer, their representative before God bringing Him their questions to decide. You will tell him...tell them His decisions in showing them the principles of Godly living." And that's in Exodus 18.19. Let us pray-

Please rise and join in singing together the patriotic song of our country, "God Bless America," led by Senator Nash and by Senator Rhoads.

SENATOR VADALABENE:

Be seated. Senator James Donnewald will introduce our honored guests. Senator Donnewald.

SENATOR DONNEWALD:

Yes, thank you very much, Mr. Presiding Officer, Senator Vadalabene. I take great pleasure at this time in introducing Major General John R. Phipps the Illinois Army National Guard Adjutant General of the State of Illinois. Also... just a moment...Colonel Richard M. Esslinger, Illinois National...Air National Guard, Commander of the 103rd Tactical Air Fighter Group, Springfield; Captain William "Bill" Forsythe liaison to General Phipps, the USN; Lieutenant Junior Grade Tim Beatty of the U.S. Navy and aide to

Admiral Flatley: Lieutenant Colonel Carl O. Johnson, Jr., Illinois Army National Guard Public Relations Officer; the Honorable Thomas Jones, Assistant Director of the Department of Veteran's Affairs. And at this time I have a... I take great pleasure in introducing Rear Admiral Flatley reported to the office...who will be our principle speaker. reported to the Office of Chief ... Naval Operations in August of 1978 where he served as an Executive Assistant and Senior Aide to the Vice Chief of Naval Operations until ordered to report and assume command of the USS Saratoga. Following fourteen months of training and battle group operations, he sailed on the USS Saratoga to the Philadelphia Naval Shipyard for induction into the twenty-eight month service life extension program for improving the battle readiness of our...of their ship by a greater margin than any other ship in the Atlantic fleet during the Fiscal Year of 1980. The crew of the USS Saratoga was awarded the coveted Admiral Arley Burk Award, and Rear Admiral Flatley was coincidentally honored by the Navy League of the United States with its John Paul Jones Award for inspirational leadership. One of the personal highlights of Rear Admiral Flatley's command tour was recording his one hundred...his fifteen hundred carrier arrested landing in an F-4 Phanton with his son, Midshipman James H. Flatley IV in the rear seat. The personal declarations of Rear Admiral Flatley include a Silver Star Medal, two Legion of Merits, three Distinguished Flying Crosses, a Bronze Star, Thirty-Year Medals, six Navy Commendation Medals, a Navy Unit Achievement Medal, the Presidential Commendation, the ... the Navy Unit Commendation and the Meritorious Unit Commendation. Rear Admiral Flatley is married to the former Mancy Monica Christi, they have three sons and three daughters. I guess it's at this time to present Rear Admiral Flatley.

REAR ADMIRAL PLATLEY:
