27. expiring January 20, 1986, Roy J. May of Waterloo. And to
28. be a member of the Advisory Board of Necropsy Services to
29. Coroners for a term expiring January 16, 1984, Norman T. Richter
30. of Springfield. And to be members of the Advisory Board of
31. Livestock Commissioners for a term expiring January 17, 1983...

32. PRESIDING OFFICER: (SENATOR BRUCE)

33. ...Have some order please. Senator Vadalabene.

1. SENATOR VADALABENE:

2. ...Wilmer Smith of Davis, John F. Rundquist of Butler,
3. Carman Y. Potter of Jacksonville, James H. Handy of Waverly,
4. Merlyn J. Eickman of Pecatonica and Harlan Bane of Riverside.
5. And Mr. President and members of the Senate, having read the
6. unsalaried appointments, I now seek leave to consider these
7. appointments on one roll call unless some Senator has objection
8. to a specific appointment.

9. PRESIDING OFFICER: (SENATOR BRUCE)

10. Senator Vadalabene is seeking leave to consider the

8. Ivan Pavkovic of Glenview. And Mr. President, having read
9. the salaried appointments, I now seek leave to consider these
10. appointments on one roll call, unless some Senator has objection
11. to a specific appointment.

12. PRESIDING OFFICER: (SENATOR BRUCE)

13. Senator Vadalabene is seeking leave to consider the
14. nominations just made on one roll call. Is there leave?
15. Is there leave? Leave is granted. Senator Vadalabene.

16. SENATOR VADALABENE:

17. Yes, thank you, Mr. President. Will you put the question
18. as required by our rules.

19. PRESIDING OFFICER: (SENATOR BRUCE)

20. The question is does the Senate advise and consent

25. Present. A majority of Senators elected concurring by

28. SENATOR VADALABENE:

29. Yes, thank you, Mr. President and members of the Senate.
30. I now move that the Senate arise from Executive Session.

31. PRESIDING OFFICER: (SENATOR BRUCE)

32. The motion is...the Senate...arise from Executive Session.
33. On the motion, all in favor say Aye. Opposed Nay. The Ayes

1. have it. Executive Session is dissolved. For what purpose
2. does Senator Demuzio arise?

3. SENATOR DEMUZIO:

4. Yes, thank you, Mr. President. Are we on announcements?

5. PRESIDING OFFICER: (SENATOR BRUCE)

6. Not yet, Senator, but...

7. SENATOR DEMUZIO:

8. Well, then you don't want me to announce that there's
9. ...there will not be a Finance Committee meeting this evening
10. until...till later on in the...in the Session?

11. PRESIDING OFFICER: (SENATOR BRUCE)

12. No, that would be fine. Make your announcements.

13. SENATOR DEMUZIO:

14. There will be no...no meeting this evening...of the
15. Senate Finance and Credit Regulations Committee. We can
16. get all the bills heard at the next meeting.

17. PRESIDING OFFICER: (SENATOR BRUCE)

18. All right. Senator McLendon.

19. SENATOR McLENDON:

20. Yes, Mr. President, I rise for the purpose of making an
21. announcement. Judiciary I will meet tomorrow morning at
22. 9:30 instead of 8:30 as scheduled. Thank you, very much.

23. PRESIDING OFFICER: (SENATOR BRUCE)

24. All right. Judiciary I at 9:30 rather than at 8:30
25. tomorrow morning. Further announcements? Senator Nash.

26. SENATOR NASH:

27. Mr. President, Ladies and Gentlemen of the Senate. I
28. ask leave, House Bill 1263 to show Nedza-Nash as hyphenated
29. cosponsors.

30. PRESIDING OFFICER: (SENATOR BRUCE)

31. Is there leave? Leave is granted. Senator Netsch,
32. for what purpose do you arise?

33. SENATOR NETSCH:

1. For purposes of an announcement. The Revenue Committee
2. will not meet tomorrow evening. Our scheduled meeting will
3. be cancelled and we'll conduct all of our business at the
4. meeting scheduled the following week. This was by unanimous
5. vote of the members with the chairman not present.
6. PRESIDING OFFICER: (SENATOR BRUCE)

7. All right. So we've cancelled Finance and Credit
8. Regs for tonight and Revenue is cancelled for tomorrow night,
9. Judiciary I is moved back from 8:30 to 9:30 in the morning.
10. Senator Sangmeister.
11. SENATOR SANGMEISTER:

12. Well, for what it's worth, Judiciary II is on at seven
13. o'clock tonight. There...if we...don't boo the best committee
14. in the Senate. All right. It is on and if we get there and
15. do our work maybe next week's meeting may not be necessary. So
16. let's have a full...let's at least have a quorum, huh.
17. PRESIDING OFFICER: (SENATOR BRUCE)

18. Judiciary II will meet tonight at 7:00 p. m. Is there
19. leave to go to the Order of House Bills...for what purpose
20. does Senator Egan arise?
21. SENATOR EGAN:

22. The Calendar indicates that there is an Executive meeting
23. at 1:30 on Thursday, June 4th, which is incorrect. I just would
24. like the record to reflect that. There is no meeting scheduled

32. PRESIDING OFFICER: (SENATOR BRUCE)

33. That was the...that was the schedule given the Secretary,

2. SENATOR EGAN:

3. Well, I'm not accusing anyone, but the fact is that there
4. is no such meeting.

5. PRESIDING OFFICER: (SENATOR BRUCE)

6. If there ever was a meeting, it's cancelled. Right?
7. All right. ...The meeting that was not going to occur is
8. not going to occur...tomorrow. For what purpose does Senator
9. Johns arise?

10. SENATOR JOHNS:

11. Everybody ought to enjoy one of those meetings. I'd
12. like to take this time to change the way the House Bill 868
13. is listed. I am now the chief sponsor with Senator Gitz as
14. a hyphenated cosponsor. I would like to have leave of this
15. Body to just reverse that and put Senator Gitz the first
16. leader item on the Calendar.

26. Thank you, Mr. President. The...the Appropriations I
27. Committee, which is scheduled for 1:30 will convene at 1:30

29. PRESIDING OFFICER: (SENATOR BRUCE)

30. All right. Appropriations I, 1:30, Room 212. Senator
31. Buzbee.

32. SENATOR BUZBEE:

33. Thank you, Mr. President. The Calendar does not reflect

2. II Committee will be meeting Friday morning at 8:30 a. m. We
3. have four meeting days left, we have eighty percent of a four-
4. teen billion dollar budget to hear yet. So, got our work cut

6. PRESIDING OFFICER: (SENATOR BRUCE)

9. Yes, I'm sort of confused when all these meetings are
10. going to be, however, I would like to take this time to rerefer
11. House Bill 386, which is presently in Judiciary I, to the
12. Committee on License and Insurance and suspend the Six Day
