PRESIDENT:

The Senate will please come to order. Will the members please be at their desks and will our guests in the gallery please rise. Prayer this morning by the Reverend Victor Kaltenbach, St. Patrick's Catholic Church, Springfield, Illinois, Father.

REVEREND KALTENBACH:

(Prayer given by Reverend Kaltenbach)

PRESIDENT:

Thank you, Father. Reading of the Journal. Senator Johns.

SENATOR JOHNS:

Mr. President, I move that reading and approval of the Journals of Thursday, May the 20th; Monday, May the 24th; Tuesday, May the 25th; Wednesday, May the 26th; Thursday, May the 27th; Tuesday, June the 1st; and Wednesday, June the 2nd in the year of 1982 be postponed pending arrival of the printed Journals.

PRESIDENT:

You've heard the motion as placed by Senator Johns. Any discussion? If not, all in favor signify by saying Aye. All opposed? The Ayes have it. The motion carries. It's so ordered. Committee reports.

SECRETARY:

Senator Carroll, Chairman of Appropriations I Committee, reports out the following House Bills: 2451 and 2452 with the recommendation Do Pass.

Senator Egan, Chairman of Executive Committee, reports out the following House Bills and Senate Resolutions: 1302 and 2503 with the recommendation Do Pass.

Senate Resolution 57 and Senate Joint Resolution 79 and 98 recommend adoption.

Pursuant to Amended Rule 5, the Rules Committee met at 10:00 a.m. June the 3rd, 1982 in Room 400 and makes the

PRESIDENT:

Resolutions.

SECRETARY:

Senate Resolution 566 offered by Senator Bruce. It's congratulatory.

Senate Resolution 567 offered by Senator Bloom. It's congratulatory.

Senate Resolution 568 offered by Senators Degnan and

Lenke and all Senators, and it's congratulatory.

Senate Joint Resolution 99 offered by Senator Lenke and it's commendatory.

PRESIDENT:

All right. Is there leave to add those four resolutions to the Resolutions Consent Calendar? That's 566, 567, 568, and Senate Joint Resolution 99. Leave is granted. Mr. Secretary, any objections been filed to the Resolutions Consent Calendar?

SECRETARY:

No objections have been filed, Mr. President.

PRESIDENT:

All right, Senator Donnewald moves the adoption of the Resolutions Consent Calendar, Senate Resolution 558, 559, 560, 561, 562, 563, 564, 565, 566, 567, 568; Senate Joint Resolution 99 and House Joint Resolution 90. Any discussion? If not, all in favor signify by saying Aye. All opposed? The Ayes have it. The resolutions are adopted. Introduction of bills.

SECRETARY:

Senate Bill 1689 offered by Senators Netsch and Rhoads.

(Secretary reads title of bill)

2nd...1st reading of the bill.

PRESIDENT:

Rules Committee. Secretary is in receipt of a letter from a member of the House pursuant to our rules. The House sponsor requests that House Bill 2541...that Senator Schaffer be the Senate sponsor of House Bill 2541. Senator Donnewald for what purpose do you arise?

SENATOR DONNEWALD:

Well, while we have a little time, I want to re-refer House Bills 2342 and 2278 from Judiciary I to Finance and Credit Regulations. Those bills were...they are identical bills to Senate bills that were in that committee earlier

this Session.

PRESIDENT:

Will you restate the motion.

SENATOR DONNEWALD:

Well, the motion would be to discharge Judiciary I from consideration of House Bills 2342 and 2278 and refer them to Finance and Credit Regulations. These bills were heard in the Senate as Senate Bills and they are identical, and it would go to the same committee.

PRESIDENT:

All right, you've heard the motion. Any discussion? Is leave granted? Leave is granted. It's so ordered. Senator Gitz, for what purpose do you arise?

SENATOR GITZ:

Mr. President and members of the Senate, I would wish to move to add Senator Vadalabene as a hyphenated sponsor to House Bill 1321. So the bill will read Gitz-Vadalabene.

PRESIDENT:

1321, is there leave to have Senator Vadalabene shown as a co-sponsor? Leave is granted.

SENATOR GITZ:

Wait a minute.

PRESIDENT:

Senator Gitz.

SENATOR GITZ:

And on House Bill 2356 to add Senator Sangmeister as a hyphenated co-sponsor.

PRESIDENT:

House Bill 2356, leave has been requested to add Senator Sangmeister as a co-sponsor. Is leave granted? Leave is granted. So ordered. Senator Sangmeister.

SENATOR SANGMEISTER:

Yes, I'd like to be relieved as the sponsor of House Bill 2195 and have Senator Coffey put in my place. 2195, House

Bill.

PRESIDENT:

2195, Senator Sangmeister seeks leave to afford Senator Coffey the opportunity to be the Senate sponsor. Is leave granted? Leave is granted. Senator Schaffer. If I can have your attention, if you'll turn to page 4 on the Calendar, on the Order of Secretary's Desk Concurrence is Senate Bill 1669. It is a supplemental appropriation, and apparently, it...we're going to conference. With leave of the Body we'll move to the Order of Secretary's Desk Concurrence for Senate Bill 1699 with House Amendments 1 and 2. 1669, Senator Schaffer.

SENATOR SCHAFFER:

Mr. President, I'd just like to move to nonconcur on those two amendments and get the process moving again.

PRESIDENT:

All right, Senator Schaffer has moved to nonconcur with House Amendments 1 and 2 to Senate Bill 1669. All in favor signify by saying Aye. All opposed. The Ayes have it. The motion carries and the Secretary shall so inform the House.

PRESIDING OFFICER: (SENATOR BRUCE)

For what purpose Senator Rock rise?

SENATOR ROCK:

Thank you, Mr. President. I would move that the Senate, pursuant to the adjournment resolution, stand adjourned until Monday, seventh day, at the hour of one o'clock. One o'clock on Monday.

PRESIDING OFFICER: (SENATOR BRUCE)

Any further business to come before the Senate? Announcements? Senator Gitz. For what purpose does Senator Philip arise?

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. A...a purpose of a...announcement.

PRESIDING OFFICER: (SENATOR BRUCE)

All right.

SENATOR PHILIP:

I am led to believe that we have the House-Senate annual ballgame next week and that everybody ought to bring down their shoes and equipment...and hopefully, for a change, we may reverse the trend. I heard that laugh. I heard that laugh again.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. Further announcements? Senator Gitz, at Senator Chew's desk.

SENATOR GITZ:

Yes, Mr. President, I have conferred with the Chairman of the Agriculture, Energy, Conservation Committee and Local Government Committee. Currently House Bill 1398 has been released from Rules, it was heard originally in Local Government. With the agreement of both chairmen, I would like to refer House Bill 1398 to the Agriculture, Energy, Conservation Committee, and further, I'd like to waive the posting requirement so it can be held...heard this coming week.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is that the bill be referred to the...House Bill 1398 be re-referred to the Committee on Agriculture and that the Six-Day Posting requirement be waived. Is there leave? Leave is granted. Senator Philip. Senator Philip, I'm advised that the posting requirements have already been waived. All right. Further...Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President. I'd like the record to show that Senator Becker is once again home convalescing because of an illness.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. Senator Nimrod.

SENATOR NIMROD:

Thank you, Mr. President. Just a further follow-up to our Minority Leader's comments about the baseball game. On Monday night, it's my understanding that we do have a game with the lobbyists. So it's important that everyone not only bring their equipment, but that they all come out because it is a game that night. That's Monday at about four...I think it's either four or four-thirty, we'll announce the exact time then. But there will be a game Monday, and there will be some...and probably another game on Tuesday with the staff, but we've had a chance to get out there and it is important we do this. This game has been going on since 1941, and you know, the...the funds have gone to a very...worthy cause and Coach Pete Miller said that several of you are missing and he wants to be sure that you're out there for Monday night. So, that's Monday night, baseball game, a game against the lobbyists, so all of us be sure to bring your equipment and be out there. Thank you.

PRESIDING OFFICER: (SENATOR BRUCE)

Any further business to come before the Senate? Senator Rock has moved that the Senate stand adjourned until Monday the 7th at the hour of one o'clock. On the motion, all in favor say Aye. Opposed Nay. The Ayes have it. The Senate stands adjourned 'til Monday at one.
