30. Senator Vadalabene on Amendment No. 1...or Senator Hall.
31. SENATOR HALL:
32. Thank you, Mr. President and Ladies and Gentlemen of the
33. Senate. Now, Amendment No. 1...it affects Senator Vadalabene's

1. district also and Senator Buzbee's. Now, what this does...  
2. the...it provides that each participant under the bistate  
3. metropolitan development district shall receive one-thirty-  
4. second of certain sales tax collected. Now, in February  
5. of this year Madison, St. Clair and Monroe Counties began  
6. collecting of a local match for State funds to support bistate  
7. development agents,...transits operation in those counties.  
8. Madison imposed a one-fourth tax, St. Clair, one-fourth tax  
9. and Monroe, one-eighth. However, the people of St. Clair  
10. County held an advisory referendum that would be conducted  
11. at the April election to determine if the county citizens  
12. wished to continue paying the tax. The people voted on April  
13. the 7th, as a result St. Clair County Board passed a resolution  
14. calling for abolishment of the tax. On April 28th the Mass  
15. Transit Board of St. Clair voted to eliminate the one-fourth  
16. tax effective June 30, 1981. So it was necessary prior to  
17. the establishing of the district the tax on metro east counties  
18. were the only areas in the State which did not provide local  
19. support for public transportation and I hope Senator Davidson  
20. is listening at that. This proposal, if enacted, would have  
21. each district, regardless of the amount of taxes collected,  
22. to receive one-thirty-second of the net review...realized.  
23. Since St. Clair County did not then they have opted out, but
