I'd urge its adoption.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator D*Arco has moved to suspend the rules for the immediate consideration and adoption of a congratulatory resolution. On the motion to suspend, all in favor say Aye. Opposed Nay. The Ayes have it. The rules are suspended. On the motion to adopt. Discussion? All in favor say Aye. Opposed Nay. The Ayes have it. Senate Resolution 581 is

adopted. (Machine cutoff)...Rock.
SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Before I place the motion to adjourn, we'll adjourn today until tomorrow morning at eleven o'clock. Senator Philip and I have discussed that the Session tomorrow morning will probably be relatively brief. There is one emergency appropriation that Senator Mahar has, and other than that, there probably won't be a lot done, but we will adjourn until eleven tomorrow. I wonder, with leave of the Body, if we could go to the Secretary's Desk Resolutions. There is a joint resolution that I would like to get over to the House. The House, I'm told, will adjourn today and not return until next Wednesday, and this joint resolution calls for the creation of a joint committee to compose and promulgate the argument with respect to the November ballot submission of the bail reform amendment. It calls for a June 23rd reporting date, so the quicker we can get it over there and get it accomplished we can set the committee up and we should have it done by the 23rd, but because of that shortness of the reporting date, I would like to move to that order with leave of the Body.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave to go to the Order of Resolutions? Leave is granted. Senate Joint Resolution...Senate Joint Resolution 98. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. Senate Joint Resolution 98 calls for the creation of a joint committee consisting of eight legislative members, two each appointed by each of the four leaders. The Joint Committee for the Bail Reform Amendment, they are to compose an argument in favor of and an argument against in the form in which the amendment will appear on the ballot. And they are to report back for

approval by both Houses of the Assembly by June 23rd. I know of no objection. I would move the adoption of Senate Joint Resolution 98.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock has moved the adoption of Senate Joint Resolution 98. All right, because that will require the expenditure of money...a roll call will be required. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 57, the Nays are none, none Voting Present. The Senate does adopt Senate Joint Resolution 98. Senator Johns, for what purpose do you arise?

SENATOR JOHNS:

Yes, I'd like to speak on behalf of Senator Mahar's bill, 1391, which will come up tomorrow, and I would urge my colleagues on the Floor to give serious consideration to voting for this. It's to aid the tornado victims in Marion, Illinois. It's to aid the...Department of Emergency Services. And the amendment is exactly what I started to put on here, and because of our inability to get to it over here, the House has got to it, and I see no need to duplicate it, and so therefore, I urge my colleagues on this side to support this amendment tomorrow on Senator Mahar's Bill 1391.

PRESIDING OFFICER: (SENATOR BRUCE)

BRESIDING OFFICER: (SENATOR DROC

All right. Senator Netsch.

SENATOR NETSCH:

Thank you. Just an announcement, Mr. President. The Revenue Committee will meet at two o'clock sharp. We have one colleague with...who has a bill who has a...an early commitment and must be heard promptly at two o'clock. So, if you will please be there on time, we can dispose of our business expeditiously.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Demuzio.

SENATOR DEMUZIO:

Well, I'm...I'm...I have an announcement. I'm sure that Senator Netsch's committee members are delighted they should bring their blankets and everything the way the length of that committee has been functioning. Finance and Credit Regulations will meet at two o'clock sharp, and we have about three bills and shouldn't be more than fifteen minutes in room 400.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Collins.

SENATOR COLLINS:

Yes, purpose of an announcement. The Labor and Commerce... Committee scheduled for 9:00 a.m. tomorrow will meet today following the Insurance Committee meeting right here on the Floor. I've...we only have one bill, and due to the fact that several members on that committee wishes to have some other engagements for tomorrow morning, we will have that meeting following...after the Session and after the License and Insurance Committee.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Jerome Joyce.

SENATOR JEROME JOYCE:

Yes, announcement that the Ag, Conservation and Energy Committee will meet tomorrow morning at nine. It's not on your Calendar but we'll consider two bills, 1882 and 2496.

PRESIDING OFFICER: (SENATOR BRUCE)

RESIDING OFFICER: (SENATOR DR

Senator D'Arco.

SENATOR D'ARCO:

Yeah, Insurance and Licensed Activities Committee will meet immediately upon adjournment on the Senate Floor. We have one bill that we have to consider so we can expedite it and...and right away.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Lemke.

SENATOR LENKE:

Just to ask leave of the Body to be excused tomorrow, I have some personal matters to take care of in Chicago, and if I was present, I would vote for the emergency victims down in...tornado victims in Southern Illinois. But I have to do some personal matters tomorrow and I'd...would like to be excused.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rupp, for what purpose do you arise? SENATOR RUPP:

Mr. President, I...would rise in order to question the propriety of a...of another Insurance Committee meeting. The bill that is to be considered today, already was considered yesterday, was put in a committee, and if we're going to permit additional meetings to be called right at the drop of the hat to reconsider items, I think I...and I asked the Chairman if he would also reconsider a couple who were...which were passed, and I was told, no. I don't think that we should have a special meeting to consider an item that has already been considered and put in committee. I ask for a ruling of the Chair if it's possible to do that, to call a meeting without proper notice to reconsider something that's already been handled.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator D'Arco.

SENATOR D'ARCO:

Mr. President, the Six Day Notice Rule has...has already been waived and...and the reason that we want to reconsider this bill is because there was not afforded the proponents or...opponents of the bill an opportunity to present their testimony yesterday, and both sides wish to do that and the bill was put on the interim study Calendar and we wish them a opportunity to either wote the bill up or down on its merits.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rupp.

SENATOR RUPP:

A question, Mr. President.

PRESIDING OFFICER: (SENATOR BRUCE)

Yes, Senator.

SENATOR RUPP:

The waiver of the Six Day Rule was just for posting, I believe, not for calling a meeting, is that correct? Was for the posting and the notice of bills, rather than the calling of a meeting.

PRESIDING OFFICER: (SENATOR BRUCE)

Well, we don't have a...a notice of calling, we only have a notice of posting and we waived that. I'm...I've been advised by the Secretary of the Senate that the bill has not been reported to him on any committee report, so it is within the domain of the committee and could be considered. Had it been either accepted or rejected by the committee, there might be a different ruling but, as I understand it, it has not been reported out of committee. Senator Rupp.

SENATOR RUPP:

I'm not questioning the content of the bill or whether it's right or wrong. If we're going to start this procedure though, I can see that we will be here quite awhile, because there should have been someone else who could call back a bill right now, one bill that I didn't get through, am I going to be accorded the same privilege?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator D'Arco.

SENATOR D'ARCO:

Well, the fact of the matter is that the bill was...never reported out of committee on a Do Pass or a Do Not Pass motion. So there is no...in the committee report of the Senate Insurance Committee, that particular bill is not on

that report, and it is still in the committee and within the purview of our committee, and we can act on that bill at anytime, as long as it's within the purview of our committee.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the House. I would suggest the proper motion would be motion to discharge. When this side of the aisle gets a bill beat in committee, we have to file a motion with the Secretary to discharge, that's what the proper motion is. That committee was adjourned yesterday. It would seem to me you'd have to suspend the appropriate rule to consider anything in that committee, and we certainly violently object to his motion. PRESIDING OFFICER: (SENATOR BRUCE)

Just so the...the Body is aware, there is no motion before us. Senator D'Arco, as Chairman of the committee, has called a meeting of his committee and made an announcement to that effect, over which there is some objection, but as Chairman, he may call the meeting, and whatever happens in that committee it has...Senator Philip as to your question about the motion to discharge, that would be appropriate had they acted on it and reported it or had failed to act on it, but...I think the...the crux of the issue is that the Chairman, in fact, does plan to act on it. Senator Philip.

Mr. President, I...I have been led to believe they adjourned yesterday. Now there is no other meeting posted. It would seem to me he'd have to make a motion to Rule 7 and suspend the...the appropriate rule to hear this...today, and he hasn't done that. All he has said, I'm going to have a meeting.

PRESIDING OFFICER: (SENATOR BRUCE)

Well, committees don't adjourn sine die I mean, they're

alive to consider whatever is before them. Okay, any further business to come before the Senate? Senator Rock moves that the Senate...stand adjourned until eleven...Senator Philip...Senator Vadalabene.

SENATOR VADALABENE:

Yeah, I...I have a suggested address for Flag Day for June 14th at my desk, compliments of Senator Robert Mitchler, and the first ones that come and get one.

PRESIDING OFFICER: (SENATOR BRUCE)

(Machine cutoff)...Vadalabene, that's just the touch we needed to adjourn on. Senator Donnewald moves that the Senate stand adjourned until eleven o'clock tomorrow. On the motion to adjourn, all in favor say Aye. Opposed Nay. The Ayes have it. The Senate stands adjourned until eleven tomorrow.
