19. Mr. President, and Ladies and Gentlemen of the Senate. On
20. a point of personal privilege. I'm delighted to introduce to
21. this Assembly today, James and Lorine Kokoris from Lake Forest
22. Illinois, my constituents, and their guest Mrs. Denise Feeny,
23. from Flossmore, Connecticut. They're up in the upstairs gallery
24. over here. Can we greet our guests.

26. Would they please rise and be recognized. Senator Thomas,
27. for what purpose do you arise?

28. SENATOR THOMAS:

29. Thank you, Mr. President. Also on a point of personal
30. privilege. I would like to introduce to this Body, some folks
31. from back in my area, a police officer in Rock Island County,
32. and his family, they're from Moline, Mr. and Mrs. Roy Melton

20. make an announcement, and I thought that's what you were calling
21. me for. I'd like to go back just to...

25. Yes, well I want to hold the announcement, I wanted to move
26. the bill.

28. All right, on...is leave granted to go back to House Bill
29. 732? Leave...leave is granted. On the Order of...House Bills
30. 2nd reading, House Bill 732. Senator Bruce.

32. House Bill...House Bill 732.

33. (Secretary reads title of bill)

1. 2nd reading of the bill. No committee amendments.

10. PRESIDING OFFICER: (SENATOR SAVICKAS)

11. 3rd reading. Senator, before we recognize you for any
12. announcements, we do have with us the Premier Boy's State Officers,
13. and we would at this time, like to introduce them to you.

14. FORMER SENATOR MITCHLER:

15. Thank you, very much, Mr. President, and members of the
16. Senate. Premier Boy's State is a program of the American Legion.
17. It was organized in 1934 in the State of Illinois, and it's de-
18. signed to educate the youth, that is high school junior students;
19. it the practical learning of government at all levels. This past
20. week, over at Eastern Illinois University, in Charleston, the
21. American Legion has sponsored one thousand forty high school
22. junior students in this week long program of intensified govern-
23. ment study. Eight mythical counties are formed, and each of the
24. eight mythical counties are broken down into four mythical cities.
25. From this structure of government they elect all the way from
26. alderman up to the Governor of the State of Illinois. They have
27. two major political parties, the Federalists and the Nationalists,
28. and this is the practical experience that they get. Senator Demuzio
29. and Senator Bruce were over to Charleston and visited with the
30. Boy's Staters, we certainly appreciate that. And so, my task today,
31. Mr. President, and members of the Senate, is to introduce to you
32. the 1981 Premier Boy's State...State Officers. I'll start with
33. the members of the Supreme Court, in the Fourth District Dan Tingwall,

1. from Peoria, Illinois. Dan would you step forward, raise your
2. hand so they can see you...your Senator can see you. Mark Stevenson,
3. 3rd District Justice, Illinois Supreme Court from Rantoul, Illinois.
4. Scott Eisenhower, 2nd District Justice, Illinois Supreme Court from
5. Danville, Illinois. And from Washburn, Illinois, James Zook,
6. 1st District Justice, Illinois Supreme Court. From Pekin, Illinois,
7. Senator Sommer, the State Treasurer, Jeff Ales. And from Ashkum,
8. Illinois, the Attorney General, Todd Spencer. From Pana, Illinois,
9. the Comptroller, Bruce Louie. And McHenry, Illinois, the Secretary
10. of State, Curt Rayburn. From Shorewood, Illinois, the Lieutenant
11. Governor, Scott Ward. And from Waukegan, Illinois, the Governor
12. of Premier Boy's State for 1981, Oren Alston. And I'd like him
13. to say a few words.

14. OREN ALSTON:

15. (Remarks by Oren Alston)

16. FORMER SENATOR MITCHLER:

17. Now, the Governor of Boy's State will present to Senator Savickas
18. for the President of the Illinois State Senate, I think, Phil is
19. tied up right now, a tee shirt, and it will make President Rock
20. an honorary Governor of Premier Boy's State.

21. PRESIDING OFFICER: (SENATOR SAVICKAS)

22. On behalf of Senator Rock, who is a boy at heart, I accept
23. this tee shirt. Senator Geo-Karis.

24. SENATOR GEO-KARIS:

25. Mr. President, and Ladies and Gentlemen of the Senate. I
26. want all of you to note that Mr. Alston is my constituent from
27. Waukegan, Illinois, and I am very proud of him, and congratulate
28. him and the other Gentlemen there.

29. PRESIDING OFFICER: (SENATOR SAVICKAS)

30. Senator Bruce, for the purpose of announcement.

31. SENATOR BRUCE:

32. Thank you, Mr. President. I would call the attention of the
33. membership that the Pages have distributed within the last ten

1. minutes a document on the...which contains all the Agreed Bills
2. on the Agreed Bill List with a complete analysis. I hope that
3. you would take that home and have some exciting weekend reading.
4. On the Calendar, on...starting on page 6 is the Agreed Bill List,
5. in somewhat more brief form. We will, as in the past, we'll vote
6. on that in one group, we will plan to vote on that on Wednesday
7. of next week, and probably...we will probably ask that you have
8. your objections in by Wednesday, but the exact times we will
9. announce on Monday. But it will probably be around noon on
10. Wednesday. And we would ask that you have your objections in
11. before that time. If any Senator is joined by five others, a
12. total of six, they can remove any bill from the Agreed Bill List,
13. if you would file a form with the Secretary, we'll have those
14. taken off.

15. PRESIDING OFFICER: (SENATOR SAVICKAS)

16. Is there further discussion on this? Question, Senator
17. Weaver? Go ahead, you want to make your announcement.

18. SENATOR WEAVER:

19. I would just like the record to reflect that Senator DeAngelis
20. is absent today for personal reasons.

21. PRESIDING OFFICER: (SENATOR SAVICKAS)

22. The record will so indicate. Senator Bruce.

23. SENATOR BRUCE:

24. Have we moved the Resolution Consent Calendar yet?

25. PRESIDING OFFICER: (SENATOR SAVICKAS)

26. Yes...oh, have we...

27. SENATOR BRUCE:

28. If there aren't any objections, I would move the adoption
29. of the Resolution Consent Calendar, and get that done.

30. PRESIDING OFFICER: (SENATOR SAVICKAS)

31. Yes, Senator and fellow Senators, we have added two resolutions
32. to the Senate Consent Calendar, they are 233 and 234, and this was
33. done with leave of the Body. I just want to announce that. On
