Mr. President and members of the Senate, for the members on this side, and I guess for everyone's general edification, it's obvious the House put, in most cases, put considerable amount of money back in each of these budgets, funded the personnel items beyond the point that the Senate sent to It's obvious that...that we are working towards a them. comprehensive settlement on things like percentage increase, et cetera, and to expedite the movement of paper through the system, we are going to have to put all these bills into a position where we can put together a Conference Committee, and it was the thought that fifteen, twenty minutes work here tonight will allow the staff to get that paper work going, speed up the whole general situation. The question that...that we were a little concerned about was a couple of bills were excluded for a reason...basically, they're the bills that relate to the pension funding level, and perhaps that's a issue of, shall we say, controversy that perhaps should be left when more of these chairs are filled or a consensus is worked out.
