PRESIDING OFFICER: (SENATOR BRUCE)

The hour of ten having arrived, the Senate will come to order. Prayer today by Reverend Victor Kaltenbach of St. Patrick's Catholic Church of Springfield, Illinois, and will our guests in the galleries please rise.

REVEREND VICTOR KALTENBACH:

(Prayer given by Reverend Kaltenbach)

PRESIDING OFFICER: (SENATOR BRUCE)

Reading of the Journal. Senator Demuzio.

SENATOR DEMUZIO:

Mr. President, I move the reading and approval of the Journals of Wednesday, November the 17th; Thursday, November the 18th, in the year 1982 be postponed pending the arrival of the printed Journals.

PRESIDING OFFICER: (SENATOR BRUCE)

You've heard the motion. Discussion? All in favor say Aye. Opposed Nay. The Ayes have it. The motion prevails. Messages from the House.

SECRETARY:

A Message from the House by Mr. Leone, Clerk.

Mr. President - I am directed to inform the Senate the House of Representatives has adopted the following joint resolutions, in the adoption of which I am instructed to ask concurrence of the Senate, to-wit:

House Joint Resolutions 114 through 123.

PRESIDING OFFICER: (SENATOR BRUCE)

Resolutions Consent Calendar. If I might have the attention of the Body, in today's Calendar, there were a series of bills that were left off. We are going to distribute to your desks a Supplemental No. 1 Calendar. No motions have been filed in regard to any of these bills, but we want to make sure we have a correct Calendar. So, the supplemental is being passed out but no motions are presently filed...for any of those bills. Resolutions.

SECRETARY:

Senate Resolution 681, offered by Senator Berning, it's congratulatory.

Senate Resolution 682, offered by Senator Berning and it's a death resolution.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave to place those resolutions on the Resolution Consent Calendar? Leave is granted. Is there leave to go to the Order of Resolutions? Resolutions.

SECRETARY:

Senate Joint Resolution 113, offered by Senator Donnewald.

(Secretary reads SJR 113)

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Donnewald, on the...on the adjournment resolution. Senator Donnewald moves for the suspension of the rules for the immediate consideration and adoption. On the motion to suspend, all in favor say Aye. Opposed Nay. On the motion to adopt. Discussion? All in favor say Aye. Opposed Nay. The Ayes have it. The resolution is adopted. That would bring us back at twelve o'clock noon on December the 1st. We have not adjourned. We have just adopted the adjournment resolution. Senator Netsch.

SENATOR NETSCH:

Thank you, Mr. President. If I might, I have an announcement to make. There will be a formal notice going out but the Revenue Committee will be meeting on the Wednesday that we return of that week at three o'clock, because there are at least two bills that we believe relate to our subject matter that have emerged from the House that we will...would like to have some testimony on. One is the multiplier bill and the other is the unitary bill. So, if any of you know of witnesses who would like to be heard on the Governor's proposed amendatory vetoes of those two bills,

we will be convening at approximately three o'clock or immediately following adjournment on the Wednesday that we return.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock. Senator Rock...is recognized.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. We are currently passing out or causing to be passed out, the schedule for the week of the 29th of November. We will again return to Session on noon on Wednesday, December 1st. The day and a half preceding that, of course, I'm sure everyone is aware of the New Members Conference to be held here in Springfield. Then, we will hopefully adjourn December 3rd. Today, of course, we have little remaining. We are constrained, however, under the Constitution to hold the Session open to receive whatever Messages the House deems fit to send us. So, I would suggest that we stand in recess until the hour of twelve-thirty, by which time...I have just spoken with the House and they are not yet operational. But, hopefully, they will shortly be operational and we can...we can all get finished.

PRESIDING OFFICER: (SENATOR BRUCE)

For what purpose does Senator Vadalabene arise?

SENATOR VADALABENE:

Yes, in the purpose of an announcement to alert the members on the Democratic side of the aisle whose names I call that their awards are in my office. The Amvets Awards to Senator Berman, Bruce, Collins, Chew, Degnan, Donnewald, Egan, Jeremiah Joyce, Nega, McLendon, and Taylor; and the American Legion Awards to Carroll, Donnewald, D'Arco, Gitz, Nedza, Nega, and Newhouse. Mr. Secretary, have any Senators filed objections to any of the resolutions on the Resolution Consent Calendar that was printed or the ones that we've added today, both in the resolutions from the Senate and the House joint resolutions?
