#### SENATOR JOHNS:

Mr. President, there will be a Democratic caucus in Room 212 immediately.

PRESIDING OFFICER: (SENATOR BRUCE)

Upon adjournment there will be a Democratic caucus. Further announcements? Senator Philip.

### SENATOR PHILIP:

Thank you, Mr. President. The Republicans will caucus at nine o'clock in the morning in my office.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock, for what purpose do you arise?

#### SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. As you know, the Senate Revenue Committee and the Committee on Reorganization of Government are scheduled to meet this afternoon and they will, in fact, meet this afternoon at three o'clock. So, given the fact that it is of absolute necessity that we have a caucus to discuss the Governor's proposals, among other things, I would suggest that and will now move that the Senate stand adjourned until ten o'clock tomorrow morning.

#### SENATOR SCHAFFER:

## PRESIDING OFFICER: (SENATOR BRUCE)

All right...the...the bill has to be read a first time...let\*s. The Secretary will read the motion.

#### SECRETARY:

I move to suspend Senate Rule 5 and all other appropriate rules in order that House Bill 2517 may be discharged from the Senate Rules Committee and referred to...to the Senate Committee on Reorganization of State Government. Signed, Senator Schaffer.

## PRESIDING OFFICER: (SENATOR BRUCE)

All right. Senator Netsch, we'll get to your announcement in just a moment. The motion by Senator Schaffer is to discharge House Bill 2517 from the Committee on Rules and have the bill referred to the Committee on Reorganization. Is there discussion of the motion? All in favor say Aye. Opposed Nay. The Ayes have it. The bill is discharged and...and referred and now the Secretary will read the bill a first time.

## SECRETARY:

House Bill 2517 sponsored by Senator Schaffer...Senator Schaffer is the Senate sponsor.

(Secretary reads title of bill)
1st reading of the bill.

## PRESIDING OFFICER: (SENATOR BRUCE)

The bill will be referred to the Committee on Reorganization. Senator Gitz, you have an announcement concerning the meeting of your committee? Senator Gitz is recognized.

### SENATOR GITZ:

At Senator Netsch's request, she will be using Room 212 and the Reorganization Committee will be meeting in Room 400. PRESIDING OFFICER: (SENATOR BRUCE)

Room 400, at three o'clock. May we have some order please. For what purpose does Senator Rock arise?

SENATOR BOCK:

I would like to recognize the fact that Senator Netsch has...reached her philosophical home at Senator Totten's desk.

PRESIDING OFFICER: (SENATOR BRUCE)

I believe, Senator, that's a...a new enterprise zone and Senator Netsch is setting up shop there. Senator Netsch at Senator Totten's desk.

## SENATOR NETSCH:

My only response, Senator Rock, is, that will be the day. Revenue will meet at three o'clock or shortly thereafter as we are out of caucus in Room 212. We will begin with the witnesses on the multiplier bill and will hope to conclude them in two hours or less and will then take up the unitary bill.
