Thank you, ar. President and Ladies and Gentlemen of the Senate. If I can have the attention of the members, two purposes. One, I would like the record to reflect that Senators Nedza and D'Arco were absent on February 8th and today, February 9th, due to illness. Secondly, the Governor is now awaiting the presence of the Republican members in Senator Philip's office. The only remaining bit of work for us is
