PRESIDENT:

The Senate will please come to order. Will the members be at their desks, and will our guests in the gallery please rise. Our prayer this morning by the Father Eugene Weitzel who is the Director of Chaplains at St. John's Hospital, Springfield, Illinois. Father.

PATHER BUGENE WEITZEL:

(Prayer given by Father Weitzel)

PRESIDENT:

Thank you, Father. Reading of the Journal. Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. I move that reading and approval of the Journal of Wednesday, February 23rd, in the year of 1983, be postponed pending arrival of the printed Journal.

PRESIDENT:

You've heard the motion as placed by Senator Vadalabene.

Any discussion? If not, all in favor signify by saying Aye.

All opposed. The Ayes have it. The motion carries. It's so ordered. Senator D'Arco, for what purpose do you arise?

SENATOR D'ARCO:

Point of personal privilege, Mr. President.

PRESIDENT:

State your point, sir.

SENATOR D'ARCO:

Mr. President, every year the University of Illinois College of Engineering and the Governor and the Department of Commerce sponsor a state-wide competition for high school students to research and report on the economic preparedness of their communities. It is my privilege to announce, Mr. President, that the two first place winning teams were Saint Bede Academy, in the small high school category, and in the large high school category, we have them in the gallery with

us today, Crane High School from Chicago. And I would wish that the Senate would acknowledge the fact that they won this competition in the high school category. Crane High School from Chicago.

PRESIDENT:

Will our guests please stand and be recognized.

SENATOR D'ARCO:

Oh, wait. Mr. President, we also have Saint Bede...
PRESIDENT:

Yes, Senator D'Arco.

PRESIDENT:

Senator Netsch, for what purpose do you arise?
SENATOR NETSCH:

Thank you, if it's appropriate, one small housekeeping matter. May I proceed?

PRESIDENT:

Yes.

SENATOR NETSCH:

Senate Bill 93 is shown on our official records and in the Digest as having been introduced by Senator Watson. He disclaims any responsibility for it. It is, in fact, my bill and that should be changed to my sponsorship. Senate Bill 93.

PRESIDENT:

The record will reflect Senate Bill 93...chief sponsor Senator Netsch. Senator Vadalabene, are you prepared to move ahead? Committee reports.

SECRETARY:

Senator Vadalabene, chairman of the Committee on Executive Appointments, Veterans Affairs and Administration to which was referred the Governor's Message of February the 9th, 1983, reports the same back with the recommendation that

the Senate advise and consent to the following appointments.

PRESIDENT:

Senator Vadalabene.

SENATOR VADALABENE:

Yes, Mr. President and members of the Senate, before I move that the Senate resolve itself into Executive Order, I would like to make this announcement. We...

Could we have some order, please.

PRESIDENT:

Alright: That request is in order. Is leave granted?

Senator Vadalabene.

SENATOR VADALABENE:

Alright. Thank you, Mr. President and members of the Senate. I move that the Senate resolve itself into Executive Session for the purpose of acting on the Governor's appointments set forth in the Governor's Message of February 9th, 1983.

PRESIDENT:

SENATOR VADALABENE:

PRESIDENT:

The question is, does the Senate advise and consent to the nominations just made. Those in favor will wote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 44, the Nays are none, none voting Present. A majority of the Senators elected concurring by record vote, the Senate does advise and consent to the nominations just made. Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President. PRESIDENT:

Is there objection? If not, leave is granted. Senator Vadalabene.

SENATOR VADALABENE:

Mr. President, will you put the question as required by our rules.

PRESIDENT:

The question is, does the Senate advise and consent to the nominations just made. Those in favor will vote Aye.

Those opposed will vote Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 45, the Nays are none, none voting Present. A majority of the Senators elected concurring by record vote, the Senate does advise and consent to the nominations just made. Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President. I now move that the Senate arise from Executive Session.

PRESIDENT:

You've heard the motion to arise. All in favor signify by saying Aye. All opposed. The Ayes have it. The Senate does now arise. Senator Maitland, for what purpose do you arise?

SENATOR MAITLAND:

Thank you, Mr. President, to ask leave of the Body to have Senator Kustra shown as a hyphenated co-sponsor of Senate Bill 9.

PRESIDENT:

You've heard the request, Senator Kustra to be shown as a hyphenated co-sponsor of Senate Bill 9. Without objection, all in favor say Aye. All opposed. The Ayes have it. So ordered. Besolutions.

SECRETARY:

Senate Resolution No. 30 offered by Senators Rupp and all Senators, and it's congratulatory.

PRESIDENT:

Consent Calendar. The Consent Calendar has been distributed, if you'll just add that number. It is Senate Resolution No. 30.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave to go to the Order of Resolutions? Resolutions.

SECRETARY:

Senate Joint Resolution No. 5 offered by Senator Rock.

(Secretary reads SJR No. 5)

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is the adjournment resolution. At the close of business today, which I hope will be very shortly, we have a motion to discharge, introduction of bills and the adoption of the Consent Calendar and then we are effectively finished with our business, it calls for us to return to Springfield next Tuesday at the hour of noon. On Wednesday at one o'clock then, the...Governor will deliver his Budget Address to a joint Session. But we will come back to Springfield, as will the House, Tuesday at noon. So, Mr. President, I would move for the suspension of the rules and the immediate consideration and adoption of Senate Joint Resolution No. 5.

PRESIDING OFFICER: (SENATOR BRUCE)

You've heard the motion. The motion is to suspend the rules. On the motion, all in favor say Aye. Opposed Nay. On the motion to adopt, all in favor say Aye. Opposed Nay. The Ayes have it. The resolution is adopted. Senator Netsch, for what purpose do you rise?

SENATOR NETSCH:

Thank you, Mr. President. This is a piece of business that is known to both sides of the aisle. A House Joint Resolution 12 which has already passed the House is intended to create a joint study committee with a reporting date of May 1st, to attempt to work out some of the questions and problems of implementation of a bill that we passed last Session, Senate Bill 1540. Because of the early implementation date, we would like to get the joint study committee on its way, appointed and ready to go to work. First of all, I

would like to ask that I and Senator Etheredge be shown as the hyphenated sponsor...Senate sponsors of Bouse Joint Resolution 12. I would then like to request suspension of the rules so that we could immediately consider Bouse Joint Resolution 12, and I will then move for adoption.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Netsch has moved to add Senator Etheredge as a joint co-sponsor of House Joint Resolution 12. On that motion, is there discussion? All in favor say Aye. Opposed Nay. The Ayes have it. He will be shown as a joint co-sponsor. Senator Netsch has now moved to discharge the Committee on Executive from further consideration of House Joint Resolution 12. Is there discussion of that motion? Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I can't find that resolution in our book, and I would like to have an explanation...a short explanation of what it is.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Netsch, would you briefly explain the contents of the resolution.

SENATOR NETSCH:

Yes, I...I thought I just did. It creates the Joint Study Committee on the Adjustment of the Equalization Factor to Reflect Fair Cash Value, that's the name of the joint committee. The point of it is to have hearings and see what needs to be done to reflect accurately a hill which we did, in fact, pass last Session, Senate Bill 1540. It was a part of the package of reforms having to do with the...the property tax and the equalization factor. It doesn't have anything to do with abolishing the multiplier or anything of that sort. It was one of the technical bills that had been proposed in part by the Taxpayers Federation. And we...we need to look at the department's implementation of it and we

need to do it fairly quickly. The reporting date in May 1, which is why we would like to get started.

PRESIDING OFFICER: (SENATOR BRUCE)

Further discussion? Senator Etheredge.

SENATOR ETHEREDGE:

...Mr. President and Ladies and Gentlemen of the Senate, I rise in support of this motion. I think the implementation of new green sheets as has been explained has created some difficulties. I believe that all parties involved are in support of this...this study commission. So, I would urge an Aye vote.

PRESIDING OFFICER: (SENATOR BRUCE)

The motion is to discharge. Further discussion? All in favor say Aye. Opposed Nay. The Ayes have it. House Joint Resolution 12 is discharged from the Committee on Executive. On the motion to adopt, Senator Netsch.

SENATOR NETSCH:

I would move to adopt the House Joint Resolution 12.

PRESIDING OFFICER: (SENATOR BRUCE)

The motion is to adopt. Is there discussion? Senator Schuneman.

SENATOR SCHUNENAN:

Yes, a question of the sponsor, Mr. President.

PRESIDING OFFICER: (SENATOR BRUCE)

Indicates she will yield. Senator Schuneman.

SENATOR SCHUNEMAN:

Senator, I understood that originally there was a bill in the House that would have, in effect, granted a moratorium on the objectionable provisions of...of the bill and also granted immunity to those persons who may have improperly completed that green sheet in...in the meantime. Now, what's the game plan here? Is that bill going to be held and instead we're going to try to deal with this by means of resolution? And...and if so, then I guess my guestion is,

what happens to the...to people who may refuse to complete the green sheet or who may improperly complete the green sheet in the meantime?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Netsch.

SENATOR NETSCH:

I would have to say that I was not aware of the history of the bill that you're talking about in the House. Senator Etheredge, do you know the answer to that question?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Etheredge.

SENATOR ETHEREDGE:

It is my understanding that the proposal before us now in this motion is the...is the new game plan that has been agreed upon in order to resolve the...the problem of...of the green sheets.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Schuneman.

SENATOR SCHUNEMAN:

Well, that's fine, I'm willing to go along with any good game plan. But I...I guess my question still remains as to the possible liability of people who may be completing these green sheets in the interim. Anybody have a question...answer to that question?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Netsch.

SENATOR NETSCH:

I guess the only answer that I can give you is that that is something that obviously the committee ought to ask as a very early guestion when the committee is formed and see if it can come up with an answer. I cannot answer your guestion.

PRESIDING OFFICER: (SENATOR BRUCE)

Further discussion? On the motion to adopt, since the

committee may expend State funds in their study of the problem, it will require a roll call. Those in favor of adoption of House Joint Resolution 12 will wote Aye. Senator Bock. SENATOR BOCK:

Just to point out to the membership, this was adopted unanimously in the House and I think it's a matter of some urgency, and there is, as the Senator rightly pointed out, a May 1 reporting date. It's something that the Department of Revenue, frankly, is looking for some direction about. It will affect substantially every district in the State of Illinois, and I think it's to our best interest to adopt this immediately. I have spoken with the Minority Leader and we are prepared to make the proper appointments and get the committee rolling virtually immediately.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Lechowicz.

SENATOR LECHOWICZ:

Just a parlimentary inquiry, Mr. President. I believe you would have to have leave of the Body for the immediate consideration and then ask for a roll call, because there is an expenditure of appropriation money. The lady took the bill out of committee, now I believe the proper motion should be to ask leave of the Senate members for immediate consideration and a roll call on the matter.

PRESIDING OFFICER: (SENATOR BRUCE)

It was discharged and placed here, so we can...it's before us. The question is on the adoption of House Joint Resolution 12. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 43, the Nays are none, none voting Present. The...Senate does adopt House Joint Resolution 12. Is there leave to go to the Order of Resolution Consent Calendar? Leave is granted. Resolution Consent Calendar. Mr. Secre-

SECRETARY:

PRESIDING OFFICER: (SENATOR BRUCE)

Alright. Senator Maitland's name will be added on House Joint Resolution No. 9, with leave of the Body. Leave is granted. Senator Hall moves the adoption of the Resolution Consent Calendar. On that motion, all in favor say Aye. Opposed Nay. The Ayes have it. The resolutions are deemed adopted. For what purpose does Senator Hall arise?

Thank you, Mr. President. I'd like the record to show that Senator Newhouse is absent today because of illness.

PRESIDING OFFICER: (SENATOR BRUCE)

The Journal will so indicate. Senator Jerome Joyce.
SENATOR JEROME JOYCE:

PRESIDING OFFICER: (SENATOR BRUCE)

Thank you, Senator DeAngelis. Our recorded transcript

SENATOR ROCK:

Thank you, Mr. President. A similar announcement with...again with respect to Senator Berman who is absent today due to a family illness. Senator Egan is out of the country on a...as a member of the official delegation. Also, while I'm on my feet, I would like, Mr. President, to ask the sergeant-at-arms to see that the schedule, the committee schedule proposed is, in fact, distributed. It will call for the committees to commence on March the 8th and will afford each committee the opportunity to meet three or four times before Easter. And I would also like to remind the members that April 15th has been adopted by this Body as the final date for introduction, and that May 6th, the first week of May, is the final day for Senate committees to act on Senate nonappropriation bills. So, govern your schedule accordingly. The committees have now received from the Assignment of Bills Committee a rather lengthy agenda. After the introduction today they will be even more lengthy. I would urge the committee chairmen and the minority spokesmen and the sponsors of the legislation to start setting these bills for hearing so that you don't get caught in the end of April or the first of May in the crunch period. The earlier we can begin to move some of these rather weighty measures, the better off we'll all be.
