PRESIDENT:

All right, you've heard the request of Senator Vadalabene. Is there objection? Hearing none, leave is granted, Senator.

SENATOR VADALABENE:

PRESIDENT:

Further business to come before the Senate? I understand Senator Bloom has a resolution. Resolutions, Mr. Secretary. SECRETARY:

Senate Resolution 455 offered by Senators Bloom, Dawson, Carroll, DeAngelis and Smith.

(Secretary reads SR 455)

PRESIDENT:

Senator Bloom.

SENATOR BLOOM:

Thank you, Mr. President and fellow Senators. That was

Donahue and not DeAngelis: Bloom, Dawson, Carroll, Donahue and Smith. First, I would like to add Senator Smith as a cosponsor of Senate 495. A brief trip down memory lane, as you may recall, last May we had 495, the hospital cost containment bill, on 3rd reading, and by a special resolution we put it on the Order of Final Passage and set up a select committee with the power to appoint a technical advisory panel of representatives of the various parties with a direct interest in this. There has been progress, it has been slow. 23rd of February, the Illinois Hospital Association finally sent to us their proposal, a draft...draft legislation, pardon me, on cost containment. The Medical Society has now taken a position and they will be putting in their draft legislation. Senator Carroll and I have met with representatives of the administration and they are interested in this process. The technical advisory panel has come up with some concepts to change 495, which as you may recall we said all along was not written in granite. We just wanted the provider groups to understand that the problem was not just, as they put it, government underpayment but rather that the system was out of control. I think that by virtue of the Hospital Association putting in their own legislation which would set up a cap on hospital revenues and by virtue of the Medical Society coming up with a proposal not unlike the California model that now we have the basis to proceed with something that could provide a compromise. If that can be done, then we can be about our business this Spring without having various provider groups and other groups, lobbyists coming down and distracting us. The technical advisory panel is making progress. It's not as fast as we'd like but the progress is there. The...the chairman of the technical advisory panel has gotten consensus on certain key issues. Now, we have to harmonize these various ideas and come up with a draft...excuse me, come up with proposed amendments to 495,

and I believe that by putting off the reporting date until the 17th of May that we will come up with something that every member of this Body can live with. I think that we've taken an unprecedented move in passing this resolution, putting this bill on the Order of Final Passage and that a clear message has been sent to both the provider groups and those elements in other parts of government that we are going to get a handle on this, and I would seek your support in putting the reporting date to the 17th of May. Answer any questions; otherwise, I think it's pretty thoroughly explained. Thank you.

PRESIDENT:

All right, Senator Bloom has moved to suspend the rules for the immediate consideration and adoption of Senate Resolution 455. Is there any discussion on the motion to suspend? If not, all in favor of the motion to suspend indicate by saying Aye. All opposed. The Ayes have it. The rules are suspended. Now, under consideration is the adoption of Senate Resolution 455. Any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The resolution is adopted. Any further business to come before the Senate? Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I'd like the record to indicate that Senator Barkhausen, Senator Coffey, Senator DeAngelis, Senator Fawell, Senator Grotberg, Senator Macdonald, Senator Rupp are not here because of inclement weather. Also Senator Hudson is convalescing with a ankle injury. I'd like the record to indicate that, please.

PRESIDENT:

Senator Netsch, for what purpose do you arise? SENATOR NETSCH:

Thank you. Because of the absence of so many of our

committee members and the fact that a few of the individuals who were asked to testify at the Revenue Committee meeting are not here for the same reason that Senator Philip just described to his missing members, inclement weather, what we will do is, Senator Etheredge and I will simply go up and explain to any of those who have arrived that we will not be having full testimony today but the other members of the committee are excused from attendance.

PRESIDENT:

Senator Hall, for what purpose do you arise? SENATOR HALL:

Thank you, Mr. President. I'd like for the record to show that because of the inclement...weather Senator Berman, Senator Bruce, Senator...Collins, Senator Chew, Senator D'Arco, Senator Demuzio,...that he was driving and he got turned around and couldn't get here so far...Senator Buzbee, Senator Johns, Senator Jones, Senator Jeremiah Joyce, Senator Lechowicz, Senator Nedza, Senator Newhouse, Senator Sangmeister and Senator Zito are all absent because of the inclement weather.

PRESIDENT:

All right, the record will so reflect.

SENATOR HALL:

...and Senator Dawson, also.

PRESIDENT:

The record will so reflect, and I have just received word that Senator Demuzio is approaching the building, finally.

Senator Egan, for what purpose do you arise?

SENATOR EGAN:

Well, in deference to those in Chicago that could not come today, I just want to tell everybody, I came early yesterday, and that's...I beat the weather.

PRESIDENT:

Any further business to come before the Senate? With

leave of the Body, those who arrive before the close of the business day at six o'clock will certainly be entitled to be added to the roll call. The roads are just miserable. Senator Vadalabene.

SENATOR VADALABENE:

Yes, along with Senator Egan, I just want to let him know that I came up from the south in the eye of the hurricane for four and a half hours.

PRESIDENT:

Yeah, right. Senator Geo-Karis.

SENATOR GEO-KARIS:

Well, Mr. President and Ladies and Gentlemen of the Senate, don't feel so bad, I took the plane to Peoria because mine was cancelled twenty minutes before it was suppose to leave, went to Peoria, then I rented a car, so it cost me about another hundred dollars to get here last night...by eleven-thirty at night.

PRESIDENT:

I...I think that's a matter you ought to take up directly with Senator Philip. I'm sure he will reimburse you immediately. Senator Philip doesn't have any story. I...I was with him this morning. Any further business? If not, Senator Vadalabene moves that the Senate stand adjourned until 10:00 a.m. tomorrow morning. 10:00 a.m. tomorrow morning and the Session will be short and sweet, I assure you. 10:00 a.m. tomorrow morning.
