SENATOR VADALABENE:

ACTING PRESIDENT: (SENATOR BRUCE)

ACTING PRESIDENT: (SENATOR BRUCE)

Alright. The motion by the sponsor is to Table Senate Bill 121. On the motion to Table by the sponsor, all in favor say Aye. Opposed Nay. The Ayes have it and the bill

#### SENATOR GEC-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I have requested permission from Senator Jeremiah Joyce and been granted permission to be added as an additional hyphenated co-sponsor to him and Senator Degnan on Senate Bill 20.

## ACTING PRESIDENT: (SENATOR BRUCE)

...and Senator Lechowicz...Senator Geo-Karis...wait a minute. Senator Geo-Karis...Senator, is it to join as a co-sponsor or as a hyphenated co-sponsor? Senator Geo-Karis. Senator...Senator Geo-Karis, let me get back to you. We've got a problem in the...how many joint co-sponsors they can print down in the Legislative Reference Bureau, and as soon as the Secretary checks with it, we...we'll get back to you. For what purpose does Senator Darrow arise?

## SENATOR DARROW:

Mr. President, Senator Joyce has given me permission to be added as a co-sponsor to Senate Eill 221.

# ACTING PRESIDENT: (SENATOR BRUCE)

Alright. Now, just...if I might have the attention of

the Body, under the Senate Rules, which are temporary in nature, but are the rules under which we are now operating, co-sponsors need no longer take up Floor time to indicate that you will be a co-sponsor. And, all you have to do is send a note to the Secretary that you would like to be added as a co-sponsor, and he will do that internally to our printing of our Journal, and...and to the printing of the Digest. So, co-sponsors, just tell the Secretary. If you want to be a joint hyphenated co-sponsor, that will still be done on the Floor. In...in both instances it is common courtesy to notify the sponsor that you are joining him in his efforts...or her. For what purpose does Senator Rock arise?

Thank you, Mr. President, Ladies and Gentlemen of the Senate. If I can have your attention, we are shortly to proceed to the House for the Joint Session and the Governor's Budget Address; but I am pleased to introduce to you today and I would ask that we move to the Order of Senate Resolution 37, so that he can be properly introduced. He is a man who is an old friend of mine, although he is not an old man. I would like with leave of the Body to read Senate Resolution 37. I have asked leave that all members be shown as co-sponsors.
