Thank you, Ar. President and Ladies and Gentlemen of the If I can have the attention of the membership because I've been asked fifteen times this morning already about the schedule. This will put some limit on the schedule. This is the adjournment resolution. So, will he you invited...you will...shortly be receiving an invitation from the Hyatt Hotel Corporation to attend a seminar at the hotel, and I hope that you will try to keep that weekend open for that purpose. It will be a...I...I can assure you a good time will be had by all, and we will get an enormous amount

of work done, I'm sure. And then the Easter break, as I indicated, will start on that...on the 13th, so that's the deadline for introductions. So, any members who have legislative proposals or campaign promises or whatever, get it into the Reference Bureau because the last day for introduction is going to be the 13th of April. I think, Hr. President, perhaps we ought to now Recess, and I'd ask the members to meet as a group in front of the House...Chamber door; and the Committee on Escort, again, are Senators Bruce, Buzbee, Chew, Geo-Karis and Davidson, and we will reconvene immediately after the Joint Session right back here.

Well, thank you, Mr. President. This merely adds at the Governor's request two additional number...from twelve to fourteen, I believe is the correct number, of enterprise zones allowable this year by the administration. I move for the adoption.
