PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Hall moves for the adoption of the Resolutions Consent Calendar. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Resolution Consent Calendar

is adopted. Senator Lemke, for what purpose do you arise?

SENATOR LENKE:

I'd like to make a motion to bring House Bill...House Bill 133 back for purpose of amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, Senator, we're not on that order of business. Where...where...where is the bill?

SENATOR LENKE:

At the present time, it's on 3rd reading. I think Senator Sangmeister and Senator DeAngelis filed the amendment, and I'd like to bring...to put the amendment on the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Alright. You've heard the request of Senator Lenke that the Senate go to House bills 3rd reading, House bill 133 for the purpose of an amendment. Is leave granted to go to that order of business? Leave is granted. Alright. House bills 3rd reading. Senator Lemke moves to return House Bill 133 back to the Order of 2nd Reading for the purpose of an amendment. Is leave granted? Leave is granted. House Bill 133, Mr. Secretary.

SECRETARY:

Amendment No. 2 offered by Senator Sangmeister and DeAngelis.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Sangmeister.

SENATOR SANGMEISTER:

Thank you, Mr. President, members of the Senate. What this amendment does is it specifically takes care of a problem that we have in the enterprise zone in Will County. As you know, the original Act that we passed restricted the area to ten square miles. We have a Texaco plant that is now defunct at the north end of that district, and we would like to add another three square miles to it so that we can put it in the enterprise zone, and that's all that it does; and as

you see, Senator DeAngelis is a cosponsor of that, and I think it's all cleared on the other side, and I would move for the adoption of the amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator DeAngelis.

SENATOR DeANGELIS:

Thank you, Mr. President. Very quickly, I rise in support of this amendment. It's a very unique problem pertaining to a particular area, and we would be destroying an opportunity without passing this amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Alright. Further discussion? Further discussion? Senator Sangmeister has moved the adoption of Amendment No. 2 to House Bill 133. Those in favor signify by saying Aye. Opposed Nay. The Ayes have it. Amendment No. 2 is adopted. Any further amendments?

SENATOR LEMKE:

House Bill 133 expands the enterprise zones from eight to twelve and makes various technical changes to the Enterprise Zone Act that is requested by DCCA. And also, Senator Sangmeister just put an amendment on to help the Joilet area. I think it's a good bill and I ask for its favorable consideration.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Alright. Any discussion? Any discussion? The question...alright. Any further discussion? The question is, shall House Bill 133 pass. Those in favor vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Leroy. Have all voted who wish? Have all voted who wish? Take the record. That question, the Ayes are 40, the Nays are none, none voting Present. House Bill 133 having received the required constitutional majority is declared passed. Senator Keats, for what purpose do you arise?

SENATOR KEATS:

Thank you, Mr. President. I just wanted to say on 133, I, on a personal level, a very significant conflict of interest; but as usual, I've always voted my conscious. I just wanted to put that in the record. Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Hall, for what purpose do you arise?

SENATOR HALL:

Thank you, Mr. President. I would like for the record to show the following Senators and they should have been included yesterday: Senator Rock and Senator Nedza both are out of the city, Senator Newhouse is absent today because of city business, Senator Chew is at a AANVA Conference, Senator

Dawson has illness, Senator Johns has legislative business, Senator Savickas has personal business, and Farlean Collins, Senator Collins, is ill. So...and also Senator Bruce. So I would like for the record to so reflect.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Alright. The record will so reflect. Senator Philip, for what purpose do you arise?

SENATOR PHILIP:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I'd like the...record to show that Senator Hudson is home with the flu, Senator Coffey is in New Orleans attending a transportation workshop. Also, Mr. President, it is Senator Geo-Karis' thirty-ninth birthday tomorrow, and I wish that the Senate would arise and wish her a happy, happy birthday.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Congratulations. For...Senator Geo-Karis, for what purpose do you arise?

SENATOR GEO-KARIS:

Two reasons; one, I was hoping everyone would forget about it but, anyway, Mr. President, Ladies and Gentlemen of the Senate, thank you for your kind words. Second, I have a conflict of interest on that enterprise bill because my conflict is that I want my city of Zion to be considered; therefore, I want you to know my conflict. I'm voting for it in spite of it.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Alright. Further business? We have introduction of bills.

SECRETARY:
