Thank you, Mr. President. Committee Amendment No. 1 was in effective...there were two amendments actually...Amendment No. 1 was an effective date. Amendment No. 2 opened it up State-wide rather than limiting to Cook County.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to adopt committee Amendment No. 1. Discussion of the motion? All in favor say Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Further committee amendments?

SECRETARY:

PRESIDING OFFICER: (SENATOR BRUCE)

Are there amendments from the Floor?

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. Senate Bill 108, Senator Zito. Read the bill, Mr. Secretary, please. No. Okay. Senate Bill 117, Senator Davidson. Read the bill, Mr. Secretary, please.

Senate Bill 117.

(Secretary reads title of bill)

2nd reading of the bill. Committee on Agriculture, Conservation and Energy offers one amendment.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Davidson.

SENATOR DAVIDSON:

The amendment is technical, amended to make a definition of white deer. Move the adoption of Amendment No. 1.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to adopt. Discussion? All in favor say Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted.

Further committee amendments?

SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

Are there amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. Senate Bill 124, Senator Berman. Senate Bill 127, Senator Vadalabene. Read the bill, Mr. Secretary, please.

SECRETARY:

Senate Bill 127.

(Secretary reads title of bill)

2nd reading of the bill. No committee amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

Are...are there amendments from the Floor?

SECRETARY:

Amendment No. 1 offered by Senator Berman.

PRESIDING OFFICER: (SENATOR BRUCE)

Sixteen and seventeen year old drivers, Senator Berman.
SENATOR BERMAN:

Thank you, Mr. President. This amendment...preserves the rights of sixteen and seventeen year olds as they presently exist, and it makes the bill effective to those that will be sixteen after...enactment of the bill. Move the adoption of Amendment No. 1.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to adopt Amendment No. 1. Discussion of that motion? All in favor say Aye. Opposed Nay. The Ayes have it and Amendment...all right, there is discussion. If I might have the...if I might have the attention of the Body, we're on Amendment No. 1 to Senate Bill 127 and there is discussion of this amendment. Senator Coffey is recognized.

SENATOR COFFEY:

Yes, if I could, Mr. President, ask a question of the sponsor.

PRESIDING OFFICER: (SENATOR BRUCE)

Indicates he will yield. Senator Coffey.

SENATOR COFFEY:

I'm sorry, Senator, I just caught the tail end of what you was doing there. Would you explain that again what we're doing?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Berman.

SENATOR BERMAN:

The amendment says that the bill will affect those persons who become sixteen after the passage of the bill. So that those who presently have the privilege of their existing drivers license will not lose any of the rights that they presently have.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Coffey.

SENATOR COFFEY:

Senator, is...is...was this the amendment we discussed in the committee that you wanted to put on on the Floor? What...Senator Sam, maybe...

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Vadalabene.

SENATOR VADALABENE:

No, I can't recall. Senator Berman came up with this amendment after I came up to the Floor of the Senate and requested that we...the sixteen and seventeen year olds that are under the provisional drivers license would not be...they would not lose their driving privileges after this becomes law.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Coffey.

SENATOR COFFEY:

Yes, Mr. President, if I could...to the sponsor of this bill. It's...my understanding, from the Secretary's Office, that we were not going to move this bill off of 2nd reading at this time. I guess...I'm not sure I can address this question to...to the sponsor of the bill. I understood that...from the Secretary's Office that we were not going to move this bill at this time.

PRESIDING OFFICER: (SENATOR BRUCE)

The...the Chair is waiting for a signal. Senator Vadalabene, do you wish to take it out of the record? Senator Vadalabene.

SENATOR VADALABENE:

Yes, just for my information, I don't see anybody here from the Secretary of State. What is the reason we're holding it, Senator Coffey?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Coffey.

SENATOR COFFEY:

It's my understanding...of course, I objected to the bill when it was in the committee, and my understanding this was a bill to address the problem if there was to be a bill to come on the Floor to change the driving age to eighteen years of age that this would be the solution to solving that problem, but as far as I know, there is no bill on here to change the driving age to eighteen. Therefore, I, you know, objected to it and it was my understanding from the Secretary's that they would probably leave this on 2nd to see what happened. Now that's...I don't want to speak for the Secretary, but that's my understanding.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Vadalabene.

SENATOR VADALABENE:

Well, I think what Senator Coffey is doing, he's speaking

on the bill itself and not the amendment that Senator Berman has offered. At 3rd reading possibly Senator Coffey can express his objections to the bill. I...I don't know what his objections to moving it to 3rd are.

PRESIDING OFFICER: (SENATOR BRUCE)

Well, Senator, Senator Coffey is asking whether or not you plan to hold the bill and he was trying to explain the reasons, and...and we are actually on the amendment. If you do not wish to hold it, we will go immediately to the...the question of the amendment. Senator Vadalabene, do you wish to...

SENATOR VADALABENE:

...yes, I'm willing...I'm willing to hold the bill, but I think he's expressing his objections to the bill rather than moving it to 3rd.

PRESIDING OFFICER: (SENATOR BRUCE)

And you will hold it?

SENATOR VADALABENE:

No. I'm asking Senator Coffey, does he object to the bill or does he want it held on 2nd?

PRESIDING OFFICER: (SENATOR BRUCE)

Gentlemen, let's just go ahead with the amendment and...and roll it. If the sponsor wishes to roll it, that's his prerogative. We'll go with...the amendment is before the Body. Is there further discussion? Senator Davidson, on the amendment.

SENATOR DAVIDSON:

Would the sponsor of the amendment reiterate what it does. Among the confusion I did not get a clear explanation.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Berman. May we have some order please. Senator Berman.

SENATOR BERMAN:

Senator Davidson, the bill as introduced would cause a

person who is sixteen or seventeen years of age and gets a moving violation to be subject to being...to having their license suspended. What my amendment does is to say that this will affect persons who are sixteen years of age after the bill is passed. So that a person who has a...a full license now doesn't lose something in the process. That's all the amendment does.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Davidson.

SENATOR DAVIDSON:

Well, I...I see no objection to the amendment. This bill came out of a pretty extensive hearing for almost a year between Motor Vehicle Laws, Secretary of State, the school officials and et cetera, in relation to try to do something on a provisional drivers license. And I think it's a good bill, and the amendment just clarifies that those who have it now would not put in jeopardy, and I have no problem with that. I support the amendment.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rupp.

SENATOR RUPP:

Thank you, Mr. President. Now it's my understanding, having sat in this committee, that before an amendment was to be submitted that they were to suggest...make...get with Senator Coffey and have some conversation about it. And did they get together with you, Senator Coffey? That's what my...that was my understanding. That might be possibly the...the confusion.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. Further discussion on the amendment? Senator Vadalabene, on the amendment.

SENATOR VADALABENE:

Well, I agree with the amendment, but I'm willing to hold the bill on 2nd reading and...and let Senator Coffey discuss

who he wants to discuss with and what on what kind of amendment he's talking about. I don't have any amendment. The Secretary of State doesn't have any amendment. And if you have an amendment, Senator Coffey, I'll hold it on 2nd so you can offer it.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Coffey.

SENATOR COFFEY:

Well, when that...and...and again, I guess we're...we're talking about the bill. Maybe we ought to let the amendment go on, but...in the committee I suggested if we're to...to amend that bill that maybe we would deal with wreckless driving, deal with DUI's, that, I had no problem with that. Immediately after that meeting, the Secretary called me down to his office, we discussed that. I thought the bill was going to stay until that was worked out. That's...that's my point, Sam.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. On the amendment, Senator Vadalabene.

SENATOR VADALABENE:

Yes, I'm in favor of the amendment. I would like for us to adopt it and I would like for it to be moved to 3rd, and if there's any problems, we'll bring it back.

PRESIDING OFFICER: (SENATOR BRUCE)

The motion is to adopt. Senator Berman may close.

SENATOR BERMAN:

Roll call.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. There's been a request for a roll call...there's been a request for a roll call. Those in favor...is there a request for a roll call? Yes, there is a request for a roll call. Those in favor of Amendment No. 1 will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish?

Take the record. On that question, the Ayes are 45, the Nays are 5, none voting Present. Amendment...Amendment No. 1 to Senate Bill 127 is adopted. Further amendments?

SECRETARY:

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. Senate Bill 128, Senator Carroll. Senate Bill 134, Senator Zito. Senate Bill 135, Senator Luft. Read the bill, Mr. Secretary, please.

SECRETARY:

Senate Bill 135.

(Secretary reads title of bill)

2nd reading of the bill. Committee on Local Government offers one amendment.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Luft to explain Committee Amendment No. 1.

SENATOR LUFT:

Thank you, Mr. President. For the purpose of inventory control, the township road commissioner today would have to inventory everything over fifty dollars cost. The...everybody thought that was too high...too low, and what the bill tried to do is to raise that cost for the purpose of inventory control to five hundred dollars. The committee thought two hundred dollars would be a more realistic figure. So the committee amended...amendment reduces from five hundred dollars to two hundred dollars that figure which has to be on the year-end inventory control. And I would ask for acceptance of the amendment.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to adopt Amendment No. 1. Discussion? All in favor say Aye. Opposed Nay. The Ayes have it. Amendment No. 1 is adopted. Further amendments?

SECRETARY:

No further committee amendments.

SENATOR LUFT:

Thank you, Mr. President. The committee amendment raises from ten thousand to fifteen thousand dollars the annual salary that a road commissioner must get before he is considered a full-time employee.

PRESIDING OFFICER: (SENATOR BRUCE)

Are..the motion is to adopt committee Amendment No. 1. All those in favor say Aye. Opposed Nay. The Ayes have it. Committee Amendment No. 1 is adopted. Further committee amendments?

SECRETARY:

No further committee amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

Are there amendments from the Floor?

SECRETARY:

No...no Floor amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. Senate Bill 137, Senator Macdonald. Senator Macdonald. Read the bill, Mr. Secretary, please.

SECRETARY:

Senate Bill 137.

(Secretary reads title of bill)

2nd reading of the bill. No committee amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

Are there amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. Senate Bill 141, Senator Sommer. Read the bill, Mr. Secretary, please.

SECRETARY:

Senate Bill 141.

(Secretary reads title of bill)

2nd reading of the bill. No committee amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

Are there amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

3rd reading. Senate Bill 146, Senator Sangmeister. Senate Bill 152, Senator Bloom. Read the bill, Mr. Secretary, please.

SECRETARY:

Senate Bill...Senate Bill 152.

(Secretary reads title of bill)

2nd reading of the bill. No committee amendments.

PRESIDING OFFICER: (SENATOR BRUCE)

Are there amendments from the Floor?

SECRETARY:

Amendment No. 1 offered by Senators Bloom, Etheredge and Netsch.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Bloom to explain Floor Amendment No. 1.

SENATOR BLOOM:

Thank you, Mr. President. The chairman and Minority Spokesman and I got together and examined this bill and felt that a better way of achieving its purpose was to say that for refund claims filed by individuals' trusts or estates, if they haven't received notice from the Department of Revenue of any kind of action they are deemed to be proved, but for everyone else it's still deemed denied. And then we added that they had to send a...six months status notice to everyone else. This achieves the aims of the bill without allowing...without allowing those would manipulate the system to do so. I'd answer any questions and urge the adoption otherwise.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to adopt Amendment No. 1. Is there discussion of that motion? Senator Netsch.

SENATOR NETSCH:

Thank you, Mr. President. I...I would support the amendment. I realize that those who were on the administrative end are likely to go through the ceiling, but it seems to me, that in principle, it is unassailable. What it says is that...a department, an administrative agency, has got to do something. It cannot, in effect, sit on matters for long, long periods of time. We who are the taxpayers certainly do not get that luxury. Our interest and penalties begin to accumulate rather rapidly and, in a sense, this is the other side of that coin. And, as I indicated, I think it is absolutely and eminently fair.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to adopt. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. Question of the sponsor.

PRESIDING OFFICER: (SENATOR BRUCE)

Indicates he will yield. Senator Rock.

SENATOR ROCK:

Thank you. As I understand it, Senator Bloom, the bill was introduced to suggest or mandate that the department can't sit on something and then six months later have it work an automatic denial. We're going totally the other way now. Is that correct? Is that what this amendment does?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Bloom.

SENATOR BLOOM:

The bill was introduced to correct a glitch. Once you went in, you had to then, as an individual taxpayer, before six months ran, protest whether they took any action or not. Originally we put it into eliminate that and what we're saying now, insofar as individuals are concerned, the Department of Revenue has six months to act or not act. On the more complex corporate returns, we...we can see that perhaps there would be...there would be some more work necessary. That's basically the thrust behind the amendment.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock.

SENATOR ROCK:

May...may I ask, did the department have knowledge of this proposed amendment and...and what their position is?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Bloom.

SENATOR BLOOM:

They had knowledge that the amendment...there were two alternative amendments prepared, they knew an amendment was going to be prepared, and I have not heard their position on this, no.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Rock.

SENATOR ROCK:

Well, I...I just think, frankly, we are, in these tough fiscal times, putting one heck of a burden on that depart-

ment. There are some individual returns that are, frankly, sometimes complex. Having just gone through an audit myself, I can understand the complexity of some returns. And to suggest that they better do it in six months or it's automatically approved seems to me to be opening the door for many claims that perhaps are unjustified. I...I just don't know why we're going this far. I can understand the bill as introduced saying, we can't sit on it and work an automatic denial; but to go the other way, it seems to me to be creating an administrative burden that we may wish we didn't.

PRESIDING OFFICER: (SENATOR BRUCE)

Further discussion? Senator Bloom may close.

SENATOR BLOOM:

Well, I think the...I think the...I think your point is well taken up to a point, but the...the pattern has been, at least for individuals, that the overwhelming majority of these applications are pretty much ministerial in function. And the feedback I've gotten from my constituents and others, and these are people that are just filing ordinary short form returns, is that it takes an unconscionably long time, and a couple of them, because they are not particularly...not particularly sophisticated, some of them, have basically ended up with...on the short end of the stick, if you will. I would say this, that if we could put this on, I would hold it and...and perhaps if there were some language that could achieve these ends, I'd be willing to do that 'cause I do understand the point you've made but, otherwise, I'd urge the adoption of this amendment.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to adopt...Senator Rock.

SENATOR ROCK:

I...I don't ordinarily try to speak twice, but I think this one is important enough. The...one of the difficulties I foresee, frankly, with this amendment receiving at least

our tacit approval, if, in fact, it does, and I intend to ask for a roll call and intend to vote No, is that you know very well by the time it comes back here for concurrence, our corporate friends are going to be included in this. Yeah, I know, me...me thinks he doth protest too much. The fact is that the corporations are going to make sure they get in here, and then we have created truly a monster, and we will have to build a building that is not yet completely under roof, we're going to have to expand it, twofold at least. I...I think your idea in the introduction of the original bill was certainly a salutary one that the..that the bureaucrats can't sit and at the end of six months somehow it all goes away, that we do put a burden on them to, at some point, make a final determination. But to suggest that there's automatic approval, I think is going too far and I intend, Mr. President, to vote No and would request a roll call.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Bloom, to close.

SENATOR BLOOM:

Do I really get to close now?

PRESIDING OFFICER: (SENATOR BRUCE)

Well...

SENATOR BLOOM:

Up to a point, okay. I was following you and...and to a degree...tacitly absorbing your concerns...until we...we got to the corporate monsters. Quite frankly, if it came back in the form that you suggested would out of the House, A, I'd be very suprised, giving the...given the complexion of that Body and, B, I would not be a party to sending it down to the Governor's Desk allowing those entities to get...take advantage of this. This is, basically, intended and we thought the language would clarify it and put further pressure on the...the agency to respond to your individual type...short

form type taxpayers who are the overwhelming majority of the type of people we're trying to help, and that's why we wrote out all others. That is the response I'd make now. I'd urge support of this amendment and would represent to the Body that I'll...I'll hold it on 3rd for a couple weeks and move it back if there's a better way to skin this cat. Otherwise, I'd urge a favorable vote.

PRESIDING OFFICER: (SENATOR BRUCE)

Question is on the adoption of Amendment No. 1 to Senate Bill 152. There's been a request for a roll call. Those in favor vote Aye. Those opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 28, the Nays are 26. Amendment No. 1 is adopted...further amendments?
