# SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I have caused to have a copy of Senate Joint Resolu-

tion 101...now numbered 101 put on all members\* desks. You recall there was some publicity about the fact that last week there was a summit meeting called by the Governor of Illinois, the leadership of the Assembly, the Mayor of Chicago, the Representatives of the Chicago City Council and the Chicago Park District and members of the World's Fair Authority of 1992 convened to discuss the issues yet unresolved with respect to the World's Fair. One of the issues that was discussed and which is addressed by this joint resolution was the question that he...we mandated or directed at least that there be a...an intergovernmental cooperation agreement with respect to the allicotion of cost for capital improvements between the City of Chicago and the State of Illinois. That agreement, I am told and was presented to the summit meeting, is virtually completed. The yet unremaining aspect is it...it requires concurrence in and ratification by the Chicago City Under the legislation as passed it called for that Council. agreement to be finalized by the 30th day of April. Given the fact that the City Council will also enjoy an Easter recess as will the General Assembly, the chairman of the City Council Committee made it quite clear to all present that the April 30 deadline was unrealistic, and it was agreed by the members of the summit committee...or the summit meeting that a thirty-day extension would do no substantial harm either to the agreement or to the ultimate disposition of the Fair by the General Assembly. So, Senate Joint Resolution 101 merely says that the World's Pair Authority, the City of Chicago submit an intergovernmental cooperate...cooperative agreement as required by our Public Act no later than May 31, 1984. is nothing more nor less than a thirty-day extension of the direction of this Assembly and the Governor to the city and the state that this agreement be finalized. It will afford proper deliberation by the Chicago City Council. There is no disagreement by any who participated, that I am aware of; and I would ask for your favorable...I would ask for a suspension of the rules for the immediate consideration and adoption of Senate Joint Resolution 101.

## PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to suspend rules. Discussion of that motion? Those in favor say Aye. Opposed Nay. The Ayes are...have it. The rules are suspended. Is there discussion of the motion to adopt? #### SENATOR BLOOM:

I have communicated with the chairman of Executive Committee, who unfortunately hasn't gotten back from lunch, but I've checked with the Committee Chairman and the Minority Spokesman and they have no objection to its being considered this week. So, I'd seek leave to have that added to Executive's call. Thank you.

## PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to suspend the Seven-day Posting Notice as to Senate Joint Resolution 98, that it might be heard in Executive Committee today or...or at its next meeting...at its next meeting. # Senate. If I can have the attention of the membership...Senator Chew, are you ready? You're...you're the one that's been asking me since you got here when we're leaving. Yeah, right. Okay. My suggestion, and I've discussed this with Senator Philip, is that there is no need, in my judgment, for the members of the Senate to in Springfield any longer than is necessary. So, my suggestion, and I would make it as a sugesstion, is that we will be in Session tomorrow, Wednesday, April 11: and then the committees will meet; and on Thursday morning we will be in Session but it will be a perfunctory Session, at which time nobody need appear unless they wish. Friday we will not be here at all, and for those who have legislation or bills yet to be introduced, we have been in touch with the Reference Bureau, they tell us frankly they're in pretty good shape; but in order to accommdate the membership, I'm going to suggest that bills that...in order to meet that deadline

can be filed with the Office of the Secretary of the Senate

until the close of business on Friday, and that will be the ultimate cutoff, so that when we conclude our business on Wednesday and the two committees meet on Wednesday afternoon that will effectively conclude our business until the 24th of April. And Thursday we will be in just as long as necessary for the purpose of introduction, and if...if in fact, all bills are not introduced on Thursday, the Office of the Secretary of the Senate will be open Friday to accommdate the membership; but in terms of your schedules, I think we can plan on leaving on Wednesday, late Wednesday.

Just want to remind the membership those who want to participate I...urge each and every one of you to participate in the fitness check, the wellness check, tomorrow in Room 400, starts at 9 a.m. If you're going to do the whole series of tests, take approximately half an hour or a few minutes less. You can do any or all part of it; the flexibility, the stress walk. If you're going to participate in the blood testing, please remember for it to be accurate, to give you any real accuracy of help to you, you need to have twelve hours of fasting; that means, food and drink prior to taking the test. Now, if you want to go out tonight, fine. Just go take your test tomorrow twelve hours from the last time you indulge in food or drink this evening. And this is being sponsored by the Illinois Association of Physical Health and a number of other corporations which was laid on your desks along with the apple. I urge each...and every one of you to do this, it will give you an idea what kind of stress you can take during the final days of this stressful Session before it's over with. Thank you.
