PRESIDING OFFICER: (SENATOR BRUCE)

All right, the...the motion is to discharge Executive Order No. 2 from the Committee on Executive and have it rereferred to the Committee on Reorganization of State Government. On the motion, discussion? Those in favor say Aye. Opposed Nay. The Ayes have it. Executive Order No. 2

is discharged and rereferred per the motion. For...for what purpose does Senator Marovitz arise?

SENATOR MAROVITZ:

For the purpose of a motion which I ve spoken to the Senate...to the Senator about, and this is a motion to discharge the Committee on Executive from the consideration of House Joint Resolution 71 and have the rules suspended for immediate consideration of HJR 71.

PRESIDING OFFICER: (SENATOR BRUCE)

All right, the motion is to discharge HJR 71 from the...Senate Committee on Executive. May we have some order, please. Senator Marovitz, there's been a question. If you would just perhaps explain the nature briefly of the resolution. Senator Marovitz.

SENATOR MAROVITZ:

It's a resolution that all of us are concerned about. passed the House of Representatives. It's relative to the Rathskeller...performance of the Rathskeller in the Capitol Building. It has passed the House. It is now ensconced, hopefully, in the Executive Committee. It will be ensconced on this Floor so that we can just ... have our concern about the Rathskeller and its operation noted in the record. has been noted in the House. The Secretary of State would be directed by this resolution to remove Heritage House from the bid list when and only when their contract expires and to rigidly enforce all provisions of their existing contract which have not been enforced heretofore with the Heritage House and in regards to their operation of the Rathskeller which has been totally abhorrent and dangerous to everyone who goes down there. In other words, it's the pits, right. PRESIDING OFFICER: (SENATOR ERUCE)

Discussion? Discussion? The motion is to discharge and have it placed on the Calendar. Is that correct, Senator Marovitz? All right, the motion is to discharge the Commit-

tee on Executive. On that motion, discussion? Those in favor say Aye. Opposed Nay. The Ayes have it. The Committee on Executive is discharged and...and the resolution will be placed on the Calendar. For what purpose does Senator Buzbee seek recognition?

SENATOR BUZBEE:

Just to announce that five minutes after we...we complete Session the Appropriations II Committee will reconvene in...in Boom 212. We anticipate being there about thirty minutes.

PRESIDING OFFICER: (SENATOR BRUCE)

All right. Senator Vadalabene.

SENATOR VADALABENE:

Yes, in regard to Senator Marovitz motion, can we advance that to 3rd reading and vote on it now?

PRESIDING OFFICER: (SENATOR BRUCE)

Well, I think the agreement, Senator Vadalabene, is we'll put it on the Calendar for consideration. All right, on the Secretary's Desk. Senator Barkhausen.

SENATOR BARKHAUSEN:

Mr. President, I would...move to Table Senate Bill 1442, of which I am the sponsor, since it's largely a duplicate of Senate Bill 1602, sponsored by Senator Luft and myself.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to Table Senate Bill 1442 by the sponsor. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it and the bill is Tabled. Senator Marovitz, for what purpose do you seek recognition?

SENATOR MAROVITZ:

To show that not only Republicans can save the time of the Senate but Democrats as well, I would move to Table Senate Bill 293 and remove it from the Calendar.

PRESIDING OFFICER: (SENATOR BRUCE)

Motion is to Table Senate Bill 293 by the sponsor. On the

motion, those in favor say Aye. Opposed Nay. The Ayes have it and the bill is Tabled. Any further...any further business to come before the Senate? All right. Any further business? Senator...Senator Bock.

SENATOR ROCK:

Thank you, Mr. President. I would again reiterate that tomorrow the Senate will convene at nine-thirty and the Session will be brief. The Secretary of the Senate will keep his office open all day Friday until the close of business for the purpose of introduction, and those bills introduced up until the close of business on Friday will be read in appropriately on the 24th and we will deal with them in the ordinary course; but I don't think it's necessary for all of us to stay here. For those who have accepted the kind invitation of the Chicago business community, we look forward to seeing you. I have spoken with the hotel people.
