PRESIDING OFFICER: (SENATOR ERUCE)

SENATOR NETSCH:

tonight as originally scheduled in Boom A-1. In addition, we will...and I might say Dr. Mandeville is not going to be in town the next two days, so we do have to go ahead with that tonight. In addition, we will meet Friday morning. There will be an administrative Session of the Legislature, of the Senate, and the Senate Select Committee will meet at eight-thirty on Friday morning.
