## PRESIDING OFFICER: (SENATOR BRUCE)

The hour of one having arrived, the Senate will come to order. The prayer today will be by Reverend Rudolph Shoultz of the Union Baptist Church of Springfield, Illinois. And will our guests in the galleries please rise.

## REVEREND RUDOLPH SHOULTZ:

(Prayer given by Reverend Shoultz)

PRESIDING OFFICER: (SENATOR BRUCE)

Reading of the Journal. Senator Johns.

#### SENATOR JOHNS:

Mr. President, I move that reading and approval of the Journals of Thursday, April the 14th; Friday, April the 15th; Tuesday, April the 19th; Wednesday, April the 20th, in the year 1983, be postponed pending arrival of the printed Journal.

## PRESIDING OFFICER: (SENATOR BRUCE)

You've heard the motion. Discussion? All in favor say Aye. Opposed Nay. The Ayes have it. The motion prevails. Committee reports.

#### SECRETARY:

PRESIDING OFFICER: (SENATOR BRUCE)

Motions in writing.

#### SECRETARY:

The following motions in writing are from Senator Savickas, chairman of Assignment of Bills committee:
...Senate Bill 625, discharge in Executive Committee and re-referring the...the bill to Public Health, Welfare and Corrections. Senate Bill 692, discharging Elementary and Secondary Education, re-referring the bill to Executive. Senate Bill 1117, discharging Executive Appointments Committee and re-referring the bill to Executive.

## PRESIDING OFFICER: (SENATOR BRUCE)

Senator Savickas moves the adoption of the written motions. Is there discussion? Those in favor say Aye. Those opposed say Nay. The Ayes have it, and the bills are so discharged and so re-referred pursuant to the written motion. For what purpose does Senator Marovitz arise? SENATOR MAROVITZ:

Thank you, Mr. President. As chief sponsor of Senate Bill 1311, I would ask that Senator Zito be added as a hyphenated sponsor to my Senate Bill 1311.

## PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave to add Senator Zito to Senate Bill 1311? Rearing no objection, that will be the order. Setator Berman, for what purpose do you arise?

## SENATOR BERMAN:

Thank you, Mr. President. For next week's Elementary and Secondary Education Committee we have already posted, but Senator Fawell has Senate Bill 561. I would ask for leave to waive the appropriate posting requirements as to Senate Bill 561 so that we can post a supplemental notice to include that bill on our April 26th hearing. Senate Bill 561.

PRESIDING OFFICER: (SENATOR BRUCE)

Has it...has it been posted before, Senator?
SENATOR BERMAN:

No.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright. Senator Berman moves that the posting requirement for Senate Bill 561 be...be waived. Six Day Posting Notice. Is there discussion? Those in favor say Aye. Opposed Nay. The Ayes have it. The rules are waived as to Senate Bill 561. Senator Marovitz, for what purpose do you arise?

### SENATOR MARCVITZ:

## PRESIDING OFFICER: (SENATOR BRUCE)

Senator Marovitz asks leave to add Senator Lemke to Senate Bills 354, 418, 432, 433, 434 and 436. Is there objection? Hearing none, that will be the order. For what purpose does Senator Vadalabene arise?

#### SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. I would ask leave to be added as a hyphenated sponsor on Senate Bill 1308. This is Senator Grotberg's bill and he has agreed to have me join him as a hyphenated sponsor.

## PRESIDING OFFICER: (SENATOR BRUCE)

Senator Vadalabene seeks leave to be added to 1308. Is

there leave? Leave is granted. For what purpose does Senator Macdonald arise?

#### SENATOR MACDONALD:

Yes, I would like to ask permission to have Senator Barkhausen added as a chief co-sponsor of Senate Bill 1081. PRESIDING OFFICER: (SENATOR BRUCE)

Senator Macdonald, is that to be a hyphenated co-sponsor? SENATOR MACDONALD:

Yes.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright. Fine. Is there leave to add Senator Barkhausen to 1081 as hyphenated co-sponsor? Leave is granted. Senator Bloom, for what purpose do you arise?

## SENATOR BLOOM:

Thank you, Mr. President. To Senate Bill 495, I would like to add as co-sponsors Senators Lechowicz, Schuneman, Smith, Kustra, Lemke and Luft. Got it?

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Bloom, on those you can just give the Secretary a list as to co-sponsors.

#### SENATOR BLOOM:

I apologize, I'm sorry, I just remembered Kenny...or the Secretary informed me and I'm sorry to take up your time.

PRESIDING OFFICER: (SENATOR BRUCE)

Okay. Further announcements? Senator Johns, for what purpose do you arise?

# SENATOR JOHNS:

I'd like to be shown as co-sponsor of House hill...I mean Senate Bill 325. I think Senator Buzbee is the hyphenated co-sponsor, or will be, but I want to be shown as one of the sponsors of 325.

## PRESIDING OFFICER: (SENATOR BRUCE)

Alright, Senator Johns will be shown as a sponsor of Senate Bill...co-sponsor of 325. Senator Buzbee.

#### SENATOR BUZBEE:

Thank you, Mr. President. Senator Demuzio is the principal sponsor of Senate Bill 325 and I would like to be shown as the hyphenated co-sponsor. It would be Demuzio-Buzbee, then Johns.

## PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave for...as sponsors of Senate Bill 325 we show Senator Demuzio-Buzbee-Johns? Leave is granted. Reso-lutions.

#### SECRETARY:

Senate Resolution 119 offered by Senator Savickas and all Senators, and it's a death resolution.

## PRESIDING OFFICER: (SENATOR BRUCE)

Consent Calendar.

## SECRETARY:

Senate Resolution 120 offered by Senator Mahar, and it's congratulatory.

## PRESIDING OFFICER: (SENATOR BRUCE)

Consent... Resolution Consent Calendar.

## SECRETARY:

Senate...Senate Joint Resolution 29 offered by Senator Vadaläbene.

## PRESIDING OFFICER: (SENATOR BRUCE)

Executive Committee. For what purpose does Senator Nedza arise?

### SENATOR NEDZA:

Thank you, Mr. President. For purposes of an announcement. The Transportation Committee will not be meeting tomorrow, and the meeting has been rescheduled for Tuesday at 7 p.m. in Room 400.

#### PRESIDING OFFICER: (SENATOR BRUCE)

Alright, if you'll look on your Calendar, it shows next Tuesday night for Public Health, Welfare and Corrections being cancelled for tomorrow in Room 212, 7 p.m. Transporta-

tion, I'm sorry...Senator Buzbee, for what purpose do you arise?

#### SENATOR BUZBEE:

Thank you, Mr. President. Just an announcement that Senate Appropriations II Committee is due to meet at two o'clock in Room 212. We'll be considering the Higher Education budgets this afternoon. I anticipate that there will be about a fifteen minute delay in getting started. So, about two-fifteen we'll be starting on...on that committee. PRESIDING OFFICER: (SENATOR BRUCE)

Senator Marovitz, for what purpose do you arise?
SENATOR MAROVITZ:

The Divorce Subcommittee of the Judiciary I Committee will hold its hearing today on the Senate Floor, fifteen minutes after adjournment. Two o'clock, or fifteen minutes after adjournment, right here on the Senate Floor. We have about seven bills, there are several judges that are down and lawyers...about an hour is all it will take, right here on the Senate Floor. Divorce Subcommittee of Judiciary I.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Marovitz, the Chair would notice that that was called the Marriage Subcommittee yesterday and the Divorce Subcommittee today, what a difference a day makes. Further announcements? Senator Netsch.

## SENATOR NETSCH:

Thank you, Mr. President. I would like to make two announcements. One, the Revenue Committee will, as scheduled...

PRESIDING OFFICER: (SENATOR BRUCE)

May we have some order, please. Senator Netsch. SENATOR NETSCH:

...will, as scheduled, meet at two o'clock today in Room 400. More importantly, the Senate Select Committee on Budget and Finance will meet tomorrow morning. My understanding is

that we will have Session at 9 a.m.,...Senate Session at 9 a.m. tomorrow. The Senate Select Committee will begin its meeting at 9:30 a.m. in Room 212. We will meet, we have the Economic and Fiscal Commission, Revenue and some other matters to dispose of. It will be our last meeting at which we will have witnesses, if you will. So, it is quite important. 9:30 a.m. tomorrow in Room 212, the Senate Select Committee on Budget and Finance.

## PRESIDING OFFICER: (SENATOR BRUCE)

Any further announcements? If I might have the attention of the Body just for an announcement concerning tomorrow's Session. When we adjourn today, it is our plans that we would come back tomorrow at 9 a.m., 9 a.m. tomorrow for a brief administrative meeting to take in committee reports and move certain papers through the Secretary's office. We will not be having a perfunctory Session anymore, we will be having administrative meetings of the Senate. Your attendance is not required. However, we will be in attendance tomorrow morning at nine o'clock for a brief administrative meeting. And Senator Netsch has graciously moved her committee back to nine-thirty, and for those of you who read your Calendar, on Page -20, there is a Transportation Committee meeting scheduled for 10 a.m., that has been postponed until next week in the evening. # SENATOR JEROME JOYCE:

Thank you, Mr. President, I would like leave to have shown as hyphenated sponsors to Senate Bill 5, Demuzio, Welch, Buzbee, Darrow, Johns and J.E. Joyce.

#### PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave? Leave is granted. For what purpose does
Senator Welch arise?

#### SENATOR WELCH:

Thank you, Mr. President, I would like to ask that Senator Marovitz be added as a hyphenated co-sponsor to Senate Bill 625.

# PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave? Leave is granted. If I might have the attention of the Body, there is one...there is one resolution that we need to pass today, and that is on Page 19 of your Calendar, and it will require a roll call since it requires the expenditure of funds. For what purpose does Senator Philip arise?

#### SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Behind me is the new chancellor for the Circle Campus and Medical School for the University of Illinois, Don Langenberg. And I'd like the Senate to acknowledge his presence.

## PRESIDING OFFICER: (SENATOR BRUCE)

Welcome to the Senate, Dr. Langenberg. Senator Philip. SENATOR PHILIP:

Secondly, I'd like the record to show that Senator Baitland is in Washington, D.C. in regards to the Job Training Partnership Act. Also, I'd like to shock everybody and Table Senate Bill 1286. You can all guess and think about that.

## PRESIDING OFFICER: (SENATOR BRUCE)

It's not the income tax guys, don't get too excited. Senator Netsch. On page...for House bill...House Joint Resolution 22, Senator Netsch is recognized.

#### SENATOR NETSCH:

Thank you. This is a resolution that has total bipartisan support, both through the House and in this Body as well. Senator Etheredge is a joint sponsor. It's purpose is to bring about a joint committee, in effect, that will

look into the question of the consolidation of the substance abuse programs of the State of Illinois. There had been some difference of opinion as to how it ought to be done. There is a rather widespread base of opinion that something should be done to bring them together. Rather than try to pass a piece of substantive legislation where there was not total agreement, it was...everyone agreed who was interested in this problem that we would have this joint committee on the consolidation of alcoholism and drug abuse programs which must report back to this General Assembly. It is important to get the work underway. I would move the adoption of House Joint Resolution 22.

## PRESIDING OFFICER: (SENATOR BRUCE)

Is there discussion? The question is on the adoption of HJR 22. Those in favor vote Aye. Those opposed vote Nay. The voting is open. (Machine cutoff)...voted who wish? Have all voted who wish? Take the record. On that guestion, the Ayes are 51, the Nays are none. The...the Senate does adopt HJR 22. Senator Philip, I inadvertently did not Table 1286 on your behalf, and Senator...Senator Philip has moved to Table 1286. Those in favor say Aye. Opposed Nay. The Ayes have "it. The bill is Tabled. For what purpose does Senator Jerome Joyce arise?

## SENATOR JEROME JOYCE:

Yes, I... Mr. President, I would like to Table Senate Bill 366.

# PRESIDING OFFICER: (SENATOR BRUCE)

And you are the principal sponsor? Motion is to Table Senate Bill 366. Discussion? All in favor say Aye. Opposed Nay. The Ayes have it. The bill is Tabled. Resolutions. SECRETARY:

Senate Joint Resolution No. 30 offered by Senator Savickas.

(Secretary starts to read title SJR 30)

PRESIDING OFFICER: (SENATOR BRUCE)

May we have some order, please. This is the adjournment resolution which will bring us back next week, you may want to know when to come. Mr. Secretary.

SECRETARY:

(Secretary finishes SJR 30)

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Savickas.

SENATOR SAVICKAS:

I move its adoption.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Savickas moves to suspend the rules for the immediate consideration and adoption. On the motion to suspend, all in favor say Aye. Opposed Nay. The Ayes have it. The rules are suspended. On the motion to adopt, discussion? All in favor say Aye. Opposed Nay. The Ayes have it. The adjournment resolution is adopted. Further business? Senator Davidson.

SENATOR DAVIDSON:

Mr. President, a point of personal privilege.

PRESIDING OFFICER: (SENATOR BRUCE\$)

State your point.

SENATOR DAVIDSON:

I'd like to introduce to the members of the Senate the officers and the counselors from the Illinois Association of Vocational-Industrial Clubs of America who are having their olympic skills and skill tests going on starting tonight over at the Prairie Convention Center for the next three days. And they are accompanied by their chairman of the board, Mr. Ray Neiswander, from Sterling...or Dixon, Illinois and Joyce Rogers from here in Springfield, Illinois.

PRESIDING OFFICER: (SENATOR BRUCE)

#### SECRETARY:

Senate Resolution 121 offered by Senator Kent.

PRESIDING OFFICER: (SENATOR BRUCE)

Resolution Consent Calendar. Alright. Is there leave to go to the Order of the Resolution Consent Calendar? Leave is granted. Resolution Consent Calendar. Mr. Secretary, have any Senators filed objection to any of the Senators on the Resolution Consent Calendar?

#### SECRETARY:

No objections have been filed, Mr. President.

PRESIDING OFFICER: (SENATOR BRUCE)

No objections being filed, Senator Kelly moves the adoption of the Resolution Consent Calendar. Those in favor say Aye. Opposed Nay. The Ayes have it. The resolutions are deemed adopted. Any further business to come before the Senate? Any further business? Senator Berman moves that the Senate stand adjourned until the hour of noon on Tuesday, April the...April the...no, that's right, we have perfunctory tomorrow. We adjourn and come back the 26th. Pursuant to the adjournment resolution, Senator Berman moves that we stand adjourned until 9 a.m. tomorrow for a perfunctory Session. On the motion to adjourn until 9 a.m. tomorrow, all in favor say Aye. Opposed Nay. The Ayes have it. The Senate stands adjourned until 9 a.m. tomorrow.
