Senator Rupp, for what purpose do you arise? SENATOR RUPP:

Thank you, Mr. President, a point of personal...privilege, please.

#### PRESIDENT:

State your point, sir.

# SENATOR RUPP:

In the gallery are a group of eighth grade students also from St. James with the teacher, Boy Pollard. Father Adamski gave the opening prayer and I have to mention this because I...in talking to some of the youngsters about this, I was real proud of the fact that here, I said, "you know and the Pather is going to give the opening prayer." And the one student looked at me as if to say, well, you know, we hear him a couple of times every day, what's so great about that? #### SENATOR BLOOM:

Thank you, Mr. President. If we could go to the order of business and get SJE 98 read a second time, please.

# PRESIDENT:

The Senator has requested leave to go to the Order of Constitutional Amendments 2nd Beading, top of page 6 on the Calendar. Is leave granted? Leave is granted. On the Order of Constitutional Amendment on 2nd Beading is SJR 98. Mr. Secretary, read the resolution.

#### SECRETARY:

House Joint Resolution 98...Senate Joint Resolution 98

(Secretary reads SJR98CA)

2nd reading of Senate Joint Besolution 98 Constitutional Amendment.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

Resolutions. With leave of the Body, we'll go to the Order of Secretary's Desk Resolutions. Is leave granted? Leave is granted. On the Order of Resolutions, Senate Resolution 496. Senator Lechowicz.

# SENATOR LECHOWICZ:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Senate... Resolution 496 is requesting of Doctor Irwin France a response from two public community meetings that we had in Chicago, one at the... from the Logans Court Neighborhood Association; the second being at the Grace Lutheran Church where members of the department... requested certain questions and they did not respond, they were supposed to get back to the community. I also wrote a letter to Doctor Irwin France dated February 2nd of 1984. He responded somewhat but some of the questions were still left

unanswered. The questions that are posed in Senate Resolution 496 request that he respond to the questions by the end of May. I think it's an area of trust and understanding that is being...trying to be adopted by the community associations and his department, and with the answer to these questions it will be a great aid and I move for the adoption of 496.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? If not, the question is, shall Senate Resolution...Senator Jones.

SENATOR JONES:

Yeah, thank you, Mr. President. Will the sponsor kindly tell me exactly what the resolution says?

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Lechowicz.

#### SENATOR LECHOWICZ:

I'll be more than happy to. Basically it's in the last resolve clauses by the Senate of the 83rd General Assembly of the State of Illinois. The Chicago Housing Authority is directed to compile information concerning the following questions which were raised at two public community meetings. What...(1) what will happen to the residents who will be displaced by the establishment of the public housing facilities; (2) the extent to which the eligible residents of the community in which a new public housing facility will be established will be accorded a priority for housing in that facility over persons who are not residents of that community; (3) what is the geographic boundary which determines whether a person is a resident of the area entitled to preferential treatment for the public housing; (4) whether the extent to which the eligible person that was displaced by the new facility will be accorded additional preference; (5) how the new housing will be allocated among families, senior citizens and single individuals; (6) what limitations, if any, will be placed upon the number of individuals who may occupy an

apartment or a room in a new facility; and (7) any other relevant information that the Authority is...is able to provide; and be it further resolved, that the matter be responded to by May 31st of 1984.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Jones.

# SENATOR JONES:

Thank you, Mr. President. Speaking to the resolution to let the sponsor know that the Legislative Investigative Commission responded to two similar resolutions and held hearings: they're still working on that particular matter. How...however, it was discussed by then the acting executive director in reading the court order indicating that it is okay if the agency so decides that they want to deal with various community groups; however, they do not have to if they don't want to. I heard you in your comments mention Doctor Irwin France but, as you know, the ... the CHA has just appointed a new director...executive director; Doctor France was no longer with CHA, and I really think the resolution is not needed because even though CHA is a creature of the State, its actions are directed by the court. And for us to be passing a...a resolution trying to circumvent a Federal court order is actually really foolish on our part. I don't think this resolution should even be considered.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? Senator Chew. SENATOR CHEW:

Well...thank you, Mr. President. I don't believe that the General Assembly has the moral right let alone a legal right to interfere with an agency that is in effect being directed by the Federal courts. All of us are aware of what has happened with the Chicago Housing Authority, and we're further aware of the division and attitudes and persuasions as to what this resolution does. I suppose the resolution is

put in to get some flowery coloring on what I attempted to do. We know it has no binding effect because the Legislature, in fact, cannot dictate to the "Chicago Housing Authority" which is, in fact, funded elsewhere. We have just confirmed a new director. The Federal judge has mandated the Chicago Housing Authority for things certain and of course, time certain. The resolution is of no value. We should not be taking your valuable time discussing it, and I would ask the sponsor to respectfully take it out of the record so we could get on to the business of what we're here for. And let me hasten to add, the sponsor of this resolution is not only a personal friend of mine but he's a gentleman and I admire him, and this is as sincere as I could be. I understand why the resolution is here, but I just happen to peacefully disagree with him.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Lechowicz.

#### SENATOR LECHOWICZ:

Well, Mr. President, Ladies and Gentlemen of the Senate, in response to the...individuals who spoke in question Senate Resolution 496, I am quite familiar with the Federal court's rulings and their guidelines. But I think that there's a responsibility also as far as when you have two public meetings and questions were raised and the questions were supposed to be responded to and I, in good faith, write...write the director asking him to respond to the questions a month after the public hearings. February 2nd of 1984 I wrote that letter, again, congratulating the director as far as in this task and wishing him well in a very difficult task that he's been assigned, hoping to work with him to promote the necessary understanding that is needed; and in...in that vein, these questions were asked and they were not responded to. All we're trying to do is to get a response to the questions that were raised at two community hearings in our area. I don't believe that's being unjust, I don't believe it's being unduly critical of any agency or of any director. All we're trying to do is have the people's questions responded to, and that's all this resolution does. And anyone who is opposed to this resolution hased upon an understanding of a response to a question is in total error. There shouldn't be one No vote against this resolution, and I would...encourage your consideration and support in Senate Resolution 496.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

The question is, shall Senate Besolution 496 be adopted. Those in favor indicate by saying Aye. Those opposed. The Ayes...a roll call requested. The Ayes have it and Senate Resolution 496 is adopted. Yes, Senator Chew, do you seek recognition?

# SENATOR CHEW:

Mr. President, if you're going to rule on the Nay and Aye, you know the Nays had this; and if you're going to rule in that arbitrary manner, I would be less than candid if I were not to call for a roll call. I would accept the fact that you had a tie vote...

## PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator, my hearing is excellent, if two other Senators join Senator Chew he's entitled to the roll call.

#### SENATOR CHER:

I think I have two other Senators here will ...

PRESIDING OFFICER: (SENATOR SAVICKAS)

I only see one, Senator: I see two now.

# SENATOR CHEW:

...we'll ask for a roll...I didn't really want it to come to that.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

Chicago's chief supporter, Senator Hall, has joined you in this request.

# SENATOR CHEW:

You know very well that you should rule that it's a tie vote and we'll all laugh about it.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

On Senate Resolution 496, those in favor will vote Aye. Those opposed vote Nay. The voting is open. Right. On that...has...have all voted who wish? Have all voted who wish? Take the record. On that question, the Yeas, and my hearing must have been correct, is 37, the Nays are 5. Senate Resolution 496 having received the required majority vote is declared adopted. Mr. Secretary, do we have further resolutions?

#### SECRETARY:

Senate Resolution 567...offered by Senator Lemke. It's congratulatory.

Senate Resolution 568, by Senators Lechowicz, Nedza, Rock and all members and it's commendatory.

Senate Resolution 569, by Senator Becker. It's congratulatory.

Senate Resolution 570, by Senator Maitland. It's congratulatory.

Senate Resolution 571, by Senator Schuneman. It's congratulatory.

And Senate Resolution 572, by Senator Savickas and it's congratulatory.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

Consent Calendar. With leave of the Body, we'll return to page 2 of the Calendar on Senate bills 2nd reading. Is leave granted? Leave is granted. We have two bills that must be moved, these are the Treasurer's bills, Senate Bill 1456 and Senate Bill 1457. Senator Egan.

#### SENATOR EGAN:

Thank you, Mr. President and members of the Senate. I move that we advance the bills from 2nd reading to 3rd.

There is no amendment from the committee and there's no amendment from the Floor that I know of. The Senate Eill 1456 amends the...several Bond Acts to delete the requirement that the Treasurer compute the amount of principal and interest on bond payments and requires the Treasurer to verify the computation of the Comptroller. It's an administration of the Treasurer's Office bill. I know of no objection and I ask that it be moved from 2nd to 3rd.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Mr. Secretary, would you read the bill.

SECRETARY:

Senate Bill 1456.

(Secretary reads title of bill)

2nd reading of the bill. No committee amendments.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Any...any amendments from the Floor?

SECRETARY:

No Floor amendments.

PRESIDING OFFICER: (SENATOR SAVICKAS)

3rd reading. House...Senate Bill 1457.

SECRETARY:

Senate Fill 1457.

(Secretary reads title of bill)

2nd reading of the bill. No committee amendments.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Any...any amendments from the Floor?

SECERTARY:

Amendment No. 1 offered by Senator Egan.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Egan.

SENATOR EGAN:

Thank you, Mr. President and members of the Senate. The amendment includes credit unions along with savings and loans and banks which is totally acceptable to the Treasurer and I

move its adoption.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there any discussion? Senator Fawell.

#### SENATOR FAMELL:

Thank you, Mr. President. Could you explain why we shouldn't notify the banks or is this just a technical...till

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Eqan.

#### SENATOR EGAN:

No, we do notify the banks. This also requires notification to the savings and loans and now credit unions with this amendment. It's a month...or a yearly notification. The reason for the bill is to allow the Treasurer to notify them when he has available funds. The need...the...the present law requires him to...to do it automatically, this gives him the discretion when he has the funds. For some time we...he hasn't had enough funds and it's been really a waste of notice.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there further discussion? If not, Senator Egan moves the adoption of Amendment No. 1 to Senate Eill 1457. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. Amendment No. 1 is adopted. Any further amendments?

#### SECRETARY:

No further amendments.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

3rd reading. With leave of the Body, Senate Bill 1456 was moved and there was an amendment on the Secretary's Desk. So with leave of the Body, we ask leave to bring it back from 3rd to the Order of 2nd Beading for the purpose of amendment. Is leave granted? Leave is granted. Mr. Secretary.

#### SECRETARY:

Amendment No. 1 offered by Senator Lechowicz.

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Lechowicz.

#### SENATOR LECHOWICZ:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. Amendment No. 1 deletes the requirement that the State Treasurer verify the amount of bond principal and interest. It requires that the Comptroller to certify to the State Treasurer the amount of bond principal and interest. It's a corrective amendment and I move for its adoption.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there any discussion? If not, Senator Lechowicz moves the adoption of Amendment No. 1 to Senate Bill 1456. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. Amendment No. 1 is adopted. Any further amendments?

#### SECRETABY:

No further amendments.

PRESIDING OFFICER: (SENATOR SAVICKAS)

3rd reading. We also have a request from Senator Smith on Senate Bill 1585. Monies must be expended shortly and Senate Bill 1585 should be moved. With leave of the Body, we'll call on Senate Bill 1585. Read the bill, Mr. Secretary.

## SENATOR SCHAFFER:

...Mr. President, I rise for the purpose of making a motion to discharge the Committee on Agriculture from hearing Senate Bill 1381 and to have that reassigned to the Committee on Executive. It's a bill that was heard last...an amendment to a bill that was heard last year in Executive. I've talked to both chairmen and...chairman of the Committee on Assignment of Bills and I don't believe there's any objection.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard the motion. Is leave granted? Leave is granted. With leave of the Eody, we'd like to move to the Order of House Bills 2nd Reading. Is leave granted? Leave is granted. On the Order of House Fills 2nd Feading, House Bill 2353. Senator Rock.

PRESIDING OFFICER: (SENATOR SAVICKAS)

PRESIDING OFFICER: (SENATOR SAVICKAS)

Senator Rock.

# SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the

Senate. Senate Joint Resolution 107 is the adjournment resolution. We will...when we conclude our business today, we will return to Springfield Monday, at the hour of noon. I would ask the members...I will shortly distribute a schedule of committee...proposed committee hearings. I'd ask the committee chairmen to post all the bills that they have received from the Rules Committee so that they can be heard. Friday, May 4, is the final day to consider Senate bills in the Senate committee. So next week will be a...hopefully not a long one but a very intense one. And Friday we will attempt to conclude our business as quickly and as early as possible. But we have deliberately left Friday morning and Friday afternoon open in the event that some of the committees need additional time to conclude their work and to afford the members an opportunity to have their bills heard. But it's absolutely essential that we return to Springfield on Monday, April 30, at the hour of noon. I'd move to suspend the rules for the immediate consideration and adoption of Senate Joint Resolution 107.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

You've heard the motion. Any discussion? If not, the question is, shall Senate Joint Resolution 107 be adopted. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. The resolution is adopted. Mr. Secretary, have any objections been filed to the Consent Calendar? SECRETARY:

No objections have been filed, Er. Fresident, but we have added Senate... Resolution 567, 568, 569, 570, 571, 572 and House Joint Resolutions 139, 140 and 141 with the consent of the Body.

# PRESIDING OFFICER: (SENATOR SAVICKAS)

Is there any objection to the new numbers that have just been read by the Secretary on Resolutions No. 567, 568, 571 and House...569, 570 and 572, plus...House Joint Resolution

139 and 140 and 141? If there are no objections, Senator Demuzio moves for the adoption of the resolutions on the Consent Calendar. Those in favor indicate by saying Aye. Those opposed. The Ayes have it. The Consent Calendar resolutions are adopted. For what purpose does Senator Berman arise?

PRESIDING OFFICER: (SENATOR SAVICKAS)

State your point.

# SENATOR EERMAN:

...few short moments. We have just adopted Senate Resolution 557 introduced by Senators Carroll, Marovitz and myself and all Senators. This morning, at eleven o'clock at State Capitol we had our annual observance commemorating the Holocaust. This was a one hour service and I felt that it's important before we leave this Chamber go back to our districts and to our homes and to our families take a second to reflect. That one hour just to service...and I, on behalf of Senators Carroll, Marovitz and myself, we want to thank Senators Rustra and Kelly and Smith who were able to break away from their other duties and join us. It allowed us in our helter-skelter busy agendas to take one hour of reflection to think about one of history's darkest moments. It's important in these days, and even today as the Governor so aptly stated in his comments at the commemoration meeting, that even though the is...memoralized one week each year, there are still many instances of blatant genocide, blatant inhumanity of man to other men that we see almost every day. We appreciate the opportunity to hold this memorial service in the Capitol of our State. We will be holding it again next year, and I just wanted to impose upon each of your times for this short few seconds to allow each of us to remember those terrible days of the Holocaust, not only of the six million Jews that perished only because they were Jews, but of the five million non-Jews that also died at that same period of time. And it is with this type of remembrance that we hope that more of you will be able to join with us next year to take a moment to reflect upon this very terrible period in our history. Thank you, Mr. President.

#### SENATOR EECKER:

# SENATOR MAROVITZ:
