PRESIDENT:

PRESIDENT:

Thank you, Father. Reading of the Journal.

PRESIDENT:

Senator Luft.

SENATOR LUFT:

Mr. President, I move that the Journals just read by the Secretary be approved unless some Senator has additional...additions or corrections to offer.

You've heard the motion as placed by Senator Luft. Any discussion? If not, all in favor signify by saying Aye. All opposed. The Ayes have it. Motion carries. It's so ordered. Senator Luft.

PRESIDENT:

Senator Collins, for what purpose do you arise?

SENATOR COLLINS:

Point of personal privilege.

PRESIDENT:

State your point. May we have some order.

SENATOR COLLINS:

Yes, I...

PRESIDENT:

Will the members be at their desks. Yes, Senator Collins.

SENATOR COLLINS:

...yes, Ladies and Gentlemen of the Senate, I would just like to take this opportunity to introduce two of our most distinguished aldermens in the City Council of Chicago and newly elected Democratic committeemens, Alderman Edward Smith of the 28 Ward, which is in my senatorial district, and Alderman Wallace Davis who is also in my senatorial district.

PRESIDENT:

Welcome to Springfield. Senator D'Arco, for what purpose do you arise, sir?

SENATOR D'ARCO:

Well, I just would acknowledge that, you know, Wallace Davis is one of my ward committeemen in the district that I run in too, and I...you know, I just...I want to make that on the record, you know.

PRESIDENT:

Alderman Davis and his constituents are well represented. The record will so reflect. All right, with leave of the Body, we're going to move to the Order of Senate Bills 3rd Reading, if...I can have your attention. There has been a request from Senator Margaret Smith. Turn to the bottom of page 4 and with leave of the Body, we'll move to the Order of Senate Bills 3rd Reading, Senate Bill 1585. Leave having been granted, we're on the Order of Senate Bills 3rd Reading, Senate Bill 1585. Read the bill, Mr. Secretary.

SECRETARY:

Senate Bill 1585.

(Secretary reads title of bill)

3rd reading of the bill.

PRESIDENT:

Senator Smith.

SENATOR SMITH:

Thank you, Mr. President and members of the Senate. This is a urgent matter and so I'm asking for your consideration here to recreate the Aldelbert Roberts Memorial Statue Committee which expired 12-1-83. The committee expired 12-1-83 has thus been able to pay bills which came due after that date, and the committee has been recreated to extend to 9-31-84 to allow us to expend its appropriations to pay its bills before the unveiling of the statue. The legislation is identical to the original formation of the committee except that the repeal date is changed to 9-31-84. I ask for your consideration for the passage of this legislation.

PRESIDENT:

Is there any discussion? Any discussion? If not, the question is, shall Senate Bill 1585 pass. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 53, the Nays are none, none voting Present. Senate Bill 1585 having received the required constitutional majority is declared passed. Further business to come before the Senate? Senator Savickas, for what purpose do you arise?

SENATOR SAVICKAS:

Yes, Mr. President, I'd like the record to show that Senator Lechowicz was absent April 30th, Monday, on official business.

PRESIDENT:

The record will so reflect. Senator Becker, for what purpose do you arise?

SENATOR BECKER:

Thank...thank you, Mr. President. I request that the following Senators be shown as hyphenated sponsors to Senate Bill 1853: Senators Rock, Weaver, DeAngelis, Philip, Davidson and Grothberg.

PRESIDENT:

You've heard the request. I'm not sure how I got in that grouping, but you've heard the request. Is leave granted? Leave is granted. Senator Geo-Karis, for what purpose do you arise?

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I would like to add as a hyphenated cosponsor to my Senate Bill 1613 Senator Lechowicz.

PRESIDENT:

Heard the request...request leave to add Senator Lechowicz to Senate bill...hyphenated cosponsor of Senate Bill 1613. Is leave granted? Leave is granted. It's so ordered. Further business to come before the Senate? Senator Berman, for what purpose do you arise, sir?

SENATOR BERMAN:

Thank you, Mr. President. I would ask for leave to add Senator Jones as a cosponsor on Senate Bill 1855.

PRESIDENT:

1-8-5-5, the gentleman has requested leave to show Senator Jones as a cosponsor. Is leave granted? Leave is granted. Further business to come before the Senate? Senator Marovitz, for what purpose do you arise?

SENATOR MAROVITZ:

...thank you, Mr. President and members of the Senate. I would like Senate Bill 1725 to read Marovitz-Lemke-Lechowicz. How about that, huh? How about that for a parlay?

PRESIDENT:

All right, you've heard the gentleman's request. Senate



Bill 1725, Marovitz-Lemke-Lechowicz. Is leave granted? Leave is granted. Senator Newhouse, for what purpose do you arise?

SENATOR NEWHOUSE:

Thank you, Mr. President. I ask leave to have Senator Marovitz added as hyphenated cosponsor on Senate Bill 1797.

PRESIDENT:

1-7-9-7, the gentleman has requested leave to show Senator Marovitz as a hyphenated cosponsor. Is leave granted? Leave is granted. It's so ordered. Any further business to come before the Senate? Senator Philip.

SENATOR PHILIP:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I'd like the record to show that Senator Grotberg is in Washington D.C. on State business.

PRESIDENT:

The record will so reflect. Senator Nedza.

SENATOR NEDZA:

Thank you, Mr. President. I'd...I'd like to make an announcement that the Local Government Committee will meet immediately at the...the ending of the procedures and...

PRESIDENT:

All right, committees are scheduled, Executive at two o'clock, Judiciary I at two o'clock and Local Government, Room A-1, Room 400 and Room 212. Further business to come before the Senate? Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I would like to withdraw as lead sponsor and be a hyphenated sponsor to Senator Sommer as lead sponsor of House Bill 2689.

PRESIDENT:

2689. All right, Senator Sommer will be shown as the Senate sponsor of 2689 hyphenated with Senator Geo-Karis. Is leave granted? Leave is granted. Any further business to

come before the Senate? If not, Senator D'Arco moves that the Senate stand adjourned until Wednesday...tomorrow, Wednesday, May 2nd, at the hour of one o'clock in the afternoon. One o'clock tomorrow. Senate stands adjourned.
