## PRESIDENT:

Senator Newhouse, for what purpose do you arise?
SENATOR NEWHOUSE:

...on a point of, I guess, personal privilege, Mr. President.

## PRESIDENT:

Could we have your attention, please. Senator Newhouse. SENATOR NEWHOUSE:

Mr. President, in our Higher Ed. Committee this morning we had a bill which apparently has a duplicate down in Appropriations, it was a Higher Education bill. And I come to find out that there are more than one bill in that Appropriations Committee that are really substantive bills and should have been heard in Higher Ed. rather than in Appropriations. I know the day and hour is late and I'm certainly not asking for another... Higher Ed. meeting, but I would like to register, on behalf of my committee, how concerned that there was this kind of mix-up which certainly proved embarrassing to us and particularly when we have to go into Appropriations this afternoon to vote on a duplicate bill that we acted on in Higher Ed. this morning. So, Mr. President, I wanted to register that and get it into the record because it's the kind of an error, it seems to me, that is a serious one and it should not happen again.

### PRESIDENT:

Senator Bloom, for what purpose do you arise? SENATOR BLOOM:

Thank you, Mr. President. Senator Geo-Karis is...would like to add her as a hyphenated cosponsor after Bloom and Sangmeister on...Senate Bill 1793.

## PRESIDENT:

All right. Senate Bill 1793, Senator Geo-Karis seeks leave to be added as a hyphenated cosponsor. Leave granted? Leave is granted. Senator Bruce, for what purpose do you arise?

## SENATOR BRUCE:

Thank you, Mr. President and members of the Senate. One of my bills has been questioned by the chairman of the Higher Education Committee, and I think the Body ought to have some response as to what happened to that particular bill since it appears that I have made the error and no one else. I have introduced to this Body two separate, distinct community col-

lege funding bills because there were two distinct and arate approaches to how we should fund community colleges. On the day in which one of my bills was assigned, I, unfortunately was called to another meeting and Senator Savickas was alone in assigning bills. Because I was not there, the bill through my error was assigned to another committee. I have another bill of the same number, 1395 and 1595, those two bills in...because of me, I didn't catch the difference between 1595 and 1395 until late this morning, and because of that, I did not ask that they be reassigned. And so, because of that, 1395, 1595, 1596, and unfortunately the bill that is in controversy is 1906, all the bills together led to some confusion. That was all it is, no one had any intention of assigning or not assigning the bills to the appropriate committees. I am happy as a member...the member of the Higher Education Committee to meet today, tonight, tomorrow morning, Thursday morning, Thursday night, Friday morning, Priday night and have those bills heard in tandem. I told that to committee this morning. It was my error in not watching where it went to. When I saw the assignment of 1395 to Higher Education I assumed it was 1595. It was not, that is my error, I should have watched my appropriate...my bills more closely. But honest, guys, there are a few mistakes made around here, I made this one, I apologize.

## PRESIDENT:

All right. Senator Netsch, for what purpose do you arise?

### SENATOR NETSCH:

Thank you, Mr. President. I request with the sponsor's permission that I be added as a hyphenated cosponsor on Senate Bill 1653 with Senator Jeremiah Joyce.

### PRESIDENT:

Senator Netsch seeks leave to be added as a cosponsor of Senate Bill 1653. Is leave granted? Leave is granted.

Senator Maitland.

### SENATOR MAITLAND:

Thank you, Mr. President. On the same subject, I m the sponsor presently of Senate Bill 1223 and I...I would like the sponsorship of that bill changed to read Maitland-Savickas-Schuneman.

### PRESIDENT:

The number, sir?

## SENATOR MAITLAND:

Senate Bill 1223.

### PRESIDENT:

Senate Bill 1223, the Senator seeks leave to show it as Maitland-Savickas-Schuneman. Is leave granted? Leave is granted. So ordered. Resolutions.

#### SECRETARY:

Senate Resolution 576 offered by Senator Kustra. It's congratulatory.

And Senate...Resolution 577, by the same sponsor and it's congratulatory.

## PRESIDENT:

Consent Calendar. Senator Kelly, for what purpose do you arise?

### SENATOR KELLY:

Thank you, Mr. President, members of the Senate. I'd like to move to recede from Senate Amendment No. 1 to House Bill 2305.

### PRESIDENT:

All right, if you'll turn to page 13 on the Calendar, the gentleman has asked leave to go to the Order of Secretary's Desk Nonconcurrence. Is leave granted? Leave is granted. On the Order of Secretary's Desk Nonconcurrence is House Bill 2305. Senator Kelly.

## SENATOR KELLY:

Thank you, Mr. President. Senate Amendment No. 1 would

make it...optional for all units of government to pick up their employees IMRP as of July 1, 1984 and then pass this expense on to their employees as a salary deduction. what the House sponsor intended was to have this be the case for all units of government except school districts which are already paying the IMRF for their employees. The County Problems Commission, which sent each member of this Body a letter explaining this information, initiated this bill and asked me to withdraw the Senate amendment, as did the House sponsor. The counties want this bill because they feel it will clarify their responsibilities on the IMBF law which goes into effect on July 1, 1984. The county governments also consider this bill to be an emergency matter, and I therefore renew my motion to recede from Senate Amendment No. to House Bill 2305 and I solicit your support. I do believe, Mr. President, this is final action, and I'd like that to bring it to the attention of the members; and also as far as I...I know, that...everyone is on board now and I don't know of any opposition to this bill or to the motion. PRESIDENT:

All right. Senator Kelly has moved that the Senate recede from Senate Amendment No. 1 to House Bill 2305. discussion? Senator Buzbee. Is there any discussion? If not, the question is, shall the Senate recede from Senate Amendment No. 1 to House Bill 2305. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes are 57, the Nays are none, none voting Present. The Senate does recede from Amendment No. 1 to House Eill 2305 and the bill having received the required constitutional majority is declared passed. Senator Kelly.

## SENATOR KELLY:

Thank you, Mr. President and members. I'd like to ask

leave now to be added as a hyphenated sponsor on Senate Bill 1781 in which Senator Collins is the principal sponsor. I talked to her and like leave of this Body.

### PRESIDENT:

All right. The gentleman has requested leave to be shown as the cosponsor of 1781, Senate Bill 1781. Leave granted? Leave is granted. Senator Buzbee, for what purpose do you arise?

## SENATOR BUZEEE:

Thank you, Mr. Fresident. I would also request leave to be added as a hyphenated cosponsor of Senate Bill 1385. Senator Carroll was the principal sponsor.

## PRESIDENT:

1385, the gentleman has requested leave to be shown as the hyphenated cosponsor. Is leave granted? Leave is granted. Turn to page 10 on the Calendar. With leave of the Body, we'll move to the Order of House Bills 1st Reading. I'd ask the members to indicate to the Secretary their willingness to sponsor. #### PRESIDENT:

Senator Vadalabene, for what purpose do you arise?
SENATOR VADALABENE:

Yes, Mr. President, in the form of an announcement.
