Yes, the first amendment struck lines 7 through 27, which took away the penalties of removing the driver's license, and it also requires the explanation of parking space assigned for handicapped to be posted with the logo. It also requires the posting of the minimum penalty for violation of parking space upon conviction. I move for the adoption of the amendment.

### PRESIDING OFFICER: (SENATOR JOHNS)

Senator Macdonald has moved for the adoption of Amendment No. 1 to...Committee Amendment No. 1 to Senate Bill 533. All those in favor vote Aye. Those opposed Nay. The Ayes have it. The amendment is adopted. Senator...Senator Macdonald. SENATOR MACDONALD:

Amendment No. 2 is an amendment which requires the posting of the notice at all entrances to private parking lots, when such lots are subject to police traffic enforcements. They are to indicate the law enforcement jurisdiction so that the motoring public will know that traffic laws and enforcement agencies will be enforcing the traffic regulations on those premises. I move for the adoption of the amendment.

#### SENATOR FAWELL:

Thank you, Mr...Chairman. This is an amendment to expand the handicapped license plates to allow persons with such diseases as emphysema or heart conditions who find it difficult to be outside in the cold to apply for these plates, so they can park closer to the stores and restaurants. Presently, the law only covers amputees and persons confined to wheelchairs. I have talked to the director of Public Health, Bill Kempner, and to the Secretary of State, Jim Edgar, about this and they liked the idea, but they wanted this language so they could set up a medical advisory committee and set the rules.

## PRESIDING OFFICER: (SENATOR JOHNS)

Any discussion of the amendment offered by Senator...If not, Senator Fawell moves for the adoption of the amendment. All those in favor vote Aye. Those opposed Nay. The Ayes have it. The amendment is adopted. Any further amendments? SECRETARY:
