Johnson, Jr. Captain William Forsythe the...U.S. Navy Reserve. Brigadier General Ralph A. Bush, Assistant...Adjutant General of Springfield. Charles M. Daniels, Commanding Master Chief, U.S. Naval Training Center, Great Lakes, Illinois. And Captain Paul Lawrence Grundo, Commanding Officer of the Naval Administration Command of the Great Lakes, Illinois. Colonel John W. Johnson, Administrative Assistant to the Adjutant General of

Camp Lincoln, Springfield, Illinois. Mr. Warren Purcell, the past National Vice-president of the Navy League of the United States, Springfield, Illinois. The Memorial Day poem will now be presented by Senator Margaret Smith. Senator Smith. SENATOR SMITH:

Mr. Chairman, Ladies and Gentlemen of the Senate, William J. Acker, a ninety-one year old self-taught poet was born and raised in...on a farm in Waterloo, Illinois. Acker saw service in the Army first in the Quartermasters Corp in Texas, and in the border patrol under General John J. Perishing in 1916 and 1917, and later in World War I as a Warrant Officer in France. Asked by the Veterans' Administration to write a commemorative poem for veterans everywhere on Memorial Day, Acker said he had just the thing. After flipping through a well-thumbed black scrapbook of his poetry, he retrieved and updated a poem he had written in 1941, entitled "Memorial Day."

The director of the Illinois Department of Veterans' Affairs, David Hardwick, is here. David Hardwick. You may be seated. The honor of introducing our guest speaker today will be Senator Adeline L. Geo-Karis.

SENATOR GEO-KARIS:

Senator Vadalabene, President Rock, Minority Leader, Senator Philip, distinguished guests and Ladies and Gentlemen, it's truly an honor for me to present the guest speaker of this morning's ceremonies. He is a gentlemen who came up in the ranks in the U.S. Navy. He enlisted in May of 1945, he attained the rate of Chief Personnel Man in 1953. During his...enlisted service, Captain Highland served two

short...tours at Great Lakes, and his seat tours were in the...on the USS Albany and the USS Wisconsin. He was selected for direct commission status under the integration program in 1956. After commissioning in August 1956, Captain Highland was assigned to the Battleship USS...Iowa as Personnel Officer followed by duty as a Deck Division Officer in the Aircraft Carrier USS Valley Forge, and as Executive Officer of the Minesweeper USS Stalwart. His fine duty is so much that it would take me about an hour to mention all it, but let me say that he is not only a fine naval officer but also a very...community-minded, and well-spirited, and highly honored, and highly respected citizen of Lake County. Captain Highland is married to the former Marjory Smith of Lexington, Kentucky, and he and his wife currently reside in quarters at the Naval Training Center at Great Lakes, which is in my 31st Senatorial District. They have two children, Charles Jr. of Pensacola, Florida, and Jeff of Virginia Beach, Virginia. During his career, Captain Highland has been awared the following declarations: The Legion of Merit, Meritorious Service Medal, Navy Commendation Medal with Combat Five...V, Combat: Action Ribbon, Navy....Good Conduct Award, American Theater Service Medal, World War II Victory Medal, National Defense Medal, Vietnam Service Medal and the Vietnam Gallantry Cross. I...it really is a privilege for me to introduce my neighbor, who has had an excellent career the Navy, and one of the few who has made it to the top as an enlisted man, none other than Captain Charles E. Highland, U.S. Navy to give us our address today.

CAPTAIN CHARLES E. HIGHLAND:
