Members of the Senate, it is my privilege to introduce to you Miss Illinois County Fair, Cheryl Hill, from Springfield, Illinois. And just to show you Senators that we in... Springfield grow pretty girls, we're the first county to have consecutive winners. Last year's winner was Vicki Johnson, from Sangamon County; this year Miss Sangamon County was Cheryl Hill who is now Miss Illinois County Fair Queen. Would you please welcome Cheryl Hill. Cheryl, on behalf of the members of the Senate, I'd like to present to you Senate Resolution 206 which is sponsored by myself and all other Senators here present in congratulating you on being chosen Miss Illinois County Fair Queen. SENATOR DAVIDSON:

And for those members of the Senate that have any problems needing something from the Illinois Fair, the man he was telling you to get a hold of is here on the Podium with me, the red-haired gentleman, Tom Dubnick. Tom. Senator Rock, thank you for the privilege of introducing Miss Hill to the members of the Senate.

PRESIDENT:

Senator Smith, for what purpose do you arise?
SENATOR SMITH:

Mr. President, for...I stand on a point of personal...I'm pleased to present to this august Body this morning some of my constitutents of my district, it is the District 11 Educational Council and Mrs. Adkins is the president. I'm asking them if they'd please stand to be received.

PRESIDENT:

Will our guests please stand and be recognized. Welcome to Springfield. Senator Jones, for what purpose do you arise?

SENATOR JONES:

Yeah, thank you, Mr. President. I'd like leave to have my name removed as sposnor of House Bill 528 and replace that with Senator Vince Demuzio.

PRESIDENT:

House Bill 528. The gentleman requests leave to show Senator Demuzio as the Senate sponsor. Is leave granted? Leave is granted. Senator Kelly, for what purpose do you arise?

SENATOR KELLY:

Mr. President, I'd also request leave to have Senator John Friedland become the principal sponsor of House Bill 1505 of which I have been up to now the principal sponsor.

PRESIDENT:

Senator Kelly, I'm...I'm sorry. Would you repeat your request.

SENATOR KELLY:

Yes, Mr. President. I'm the principal sponsor of House Bill 1505, and I request leave of the Senate to have... Senator John Friedland to become the principal sponsor of House Bill 1505.

PRESIDENT:

Okay. House Bill 1505. The gentleman request leave to show Senator Friedland as the chief sponsor. Leave granted? Leave is granted. It's so ordered. Senator Kent, for what purpose do you arise?

SENATOR KENT:

Point of personal privilege.

PRESIDENT:

State your point.

SENATOR KENT:

There's a young man this...this afternoon on the Floor of the Senate from the City of Macomb and I'd just like to have him recognized by the Senate, Andy Garretson.

PRESIDENT:

Andy, where are you? Stand up and be recognized. Melcome. Senator Dawson, for what purpose do you arise?

SENATOR DAWSON:

Mr. President, I ask to waive the posting rule on...Resolution No. 145 to be heard in Executive Committee today.

PRESIDENT:

Senate Resolution 145, the gentleman requests leave to waive the posting requirement. Is leave granted? Leave is granted. It's so ordered. Senator Degnan, for what purpose do you arise?

SENATOR DEGNAN:

Thank you. I'd like to add Senator Lemke as a cosponsor of House Bill 1762.

PRESIDENT:

1762, the gentleman requests leave to show Senator Lenke as a cosponsor. Is leave granted? Leave is granted. It's so ordered. Committee reports. Senator Vadalabene. Committee reports.

SECRETARY:

Senator Vadalabene, chairman of the Committee on Executive Appointments, Administration and Veterans' Affairs to which was referred to the Governor's Message of April the 27th, 1983, reports the same back with the recommendation that the Senate advise and consent to the following appointments.

PRESIDENT:

PRESIDENT:

Senator Vadalabene.

SENATOR VADALABENE:

I move that the Senate resolve itself into Executive Session for the purpose of acting on the Governor's appointments set forth in the Governor's Message of April 27, 1983. PRESIDENT:

You've heard the motion as placed by Senator Vadalabene.

Any discussion? If not, all in favor signify by saying Aye.

All opposed. The Ayes have it. The motion carries. The Senate is now in Executive Session. Senator Vadalabene.

SENATOR VADALABENE:

Yes, thank you, Mr. President and members of the Senate. With respect to the Governor's Message of April 27, 1983, I will read the salaried appointments to which the committee on Executive Appointments, Veterans' Affairs and Administration recommends that the Senate do advise and consent.

To be director of the Department of Agriculture for a term expiring January 21, 1985, Larry A. Werries of Springfield.

And to be director of the Department of Conservation for a term expiring January 21, 1985, David Kenney of Springfield.

Mr. President, having read the salaried appointments, I

now seek leave to consider these appointments on one roll call unless some Senator has objection to a specific appointment.

PRESIDENT:

You've heard the request. Is leave granted? It is without objection, Senator.

SENATOR VACALABENE:

Mr. President, will you put the guestion as required by our rules.

PRESIDENT:

Question is, does the Senate advise and consent to the nominations just made. Those in favor will vote Aye. Those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that guestion, the Ayes are 57, the Nays are none, none voting Present. The majority of the Senators elected concurring by record vote, the Senate does advise and consent to the nominations just made. Senator Vadalabene.

Yes, thank you, Mr. President and members of the Senate. I move that the Senate arise from Executive Session.

PRESIDENT:

You've heard the motion. Is...all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries. Senate does now arise. Senator Hudson, for what purpose do you arise?

SENATOR EUDSON:

Thank you, Mr. Fresident. Point of personal privilege.
PRESIDENT:

State your point, sir.

SENATOR HUDSON:

The other day, last Friday, I inadvertently voted on Senate Bill 1201, I realize this is no longer in possession of the...of the Senate, but my vote on Senate Bill 1201,

Senator Joyce's bill, was recorded as No, it should have been record as Yes. That's...would like that entered into the record.

PRESIDENT:

Motion in writing. I move to suspend rule...Senate Rule 7C posting requirement so that House bills...that all House bills in the Senate may be posted no later than Friday, June the 3rd, 1983, and may be heard in committee. Signed, Senator Bruce.

PRESIDENT:

Senator Bruce.

SENATOR BRUCE:

Thank you, Mr. President and members of the Senate. This is a similar motion to what we made when we had the Senate bills. This is to suspend the posting requirement so that all bills that will be posted by this Friday in committee can be heard next week. That still gives sufficient notice, we believe, to have everyone here that's interested in legislation. So, I would move the adoption of the...of the motion to suspend the rules for bills that are posted by Friday of this week to be heard next week.

PRESIDENT:

All right, Senator Bruce has moved to suspend the Six-day Posting Requirement to require...or to afford the opportunity to post bills up through Friday. Is leave granted? Leave is granted. Motion carries. I would point out to the member-

ship also, I have...take a look, if you will, at the House Calendar. There are five pages of Senate bills on 1st reading without House sponsors. Now, some of that may have changed since the House went in, but I would urge the membership to take a look and follow up on their Senate bills over in the House to make sure they are sponsored and taken off the Calendar and posted. Senator Hall, for what purpose do you arise?

SENATOR HALL:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I would like for the record to show that Senator Chew is absent on assignment in the City of Chicago for today.

PRESIDENT:

All right, the record will so reflect. Senator Chew is in Chicago on official business. Any further business to come before the Senate? Is there any further business to come before the Senate? Any announcements? Senator Watson, for what purpose do you arise?

SENATOR WATSON:

Just like to remind the Body that tonight is the annual legislative tennis tournament and we have reservations from the following Senators and anybody who is not read off here and is interested in playing, they should contact me...yet this afternoon. SENATOR LEMKE:

I make a motion that we'd like to move our committee meeting up to one-fifteen in Judiciary. We have many tills and this way we'll get done in time.

PRESTDENT:

All right, Senator Lemke has requested the members of the Committee on Judiciary I that they will meet at one-fifteen in Room 400. Senator Marovitz, for what purpose do you arise?

SENATOR MAROVITZ:

Thank you, Mr. President. Maybe Senator Nedza, if he's listening...Senator, would you raise your hand, I know you're here someplace.

PRESIDENT:

Senator...Senator Nedza.

SENATOR MARCVITZ:

Senator Nedza. I...is there a..there's supposed to be a chairty softball game and a practice, is that correct? Is there practice today? There's not a practice today? Okay. Forget about it.

PRESIDENT:

You ought to...send him a letter, will you? Any further business to come before the Senate? If not, those on Judiciary I will meet at one-fifteen, and the rest of us can go to lunch and meet at two o'clock. If there's no further business, Senator Hall moves that the Senate stand adjourned until Thursday, June 2nd, at the hour of noon. Tomorrow at noon. Senate stands adjourned.
