## SENATOR NETSCH:

Mr. President, I would like to have leave to have House Bill 2135 designated as Davidson hyphenated Fawell, and I would like to have Senate Bill 999...

### PRESIDENT:

House bill or Senate bill?

### SENATOR FAWELL:

---House bill, I'm sorry. House Bill 999, I'd like to be removed as the sponsor and have Senator Kustra in my place.
PRESIDENT:

Alright. House Bill 2135 will be shown pursuant to request...or pursuant to leave with Davidson-Fawell, and 999 as Kustra. Is leave granted? Leave is granted. It's so ordered. Senator Buzbee, for what purpose do you arise?

SENATOR BUZBEE:

Thank you, Mr. President. I'd like to be shown as a hyphenated cosponsor of House Bills 1259 and 1260.

### PRESIDENT:

1259 and 1260, show Senator Buzbee as a cosponsor. Is leave granted? Leave is granted. It's so ordered. Alright, the Resolutions Consent Calendar, with leave of the Body, we'll move to that order. Alright, the Resolutions Consent Calendar has been distributed, Senate Resolution 209, 210, 211, 212, 213, 214, House Joint Resolution 48. Four have been added as of today, House Joint Resolution 49, House Joint Resolution 55, Senate Resolution 215 and Senate Resolution 216. Mr. Secretary, have any objections been filed? SECRETARY:

No objections have been filed, Mr. President. PRESIDENT:

Alright, hearing no objection, Senator Bruce will move the adoption of Senate Resolutions 209, 210, 211, 212, 213, 214, 215, 216, House Joint Resolutions 48, 49 and 55. All in favor signify by saying Aye. All opposed. The Ayes have it. The Consent Calendar is adopted. Senator Welch, for what purpose do you arise?

### SENATOR WELCH:

Thank you, Mr. President. I would...like to...add as hyphenated cosponsors to House Bill No. 41, Senators Bloom and Senators...Senator Luft.

### PRESIDENT:

House Bill 41, show Senators Bloom and Luft as cosponsors. Is leave granted? Leave is granted. We have committees scheduled to begin at two o'clock.
