Senator Rock, for what purpose do you arise?

SENATOR ROCK:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. If I can have the attention of the membership. As you know, Friday of this week is the deadline to report House bills out of Senate committee. We have frankly been put at something of a disadvantage because the House Messages have been less than rapid in...in being...delivered to the Senate. Fact is, we have a number of House bills on the Order of 1st Reading, and I would ask at the conclusion of my remarks that we go to that order of business and ask the members to look through that list and to pick up or sponsor those bills that they have been requested to sponsor so that they will then be in a position to be in the Rules Committee and be considered by the Rules Committee tomorrow morning. Additionally, I've asked the Secretary to prepare a supplemental Calendar, Supplemental No. 1. This the last of the...we hope, the last House Messages containing substantive bills: hopefully, the last of the House Messages altogether on bills coming over from the House. So I'd ask you to look through both lists, pick up those that the House sponsor has requested that you pick up, and then be in a position to assess whether or not, in your judgment, they are of an emergency nature or necessary for the operation of government to be presented to the Rules Committee which will meet tomorrow morning. We will be meeting tomorrow morning at eight. We'll go into Session at nine and those bills that are reported out will then, we hope, be directed to the appropriate committees. It is our intent not to be here on Friday. So we will in the next couple of days have to obviously mechanically try to accommodate the members and the committees and try to hear as many bills as are posted. The only alternative is to be here on Friday, and I don't think that anybody wants to be here on Friday. So we will make an attempt...I've asked the chairman of the Agriculture and Energy Committee to hold a second meeting which he has consented to do on Thursday of this week. And any other committees that feel they're going to need more than one meeting will ... I wish they would, once the bills are assigned, let us know so we can attempt to reconstruct the schedule. But plan on the fact that we will not be here on Priday. So everything that has to be done ought to be done or hopefully will be done by Thursday at noon. With that, Mr. President, I'd ask you to go to page 4 on the Order of House Bills 1st Reading. Let's go through these.
