I'd like to place Bill Mahar...Senator Mahar and Senator Kustra as hyphenated cosponsors on Senate Bill 2516.

PRESIDING OFFICER: (SENATOR DEMUZIC)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Alright. You've heard the request. Is leave granted? Leave is granted. It's so ordered. Senator Sangmeister, for what purpose do you arise?

# SENATOR SANGMEISTER:

Yes, Mr. President, it's my understanding that this has all been agreed to, but House Bill 2726 has been assigned to Public Health and it should have been assigned to Judiciary II. So, my motion would be to remove the bill or discharge it from the Committee on Public Health, assign it to Judiciary II and waive the posting so that the bill can be heard in committee today.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

Alright. Senator Sangmeister moves to discharge the Committee on Public Health from House Eill 2726, have it assigned to Judiciary and rules are already waived. You've heard the request. Is leave granted? So ordered. Senator Lemke.

#### PRESIDENT:

Senator Demuzio, for what purpose do you arise? SENATOR DEMUZIO:

Yes, thank you, very much, Mr. President. #### SENATOR SAVICKAS:

Mr. President, members of the Senate, I rise for the purpose of rereferring House Bill 3165 from the Committee on Revenue to the Committee on Elementary and Secondary Education. It's a tax rate bill, they want to hear the tax rates in Elementary Education.

#### PRESIDENT:

Okay. You've heard the requests. House Bill 3165 to be rereferred from the Committee on Revenue to the Committee on Elementary and Secondary Education. Is leave granted? Leave is granted. It's so ordered. Senator Marovitz, for what purpose do you arise?

#### SENATOR MARCVITZ:

Mr. President, the Committee on State Government Reorganization has been assigned the implementing legislation for Executive Order 2. Can you give me some idea when you'd like the committee to meet? It's not on the Calendar, and I'd like the committee members to know since this is deadline week.

## PRESIDENT:

Well, I would suggest you confer with the members of the committee. The...Senate bill was held in the Senate. I expect the same result with the House bill. Alright, the committees are scheduled to meet at ten o'clock. Any announcements or further business to come before the Senate? Senator Vadalabene.

#### SENATOR VADALABENE:

Yes, thank you, Mr. President, in the form of announcement. The Committee on Executive Appointments will meet immediately after adjournment. We have two appointments to consider. We should be in there...we shouldn't be there very long, so please come down right after adjournment.

#### PRESIDENT:

Senator Philip, for what purpose do you arise?
SENATOR PHILIP:

Thank you, Mr. President. I'd like the record to show that Senator Macdonald is convalescing at home from high blood pressure.

#### PRESIDENT:

The record will so indicate. It would also indicate that Senator Chew is absent due to hospitalization. Alright, any further business to come before the Senate? Further announcements? Alright, copies of the Bules Committee report has been distributed. I'd ask the members to please check because, as you're well aware, we're under a deadline. Some of the bills have been assigned to committees that are meeting today, and so it's in your best interest to check and make sure. There's no further business to come before the Senate, Senator Bruce moves that the Senate stand adjourned until Wednesday...okay. Senator Collins, for what purpose do you arise?

## SENATOR COLLINS:
